PREFACE

This report describes a comprehensive study of the City of
Houston Police Department's selection, training, and promotional procedures. The report is divided into nine volumes
as follows:

Volume IV	Job Analysis of Positions within the Houston Police Department
Volume V	Evaluation of the Selection Requirements of the Houston Police Department
Volume VI	Validation of the Physical Requirements for the Selection of Police Officers
Volume VII	Validation of the Personal Background Require- ments for the Selection of Police Officers
Volume VII	Evaluation and Validation of the Houston Police Department Academy and Probationary Training Period
Volume IX	Validation of the Houston Police Department Promotional Process

While each volume is intended to stand alone as a unified component of the study, much of the data is referred to in several volumes, but presented in detail in only one volume. For example, the job analysis data reported in Volume IV

served as a foundation for the research described in Volumes V through IX. Consequently, at times the reader will need to refer to two or more volumes to obtain a comprehensive understanding of a specific component of the research.

It is expected that this report will be read by individuals who have a wide range of familiarity with the technical nature of the research study. Consequently, the authors have attempted to provide sufficient explanations of research methodology, statistical analyses, etc., to facilitate understanding by readers who do not have formal training or experience in the applied demographic and psychological research disciplines. At the same time, however, the authors have included appropriate technical information in the report, whereby professionals experienced in demographic and validation research can review the work of the research team.

Appendix A of Volume I is a comprehensive bibliography. The bibliography also contains detailed descriptions of reference materials cited or quoted (referred to by author and date) throughout all volumes of the report.

CHAPTER 1

SUMMARY

A combination of existing data on population, population migration and labor force participation has been used to develop an estimate of the majority and minority components of the Houston Area labor force. Figure 1 graphically illustrates the general analytical method used to update and factor 1970 Census statistics to produce estimates for 1975.

Estimates have been prepared for several geographic areas, including the overall recruiting area of the Houston Police Department which includes all counties within 500 miles of Houston. Table 1 shows the percentages of the minority components in the full time labor force, aged 18 to 35, for the recruiting area and for the Houston Standard Metropolitan Statistical Area (SMSA). Later tables include population and labor force breakdowns for other geographic areas at the time of the 1970 Census and estimates for 1975.

LABOR FORCE DEVELOPMENT FLOW CHART



CHAPTER 2

DEVELOPMENT OF THE ESTIMATES

Population by Group for 1971

The labor force statistics contained in this report are based upon estimates of the 1975 population and the participation of that population in the labor force within specific geographic areas. All estimates have been built upon base data provided by the 1970 Census. The selected portions of the labor force and the geographic areas chosen specifically focus on the groups that are of primary interest to the Houston Police Department in their recruiting activities. Estimates have been developed for the following groups of 18 to 35 year old males and females:

- Recruiting Area Group All males and females residing within 500 miles of Houston, Tables 2 and 7.
- Texas Area Group All males and females residing within 500 miles and within the State of Texas,
 Tables 3 and 8.
- Houston-Galveston/Texas City Area Group All males and females residing within the Standard Metropolitan Statistical Areas (SMSA's) designated for Houston and Galveston/Texas City, Tables 4 and 9.
- Houston SMSA Area Group All males and females residing within the Houston Standard Metropolitan Statistical
 Area, Tables 5 and 10.

• Houston City Area Group - All males and females residing within the city limits of Houston, Tables 6 and 11.

Individual county statistics were collected from the 1970 Census and aggregated for each geographic area, excepting the City of Houston area. The Recruiting Area and Texas Area were determined by plotting a 500 mile radius with Houston as a centerpoint on a standard map of the United States. The Recruiting Area covers parts of ten states and includes all counties (or parishes in Louisiana) that were totally or partially included within the 500 mile limit. Appendix A of this report lists the counties included, and Appendix B lists specific Census references.

Cohort Movement - Updating 1970 Population to 1975

Determining estimates of 1975 population from 1970 data requires the use of an aging process so that proportional population differences by age over time are considered. The data aging process, normally called cohort movement, was used to identify the 1970 Census individuals who correspond to the 18 to 35 age group in 1975. The following diagram illustrates the process:

The population cohorts were grouped by ethnic origin and sex so that the process provided a tri-ethnic population base by age and sex for 1975.

Migration

An additional consideration in estimating population involves the movement of people into and out of specific geographic areas. While detailed data for in and out migration is not available for each specific study area, the Bureau of the Census does provide a net migration estimate for counties in its Current Population Report Series.

Net migration data for 1970-1974 for the counties within the Recruiting Area in each state were aggregated and then projected to 1975. The total net migration for the Recruiting Area was allocated to the ethnic origin, sex and age cohorts based upon the 1970-1975 state migration patterns.² Similar procedures

Migration data from the 1970 census includes the total in and out migrants by age, sex and selected ethnic groups at the state level. Total population and Black population statistics are detailed. Consequently, the population group White and other races is determined by the difference between Black and the total population of migrants. The Hispanic net migration estimate is based on their percentage of the White and other population. Finally, the Hispanic estimates are subtracted from the White and other races to derive the White migration component. The percentage composition of the area migration for 1970 was applied to the estimated net migration between 1970-1975. The resulting migration by ethnic origin, sex and age cohorts was then added to the 1975 base population statistics developed by the cohort movement process to derive the 1975 population estimates.

were used to derive 1975 migration and population estimates for the other study areas. Net migration for the City of Houston is based upon Houston's portion of Harris County in-migrants between 1965-1970 and the Harris County net migration between 1970-1975.

Labor Force Participation

Two separate labor force statistics were determined to provide for an estimate of the size and composition of the labor force from which the Houston Police Department may recruit; the total labor force and the full time labor force.

The total labor force is the estimate of the number of all individuals who have an attachment to the labor market at a specific point in time. This estimate is based upon an analysis of the labor force participation rate of each population group with participation rate being defined as the percentage of the population group who were either employed or unemployed during an identified reference week. Since 1970 Census data provide participation rates for ethnic, sex and age groups at the county level, these rates were used to develop the 1970 and 1975 labor force estimates for the various geographic areas.

Current data for labor force participation by ethnic origin, sex and age is available on a national basis from the Bureau of Census monthly household survey. However, the sample size is not large enough to provide detailed information at the state or county level.

A composite labor force participation rate for each of the population groups was constructed by aggregating the county data to develop a composite participation rate for the portion of each state within the Recruiting Area. The composite statewide participation rates then were combined for each population group and weighted appropriately to obtain a labor force participation rate for the entire Recruiting Area. A similar method was used to develop the statistics for the Texas Area. The labor force estimates for the entire 500-mile recruiting area and the Texas recruiting area within 500 miles are shown in Tables 12 and 13.

The 1975 labor force estimates for the Houston and the Houston-Galveston/Texas City SMSA's were projected based on the 1970 Houston SMSA labor force participation rates, Tables 14 and 15. (Houston SMSA data for 1975 include the estimated population and labor force participation rates for Waller County which has been added to the SMSA.) The 1975 City of Houston labor force estimate is the product of the 1975 population estimate and the 1970 labor force participation rates for the City, Table 16. Adjustments to compensate for annexation by the City were not attempted.

The full time labor force estimates which are given in this report represent a measure of that portion of the population that has the strongest attachment to the labor market. Again, 1970 Census data were used to calculate the percentage of each

population group that worked 50 or more weeks during that

Census year and this percentage was applied to 1975 population
estimates. Procedurally, calculations similar to those made
to estimate the total labor force were made to produce the
1975 full time labor force estimate for each population
group. The full time labor force estimates for the 500-mile
recruiting area, the Texas 500-mile recruiting area and Houston
SMSA are shown in Tables 17, 18 and 19.

Since Bureau of Census data on weeks worked are reported for a 16 to 24 age group, an adjustment was made by estimating and removing those individuals under 18 so that the full time labor force estimates would conform as closely as possible to the same age groups used in other estimates.
