ACQUISITIONS

MR. PRESIDENT, MR. CHAIRMAN, DISTINGUISHED GUESTS:

I APPRECIATE THE OPPORTUNITY TO APPEAR BEFORE YOUR
ASSOCIATION AND DISCUSS WITH YOU THE RECENTLY ENACTED FEDERAL
LAW TO COMBAT CIGARETTE SMUGGLING. THIS IS A MATTER OF
IMPORTANCE, AND IMMEDIATE INTEREST, TO THE TOBACCO INDUSTRY
AND LAW ENFORCEMENT AGENCIES.

ATF HAS A PRIMARY MISSION TO ENFORCE PUBLIC LAW 95-575, WHICH WAS PASSED BY THE CONGRESS AND SIGNED BY THE PRESIDENT AS A VEHICLE TO BREAK THE BACK OF THE MULTI-MILLION-DOLLAR CIGARETTE SMUGGLING RACKET. THIS NEW LAW SUPPORTS THE INTERESTS OF TAXPAYERS, LOCAL AND STATE GOVERNMENTS, THE FEDERAL GOVERNMENT, AND THE TOBACCO INDUSTRY.

CIGARETTE SMUGGLING HAS AN INDIRECT BUT DELETERIOUS
IMPACT ON THE TOBACCO INDUSTRY IN GENERAL, AND LEGITIMATE
TOBACCO DISTRIBUTORS IN PARTICULAR. THE NATD RECOGNIZED
THIS FACTOR AT AN EARLY DATE AND SUCCESSFULLY SUPPORTED
FEDERAL LEGISLATION TO DEAL WITH THE PROBLEM.

THE PRIMARY INVOLVEMENT OF ATF IN TOBACCO MATTERS,

PRIOR TO THE ENACTMENT OF RECENT LEGISLATION, WAS TO ASSURE

COLLECTION OF FEDERAL TOBACCO EXCISE TAXES. UNTIL NOW, ATF

HAS NOT BEEN INVOLVED IN ENFORCEMENT AIMED AT CURBING

VIOLATORS WHO TRAFFIC IN CIGARETTES WITH THE EXPRESS PURPOSE

OF EVADING STATE AND LOCAL TAXES. THIS KIND OF TAXPAYER

RIP-OFF WAS VIEWED PRIMARILY AS A STATE PROBLEM.

NOW WE HAVE A NEW LAW THAT TAKES A DIFFERENT VIEW.

IT RECOGNIZES THAT CIGARETTE SMUGGLING IS, IN THE MAIN, AN INTERSTATE PROBLEM. THE VIOLATION OCCURS WHEN CIGARETTES ARE TRANSPORTED FROM A STATE WITH A LOW TOBACCO EXCISE TAX AND MARKETED ILLEGALLY IN STATES HAVING A HIGH TOBACCO TAX. THE RESULT IS A HEAVY LOSS, IN THE HUNDREDS OF MILLIONS OF DOLLARS AT MINIMUM, TO AFFECTED JURISDICTIONS. A CONCOM—ITANT RESULT IS THAT CIGARETTE SMUGGLING PROFITS INCREASE THE FINANCIAL POSTURE OF ORGANIZED CRIME.

PRACTICAL REALITIES MAKE IT VIRTUALLY IMPOSSIBLE FOR

MUNICIPALITIES, COUNTIES AND STATES TO COMBAT INTERSTATE

CIGARETTE SMUGGLING. PROBLEMS OF JURISDICTION, MANPOWER

AND COORDINATION ARE SIMPLY MONUMENTAL. THE CONGRESS RECOGNIZED

THESE DIFFICULTIES IN PASSING LEGISLATION THAT CALLED FOR

ENFORCEMENT, AGAINST CIGARETTE SMUGGLING, COORDINATED AT

THE FEDERAL LEVEL.

(MORE)

LET US TAKE A CLOSER LOOK AT THE CONTRABAND CIGARETTE
LAW. IT IS IMPORTANT TO REMEMBER THE LAW DEALS ONLY WITH
CIGARETTES. NO OTHER TOBACCO PRODUCTS ARE INCLUDED.

UNDER THE NEW LAW, IT IS UNLAWFUL FOR ANY PERSON...

EXCEPT IN CERTAIN REGULATED INDUSTRY CATEGORIES...TO POSSESS

MORE THAN 60,000 CIGARETTES...WHICH DO NOT BEAR EVIDENCE OF

APPLICABLE TAX PAYMENT IN THE STATE WHERE SUCH CIGARETTES

ARE FOUND.

I WILL BE MORE SPECIFIC ABOUT REGULATED INDUSTRY CATEGORIES, RECOGNIZING THE PARTICULAR RELEVANCE OF THIS POINT TO MEMBERS OF YOUR ASSOCIATION. PERSONS IN REGULATED INDUSTRY CATEGORIES INCLUDE THE LICENSED CIGARETTE MANUFACTURER -- THE EXPORT WAREHOUSE PROPRIETOR -- THE OPERATOR OF A CUSTOMS BONDED WAREHOUSE -- THE COMMON OR CONTRACT CARRIER TRANSPORTING CIGARETTES UNDER A PROPER BILL OF LADING OR FREIGHT BILL -- AND THE PERSON AUTHORIZED BY A STATE TO ACCOUNT FOR AND PAY TAXES IMPOSED BY THAT STATE.

IN SUMMARY, THE EXEMPTIONS PROHIBIT ANYONE OTHER THAN

LEGITIMATE MEMBERS OF THE CIGARETTE INDUSTRY FROM TRANSPOR
TING LARGE QUANTITIES OF CIGARETTES IN INTERSTATE COMMERCE.

OR, WE MIGHT SAY THAT WITH LEGITIMATE SHIPMENTS OF CIGARETTES,

THERE IS RECOGNITION OF LAWFUL TAX OBLIGATIONS TO STATE AND

LOCAL GOVERNMENTS. TRAFFIC IN CIGARETTES -- WHERE THIS TAX

OBLIGATION IS NOT RECOGNIZED -- IS ILLEGAL.

RECORDKEEPING REQUIREMENTS OF THE NEW LAW ARE, I KNOW,
A MATTER OF CONCERN TO YOU. THE LAW STATES THAT ANY PERSON
WHO SELLS, SHIPS OR DISTRIBUTES ANY QUANTITY OF CIGARETTES...
IN EXCESS OF 60,000 CIGARETTES, IN A SINGLE TRANSACTION...
SHALL MAINTAIN SUCH INFORMATION ABOUT THE SHIPMENT, RECEIPT,
SALE AND DISTRIBUTION OF CIGARETTES...AS THE SECRETARY OF
THE TREASURY MAY REQUIRE BY RULE OR REGULATION. ATF IS, OF
COURSE, A TREASURY BUREAU, AND THE ATF DIRECTOR REPORTS TO
THE SECRETARY OF THE TREASURY.

NOW, TO KEY ON THE RECORDKEEPING REQUIREMENTS. RECORDS

THAT MAY BE REQUIRED OF CIGARETTE INDUSTRY MEMBERS ARE RE
STRICTED TO CERTAIN ITEMS SPECIFICALLY MENTIONED IN THE LAW.

LET ME EMPHASIZE THAT UNDER NO CIRCUMSTANCE WILL ATF REQUIRE

RECORDS THAT ARE AN UNNECESSARY BURDEN ON THE LAWFUL CIGARETTE

INDUSTRY, AND WHICH ARE NOT NECESSARY FOR LAW ENFORCEMENT

PURPOSES.

OUR PROPOSED REGULATIONS ARE IN THE RESEARCH AND DRAFTING STAGE AT THIS TIME, AND NO FINAL DECISION HAS BEEN REACHED AS TO EXACTLY WHAT INFORMATION WILL BE REQUIRED. I CAN TELL YOU THAT NATD WILL RECEIVE THE PROPOSED REGULATIONS WHEN THEY ARE COMPLETED AND WILL BE GIVEN THE OPPORTUNITY TO COMMENT ON THEM PRIOR TO IMPLEMENTATION.

I THINK YOU WILL APPROVE OF ONE SECTION IN THE RECORDKEEPING PROVISIONS OF PUBLIC LAW 95-575. WHEREAS MOST
STATES REQUIRE A MONTHLY REPORT OF SALES VOLUME BY MANUFACTURERS
AND DISTRIBUTORS, THIS PROVISION IS ABSENT IN THE FEDERAL
LAW.

RECORDS AND REPORTING REQUIREMENTS MEAN TIME AND MONEY.

BE ASSURED THAT ATF RECOGNIZES THIS TRUTH.

LET ME TURN NOW TO ENFORCEMENT PROVISIONS OF THE CONTRABAND CIGARETTE LAW, AND BEGIN WITH A STATEMENT MADE DURING CONGRESSIONAL HEARINGS THAT PRECEDED PASSAGE OF PUBLIC LAW 95-575. SENATOR EDWARD M. KENNEDY FOCUSED ON THE COMPLEXITY AND SERIOUSNESS OF THE CIGARETTE SMUGGLING PROBLEM WHEN HE STATED: "NOT ONLY HAVE STATES LOST HUN-DREDS OF MILLIONS OF DOLLARS OF NEEDED TAX REVENUE, WHICH HAS ULTIMATELY FOUND ITS WAY INTO THE COFFERS OF ORGANIZED CRIME, BUT ALSO THOUSANDS OF LEGITIMATE WHOLESALERS, RETAILERS, DRIVERS, PACKERS AND SALESMEN HAVE LOST THEIR LIVELIHOOD AND BUSINESSES AS A DIRECT RESULT OF ORGANIZED CRIME TAKE-WITH THE INFILTRATION OF ORGANIZED CRIME INTO THIS OVFR. AREA, THERE HAS BEEN EVIDENCE OF INCREASING VIOLENT CRIME: EXTORTION AND BRIBERY, TRUCK HIJACKINGS, ARMED ROBBERY, SERIOUS ASSAULTS AND EVEN MURDER."

THIS IS THE REALITY OF CIGARETTE SMUGGLING.

(MORE)

IT IS THE INTENT AND OBJECTIVE OF THE BUREAU OF
ALCOHOL, TOBACCO AND FIREARMS TO DIRECT OUR CRIMINAL ENFORCEMENT RESOURCES TOWARD THE PERFECTION OF CRIMINAL CASES
AGAINST, AND THE SUBSEQUENT PROSECUTION OF, CIGARETTE
SMUGGLERS. ATF WILL CONCENTRATE ON INTERSTATE VIOLATIONS,
AND PARTICULARLY THOSE LARGE SCALE SMUGGLING RINGS CONTROLLED
BY ORGANIZED CRIME.

WE SHALL STRESS COOPERATION WITH STATE AND LOCAL OFFICIALS AND, IN FACT, THIS WORK HAS BEGUN. I AM PLEASED TO REPORT THAT WITHIN THE PAST FEW WEEKS, ATF JOINED WITH STATE OFFICIALS TO SEIZE MORE THAN 9,000 CARTONS OF CONTRABAND CIGARETTES.

FIVE VIOLATORS WERE ARRESTED AND FOUR VEHICLES USED TO TRANSPORT SMUGGLED CIGARETTES WERE IMPOUNDED. THESE INVESTIGATIONS ARE CONTINUING AND OTHERS ARE UNDERWAY.

THE SEIZURE OF CONTRABAND CIGARETTES RIGHTFULLY WILL

PLACE INCREASING CONSUMER RELIANCE ON THE LEGITIMATE TOBACCO

INDUSTRY. THIS REPRESENTS OPPORTUNITY, AND RESPONSIBILITY.

IT WILL TAKE A CONTINUING, COOPERATIVE EFFORT ON THE PART

OF INDUSTRY, INDUSTRY ASSOCIATIONS, STATE ENFORCEMENT AGENCIES

AND THE FEDERAL GOVERNMENT TO MAKE THIS NEW LAW AN EFFECTIVE

WEAPON AGAINST CRIME. WITH ADEQUATE RESOURCES, WE BELIEVE

THAT ATF CAN BRING TOGETHER A COORDINATED TEAM, COMPRISED OF

FEDERAL, STATE AND INDUSTRY MEMBERS, THAT CAN REDUCE ORGANIZED

CRIMINAL INVOLVEMENT IN CIGARETTE SMUGGLING ACTIVITIES.

THE CONTRABAND CIGARETTE BILL DOES NOT REPRESENT A

THREAT TO THE LEGITIMATE CIGARETTE INDUSTRY. I THINK THIS

IS CLEAR. ONLY THOSE PERSONS ENGAGED IN CIGARETTE SMUGGLING

ACTIVITIES NEED FEAR THE LAW.

LET ME AGAIN EXPRESS MY APPRECIATION FOR THE OPPORTUNITY
TO MEET WITH YOU TODAY AND TO SHARE YOUR COUNSEL. I LOOK
FORWARD TO OUR CONTINUED EXCELLENT RELATIONSHIP.
