



PREFACE

This report covers commitments to county and city jails and city jail farms; it should be noted that this confinement in jail does not reflect whether a person has been judged innocent or guilty. A separate commitment is reported each time a person is confined in jail on a charge of having violated a law or ordinance, for being inebriated or insane, as a material witness in a criminal case, for investigation, for protection or for any other reason. The confinement may be before or after adjudication of the case in which the prisoner is involved. A person who is recommitted after being released on bond or otherwise released, is reported each time he is placed in jail.


The statistics in this report were obtained from the Forms DC-J6, Record of Prisoners Confined in Jail. These forms are submitted monthly by the individual jails and jail farms to the Department of Corrections, Division of Finance, Jails Reimbursement Section. The primary purpose of these documents is to serve as a basis for determining costs of operation and the amount of state reimbursement to local jails and city jail farms. To serve the secondary function, that of providing statistical data, the forms are then transferred to the Bureau of Electronic Data Processing for editing and computer processing. All prisoner days figures, calculated by the individual jails, are manually edited by the Jails' Reimbursement Section and are not computer processed. The final statistical report is prepared by the Bureau of Research, Reporting and Evaluation.

COMMITMENTS TO COUNTY AND CITY JAILS

YEAR ENDED JUNE 30, 1977


During fiscal year 1977, there were 144,459 commitments to county and city jails and city jail farms. This represents a 5.0 percent increase over commitments during 1976 (137,597).

RACE AND SEX

Among the jail commitments 66.8 percent were white and 33.2 percent were non-white. The number of men received was 131,821 or 91.3 percent. The number of women was 12,638 or 8.7 percent. This is not significantly changed from last fiscal year when women comprised 8.4 percent of the commitments.





AGE

In fiscal year 1976 there were 5,402 youths committed who were under age eighteen. During this fiscal year, 3.2 percent of the commitments (4,557) were in this category, which represents a 15.6 percent decline since last year.





OFFENSE

An analysis of the offenses for fiscal 1977 shows that offenses against decency, peace and good order were the most frequent (47,896 or 33.2 percent); offenses against property were second with 28,113 or 19.5 percent; almost equaling the property offenses were violations of traffic and vehicle laws which accounted for 28,090 commitments or 19.4 percent.


Specifically the most common offenses were drunkenness/drank and disorderly which represented one quarter of all commitments (25.4 percent). The second most frequent offense was driving under the influence of intoxicants (11.3 percent).

Incarceration for violations of the narcotic laws accounted for only 6,552 commitments or 4.5 percent. This is consistent with last fiscal year when 4.4 percent of the commitments were in this category.




TYPE OF OFFENSE

Of the total commitments, more than half were charged with misdemeanors (77,420 or 53.6 percent), which is a slight increase over last year when 51 percent were committed for misdemeanors. The persons committed on local ordinances ("other offenses") numbered 34,541 (23.9 percent) while 32,496 (22.5 percent) were charged with felony offenses.



PLACE COMMITTED FROM

Virginia counties accounted for 53.5 percent of the jail commitments and the cities accounted for 46.5 percent of the commitments. From the 77,296 commitments from the counties, Fairfax had by far the greatest share with 8,883; Henrico committed 3,850 and Arlington committed 3,510 prisoners. Of the 67,163 city commitments, Norfolk had 12,577, Roanoke had 9,624 and Richmond had 6,203.



CAPACITY AND POPULATION ANALYSIS

The average of the rated capacities for all the jails in Virginia is 51 beds. In comparison, the average daily population for a Virginia jail facility was slightly less than the average rated capacity. During this fiscal year the average population was 48 persons which is a slight decline from 1976 when the average population was 52 persons.

The average number of commitments during 1977 for the 98 jail facilities was 1,474, which is an increase over the 1976 average of 1,404 commitments. The average prisoner days in 1977 was 17,648 days as compared to 19,095 days for fiscal year 1976. Although the number of commitments is rising, the length of confinement per prisoner dropped during this fiscal year. The average length of stay per commitment during fiscal year 1977 was 12.0 days. Last fiscal year the average length of stay was 13.6 days.

The average jail was holding a population over-capacity about 122 days of the year or 33 percent of the year. This is a decrease from fiscal year 1976 when the average jail recorded populations over-capacity about 40 percent of the year.

In assessing the significance of this trend of over-population, it is important to determine the size of the variance over rated capacity. Only 26 jails recorded more total prisoner days than capacity days available. The average capacity days exceeded prisoner days by 4.8 percent for all the jails considered together.





Description

$$40 \times 365 = 14,600$$

Rated capacity is extracted from the Population Survey of Local Correctional Institutions. It is the design capacity of each jail and does not necessarily represent the number of beds in the jail.

Maximum is the highest recorded population for each jail during the fiscal year.

Capacity Days are determined by multiplying the rated capacity of each jail by 365 days.

Actual Prisoner Days are the total number of prisoner days recorded by each jail for the entire fiscal year.

$$14,600 - 12,678 = 1,922$$

Net Difference is recorded as positive when the rated capacity is greater than the total prisoner days. Jails with negative numbers are therefore overcrowded.

$$1,922 \div 14,600 = 13.2 \%$$

The Percentage Difference is the net difference divided by the capacity days.

Days Above Rated Capacity are the number of days during the fiscal year that the number of prisoners being held exceeded the rated capacity.

$$18 \div 365 = 4.93 \%$$

The Percent of Year Overcapacity is the days over capacity divided by 365, the total days in a year.

Description

The Average Daily Population is actual prisoner days divided by 365 days.

County and City Populations are the provisional population projections for July 1, 1976. These figures are prepared by the Tayloe Murphy Institute, University of Virginia.

The Rate of Incarceration is expressed as average daily population divided by the county/city population. The rate is expressed per 100,000 residents.

Capacity/Population Rate is the rated capacity of the jail divided by the population of the areas served.
