## INTRODUCTION

## INTRODUCTION

In the state of Nevada there are 78 justice and municipal courts of which there are 64 courthouses or courtroom facilities. Some municipal and justice courts, while having separate duties and responsibilities, have the same judge and the same facilities.

The study which follows gives an inventory of the facilities available to the judge. This includes the actual physical plant, i.e. judge's bench, desk, etc. and the legal materials available to the judge.

The purpose of this study was to make an inventory of all the lower court facilities in the state of Nevada. This inventory will assist the Administrative Office of the Courts by providing the necessary knowledge to determine where financial resources should be allocated for the improvement of the Nevada Court System.

This study was financed by a federal grant administered through the state of Nevada's Office of Traffic Safety. The study was conducted by the Traffic Court Specialist with assistance from staff members of the Administrative Office of the Courts.

## FINDINGS AND CONCLUSIONS

### Physical Facilities

In the State of Nevada there is great diversity between densely populated urban areas and large desolate rural areas. This diversity is reflected in the courtrooms and courthouses throughout the state. What is a satisfactory arrangement for the population and community of one area (e.g. Baker) is inappropriate and inadequate for another area (e.g. Las Vegas).

Several factors needed to be considered when determining if a courthouse is adequate or not. These included community size and needs, caseload of the court, and the actual facility. In addition, the conclusions drawn in ranking courts were done, in many cases, with the assistance of the judges and clerks of the particular court involved. By judging a court's adequacy or inadequacy on these factors, we were able to fairly rank each court.

The courts were ranked excellent, good, fair, poor, and inadequate. An excellent court would incorporate most of the ideal factors listed in the study and would meet the needs of the community for size and convenience of use. At the other end of the scale, an inadequate court would have few, if any, of the ideal conditions of a court and, in addition, would not meet community standards or needs.

A facility should incorporate the following ideal factors:

- Jury box
- Public seating
- Press section
- Judge's section
- Separate judge's entry
- Robing room
- Washroom
- Jury room
- Defendent's room
- Witness room
- Judge's bench
- Witness box
- Attorney's
- Clerk's desk
- Bailiff's station
- Visual aids
- Sound amplifying equipment
- Sound recording equipment
- Flag

We have not made any attempt to rank the importance of each of these factors but used the total amount a court has as a method of ranking the courts. Of the lower courts in the state, eight courts, or 12%, had no facilities whatsoever. For these courts, court proceedings take place in the kitchen, living room, or den in the judge's home.

Of the eight courts with no facilities, all of them are in very small communities with small caseloads. The question which arises is, "Does a justice of the peace or municipal court judge warrant a court facility if he or she hears ten cases a year? 20 cases? 100 cases?" Where is the cut off point? This is a question which is beyond the scope of this study which should be addressed separately.

The ranking for the 64 municipal and justice courts in the State of Nevada was as follows:

In the State of Nevada, forty-two percent of all justice and municipal courts are in poor condition, inadequate condition, or do not have facilities at all. These courts are located in all of the districts except the second judicial district. In general, it appears that the rural areas, rather than the urban areas, suffer the most from the lack of proper facilities. However, it should be noted that the occasional "poor" court in an urban area affects a much larger segment of the population than a "poor" court in a rural area.

### Library Facilities

The library facilities of each court were incorporated into this study due to the importance of legal research materials being available to the judge. A court cannot operate effectively without at least the statutes which will determine an individual's innocence or guilt.

The library materials available to each court are in most instances minimally adequate. However, this study did discover that there are two courts in the state that do not have access to the Nevada Revised Statutes, and several courts which have outdated sets of statutes. Except for these isolated cases, the limited library facilities of the lower courts are in relatively good condition.

**RECOMMENDATIONS**

## RECOMMENDATIONS

The following five recommendations are listed in order of priority.

1. The first recommendation of this study is to improve the quality and quantity of reference materials available to the lower courts. The availability of the Nevada Revised Statutes, Nevada Reports and other legal documents has a direct result on the quality of justice. It is incomprehensible to the author that in the year of 1978 we have judges in the state of Nevada who make judgements without the benefit of the written law. The cost of improving the legal reference materials for the justice and municipal courts is not substantial especially when taking into account the result of the expenditure, the improvement of the quality of justice.

The courts which need an improvement of their library facilities are Logandale Justice Court, Henderson Municipal Court, Ely Municipal Court, McDermitt Justice Court, and Jarbidge Justice Court.

2. The second recommendation of this study is that the six courts ranked "inadequate" should be improved. In all cases, the courts ranked "inadequate", have a substantial caseload with totally unacceptable facilities. These courts should be improved if not replaced. The caseload of these courts justify an adequate facility.

The courts which are ranked inadequate are Jean Justice Court, Canal Justice Court, Moapa Justice Court, Smith Justice Court, Caliente Municipal Court, and McDermitt Justice Court.

The courts are listed in sequence with Jean Justice Court needing improvement of facilities the most and McDermitt needing it the least.

3. Following the implementation of the above recommendations those courts ranked "poor" should be improved.

Those courts ranked "poor" include Austin Justice Court, Beowawe Justice Court, Fallon Municipal Court, Tecoma Justice Court, Mountain City Justice Court, Gabbs Municipal Court, Hawthorne Justice Court, Mina Justice Court, Lovelock Municipal Court, Lake Justice Court, Meadow Valley Justice Court, Las Vegas Justice Court, and Logandale Justice Court.

4. The author further recommends that a study should be conducted on the eight courts that do not have a facility. These courts are located in a rural area, are geographically isolated from other courts, and have a small caseload. While the court is important to the local community, can the cost of a court facility be justified?

Those courts with no facility include Jackpot Justice Court, Jarbidge Justice Court, Eastline Justice Court, Goldrun Justice Court, Paradise Valley Justice Court,

Baker Justice Court, Lund Justice Court, and Alamo Justice Court.

5. The final recommendation is that this study should be updated periodically and that facilities are monitored so that once these recommendations have been implemented, court facilities in the state of Nevada will never again fall into a category of "Inadequate".



Percentage of total facilities having ideal factors.




LOWER COURT LIBRARY STUDY


STATE TOTALS


MAP OF STATE

FIRST JUDICIAL DISTRICT




FIRST JUDICIAL DISTRICT












