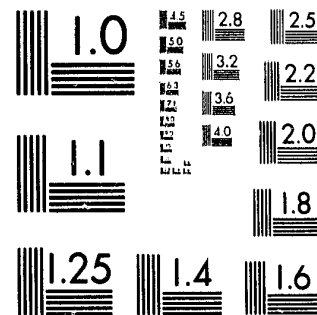

INTRODUCTION

ACQUISITIONS

This report is a statistical description of characteristics of court commitments to the Massachusetts Department of Correction during 1977.* The tables which follow contain information on history of present offense, personal background characteristics, and criminal history of admissions from the courts to MCI-Walpole, Concord and Framingham. These tables were derived from the computerized data base developed by the Correction and Parole Management Information System (CAPMIS) and produced by the Research Unit of the Massachusetts Department of Correction on the Massachusetts State College Computer Network (MSCCN).

In reading the tables in this report the reader should note the following: (1) the commitment population is divided according to the institution committed to, (2) the top number in each cell represents the number of individuals who fall into the corresponding category in the table, and (3) the bottom number in each cell represents the percentage of the number of individuals in a particular category to the total number of commitments from that institution (column percents). For example upon referring to table I on page 2, court from which committed is presented and the following types of information can be obtained:

- (1) The total number of individuals broken down by committing institution. This is labeled and presented horizontally across the head of the table.
- (2) The specific courts are labeled and presented vertically.
- (3) Of the 1145 individuals committed during 1977, 467 were committed to Walpole.
- (4) Of the 467 individuals committed to Walpole, 8 (2%) were committed from Barnstable Superior Court.

* In 1977, a teachers strike resulted in 28 civil commitments to MCI Framingham. Data concerning these commitments was not collected in the normal manner; hence were not included in the CAPMIS data base.
