

The Legislation

The legislation under which the Board functions is The Compensation for Victims of Crime Act, 1971, which came into force on September 1, 1971 superseding The Law Enforcement Compensation Act, 1967.

The Board is required by the Act to find the commission of a crime (in the principal class of application coming before it). A basic qualification for the consideration of an award is that there must be adequate and reliable evidence in this regard. In addition, the Board is required to consider all relevant circumstances including the behaviour of the victim at the time of the incident and the co-operation given by the victim to the law enforcement agencies.

Subrogation

The Board is subrogated to all the rights of any person to whom payment is made under this Act, to recover damages by civil proceedings in respect to injury or death.

Hearings

The members of the Board, of whom six are on a part-time basis, usually sit in panels of two.

During the fiscal year, hearings, in addition to those held in Toronto, took place in Thunder Bay, Sudbury, Sault Ste. Marie, Windsor, London and Ottawa. This is done to facilitate applicants, and to generate a better understanding of the work of the Board.

Administration

The administrative staff of the Board is comprised of the Registrar, the Chief of Investigation and two investigators, in addition to a clerical, stenographic and secretarial staff of eight. This small staff has been most dedicated in its efforts to maintain a high standard of service to the Board and to the public. Improvement in procedures by the staff have enabled the Board to increase its output significantly.

Productivity

The Board heard 713 applications as against 570 in the previous fiscal year which represents an increase of 25%. Total awards granted increased by 8% from \$1,611,836 to \$1,748,484 while the average award declined from \$2,328 to \$1,960 or by 15%. This decline is probably due to an increased proportion of the minor claims, arising from a wider awareness of the existence of the programme. Procedures were developed for the hearing of child abuse cases, in consultation with the Official Guardian and representatives of the Ministries of the Attorney General and Community and Social Services. Under these new procedures two such cases have been heard and the decisions completed.

Public Awareness and Workload

Large posters, together with a supply of explanatory brochures, are displayed in hospital emergency wards and staff lounges. The various police forces throughout the province have been provided with wallet-size cards which are designed to draw to the attention of the victims of a crime of violence that they may be eligible for compensation and advising how to make the application to the Board. The increase in the number of applications from 971 two years ago to 1219 in this fiscal year is, no doubt, in part due to these measures.

Cost Sharing

Awards made under The Compensation for Victims of Crime Act are cost shared between the Federal Government and the Government of Ontario. The contribution by the Federal Government amounts to 50% of the awards (net of any recoveries) to a maximum of ten cents per capita of the population of Ontario. For the fiscal year 1977-78, this share amounted to \$811,928.57

SUMMARY OF DECISIONS

APRIL 1, 1978 TO MARCH 31,1979

The volume of cases dealt with by the Board is such that to prevent this report from becoming unduly long, every second Board Order has been summarized.

200-849 The applicant, age 56, was attacked from the rear without provocation. Her assailant hit her head, flung her to the pavement, kicked and struck a severe blow over the right eye. She suffers from loss of grip and strength in her right arm and has lost the sight in her right eye. The offender escaped and was never apprehended.

Award: \$7,230.43 (pain and suffering \$7,000.00)

200-1016 The applicant, age 62, was shot in the back by her husband who did not stand trial because of his mental condition and is now hospitalized. She lost a kidney and is left with weakness of hip flexion, knee extension and flexion of the foot which caused her to walk with a limp. She also suffered severe mental shock.

Award: \$5,483.50 and \$65.00 per month (pain and suffering \$5,000.00)

200-I038 The applicant, a 56 year old cleaning supervisor, was attacked by a patient in a psychiatric hospital where he was employed. He received lacerations and abrasions to his scalp.

Award: \$7,371.25 (pain and suffering \$2,500.00) plus \$60.00 per month.

200-II78 The victim, age IO, was hit in the face by a bullet, fired from across a bay which came through her cottage window. The bullet passed under the eye and lodged itself in the back of her neck. After preliminary enquiry, the alleged offender was not committed for trial.

Award: \$2,999.59 (pain and suffering \$2,000.00)

200-1204 The victim, a minor, was assaulted from behind by another juvenile while standing on a street corner. His bottom lip was lacerated and two front teeth were knocked out. The offender was convicted of assault causing bodily harm and given a probation order.

Award: \$250.00 (pain and suffering \$250.00)

200-1212 The applicant, a 48 year old correctional officer, was kicked in the right shoulder while helping another officer subdue an inmate. After surgery he has a 15 degree loss of reduction and a 20 percent loss of internal rotation. The offender was convicted on two counts of assault causing bodily harm and sentenced to 40 days concurrent on each charge.

Award: \$2,000.00 (pain and suffering \$2,000.00)

200-140. The applicant's husband was involved in an altercation at a hotel and found later unconscious on the sidewalk. He subsequently died. Two persons

were charged with assault causing bodily harm but charges were dismissed because of lack of evidence.

Award: \$448.00 plus \$112.00 per month.

200-1479 The applicant, a 28 year old policeman, was shot in the right elbow while investigating a complaint. He will continue to have pain in his right hand. The offender was convicted of attempted murder and was sentenced to six years in jail.

Award: \$3,332.60 (pain and suffering \$3,000.00)

200-1544 The applicant, age 34, attending a party at a hotel, was assaulted with a broken chair by a drunken patron who had been ordered to leave after indecently assaulting a young woman in a wheelchair. His ankle was seriously fractured and his face was cut in several places. The offender was convicted of common assault and fined \$200.00 or 30 days in jail. Award: \$9,156.35 (pain and suffering \$3,500.00)

200-1658 The applicant, a 46 year old cash supervisor, sustained a slipped disc in her lower back when she jerked to avoid the blow of an upset customer. She has undergone extensive treatment and hospitalization for four years. The offender was committed to a mental institution.

Award: \$11,481.17 (pain and suffering \$4,000.00)

200-1663 The applicant, a 53 year old taxi driver, was assaulted and robbed at knifepoint by four youths. He was punched, kicked, and clawed, aggravating a previous back injury and rendering him unemployable. The four offenders were convicted of armed robbery. Two were sentenced to nine months definite and three months indefinite each. One was sentenced to nine months definite and one year indefinite and the other was sentenced to one year definite and one year indefinite.

Award: \$6,282.2l (pain and suffering \$2,750.00)

200-1755 The applicant, a 60 year old postal supervisor argued with a security officer about permission to take articles from the premises. A scuffle ensued during which the applicant was struck with a broken bat. His left arm was broken. The offender was found guilty of assault causing bodily harm and given a conditional discharge plus one year probation.

Award: \$2,796.00 (pain and suffering \$2,000.00)

200-1841 The applicant, age 64, was assaulted by a male tenant of her rooming house. She was punched in the stomach and slapped in the face, resulting in abdominal pains, a swollen face, abrasions and contusions to her elbow, back, and face, which caused headaches and discomfort for two weeks. The offender was convicted of assault. He received a suspended sentence with two years probation and required to abstain from drinking.

Award: \$552.50 (pain and suffering \$450.00)

200-1892. The applicant, a 42 year old restaurant owner, was the victim of an unprovoked stabbing. He received two stab wounds in the back and after a

lengthy convalescence, still has pain and nervous anxiety. The offender was charged with attempted murder and found not guilty by reason of insanity. Award: \$12,395.83 (pain and suffering \$4,500.00)

200-I933 The applicant, age 48, was stabbed I2 times while trying to stop the offender from trying to rape his daughter. His wife, a co-applicant, suffered from shock. The offender was convicted of wounding and was sentenced to eight months in jail.

Award: \$1,947.00 (pain and suffering \$1,500.00)

200-2024 The applicant was a 64 year old woman whose husband died after a fistfight. The victim had pushed a young child away from his car to avoid possible injury. Through the exaggeration of another child, it was reported to the child's parents that he had been assaulted. The enraged father visited the applicant's husband who became upset and a fight ensued. The victim received a blow to the mouth which broke his denture and sank it into his throat. He died of asphyxiation. A murder charge was dismissed after preliminary enquiry. The Board invoked Section 17 of the Act.

Award: \$1,000.00 plus \$150.00 per month.

200-2060 The applicant, a 59 year old salesman, was assaulted without provocation, by two youths near his home, sustaining fractures to his ankle. Two offenders were convicted of assault causing bodily harm. One received a suspended sentence plus probation for one year. The other was sentenced to 21 days in jail.

Award: \$2,982.54 (pain and suffering \$1,700.00)

200-2092 The applicant, a 4I year old bar manager, intervened in an altercation between patrons. He was assaulted by three men and thrown down a flight of stairs. A pre-existing condition in his lower back was aggravated. Three offenders were convicted of assault causing bodily harm. One was fined \$300.00 or 15 days in jail plus probation for 17 months. The other two were each sentenced to 90 days in jail plus two years probation.

Award: \$2,500.00 (pain and suffering \$2,500.00)

200-2096 The applicant, a 39 year old taxi driver, picked up a passenger who, holding a knife to his throat, demanded a ride to Toronto. He was threatened with death several times before he managed to jump from the car which was travelling at 50 m.p.h. He broke his collar bone and sustained multiple bruises to his face and body. The offender was charged with forcible seizure and deported to the United States.

Award: \$2,405.00 (pain and suffering \$1,200.00)

200-2150 The applicant, a 28 year old contractor, argued with two men about money owed by him. He became involved in a fist fight with one man when the second intervened and hit the applicant on the head with a piece of 2×4 , causing multiple head injuries and concussion. No charges were laid because of the lack of eye witnesses.

Award: \$1,279.00 (pain and suffering \$800.00)

200-2215 The applicant, age 19, spent an evening drinking with three male friends. One of them produced a gun, which discharged hitting the applicant. She was wounded on the right side of her head, resulting in massive brain damage which has left her with a permanent moderate weakness of the left side of her face, arm and leg. Two offenders were convicted of possession of restricted weapon and sentenced to eight months in prison. The Board invoked Section 17 (I) of the Act to reduce the award for pain and suffering. Award: \$2,121.00 (pain and suffering \$1,500.00)

200-2283 The applicant, a 24 year old policeman, was thrown to the ground while trying to arrest an offender. He sustained a muscle strain injury to his lower back, requiring extensive physio-therapy treatments. The offender was convicted of common assault and fined \$50,00 or 15 days in jail.

Award: \$700.00 (pain and suffering \$700.00)

200-2290 The applicant, age I9, was stabbed by a neighbour following an argument about the applicant's younger brother playing in the offender's car. He was wounded in the left flank. The offender was convicted of assault causing bodily harm and fined \$300.00 or 20 days in jail.

Award: \$3,675.00 (pain and suffering \$2,000.00)

200-2299 The applicant, a 28 year old part-time doorman, was struck by a beverage room patron with an empty beer glass. In the ensuing scuffle, he was struck on the back of the neck by the offender's fist holding a shuffleboard puck as a weapon. The applicant suffered a face laceration which left some scarring, neck pain, and a wrist injury more serious than expected because of bone problem. Post-traumatic arthritis in the wrist area is a probability. The offender escaped and has never been identified.

Award: \$5,250.25 (pain and suffering \$3,700.00)

200-2372 The applicant claimed on behalf of her I3 year old son who was assaulted by a youth causing chest, rib and elbow injuries. There was a possibility of a causal connection between the attack and subsequent complications of a urinary tract infection. The offender was convicted in Juvenile Court.

Award: \$1,005.00 (pain and suffering \$750.00)

200-2399 The applicant, a 70 year old housewife, was assaulted without provocation by two masked men who were attempting a robbery at her house. Her right wrist was fractured. A warrant for the arrest of the offender is outstanding.

Award: \$750.00 (pain and suffering \$750.00)

200-2404 The applicant, a supervisor with an animal control centre, was confronted by a man angry because he was required to pay to retrieve his dog. The man threatened him and bent his right arm backwards over the edge of the desk. The applicant is left with a partial permanent injury to his hand. No charges were laid because of a misunderstanding between the applicant and his employer.

Award: \$5,436.00 (pain and suffering \$5,000.00)

200-2478 The applicant, a 38 year old welder, intervened to stop a knife fight which erupted at a dance and was viciously attacked by one of the participants. He sustained severe lacerations to his chest and leg. The offender was convicted of wounding and sentenced to six months in jail plus two years probation.

Award: \$6,643.36 (pain and suffering \$2,800.00)

200-2495 The applicant, a 49 year old nurse, was attacked from behind by an unknown male. He knocked her down with a karate type blow to the back of her neck, then kicked and punched her. She sustained multiple bruises to her face and head. The severe anxiety trauma aggravated a pre-existing emotional condition. The offender was never found.

Award: \$4,663.40 (pain and suffering \$1,500.00)

200-2513 The applicant, a 17 year old student, went to the assistance of a friend who was engaged in a struggle with another student. That student wounded the applicant with a four-inch knife, causing lacerations to the neck and left ear and a contusion to the right thumb. The applicant suffered nightmares and anxiety for two months. The offender was convicted of assault with intent and received a conditional discharge with 12 months probation.

Award: \$1,040.00 (pain and suffering \$850.00)

200-2586 The applicant, a 33 year old housewife, was assaulted by her husband during a domestic dispute. She sustained head and scalp lacerations, a broken cheekbone, a black eye, and multiple bruises. The offender was found guilty of assault causing bodily harm and given a conditional discharge with probation. The Board invoked Section I7 (I) of the Act to reduce the award for pain and suffering.

Award: \$955.20 (pain and suffering \$600.00)

200-2613 The applicant, age 23, was beaten by three men at a party when he tried to help a friend who was fighting with another guest. He received multiple contusions on his face, a fractured nose, and an injury to the left eye. Three offenders were charged with assault causing bodily harm. One was fined \$250.00 or 25 days in jail; another was fined \$100.00 or 10 days in jail; and the charge against the third was dismissed.

Award: \$2,408.00 (pain and suffering \$1,750.00)

200-2628 The applicant, age 26, was the victim of an unprovoked attack in the lobby of an apartment building. The offender kicked him in the head until he was unconscious. He was detained in hospital for six days because of a skull fracture. The offender was charged with assault causing bodily harm and sentenced to 18 months in jail plus 12 months probation.

Award: \$1,688.00 (pain and suffering \$1,000.00)

200-2640 The applicant claims on behalf of her 7 year old grandson whose arm was twisted and broken by a 14 year old youth while playing on the front porch. No charges were laid.

Award: \$1,256.00 (pain and suffering \$1,000.00)

200-2659 The applicant, a 39 year old manager of a downtown social club, refused admittance to a man who later returned and threw a soft drink can at the applicant, lacerating the bridge of his nose. No stitches or plastic surgery were required. The offender was convicted of common assault and directed to hold the peace under a bond for one year.

Award: \$250.00 (pain and suffering \$250.00)

200-2674 The applicant, age 22, arranged a meeting with an ex-girlfriend. He was later threatened by young men, including the offender, the girl's new boyfriend. During a second meeting with the girl, the applicant was beaten by one of the men. He received facial bruises and broken teeth. The offender was convicted of assault causing bodily harm and sentenced to 60 days in jail. Award: \$2,994.00 (pain and suffering \$1,500.00)

200-2688 The applicant, age 49, told the woman with whom he was living that he was moving to another apartment. When he fell asleep on the sofa, she hit him on the head with a steel bar. He was treated for multiple scalp lacerations and bruises to his arm and shoulder. The offender was charged with attempted murder but died accidently shortly thereafter. The relationship between the two was unstable and the Board invoked Section 17 (I) of the Act. Award: \$1,500.00 (pain and suffering \$1,500.00)

200-2693 The applicant, age 49, was assaulted by a number of youths outside his home after telling them to leave his car alone. His injuries were cuts on his head and a sprained right wrist. Five persons were convicted of common assault. One received 75 days in jail. The others were fined. Award: \$1,010.00 (pain and suffering \$1,000.00)

200-2712 The applicant, a 36 year old truck driver, was holding booster cables to the battery in a friend's vehicle when four unknown males came out of a local hotel, jumped on the hood, driving his head into the motor and knocking him unconscious. He sustained a laceration over the left eye and left ear, a fractured nose, two black eyes and contusions and bruises to the face. The offenders were never identified.

Award: \$2,682.00 (pain and suffering \$1,500.00)

200-2747 The applicant claimed on behalf of her I7 year old son who was kicked in the jaw by an intruder while camping with friends. His jaw was lacerated and broken and some teeth were chipped and broken. The offender was convicted of assault causing bodily harm and sentenced to two days in jail plus two years probation.

Award: \$910.00 (pain and suffering \$850.00)

200-276l The applicant's husband suffered a cardiac arrest during a confrontation with a customer and subsequently died. The offender was charged with common assault and sentenced to 76 days in jail. The Board could not order an award for grief or loss of a loved one but allowed legal expenses. Award: \$350.00

200-2772 The applicant, age 26, was in a bar with some acquaintances. He was assaulted following an altercation between some of those acquaintances and another man who took offence at a comment made by one of them. As a result of his head being beaten on a steel radiator and his face being beaten, he was in a coma for 13 weeks, suffered brain damage and is now a spastic with limited speech and use of his extremities. The offender was found dead of drug overdose before he could be brought to trial.

Award: \$8,032.25 plus \$500.00 per month (pain and suffering \$7,500.00)

200-2789 The applicant, age I8, was struck in the mouth with a broomhandle from a blow meant for another person, cutting her mouth and knocking out a tooth. The offender, who had also assaulted two other people in the same occurrence, was found guilty on three counts of assault causing bodily harm and fined \$500.00 or 25 days in iail.

Award: \$965.00 (pain and suffering \$650.00)

200-2798 The applicant, age 27, let a friend into his apartment. Two men who had been chasing the friend smashed the door and pulled the applicant outside, where they struck him with a chain or belt and kicked him. He suffered a swollen upper lip, a painful right arm, damage to some teeth and blood in the right eye. Two offenders were charged with assault causing bodily harm and weapons dangerous. The charges were withdrawn because the applicant did not appear in court. His subpoena arrived three days after the trial date. Award: \$856.10 (pain and suffering \$750.00)

200-2825 The applicant, a 22 year old secretary, was attacked from behind in a parking lot. Her arms were cut and she suffered abdominal pains and headaches. Her assailant was never found.

Award: \$963.47 (pain and suffering \$750.00)

200-2842 The applicant claimed on behalf of his II year old son who was attacked with a pair of scissors and choked by his I4 year old friend after he was invited to the offender's home to listen to records. He sustained multiple stab wounds to the back and legs, lacerations to the eye, cheek and head, bruises on his neck, and a fractured front tooth. The offender was convicted in Juvenile Court.

Award: \$3,300.49 (pain and suffering \$2,500.00)

200-2844 The applicant, a 29 year old police officer, was kicked in the face and jaw while trying to put the offender in a jail cell. The kick re-injured a fractured jaw which had been broken during another assault two months earlier. The offender was convicted of three charges of assaulting a police officer. He received a six month sentence and \$500.00 fine on the first charge plus six months concurrent on charges two and three.

Award: \$3,231.25 (pain and suffering \$3,000.00)

200-2849 The applicant, a 22 year old musician, escorted his lady friend to her apartment where he was assaulted by two or three males who had broken in. He was struck several times with a hockey stick or broom and sustained a contusion

of the left shoulder and multiple bruises of the body. Several teeth were fractured. Two offenders were convicted of assault causing bodily harm. One was fined \$50.00 with five days in jail. The other was sentenced to one day in jail.

Award: \$675.45 (pain and suffering \$250.00)

200-2862 The applicant, age 43, had an argument with a tenant over whether a third party should stay overnight at the house. The tenant, who was drunk, picked up a butcher knife and stabbed the applicant in the left side. The offender was convicted of assault causing bodily harm and fined \$500.00 or 40 days. Award: \$1,140.67 (pain and suffering \$1,000.00)

200-2873 The applicant, a 33 year old taxi driver, was attacked while standing beside his taxi. He suffered a contusion injury to the brain which left him unable to work for nearly a year. He still suffers from persistent headaches and some memory disfunction. No offender has been apprehended. Award: \$2,076.04 (pain and suffering \$1,500.00)

200-2915 The applicant, age 22, was in the apartment of a friend who was showing him a .22 calibre rifle. It suddenly discharged, hitting the applicant in the head. Bullet fragments remain in the applicant's head and he is suffering from traumatic epilepsy. He still walks with a noticeable limp. The offender was convicted of criminal negligence and sentenced to one year in jail. Award: \$11,263.60 (pain and suffering \$5,000.00)

200-2964 The applicant, a 21 year old student, was wounded by another student who fired a shotgun into a high school classroom. He sustained multiple pellet wounds on the right side of his body and head. The offender is deceased. Award: \$2,881.00 (pain and suffering \$2,500.00)

200-2968 The applicant, a 46 year old security guard, was the subject of racial insults by his supervisor who later hit him several times under the right eye when he tried to walk away. The offender was charged with common assault and was given an absolute discharge.

Award: \$3,060.00 (pain and suffering \$1,800.00)

200-2975 The applicant, a 30 year old shopkeeper, visited a restaurant and was asked by the offender to leave because of his conduct. He was subsequently beaten and ejected from the premises. He sustained multiple facial bruises and a fractured jaw. Permanent absence of sensation in the lower lip because of nerve damage is probable. The offender was convicted of assault causing bodily harm and sentenced to 21 days in jail plus 18 months probation. The Board invoked Section 17(1) of the Act to reduce the award.

Award: \$5,146.00 (pain and suffering \$3,000.00)

200-2978. The applicant, a 20 year old student, was severely beaten in an altercation with another young man. He sustained a fractured middle finger on

his left hand, a broken nose, dental injuries, and bruises and lacerations to his face and body. His injured finger is permanently severely restricted in flexion. The offender was convicted of assault causing bodily harm. He received a suspended sentence and probation for two years, and a restitution order. Award: \$2,083.00 (pain and suffering \$1,700.00)

200-30II The applicant, age 28, and a friend visited a tavern and a fight ensued when they tried to remove the friend's brother, who was drunk. A group of 12 individuals, associated with a motor cycle gang decided to join in. The applicant sustained a bruised eye and an injured ankle. The offender was convicted of assault causing bodily harm and sentenced to three months in jail. Award: \$902.80 (pain and suffering \$700.00)

200-3027 The applicant, a 35 year old journalist, was struck in the face by his dance partner's estranged husband at a single's dance. His jaw was fractured in two places. The offender was convicted of assault causing bodily harm and sentenced to 2l days in jail.

Award: \$1,114.99 (pain and suffering \$700.00)

200-3032 The applicant is the widow of a man who was fatally shot during a brawl in a local hotel. The offender was convicted of manslaughter and sentenced to two years less a day.

Award: \$6,089.98 plus \$228.36 per month

200-3036 The applicant claimed on behalf of a minor, a l6 year old student, who was burned by a gasoline fire started by two youths. Approximately seven per cent of her body burned and she required two skin grafts. Two juvenile offenders were charged with criminal negligence.

Award: \$3,500.00 (pain and suffering \$3,500.00)

200-3047 The applicant, a 3I year old bartender, was struck in the face by a patron of the hotel. The next week he struck her with a broken glass, lacerating her elbow, and threw another glass at her. The offender was convicted of common assault and put on probation for 30 months.

Award: \$600.00 (pain and suffering \$600.00)

200-3078 The applicant, a 35 year old machine operator, shared a couple of drinks with two previously unknown men while waiting in a park for hospital visiting hours. They later attacked him and stole his wallet. He sustained bruises to his face and body and black eyes and had diplopia for a few weeks. The offenders were convicted of robbery and sentenced to two years in jail. Award: \$2,388.19 (pain and suffering \$1,500.00)

200-3079 The applicant, a 48 year old technologist, was severely beaten by four males when he investigated the breaking of a window of his store. He sustained a fractured skull, severe lacerations, I3 fractured ribs, contusions to the face and neck and suffered headaches, nightmares and discomfort in the chest and kidney areas. The offender was convicted of assault causing bodily

harm and sentenced to nine months in jail. Award: \$9,796.80 (pain and suffering \$4,000.00)

200-3107 The applicant, age 23, was assaulted by two men in the washroom of a hotel. He received a severe head injury and less serious injuries including a cut lip, missing upper incisor teeth, a contusion to the right of the face, a black eye, fractured ribs and abrasions to his chest. As a result of the injuries the applicant suffered brain damage and the Board was convinced he will always have a great problem in holding a regular job. Two offenders were convicted of assault causing bodily harm and sentenced to 33 months in jail. Award: \$1,515.00 and \$250.00 per month (pain and suffering \$1,500.00)

200-3114 The applicant, a 58 year old jeweller, was struck on the head with the butt of a gun during an attempted robbery, sustaining a lacerated scalp and a fractured tooth. The offender was convicted of robbery and sentenced to 16 months in jail plus one year probation.

Award: \$609.79 (pain and suffering \$500.00)

200-3117 The applicant claimed on behalf of her 14 year old son who was struck by a rock thrown by an unidentified person as he stood watching a fire. The victim sustained a laceration of the mouth which required cosmetic surgery and lost three upper front teeth. No offender was apprehended. Award: \$1,465.00 (pain and suffering \$1,000.00)

200-3123 The applicant, a 28 year old housewife, was knocked to the ground by an uninvited male when she asked him to leave. She fell against a television set and aggravated a pre-existing problem in her right knee. The offender was convicted of common assault and fined \$100.00 or 20 days in jail. Award: \$945.80 (pain and suffering \$600.00)

200-3124 The applicant, a 45 year old labourer, was involved in a minor traffic altercation. An unseen passenger of the car he bumped protested and following a heated discussion, he punched and kicked the applicant into unconsciousness. The applicant sustained injuries and bruises to his face, right eye, upper arm and chest. His denture was broken. The alleged offender denied involvement and charges were withdrawn.

Award: \$1,501.00 (pain and suffering \$800.00)

200-3139 The applicant, a 21 year old shipper, was assaulted by one of a group of young men, following an argument with another member of the group, about girls. He sustained a fracture displacement of the nasal bones and the nasal septum, and injuries to his upper and lower teeth, requiring lengthy dental treatment. The offender was convicted of assault causing bodily harm and sentenced to 45 days in jail plus 27 months probation.

Award: \$2,864.06 (pain and suffering \$1,600.00)

200-3149 The applicant, a 21 year old student, was assaulted when he stopped to offer assistance to a car which was blocking an intersection. The driver punched him in the mouth twice and a passenger stabbed him in the throat twice. The wounds required extensive surgery. Two teeth were also damaged. No offenders were ever apprehended.

Award: \$4,390.00 (pain and suffering \$3,500.00)

200-3i77 The applicant, age 35, was assaulted twice while he was a prisoner at the Don Jail. The first time he refused to name his assailant. The Board invoked Section I7 (I) of the Act. The same person assaulted him again, fracturing his fingers. He named the assailant, who was charged but disappeared before the trial

Award: \$815.00 (pain and suffering \$500.00)

200-3179 The applicant, a 29 year old police officer, was assaulted while on duty, sustaining a fractured right wrist. The offender was convicted of causing a disturbance and fined \$200.00 or 15 days in jail.

Award: \$1.861.14 (pain and suffering \$1.500.00)

200-3180 The applicant, a 24 year old bus driver, came to the assistance of a fare collector who was being assaulted by two youths. He was kicked in the right temple, right leg and the groin. One youth was convicted of assault causing bodily harm and sentenced to 35 days in jail and one year probation. Award: \$406.00 (pain and suffering \$350.00)

200-3219 The applicant, a 32 year old scale master, was assaulted without provocation in a supermarket parking lot. His mouth was cut. The offender was convicted of common assault and received a suspended sentence plus one year probation.

Award: \$250.00 (pain and suffering \$250.00)

200-3220 The applicant, a 25 year old student, was assaulted in a friend's apartment by two men whom he had met for the first time and who were intoxicated. He sustained a face laceration and stab wound in the abdomen. The offenders were convicted of wounding. One received a sentence of I8 months definite and five months indefinite. Another was fined \$300.00 or 30 days. Award: \$850.00 (pain and suffering \$850.00)

200-3225 The applicant, a 26 year old police constable, was called to the scene of a fight. While trying to restrain one of the participants, he sustained stretched ligaments of the right shoulder. An operation was required to repair the damage. The offender was charged with obstructing police and sentenced to pay \$50.00 or 10 days.

Award: \$1,250.00 (pain and suffering \$1,250.00)

200-3236 The applicant, a 23 year old labourer, was struck in the throat with a broken beer bottle in an unprovoked attack at a party. He sustained severe damage to the trachea and cricoid cartilage. The offender was convicted of wounding and sentenced to 30 months in jail. The Board invoked Section 17 (I) of the Act to reduce the award slightly because of the applicant's life style and lack of discretion.

Award: \$1,940.00 (pain and suffering \$1,250.00)

200-3238 The applicant, a 34 year old police officer, was assaulted by two men he was attempting to arrest. They broke his finger and kicked him in the eye, leaving him with a permanent disability in his left index finger and ongoing pain in his eye. The offenders were convicted of assaulting a police officer. One was sentenced to 18 months in jail plus 18 months indeterminate. The other was sentenced to 12 months definite plus 18 months indeterminate.

Award: \$5,521.27 (pain and suffering \$3,500.00)

200-324l The applicant, a 60 year old radio producer, was assaulted and robbed by three unknown males, who left him with multiple facial bruises and a fractured skull. The offenders were never apprehended.

Award: \$1,324.44 (pain and suffering \$1,000.00)

200-3249 The applicant, a 32 year old housewife, was assaulted by her estranged husband. She sustained approximately 40 stab wounds on her face, arm, body and legs, leaving severe multiple scars. The offender was convicted of wounding and sentenced to 14 months in jail.

Award: \$3,845.00 (pain and suffering \$3,500.00)

200-3262 The victim, age 23, was struck across the head with a weighted baseball bat, sustaining a severe skull fracture. He later developed post-traumatic epilepsy and degenerated to a vegetative state. He cannot eat or feed himself and lost the capacity even to realize his own condition. Therefore the Board made no award for pain and suffering. The offender was convicted of wounding and sentenced to two years in jail plus two years probation. Award: \$6,915.20 plus \$60.00 per month.

200-3263 The applicant, a 23 year old office manager, was attacked in his home by two intruders who stabbed, choked and punched him into unconsciousness. He sustained a sprain of the spine and two stab wounds and has suffered nervousness, insomnia and anxiety. The assailants have not been apprehended.

Award: \$3,725.00 (pain and suffering \$2,500.00)

200-3294 The applicant, a 42 year old cab driver, was challenged to a fight after an argument with a man. He sustained a broken jaw and multiple contusions and lacerations to the face. A charge of assault causing bodily harm against the offender was dismissed because of reasonable doubt as to who caused the assault. The Board invoked Section 17 (I) of the Act to reduce the award. Award: \$585.00 (pain and suffering \$400.00)

200-3300 The applicant, age 26, and her husband were assaulted by two males. She sustained closed head injuries and a fractured left wrist. Two offenders were charged with assault causing bodily harm and sentenced to 3 years in jail.

Award: \$2,460.00 (pain and suffering \$1,800.00)

200-3320 The applicant, age 66, was struck in the face and robbed at his home by a masked person accompanied by two others. He sustained a lacerated scalp, lip and forehead. The offender was convicted of robbery with violence and sentenced to nine months in jail definite and 18 months indefinite.

Award: \$1,684.90 (pain and suffering \$1,250.00)

200-3321 The applicant, a 33 year old trapper, had been at a party but left when an argument arose between some women. Another man left the party shortly thereafter, waited for the applicant to go by on the road and shot him. The applicant was hit in the head and face and lost his right eye. The offender was convicted of wounding and sentenced to three months in jail. Award: \$3,850.00 and \$200.00 per month

200-3350 The applicant's husband died of stab wounds inflicted by his brother-in-law during an all-night party. The victim had argued with his sister and pushed her, following which the offender stabbed him in the chest with a small knife. The offender was convicted of manslaughter and sentenced to two years less a day in jail and two years probation.

Award: \$5,536.00 plus \$50.00 per month.

200-3355 The applicant claimed on behalf of his minor son who was suddenly punched and knocked down by an unknown assailant at a neighbourhood store. He lost a tooth and his face was swollen and bruised. No offender was apprehended.

Award: \$760.00 (pain and suffering \$600.00)

200-3365 The applicant, a 28 year old machine operator, was hit across the head several times with a piece of lumber in an unprovoked racial assault. His skull was fractured and his left temple severly lacerated. Charges against an alleged juvenile offender were dropped.

Award: \$1,625.40 (pain and suffering \$1,400.00)

200-3370 The applicant, a 50 year old taxi driver, picked up four passengers. One of them broke a side window and punched the applicant in the face and chest when he inspected the damage. The applicant suffered facial bruises and a slight abrasion on his chest. No arrests were made.

Award: \$400.00 (pain and suffering \$300.00)

200-337I The applicant, a 75 year old woman, was assaulted from behind as she walked within a block of her home. She suffered a slight concussion, lacerations to her lips and scalp, nausea, nervousness, high blood pressure and sleeplessness. She continues to suffer from headaches and nervousness. No offender was apprehended.

Award: \$1,056.00 (pain and suffering \$900.00)

200-3383 The applicant, a 50 year old caretaker, was assaulted and robbed in a hotel when he went to a room with a woman. He was intoxicated at the time. He

sustained a fractured nose, two fractured ribs and face lacerations. The offender was convicted of assault causing bodily harm and sentenced to nine months in jail. The Board invoked Section I7 (I) of the Act to reduce the award for pain and suffering.

Award: \$662.00 (pain and suffering \$500,00)

200-3387 The applicant, a 55 year old waitress, was assaulted by her son's friend after she refused his request to stay for a few days. She was thrown to the floor and dragged by the leg, receiving facial abrasions, a fractured right foot and sprained neck and traumatic capsulitis of the right shoulder. The offender was convicted of causing bodily harm with intent to injure and weapons dangerous and sentenced to 18 months in jail and three months concurrent.

Award: \$2,703.95 (pain and suffering \$1,750.00)

200-3397 The applicant, age 29, was knocked to the ground and struck across the face in a parking lot by a female. There was a history of disagreement between the two women. She sustained a lacerated lip and two loose teeth. The offender was convicted of assault causing bodily harm and put on probation for a year.

Award: \$510.00 (pain and suffering \$300.00)

200-3400 The applicant, a 38 year old labourer, was asked by a co-worker for a lift in his rowboat to the freighter where they worked. He refused and the man began cursing the applicant, who became angry and approached him with his arm raised to strike him. The offender lunged with a knife and wounded the applicant in the groin with a single blow. He was convicted of assault causing bodily harm and received a suspended sentence plus one year probation. The Board invoked Section 17(1) of the Act.

Award: \$1,051.95 (pain and suffering \$600.00)

200-3403 The applicant, a 43 year old cleaner, was struck in the face by the offender as he observed an altercation between him and his father, the applicant's neighbour. His nose was fractured. The offender was on parole and charges resulting from the incident were withdrawn.

Award: \$1,098.60 (pain and suffering \$750.00)

200-3409 The applicant, a 41 year old policeman, was bitten on the nose and hand while arresting a male driver for impaired driving. The offender was charged with assaulting a police officer and fined \$500.00. Award: \$665.20 (pain and suffering \$600.00)

200-3422 The applicant, age 60, shared her apartment with the offender. Following an argument, he viciously beat her, inflicting severe injuries including eight fractured ribs, a punctured lung, concussion, a blood clot under the scalp, brain damage affecting memory and balance, a lacerated liver and damaged spleen. The offender was sentenced to 13 months in jail.

Award: \$7,002.50 (pain and suffering \$3,500.00)

200-3425 The applicant, a 25 year old machinist, was slashed across the arm with a hockey stick by another player. The incident occurred apart from the centre of play. Without provocation, the offender raised his goalstick and with two hands slashed it at the applicant.

Award: \$6,163.54 (pain and suffering \$2,000.00)

200-3434 The applicant, a 43 year old shipper, was stabbed by his common-law wife following a quarrel. They had both been drinking. He sustained an abdominal wound which lacerated a portion of his bladder. The offender was convicted of causing bodily harm with intent to wound and was sentenced to an indeterminant period not over six months plus 18 months probation. The Board invoked Section 17 (I) of the Act.

Award: \$1,637.98 (pain and suffering \$900.00)

200-344l The applicant, a 4l year old machine operator, was talking to a woman beside his car when another man who had been involved with the woman attacked them in a fit of alcoholic jealousy, with an iron pipe. The applicant received blows to the head, hands, leg and knee with the iron pipe. His left centre finger is partially numb. His knee was lacerated and his leg fractured. The offender was convicted of assault causing bodily harm and sentenced to four months in jail.

Award: \$4,434.27 (pain and suffering \$2,700.00)

200-3459 The applicant, a 3I year old waitress, was assaulted by a female patron when she asked an unruly group to leave and refused to serve them further drinks. Her face was swollen, bruised, and lacerated. She also sustained dental damage. The offender was convicted of assault causing bodily harm and received a suspended sentence, probation for two years and ordered to pay \$600.00 restitution.

Award: \$353.20 (pain and suffering \$200.00)

200-3485 The applicant, a 25 year old apprentice mechanic, was part of a group leaving a local hotel. One of the group became involved in a fight with several other young men. The group returned to help him and a scuffle broke out. The applicant stood watching then was attacked by one person. He received a penetrating knife wound under his right armpit. The offenders were never apprehended.

Award: \$1,513.35 (pain and suffering \$950.00)

200-3490 The applicant, a 27 year old pizza deliveryman, was assaulted with the shaft of a hockey stick when he got off an elevator during a delivery. He was treated for head injuries, facial lacerations and skull abrasions and bruises. Charges of assault causing bodily harm and robbery were withdrawn against the alleged offenders when the applicant returned to Greece.

Award: \$1,345.00 (pain and suffering \$1,000.00)

200-3514 The applicant, a 55 year old stationary engineer, was struck by a baseball bat in an unprovoked assault on a Toronto street. He sustained a

fractured skull and still has major speech and memory problems. No offender was apprehended.

Award: \$3,000.00 (pain and suffering \$3,000.00)

200-3545 The applicant, a 25 year old machine operator, agreed to take care of children visiting the offender. When the offender drew a knife while the two men were talking, the applicant tried to take it away and was lacerated in the left hand. Charges of assault causing bodily harm and weapons dangerous were dismissed because of failure to notify witnesses of the trial date.

Award: \$1,817.06 (pain and suffering \$1,000.00)

200-355I The applicant, a 33 year old bookkeeper, was shot in the chest by a male neighbour who was jealous because the applicant had a brief affair with the offender's girlfriend. The bullet wound in the applicant's left shoulder has resulted in total loss of function of the arm. Amputation is a possibility. The alleged offender was charged with attempted murder but died of natural causes before the trial.

Award: \$3,035.00 (pain and suffering \$3,000.00)

200-3566 The applicant, claimed funeral expenses incurred after his son was shot to death by a man who was convicted of manslaughter and sentenced to eight years in jail.

Award: \$1,050.00

200-3575 The applicant, a 3I year old teacher, and her husband were at their residence when several youths gathered on opposite property and shouted profanities at the applicant's husband, inviting him out to fight. The applicant went outside to act as a peacemaker. When her husband shot an approaching youth, another grabbed the applicant's arm and twisted it until it broke. The offender was convicted of assault causing bodily harm and sentenced to 30 days in jail.

Award: \$1,281.80 (pain and suffering \$750.00)

200-3577 The victim, a I3 year old student, was assaulted by four youths while returning from school. He was kicked in the face, chest, stomach and testicle. Two teeth were seriously damaged. The offenders were not identified or apprehended.

Award: \$1,253.50 (pain and suffering \$750.00)

200-3585 The applicant, a 29 year old construction worker, and the offender were in a tea-room together but left separately after the offender began to abuse an older patron. The offender later caught up with the applicant, tried to hit him with a club, and stabbed him in the stomach lacerating his stomach and pancreas. The offender was convicted of wounding and sentenced to nine months in jail with probation for one year.

Award: \$1,825.25 (pain and suffering \$1,600.00)

200-3597 The applicant, a 42 year old bus driver, was hit behind the right ear and in the face by an unknown male passenger who escaped and has never been apprehended. He sustained two black eyes and an undisplaced fracture of the nose which may require surgery. He suffered pain and discomfort for two months.

Award: \$1,635.00 (pain and suffering \$1,500.00)

200-3604 The applicant, a 33 year old child care worker, went to the aid of another case worker who was struggling with a juvenile in a home for disturbed children and was kicked in the groin. The offender was charged with assault causing bodily harm but the charge was withdrawn as the offender was a juvenile.

Award: \$495.40 (pain and suffering \$300.00)

200-3623 The applicant, a 20 year old millwright, was assaulted by a man who thought that the applicant's vehicle had interfered with his crossing the street. He suffered from his injuries - bruises to his legs and middle part of his body - for six months. The offender was convicted of assault causing bodily harm and mischief and sentenced to 18 months in jail.

Award: \$2,058.07 (pain and suffering \$1,000.00)

200-3628 The applicant, a 57 year old housewife, was assaulted by her former son-in-law. Her wrist was fractured and her arm is probably permanently crippled. The offender was convicted of assault causing bodily harm and sentenced to 30 days in jail plus two years probation.

Award: \$5,017.60 (pain and suffering \$5,000.00)

200-3639 The applicant, a 30 year old clerk, caught a child assaulting another child in the schoolyard and took him to the principal. He was subsequently assaulted in his home by that child's father, sustaining dental damage, abrasions, facial bruises, a laceration and a swollen mouth. The offender was convicted of common assault and received a suspended sentence plus one year probation.

Award: \$786.70 (pain and suffering \$500.00)

200-3644 The applicant, a 26 year old labourer, was the victim of an unprovoked assault in a donut shop. He received extensive contusions to his head and chest, a fractured tooth, a fractured jaw and a fractured nose. He suffers from continuing sinusitis. The offender was convicted of assault causing bodily harm and sentenced to six months in jail and one year probation.

Award: \$2,457.60 (pain and suffering \$1,800.00)

200-3650 The applicant, a 19 year old student, was assaulted by a member of a rival football team. His nose was badly broken. The offender was convicted of assault causing bodily harm and sentenced to six days in jail plus eight months probation. Because the applicant had made derogatory remarks about the offender's religion, the Board invoked Section 17 (I) of the Act to reduce the award for pain and suffering.

Award: \$2,896.72 (pain and suffering \$2,400.00)

200-3654 The applicant, age 20, and a friend, were assaulted by three males as they were leaving a park. He was hit in the face and right eye sustaining bruises and a displaced retina. Previous injury to the eye was aggravated by the injury reducing his limited vision to light perception only. He will possibly lose the eye. Three offenders were convicted of assault causing bodily harm and each fined \$150.00 or 30 days in prison.

Award: \$1,630.00

200-3671. The applicant, age 34, was struck in the face with a beer glass by a man whom he knew slightly. He sustained multiple face lacerations and two fractured teeth. The offender was convicted of assault causing bodily harm and fined \$500.00 or six months in jail.

Award: \$1,244.15 (pain and suffering \$1,000.00)

200-3674 The applicant, age 31, was walking with his fiancee when four unknown persons made racial insults to her. The applicant was stabbed when he intervened and was wounded over the left eye. The offender was convicted of assault causing bodily harm and sentenced to ten months in jail.

Award: \$750.00 (pain and suffering \$750.00)

200-3677 The applicant, a 20 year old student, was burned when gasoline poured over an outdoor washroom was ignited. He sustained first degree burns to his face and second degree burns to both hands and right wrist. The arsonist was not apprehended. The Board invoked Section 17(1) of the Act to reduce the award for pain and suffering because the applicant was aware of the potential danger and admitted his judgement may have been clouded from drinking. Award: \$777.77 (pain and suffering \$500.00)

200-3678. The applicant, age 80, was knocked down on an escalator by a young boy riding upwards on the rail. The boy ran away and was never apprehended. She sustained a fractured right hip.

Award: \$950.00 (pain and suffering \$500.00)

200-3682 The applicant, a 44 year old handyman, was punched and kicked into unconsciousness in an unprovoked attack by several men in a park. He sustained fractures to his right leg, ankle, and nasal bones, lacerations to his face and legs and serious damage to his teeth. No offender has been apprehended.

Award: \$4,886.40 (pain and suffering \$2,500.00)

200-3693 The applicant, a 66 year old widow, was pushed from behind on the lower part of her back while waiting for a bus at the subway station. She fell forward and injured her right shoulder. No offender was apprehended.

Award: \$2,791.00 (pain and suffering \$1,500.00)

200-3706 The applicant, a 55 year old production manager, was assaulted and robbed in a hotel washroom. He was struck from behind, punched, and kicked in the groin. He sustained a lip laceration and extensive swelling of his face and neck. No offender has been apprehended.

Award: \$1,304.00 (pain and suffering \$800.00)

200-3707 The applicant, a 30 year old taxi driver, was assaulted by a passenger, sustaining a fractured nose. The alleged offender was charged with common assault and was given a conditional discharge.

Award: \$903.50 (pain and suffering \$600.00)

200-3713 The applicant, aged 21, was at the home of a friend when another man entered, told him to leave, and struck him across the face with a metal bar. The applicant suffered severe lacerations and cheekbone damage. The offender was convicted of assault causing bodily harm and received a suspended sentence, plus probation for 18 months and restitution.

Award: \$847.33 (pain and suffering \$250.00)

200-3719 The applicant, a 63 year old shopkeeper, was attacked by a young man in his store. In the ensuing fight, his neck was twisted and his arm and shoulder twisted to the point of dislocation. The offender was convicted of mischief and sentenced to 60 days in jail and 12 months probation. Award: \$5,728.66 (pain and suffering \$2,750.00)

200-3724 The applicant, aged 31, was one of a group of professionals on an accounting assignment. The group was approached by four or more men who started a fight. The applicant was struck on the face, mouth, and torso and sustained a deep laceration to his lower lip. Two offenders were convicted of assault causing bodily harm and common assault. One was sentenced to one month and seven days concurrent. The other was fined \$150.00 or 15 days. Award: \$700.00 (pain and suffering \$700.00)

200-3728 The applicant, a 51 year old construction worker, walked by a man with whom he had had a fight a year earlier. The offender swung a piece of wood at him, severely fracturing his left forearm. The offender was convicted of common assault and received a conditional discharge plus 12 months probation.

Award: \$3,932.91 (pain and suffering \$1,500.00)

200-3747 The applicant, a 25 year old hotel bouncer, ejected a man from the premises. He returned with his brothers and attacked the applicant. The offender was convicted of assault and fined \$250.00. Award: \$600.00 (pain and suffering \$600.00)

200-3751 The applicant, age 44, was assaulted and robbed in the hotel where he was a permanent resident. His left leg was fractured in two places. No

offenders were apprehended. Because the applicant was very intoxicated at the time of the assault, the Board invoked Section 17(1) of the Act to reduce the award for pain and suffering.

Award: \$2,540.00 (pain and suffering \$2,500.00)

200-3752 The applicant, a 51 year old construction worker, was hit in the left eye when a gun his friend was showing him discharged. He lost completely his vision in that eye and suffers from headaches, dizzy spells, and depression. The offender was convicted of dangerous use of a firearm and sentenced to 60 days in jail plus two years probation or a \$300.00 fine.

Award: \$10,456.00 plus \$400.00 per month (pain and suffering \$7,500.00)

200-3755 The applicant, a 25 year old student, was attacked by an unknown male who tried to strangle her and pull her into the bushes. She resisted the attack but sustained a swollen lip, bruises on her arm, scratches on both legs and muscle strain. The assailant was never apprehended.

Award: \$729.00 (pain and suffering \$500.00)

200-3756 The applicant, a 29 year old computer programmer, was attacked by two men while riding on a city bus. The basis of the assault was racial discrimination. His face and body were bruised and his front teeth required capping. The offender was convicted of assault causing bodily harm and received a three month sentence.

Award: \$920.00 (pain and suffering \$700.00)

200-3763 The applicant, a 38 year old secretary, was walking to work when she was attacked by an unknown man. She sustained multiple facial bruises and black eyes. The offender was convicted of assault causing bodily harm and given a suspended sentence and one year of probation.

Award: \$426.95 (pain and suffering \$400.00)

200-3766 The applicant, a 29 year old clerk, was arrested for drunkenness. While in the drunk tank, he was kicked in the eye by another man who had also been arrested for drunkeness. The offender was charged with assault causing bodily harm and common assault and acquitted because of inconsistency of evidence.

Award: \$200.00 (pain and suffering \$200.00)

200-3767 The applicant, a 23 year old policeman, was injured by a bomb which exploded in a milk store. He sustained a mild concussion, strained back and neck muscles and tension. No offender was apprehended. Award: \$500.00 (pain and suffering \$500.00)

200-3770 The applicant, age 49, accompanied a male friend of her son who had resided at her home to a local lounge to drink beer. They returned home and continued drinking until the offender became abusive. He beat her with a strap and struck her with a boot, fracturing her cheekbone. She also sustained

multiple bruises to her face and body. The offender was convicted of assault causing bodily harm and sentenced to two months in jail. The Board invoked Section 17(1) of the Act.

Award: \$805.65 (pain and suffering \$750.00)

200-3786 The applicant, a 60 year old material handler, was assaulted with a belt and knocked through a store window in an unprovoked assault on a Toronto street. His face and arms were bruised and lacerated and he also sustained internal injuries. The offender was convicted of weapons dangerous and assault causing bodily harm and sentenced to 60 days in jail plus two years probation.

Award: \$1,183.00 (pain and suffering \$1,000.00)

200-3797 The applicant, a 46 year old store owner, was assaulted by a male, who, armed with a broken bottle, demanded money. He received lacerations to both hands which will result in a 10 percent decrease in range of movement. The offender was convicted of robbery and sentenced to two years less a day definite and two years less a day indefinite in jail.

Award: \$505.00 (pain and suffering \$500.00)

200-3804 The applicant, a 33 year old welder, took exception to remarks made by a male sitting at a nearby table in a restaurant and left. The man was waiting outside and assaulted him with his fists. The applicant sustained a fractured nose. The offender was convicted of assault causing bodily harm and fined \$200.00 or 20 days. Because the applicant was intoxicated at the time of the assault and had asked the offender to go outside to talk, the Board invoked Section 17(1) of the Act.

Award: \$686.65 (pain and suffering \$300.00)

200-3808 The applicant, a 24 year old police officer, sustained torn ligaments in his left ankle while chasing a suspect. No charges were laid.

Award: \$400.00 (pain and suffering \$400.00)

200-3816 The applicant, age 22, whose wife was superintendent of the building in which they lived, put a note on a tenant's car, requesting him to move it. The tenant tore up the note and punched the applicant in the face, breaking his jaw. The offender was convicted of assault causing bodily harm and fined \$300.00.

Award: \$1,237.40 (pain and suffering \$850.00)

200-3831 The applicant, age 40, was assaulted by another man when he stopped to inquire why the man had thrown a can at his car. He was left with a swollen nose and minor facial bruises and lacerations. The offender was convicted of common assault and fined \$300.00 or 30 days in jail. Award; \$875.50 (pain and suffering \$300.00)

200-3835 The applicant, a 33 year old student, while walking home was punched by two unknown males who made a racial slur and broke his nose with a punch. The offenders were never apprehended.

Award: \$387.00 (pain and suffering \$350.00)

200-3840 The applicant, a 33 year old shipper, was drinking at a hotel when two men at his table became involved in a fight. He was punched several times and left. The assailant caught up with him in the parking lot and assaulted him with a broken beer glass. His shoulder was lacerated and his left eye was swollen. The offender was never apprehended.

Award: \$2,658.2l (pain and suffering \$1,600.00)

200-3843 The applicant, a 44 year old housewife, agreed to let a stranger use her telephone. She later asked him to leave and he became abusive, striking her on her face and head and producing a gun to enforce his demands. She sustained a fractured cheekbone, two damaged teeth and a blackened right eye. The offender was convicted of robbery and assault causing bodily harm and sentenced to three years in jail.

Award: \$1,655.88 (pain and suffering \$1,500.00)

200-3851 The applicant claimed on behalf of her four year old son who was knocked to the ground by an unknown youth riding a bicycle. The boy's right leg was fractured. No offender was apprehended.

Award: \$860.58 (pain and suffering \$800.00)

200-3853 The applicant, age 69, was knocked down by an unknown youth who stole her purse. She sustained a fracture of the right humerus and right hip and endured a long period of therapy treatments and convalescence. The offender was never apprehended.

Award: \$3,819.00 (pain and suffering \$3,000.00)

200-3870 The applicant, age 35, was in a correctional centre when he was kicked and punched in the head by another man who had mistaken him for his brother. Blood filled into his eyes and his nose was fractured. No charges were laid against the offender.

Award: \$400.00 (pain and suffering \$400.00)

200-3880 The applicant, an I8 year old student, was hitchhiking when a vehicle drove up and a male struck the applicant through the window, knocking him to the ground. His skull and jaw were fractured. The offender was convicted of assault causing bodily harm and received a suspended sentence, I2 months probation and order to pay \$200,00 restitution.

Award: \$1,401.50 (pain and suffering \$1,050.00)

200-3882 The applicant, a 54 year old night clerk, was struck in the head by a young man who came into the hotel to buy a chocolate bar. She received a deep laceration on the back of her head. The offender was never apprehended. Award: \$1,520.00 (pain and suffering \$1,500.00)

200-3896 The applicant, age 53, became involved in an argument with his step-brother. He left the house but his step-brother, who was drunk, struck him several times with a large wooden club. He sustained left arm, leg and rib fractures and bruises on his back. The offender was convicted of assault causing bodily harm and common assault and was sentenced to 12 months definite and six months indeterminate on the first charge and one month consecutive on the second.

Award: \$2,143.00 (pain and suffering \$1,850.00)

200-3898 The applicant, a 24 year old labourer, sustained a torn ligament of the left ankle while chasing two males who had attempted to break into a service station. He was on crutches for three months. Three offenders were convicted of breaking and entering. They each received a suspended sentence plus probation for two years.

Award: \$1,314.11 (pain and suffering \$600.00)

200-3906 The applicant, a 57 year old sales clerk, was struck with an empty soft drink bottle while shopping, giving her two black eyes, a swollen cheek, a scalp laceration and a fractured nose. A male juvenile was convicted in Juvenile Court.

Award: \$851.40 (pain and suffering \$600.00)

200-3913 The applicant, a 39 year old switchboard operator, was a housekeeper for the offender. Upon investigating a light left on in his bedroom, she was assaulted by the offender, receiving minor injuries to her face, back, arms and chest. The offender was convicted of common assault and fined \$100.00 or 20 days in jail. The Board invoked Section 17 (I) of the Act to reduce the award for pain and suffering because the applicant was intoxicated at the time of the assault.

Award: \$900.25 (pain and suffering \$400.00)

200-3921 The applicant, a 27 year old bookkeeper, was the victim of a racial assault in a disco. He sustained a fractured nose, a fractured rib, concussion, multiple contusions and dental damage. The offender was convicted of assault causing bodily harm.

Award: \$2,646.44 (pain and suffering \$2,500.00)

200-3925 The applicant, a 50 year old chef, while acting as a referee at a soccer game, was struck in the mouth by a coach of one team. His upper lip was lacerated and he sustained severe dental damage. The offender was convicted of assault causing bodily harm and fined \$750.00 or 30 days in jail.

Award: \$2,686.46 (pain and suffering \$2,000.00)

200-3927 The applicant, a 22 year old policeman, off-duty at the time, approached a car which had forced him to the curb three times. The driver started up at a high speed and drove straight at the applicant, who jumped clear but was knocked against another car. He underwent surgery to repair torn cartilage of the left knee and was off work for two months. The offender was charged with criminal negligence but convicted of careless driving and fined \$200.00 or thirty days.

Award: \$1,250.00 (pain and suffering \$1,250.00)

200-3938 The applicant, a 29 year old housewife, was one of four people assaulted by members of a noisy party about which they had complained to hotel management. She sustained facial abrasions and multiple fractures of the left ring finger. Two offenders were found guilty of common assault and each fined \$50.00.

Award: \$1,028.00 (pain and suffering \$500.00)

200-395I The applicant, age 6I, was stabbed by another resident in the rooming house where he lived. Several residents had been drinking and playing cards, when a verbal argument ensued and continued until the next day when the attack occurred. The applicant received wounds in the groin and back. The offender was convicted of wounding and sentenced to one year in jail. Section 17 (I) of the Act was invoked to reduce the award.

Award: \$378.00 (pain and suffering \$250.00)

200-3962 The applicant, a 24 year old salesman, was helping the driver of an automobile involved in a two car accident, when the driver of the second car struck him several times. He sustained facial abrasions and lacerations and broken and chipped teeth. The offender was convicted of common assault and sentenced to seven days in jail.

Award: \$1,573.00 (pain and suffering \$600.00)

200-3965 The applicant, an 80 year old part-time attendant, was assaulted and robbed in his apartment. He was left bound and gagged and would have suffocated if a neighbour had not rescued him. The applicant sustained soft tissue injuries and severe emotional trauma. He has moved to a nursing home and is no longer alone. The offender was convicted of robbery with violence and sentenced to three years in jail.

Award: \$705.00 (pain and suffering \$700.00)

200-3989 The applicant, a 22 year old labourer, was assaulted when he tried to stop three men from breaking into a car in the parking lot of his apartment building. He sustained a fractured arm, multiple abrasions and bruising to his face. Two offenders were convicted of assault causing bodily harm and sentenced to 60 days in jail.

Award: \$3,801.74 (pain and suffering \$2,500.00)

200-3992 The applicant, a 44 year old service station attendant, was assaulted by two youths at a service station. He sustained extensive bruising to his head,

face and body, a fractured nose and lost three teeth. The offenders were convicted of common assault. One was sentenced to three months in jail and the other was fined \$400.00 or 40 days. Award: \$2,6II.76 (pain and suffering \$2,000.00)

200-3994 The applicant, a 22 year old doorman, was assaulted by two males when he intervened in a glass throwing incident in a tavern. He was hit in the face with a glass, causing multiple lacerations to the left side of his face and upper lip. A warrant is outstanding for the arrest of one offender. Charges against another were dropped because there was insufficient evidence. Award: \$1,361.86 (pain and suffering \$1,000.00)

200-4016 The applicant, a 26 year old labourer, was assaulted and robbed by two unkown males in an alley. He sustained a cerebral concussion, lacerated upper lip and dental injuries. The offenders were never apprehended. Award: \$350.00 (pain and suffering \$350.00)

The applicant, a 23 year old cook, was kicked in the mouth and knocked to the ground when he went to help a friend who was also being assaulted. Two teeth were chipped and his mouth was swollen. The offender was convicted of assault causing bodily harm and received a suspended sentence plus two years probation.

Award: \$300.00 (pain and suffering \$250.00)

200-4022 The applicant, a 22 year old process operator, was driving on a ramp when he was cut off by an unknown person who then opened his door and assaulted him. He was knocked unconscious and treated for a serious nose laceration and three broken teeth. No offender was apprehended. Award: \$595.00 (pain and suffering \$500.00)

200-4026 The applicant, a 25 year old labourer, attended a party where he was bothered by an argumentative guest. The applicant invited him outside to settle things and was punched on the way out. He retaliated. Other guests calmed them down but the offender attacked the applicant twice more, the second time while carrying two knives. The applicant received a deep wound to his groin and a further laceration on the hip. The offender was convicted of wounding and sentenced to 18 months in jail and two years probation. The Board invoked Section 17 (I) of the Act.

Award: \$2,189,25 (pain and suffering \$1,800.00)

200-4030 The applicant, a 26 year old clerk, was struck with a rock when he returned to the site of an earlier scuffle to look for his glasses. He received lacerations to his forehead, left hand and right wrist. The offender was charged with assault causing bodily harm but the case was dismissed. The Board invoked Section 17 (I) of the Act to reduce the award.

Award: \$1,146.92 (pain and suffering \$750.00)

200-4031 The applicant, a 26 year old store security officer, was assaulted by a

man she was attempting to arrest for shoplifting. Her finger was broken and healed crookedly. The offender was convicted of assault causing bodily harm and sentenced to six months in jail.

Award: \$500.00 (pain and suffering \$500.00)

200-4032 The applicant claimed expenses incurred on the death of her 23 year old son. He died of stab wounds. The offender has not been apprehended, but on the basis of police investigation, the Board invoked Section I7 (I) of the Act. Award: \$1,136.00

200-4036 The applicant, a 50 year old police constable, was struck in the mouth, face and upper right biceps and kicked in the right calf when he arrested a man at a public dance for being drunk and disorderly. He is left with a permanent swollen vein structure of the right calf and 50 percent loss in the use of his right arm. The offender was convicted of assaulting a police officer and received an 18 month suspended sentence and 18 months probation.

Award: \$5,040.00 (pain and suffering \$5,000.00)

200-404l The applicant, a 55 year old woman, was attacked by two youths who tried to snatch her purse. She struggled and fell, hitting her back. She was treated for fractured ribs, lumbar spine contusions, left lung collapse and three loose teeth. The offenders were never apprehended. Award: \$2,467.00 (pain and suffering \$1,000.00)

200-4049 The applicant, a 43 year old waiter, was attacked with a knife by a tenant residing in his home. His thumb was almost severed from his left hand. He suffers some discomfort in cold weather and there is a slight loss of grip. The offender was convicted of wounding and sentenced to three months in jail. Award: \$1,000.00 (pain and suffering \$1,000.00)

200-4067 The applicant, a 32 year old policeman, while off-duty, noticed a car being driven in a hazardous manner in a parking lot. He suggested the offender leave but he became violent and attacked the applicant, leaving him with cuts on the elbows and knees, a cut lip and a bite on one finger. The offender was convicted of common assault and fined \$100.00.

Award: \$517.60 (pain and suffering \$500.00)

200-4072 The applicant, age 38, was attacked with a pair of scissors by her common-law husband when he found her in bed with another man. She was wounded in the neck, on her left side and on her left thumb. The offender was convicted of assault causing bodily harm and sentenced to 40 days in jail plus 18 months probation. The Board invoked Section 17 (I) of the Act to reduce the award for pain and suffering.

Award: \$682.25 (pain and suffering \$200.00)

200-4080 The applicant, a 5I year old industrial officer, while working at a correction centre was struck on the head and left rib cage with a steel pipe by an inmate. The offender was convicted of wounding and sentenced to I8 months

determinate and nine months indeterminate. Award: \$1,210.00 (pain and suffering \$1,000.00)

200-4089 The applicant, a 69 year old security guard fell while chasing unidentified youths who were attempting to steal goods. He fractured his left hip and uses crutches to aid him in walking.

Award: \$6,107.38 plus \$500.00 per month (pain and suffering \$4,500.00)

200-4095 The applicant, a 46 year old bus driver, was on duty when an unknown male grabbed him and threw him out of the bus, giving him two fractured ribs and a bruised shoulder. No offender was apprehended. Award: \$525.00 (Pain and suffering \$500.00)

200-4098 The applicant, a 47 year old transit operator, requested an intoxicated passenger to stop smoking and was assaulted. His right thumb was fractured. The offender was convicted of assault causing bodily harm and fined \$500.00 or 30 days in jail.

Award: \$2,423.55 (pain and suffering \$1,000.00)

200-4III The applicant, a 56 year old housewife, returned to her home to discover two men leaving with pillowcases filled with stolen goods. They struck her on the face with one pillowcase, fracturing her cheekbone. She has been left with permanent numbness and pain on the right side of her face. No offenders were apprehended.

Award: \$1,605.15 (pain and suffering \$1,200.00)

200-4122 The applicant, a 23 year old machine operator, was assaulted by one of three visitors whom he had asked to leave. When he threatened to call the police, he was punched about the face. He sustained serious dental damage resulting in the loss of four upper teeth, facial bruises and a laceration below the left eye. The offender was convicted of common assault and fined \$200.00 or 14 days in jail.

Award: \$1,945.96 (pain and suffering \$850.00)

200-4l3l The applicant, a 42 year old carpenter, while acting as an interpreter in a landlord-tenant dispute was assaulted by one party. His right ankle was severely fractured. A warrant is outstanding for the arrest of the alleged offender.

Award: \$15,499.50 (pain and suffering \$5,000.00)

200-4132 The applicant's daughter was shot to death with her common-law husband in a double murder. The alleged offenders were acquitted of murder and accessory after the fact, respectively.

Award: \$1,011.00

200-4133 The applicant, age 55, was visiting a garage where he kept his truck.

A fight broke out between the owners and two brothers. One of the brothers hit the applicant on the head with a full whiskey bottle and jammed the remainder of the bottle into the applicant's face. The applicant had a heart failure and later lost his right eye. The offender was charged with wounding and sentenced to three years. The Board invoked Section 17(1) of the Act because the applicant was not sober at the time of the attack and made a remark which initiated the attack.

Award: \$6,792.29 (pain and suffering \$6,000.00)

200-4134 The applicant claimed on behalf of his 13 year old son. He and his friends were out walking, when another friend fired a pellet gun in their direction to get their attention. The victim was hit in the eye, which later was replaced by an artificial one. The offender was convicted under the Juvenile Delinguents Act.

Award: \$10,145.15 (pain and suffering \$10,000.00)

200-4136 The applicant, a 28 year old taxi driver, attempted to intervene in an argument between the offender and a female guest at a wedding reception, and was assaulted with a broken bottle. He received multiple lacerations to the left flank and both shoulders. The offender was convicted of assault causing bodily harm and sentenced to 45 days in jail.

Award: \$2,541.80 (pain and suffering \$800.00)

200-4140 The applicant, a 44 year old policeman, was struck in the mouth while attempting to arrest a male drinking beer on the sidewalk. The offender was convicted of assault causing bodily harm and sentenced to 16 days in jail plus three months probation.

Award: \$500.00 (pain and suffering \$500.00)

200-4143 The applicant claimed on behalf of her daughter, age 14, who was attacked without provocation, by a juvenile. She sustained a lower leg injury and the offender was convicted in Juvenile Court.

Award: \$883.80 (pain and suffering \$650.00)

200-4150 The applicant's daughter was killed by her estranged husband who was convicted of manslaughter and sentenced to six years in jail. The Board awarded funeral expenses.

Award: \$1,000.00

200-4152 The applicant claimed on behalf of his 16 year old son, who was the victim of an unprovoked assault by another student. His nose was broken, his face bruised and three teeth were chipped. The offender was convicted of assault causing bodily harm and received a suspended sentence plus six months probation.

Award: \$756.06 (pain and suffering \$650.00)

200-4156 The applicant, a 25 year old farm labourer, returned to a former

address to collect mail from his neighbour who, without provocation, became argumentative and shot the applicant in the thigh. His right foot is now without sensation and movement. The offender was convicted of dangerous use of a firearm and sentenced to 30 days in jail.

Award: \$5,487.61 plus \$125.00 per month (pain and suffering \$5,000.00)

200-4157 The applicant, a 24 year old policeman, was struck in the face by pellets from a sniper's gun. He still suffers earaches and headaches. The offender died from gunshot wounds.

Award: \$1,817.60 (pain and suffering \$1,800.00)

200-4172 The applicant, a 73 year old pensioner, was knocked to the ground by an unidentified youth who stole her purse. Her left shoulder was fractured and she still suffers pain and discomfort.

Award: \$1,880.00 (pain and suffering \$1,700.00)

200-4175 The applicant claimed funeral expenses for her husband, a 41 year old cook, who was killed by an explosion in the restaurant where he worked. Award: \$1,000.00

200-4181 The applicant, a 33 year old labourer, ws struck in the face with a beer bottle while in a local hotel. His right cheek was lacerated and is left with a three-inch scar. The offender pleaded guilty to assault causing bodily harm and was sentenced to six months in jail.

Award: \$1,484.50 (pain and suffering \$1,250.00)

200-4189 The applicant, a 51 year old saw mill operator, received a beating by a man after challenging him to a fight. He received severe injuries to his head, resulting in permanent vision loss in one eye. The offender was convicted of assault causing bodily harm and fined \$150.00. The Board invoked Section 17(1) of the Act to reduce the award for pain and suffering.

Award: \$2,544.00 plus \$150.00 per month (pain and suffering \$2,500.00)

200-4191 The applicant claimed on behalf of his son, a minor, who was assaulted by three males who tried to rob him as he walked to work. He was kicked several times, causing bruises to his face and arms. Three teeth were fractured. No offenders were apprehended.

Award: \$667.80 (pain and suffering \$350.00)

200-4192 The applicant, a 20 year old policeman, was investigating a possible break and enter when a man suddenly went berserk and fell on top of him, injuring his left ribs. The offender was convicted of common assault and fined \$150.00 or 15 days plus one year probation.

Award: \$500.00 (pain and suffering \$500.00)

200-4203 The applicant, age 33, was assaulted when he went to the aid of a

friend who was being choked during a tavern brawl. He sustained a concussion, multiple nose fractures, bruises, abrasions, and loosened front teeth. No offender was charged.

Award: \$1,338.95 (pain and suffering \$1,000.00)

200-4204 The applicant, a 30 year old truck driver, was shot in the right leg after he objected to remarks made by the offender to a female friend of his. The offender was convicted of wounding and sentenced to eight months in jail and three years probation.

Award: \$2,305.70 (pain and suffering \$1,100.00)

200-4205 The applicant, a 60 year old writer, was robbed at knife-point as he walked home. His face and throat were lacerated. The offender was not apprehended.

Award: \$1,250.00 (pain and suffering \$1,250.00)

200-4213 The applicant, a 29 year old hotel owner, was assaulted when he asked an unruly male patron to leave. He sustained a deep laceration on his left arm leaving a four inch scar. The offender was convicted of assault causing bodily harm and sentenced to one month in jail.

Award: \$1,153.90 (pain and suffering \$750.00)

200-4218 The applicant claimed on behalf of her 13 year old daughter who was struck over the head with a telephone receiver by her stepfather. The applicant was also assaulted and sustained a scalp laceration. The offender was convicted of assault causing bodily harm and imprisoned.

Award: \$1,650.00 (pain and suffering \$1,650.00)

200-4219 The applicant, age 50, was assaulted with a metal pipe by someone who broke into his room. Both his legs were fractured, leaving the applicant with a permanent drop left foot. His head and arms were also injured. Charges against the alleged offender were dropped because of insufficient indentification.

Award: \$10,410.00 (pain and suffering \$10,000.00)

200-4223 The applicant, a 46 year old maintenance man, was the victim of an unprovoked assault while in his car. He was punched in the mouth and required five months of dental treatment. The offender pleaded guilty to assault causing bodily harm and was fined \$250.00 or 30 days in jail. Award \$908.00 (pain and suffering \$450.00)

200-4230 The applicant, a 59 year old security guard, was assaulted by a man with a stick, who was throwing stones at cars in the applicant's apartment parking lot. His scalp was lacerated and he experienced dizzy spells. No offender was apprehended.

Award: \$1,005.96 (pain and suffering \$500.00)

200-4233 The applicant, a 24 year old auxiliary police officer, was assaulted while trying to arrest a man and received bruised ribs. The offender was convicted of assaulting a police officer and fined \$350.00 or 21 days in jail. Award: \$233.20 (pain and suffering \$200.00)

200-4240 The applicant, a 33 year old dietary aide, was seated next to a window on a streetcar when she was hit by a snowball which broke the window. Her face was lacerated. No offender was apprehended. Award: \$200.00 (pain and suffering \$200.00)

200-4242 The applicant, a 65 year old press helper, was assaulted without provocation by his 24 year old grandson. His jaw was fractured. The offender was convicted of assault causing bodily harm and sentenced to 30 days in jail plus one year probation.

Award: \$2,356.69 (pain and suffering \$1,500.00)

200-4247 The applicant, a 33 year old mine worker, was staying at a friend's home to protect the man's mother who had often been struck by her son when he had been drinking. The son arrived home drunk and punched the applicant in the mouth, smashing his dental plate and causing minor lacerations and bruises. The offender was found guilty of common assault and fined \$100.00 or 15 days.

Award: \$469.38 (pain and suffering \$300.00)

200-4257 The applicant, a 57 year old housewife, was assaulted and her purse snatched. Her left arm was severely sprained. No offender has been apprehended.

Award: \$1,472.25 (pain and suffering \$1,000.00)

200-4258 The applicant claimed on behalf of his 10 year old son who was shot in the leg while kite-flying at their cottage. No charges were laid because forensic tests on the bullet were inconclusive.

Award: \$837.00 (pain and suffering \$600.00)

200-4266 The applicant, a 41 year old seaman, was assaulted when he went to the aid of his brother who was involved in an altercation with three youths. His left eye was bruised and lacerated. No offenders were apprehended. Award: \$100.00 (pain and suffering \$100.00)

200-4271 The applicant, a 48 year old mine worker, was assaulted by two men with whom he had been drinking earlier. Their female companions then robbed him. He was treated for a broken left forearm and bruises and lacerations to his face and knees. Two male offenders were convicted of assault causing bodily harm. One was sentenced to 60 days in jail. The other received a conditional discharge and probation for one year. One female offender was convicted of possession of stolen goods. A warrant is outstanding for the arrest of another. Award: \$4,371.42 (pain and suffering \$1,500.00)

200-4279 The applicant, a 47 year old policeman, observed a man assaulting a motorist. He apprehended and arrested the man but was punched in the face while doing so. His nose was broken and both eyes blackened. The offender was convicted of assaulting a police officer and common assault and sentenced to two months in jail with one year probation on the first charge and 20 days in jail on the second charge.

Award: \$750.00 (pain and suffering \$750.00)

200-4281 The applicant, a 40 year old assembly line worker, apprehended a prowler outside his house while waiting for the police to arrive. In the struggle, he was bitten on the right ear and injured on his right shoulder and elbow. A warrant is outstanding for the arrest of the offender who was charged with assault causing bodily harm.

Award: \$1,271.60 (pain and suffering \$1,000.00)

200-4282 The applicant, a 51 year old store owner, was hit over the head with a heavy object by a man who had entered her store. Her head was lacerated. No offender was apprehended.

Award: \$840.75 (pain and suffering \$700.00)

200-4284 The applicant, a 33 year old teacher, was assaulted by two juveniles who threw a can and a bottle at her face, threw her on the ground and kicked and punched her. She sustained a serious injury to her left eye and contusion and sprain of the lumbar spine. The offenders were convicted and each ordered to pay \$250.00 to an eye research foundation or charity.

Award: \$4,065.15 (pain and suffering \$2,700.00)

200-4304 The applicant, a 29 year old carpenter, during a hotel fracas was struck in the face with a beer glass. He sustained facial lacerations and a fractured right hand. The offender was never apprehended.

Award: \$1,420.50 (pain and suffering \$1,000.00)

200-4306 The applicant, a 56 year old security guard, intervened in a quarrel between the offender and his wife when she called for help. He was stabbed in the left shoulder. The offender was convicted of common assault and fined \$200.00 plus probation for one year.

Award: \$97.92 (pain and suffering \$50.00)

200-4307 The applicant, a 50 year old store clerk, was kicked in the ribs, eye and nose, while struggling with the offender who, armed with a knife, had attempted to rob the store. The assailant was never apprehended.

Award: \$621.25 (pain and suffering \$600.00)

200-4312 The applicant, age 47, was assaulted without provocation, with a poker. His left foot was fractured. The offender was convicted of assault causing bodily harm and sentenced to 23 months in jail plus two years probation. Award: \$800.00 (pain and suffering \$800.00)

200-4320 The applicant, a 25 year old machine operator, was assaulted and thrown through a window by a man from whom he was trying to collect a debt. Lacerations to his neck and shoulder resulted in nerve damage, leaving the applicant with a 30 to 50 percent loss of strength in his right arm. The offender was convicted of assault causing bodily harm and sentenced to three months in jail.

Award: \$15,681.00 (pain and suffering \$5,000.00 plus \$500.00 per month for one year)

200-4325 The applicant, a 21 year old bank teller, was attending a local dance when a fight broke out at the next table. One of the instigators, missed his aim and hit the applicant rather than his intended victim. She sustained two black eyes, a bruised nose, and a vertical laceration between her eyes. The offender was convicted of assault causing bodily harm and fined \$200.00 or 30 days. Award: \$1,175.00 (pain and suffering \$1,000.00)

200-4338 The applicant, a 19 year old salesman, was the victim of an unprovoked racial attack on a Windsor street. He was punched in the eye and required sutures. The offender was convicted of assault causing bodily harm and sentenced to 15 days in jail plus probation.

Award: \$531.40 (pain and suffering \$350.00)

200-4355 The applicant, age 18, was attacked by two offenders while riding his bicycle. He was kicked in the groin, punched and choked with a leather strap. Two teeth were broken. Two offenders were convicted of assault causing bodily harm. They each received a suspended sentence plus two years probation. Award: \$1,015.09 (pain and suffering \$400.00)

200-4371 The applicant, a 31 year old university student from Biafra, was assaulted without provocation at a hotel. He sustained a broken nose and an eye injury which has left him legally blind in one eye. The offender was convicted of assault causing bodily harm and fined \$300.00 or 60 days in jail. Award: \$3,853.00 (pain and suffering \$3,500.00)

200-4387 The applicant, a 28 year old welder, was kicked in the right hand without provocation at a roller skating marathon, sustaining two fractured fingers. The offender was convicted of assault causing bodily harm and fined \$100.00 or 10 days in jail.

Award: \$1,772.42 (pain and suffering \$700.00)

200-4389 The applicant, a 40 year old city employee, was struck in the eye by a beer bottle thrown from a passing car. He sustained a perforating corneal wound and minor lacerations. No offender was apprehended.

Award: \$1,844.00 (pain and suffering \$1,500.00)

200-4392 The applicant, a 32 year old policeman, was kicked several times while arresting a drunken offender. He was treated for bruises and scratches to his legs and face. The offender was convicted of assaulting a police officer and

sentenced to two months in jail.

Award: \$512.25 (pain and suffering \$300.00)

200-4398 .The applicant, a 33 year old cook, was assaulted in her home by an unknown male intruder. She sustained a fractured nose, blackened eyes and facial lacerations. As a direct result of the assault, she also suffers from sinusitis. The offender has never been apprehended.

Award: \$2,285.77 (pain and suffering \$1,200.00)

200-4410 The applicant claimed on behalf of a 15 year old student who was assaulted without provocation by a group of youths while roller skating. He was treated for a swollen mouth and eyes and a fractured nose. No offenders were apprehended.

Award: \$500.00 (pain and suffering \$400.00)

200-4415 The applicant, a 24 year old land broker, was assaulted from the rear in the washroom of a hotel. He was treated for facial bruises and a vertical laceration through his right eyebrow. The offender was convicted of assault causing bodily harm and fined \$100.00 or 10 days.

Award: \$1,117.06 (pain and suffering \$500.00)

200-4421 The applicant, a 62 year old clerk, was assaulted and had her purse snatched as she walked from her home. She sustained a soft tissue injury of the back and neck, aggravating a pre-existing condition. No offender was apprehended.

Award: \$728.00 (pain and suffering \$500.00)

200-4423 The applicant, a 63 year old civil servant, was assaulted on a street corner without provocation by four young men. They punched and kicked him, leaving him with a fractured left shoulder and bruises to the left side of his body. No offenders were apprehended.

Award \$753.50 (pain and suffering \$750.00)

200-4429 The applicant, age 50, was struck on the head with a broken beer bottle by an unknown assailant while leaving a private dance. He received a laceration above the left eye and suffered from headaches and blurred vision. No offender was apprehended.

Award: \$900.20 (pain and suffering \$650.00)

200-4451 The applicant, a 31 year old pressman, was assaulted with a pool cue while in the parking lot of a shopping mall. His left ear was lacerated, his jaw fractured, his lower central teeth loosened, and his denture fractured. The offender was convicted of assault causing bodily harm and fined \$200.00 or 30 days in jail.

Award: \$1,207.03 (pain and suffering \$800.00)

200-4457 The applicant, a 54 year old bus driver, was assaulted by a passenger

who wanted him to turn off from a designated route. He sustained a laceration over his right eye and still suffers from vision problems and headaches. The offender was convicted of assault causing bodily harm and sentenced to 45 days in jail plus 12 months probation.

Award: \$1,061.00 (pain and suffering \$750.00)

200-4463 The applicant, a 27 year old supervisor, was assaulted by two men armed with baseball bats after he objected to them slapping his female cousin. His head was lacerated in two places and he sustained multiple bruises. The offender was convicted of assault causing bodily harm and sentenced to five months in jail.

Award: \$668.00 (pain and suffering \$400.00)

200-4464 The applicant, age 30, was punched in the mouth by the offender when they were discussing a dispute between their children. Two of his teeth were broken. The offender was convicted of assault causing bodily harm and fined \$300.00 or three months in jail.

Award: \$553.25 (pain and suffering \$300.00)

200-4470 The applicant, age 42, was prevented from driving his car into his garage by a car which was blocking the entrance. The car, occupied by two males and a female, drove into his car. The offenders returned later to punch the applicant about his head. His face and nose were bruised. The offenders were charged with assault causing bodily harm but were acquitted for lack of positive identification.

Award: \$1,118.00 (pain and suffering \$1,000.00)

200-4477 The applicant, a 29 year old student, was kicked in the shoulder when he apprehended a suspect involved in the robbery of an elderly woman. He claimed for replacement of his broken glasses. The offender was convicted of robbery with violence.

Award: \$101.00

200-4481 The applicant, a 43 year old policeman, while off-duty went to the assistance of another guest at a dance who was being assaulted and was hit in the eye. The offender was convicted of assault causing bodily harm and fined \$300.00 or 30 days in jail.

Award: \$413,40 (pain and suffering \$350.00)

200-4483 The applicant, age 80, was kicked and punched by an intruder when she went to the aid of her sister who was also being assaulted. Her left hip was broken and still aches. No offender was apprehended.

Award: \$2,517.50 (pain and suffering \$2,500.00)

200-4485 The applicant, a 34 year old policeman, was shot in the left knee while trying to apprehend a thief. He has a small but permanent weakness in the knee. The offender was convicted of attempted murder and sentenced to six years in jail.

Award: \$2,500.00 (pain and suffering \$2,500.00)

200-4489 The applicant, a 32 year old police officer, responded to a disturbance call. The offender invited him into her room to discuss the situation, then became abusive and slammed the door, catching the tip of the applicant's left index finger. Part of the end of the finger was amputated. The offender was convicted of assaulting a police officer and placed on probation for two years. Award: \$933.75 (pain and suffering \$750.00)

200-4493 The applicant, a 24 year old policeman, was called to an apartment to remove unwanted guests. A confrontation ensued during which the applicant was struck on the head with a full beer bottle. His jaw was fractured in two places and his right ear and lower gum were cut. The offender was convicted of assault causing bodily harm and sentenced to three months in jail. Award: \$1,500.00 (pain and suffering \$1,500.00)

200-4499 The applicant, a 25 year old policeman, was investigating a man who became violent and kicked him in the groin and punched him in the nose. The offender was convicted of common assault and given a suspended sentence and probation for one year.

Award: \$250.00 (pain and suffering \$250.00)

200-4509 The applicant, a 36 year old electrician, was shot in the thigh while playing golf. No offender was apprehended. Award: \$1,356.00 (pain and suffering \$600.00)

200-4517 The applicant, a 33 year old policeman, received a contusion on his right eyelid and a perforated eardrum while attempting to arrest an offender. Two offenders were convicted of assaulting a police officer. One was sentenced to 90 days in jail, the other to 60 days.

Award: \$306.00 (pain and suffering \$300.00)

200-4518 The applicant, a 31 year old policeman, tried to break up a fight at a county fair. He was struck and kicked in the head and groin, sustaining a concussion and multiple contusions, bruises, and lacerations. Charges against the alleged offenders were dismissed because of insufficient identification, Award: \$750.00 (pain and suffering \$750.00)

200-4519 The applicant, a 35 year old police officer, was repeatedly hit over the head with an axe handle when she attempted to handcuff an offender she had arrested. She was treated for multiple head lacerations, and contusions to the left shoulder and elbow. The offender was convicted of causing bodily harm in order to prevent arrest and sentenced to 15 months in jail. Award: \$2,782.37 (pain and suffering \$1,250.00)

200-4524 The applicant, a 36 year old bus driver, was assaulted by a drunk passenger. His ring finger was fractured while trying to restrain the offender. The offender was convicted of common assault and given a conditional discharge plus probation for six months.

Award: \$342.64 (pain and suffering \$250.00)

200-4529 The applicant, a 43 year old correctional officer, was karate chopped on his neck and shoulders by an inmate. He sustained a significant irritation to

his spine and suffered pain and weakness in the left arm and shoulder. The offender was disciplined within the institution.

Award: \$2,736.00 (pain and suffering \$2,500.00)

200-4545 The applicant, a 26 year old hotel porter, was viciously assaulted with a knife as he walked home. As a result of his wounds the power in his right hand is about 25 percent of normal. His wrist and three of his fingers are insensitive. No offenders were apprehended.

Award: \$5,289.80 (pain and suffering \$3,000.00)

200-4550 The applicant, a 40 year old shipper, was the victim of an unprovoked assault. He had bruises and lacerations to his head, face, and ribs and sustained a permanent loss of hearing in one ear. He also suffers from a loss of balance. The offender was convicted of assault causing bodily harm and sentenced to three months in jail.

Award: \$3,053.17 (pain and suffering \$2,500.00)

200-4554 The applicant, a 53 year old telephone employee, was assaulted when he went to the aid of a bus driver who was being attacked by two males. His left wrist was fractured. No offenders were apprehended.

Award: \$1,629.45 (pain and suffering \$1,250.00)

200-4559 The applicant, a 58 year old supermarket operator, was assaulted and robbed by two males in her store. They poured gasoline over her and threatened her with a lighted match. She suffered severe mental trauma. Two offenders were convicted of robbery with violence. One was sentenced to two years less a day in jail and two years probation. The other was sentenced to one year in jail plus three years probation.

Award: \$1,558.63 (pain and suffering \$1,200.00)

200-4570 The applicant, a 35 year old truck driver, went to the aid of a woman whose car was being smashed by vandals. He took her to the police station and returned with officers who arrested the offenders. During the arrest, he was kicked, punched and beaten, sustaining minor head, side and chest wounds. One offender was convicted of common assault and fined \$150.00 or seven days in jail. The other offender was convicted in Calgary, for the assault. Award: \$1,026.00 (pain and suffering \$750.00)

200-4571 The applicant, a 20 year old salesman, was thrown to the ground, kicked and punched in an unprovoked attack in a subway station. His left ankle was fractured. No offenders were apprehended.

Award: \$3,222.90 (pain and suffering \$500.00)

200-4572 The applicant, a 49 year old messenger, picked up a shipment of money at a department store. While on his way to his truck he was hit on the head and knocked unconscious. He suffers some hearing loss which could be the result of trauma suffered in the attack. The offender pleaded guilty to robbery and manslaughter of another employee of the store.

Award: \$820.00 (pain and suffering \$800.00)

200-4580 The applicant, age 47, reported to a subway token collector that some young men were creating a disturbance. One of them followed him, and hit him

in the face, breaking his glasses. The offender escaped. Award: \$36.00

200-4592 The applicant, an 18 year old postal worker, was assaulted by a former co-worker with whom he had a continuing quarrel. He sustained multiple abrasions and bruises to his face, black eyes, minor lacerations to his ear and a fractured tooth. The offender was convicted of assault causing bodily harm and fined \$200.00 or 20 days in jail.

Award: \$350.00 (pain and suffering \$350.00)

200-4594 The applicant, a 29 year old student, was attending a party where the offender threw a cartridge at a heating radiator. The cartridge exploded and the casing struck the applicant in the right eye. She permanently lost vision in the eye. The offender was convicted of criminal negligence causing bodily harm and was given a suspended sentence plus 18 months probation.

Award: \$5,790.00 (pain and suffering \$5,500.00)

200-4600 The applicant, a 36 year old housewife, was attacked by an unknown male who tried to snatch her purse. She sustained a fractured left hip which still causes her pain, a sprained right ankle, and lacerations to her head and right hand. No offender was apprehended.

Award: \$3,567.63 (pain and suffering \$3,000.00)

200-4602 The applicant, a 19 year old student, was struck in the face with a beer bottle when he asked the drunken offender to leave a private party. He sustained a fractured nose, swollen eyelids, and two loose teeth. The offender was sentenced to nine months in jail plus probation for one year on a conviction for assault causing bodily harm.

Award: \$794.70 (pain and suffering \$750.00)

200-4618 The applicant, a 25 year old salesman, was assaulted by two men after an argument about a driving incident. His head and neck were bruised and one tooth was broken. One offender was convicted of assault causing bodily harm and fined \$200.00 or 30 days in jail.

Award: \$826.00 (pain and suffering \$650.00)

200-4622 The applicant, a 53 year old disabled pensioner, was assaulted on the street by two males who attempted to snatch her purse. A previously broken right arm was injured, her forehead cut, and her arms and legs bruised. No offenders were apprehended.

Award: \$1,052.00 (pain and suffering \$1,000.00)

200-4624 The victim, an 18 year old student, was struck on the nose at a private party by another guest who accused him of breaking windows two years earlier. He sustained multiple nasal fractures and facial lacerations. The offender was convicted of assault causing bodily harm and fined \$250.00 or 45 days in jail. Award: \$522.00 (pain and suffering \$300.00)

200-4644 The applicant, a 41 year old farm foreman and bus driver, refused to give the intoxicated offender, who was visiting his home, a drink. When he phoned the offender's home, the offender struck him with both hands. He suffered swelling in his lower jaw and bruising to his right shoulder. The offender was convicted of assault causing bodily harm and given a suspended sentence plus one year probation.

Award: \$1,006.06 (pain and suffering \$500.00)

200-4646 The applicant, a 31 year old policeman, fractured three fingers while trying to arrest a man. He is left with some continuing disability. The offender was convicted of obstructing police and sentenced to 10 days in jail. Award: \$775.00 (pain and suffering \$650.00)

200-4652 The applicant, a 33 year old chef, was assaulted with a piece of lumber by a patron who had complained his meal was too hot. His left elbow was fractured and his right chest was injured. The offender was convicted of assault causing bodily harm and sentenced to 90 days in jail, six months probation, and a \$500.00 fine.

Award \$2,000.00 (pain and suffering \$2,000.00)

200-4664 The applicant, a 40 year old waiter, was assaulted, without provocation, by the superintendent of his apartment building when he complained of noise and harassment from people in the apartment above. He received a bruised and swollen wrist and a sore neck and back. The offender was convicted of common assault and fined \$100.00 or 10 days in jail. Award: \$325.81 (pain and suffering \$300.00)

200-4679 The applicant, age 18, was struck on his left side with a hammer when he tried to stop two men from stealing construction materials from houses his father was building. The blow caused some bruising. Two offenders were convicted of theft under \$200.00. One fined \$50.00 or five days in jail. The other received a conditional discharge plus probation for six months. Award: \$230.00 (pain and suffering \$100.00)

200-4689 The victim, age 16, was shot by her father during a rampage in which he wounded another daughter and killed his son. She sustained severe injuries to her left hand and forearm, right chest and right hand and suffered from emotional trauma. Her left hand cannot be used for any form of work. The offender was convicted on a murder charge and sentenced to life imprisonment. Award: \$9,510.00 (pain and suffering \$9,000.00)

200-4733 The applicant, a 27 year old streetcar operator, was assaulted by a passenger after a dispute over student fares. He sustained bruises to his arm and face, and a cut finger. The offender was convicted of common assault and sentenced to 21 days in jail.

Award: \$490.41 (pain and suffering \$400.00)

200-4739 The applicant, a 58 year old pensioner, was assaulted as he walked near a schoolyard. He sustained minor abrasions to his face and knees, and his

glasses were broken. No offenders were apprehended. Award: \$73.50

200-4742 The applicant, a 22 year old mechanic, was asked for a match by a stranger. As he reached into his pocket to find one, the man slashed him on the arm. The offender is unknown.

Award: \$426.05 (pain and suffering \$300.00)

200-4743 The applicant, a 24 year old policeman, arrested an offender on a weapons charge. While sitting in the rear seat of the police cruiser, the offender struck the applicant's face, aggravating a previous nose injury. The offender was convicted of an unrelated offence.

Award: \$534.53 (pain and suffering \$500.00)

200-4754 The applicant, an 18 year old student, was assaulted by a male previously unknown to him, at a party. He sustained a fractured nose, head and facial lacerations and two badly swollen eyes. The offender was convicted of assault causing bodily harm and sentenced to three months in jail. Award: \$1,264.40 (pain and suffering \$750.00)

200-4756 The applicant, a 46 year old Unemployment Insurance Commission employee, received a broken finger and multiple cuts, bruises, and abrasions while trying to break-up an altercation in the office. The offender was convicted of assault causing bodily harm and fined \$300.00 or 60 days in jail. Award: \$1,012.00 (pain and suffering \$1,000.00)

200-4805 The applicant, a 56 year old private investigator, was assaulted by an offender she was trying to apprehend for shop-lifting. She was treated for a left chest sprain, a bruised and swollen left hand, and a sprained left index finger. The offender was convicted of assault causing bodily harm and sentenced to 15 days in jail plus probation for three years.

Award: \$1,695.00 (pain and suffering \$1,500.00)

200-4806 The applicant, a 19 year old gas station attendant, was assaulted by four offenders when they objected to the price of gas. He was treated for multiple facial injuries and a fractured nose. Four offenders were convicted of assault causing bodily harm. One was sentenced to 45 days in jail and the other three to 30 days each.

Award: \$1,364.00 (pain and suffering \$1,000.00)

200-4809 The applicant, age 28, was stabbed in the back by his brother during a fight over money. There was a long history of arguments and violence between them. The applicant received serious injuries to his right kidney, his gall bladder and his bowels. The offender was convicted of wounding and given a three year suspended sentence. The Board invoked Section 17(1) of the Act to reduce the award.

Award: \$5,004.90 (pain and suffering \$2,500.00)

200-4826 The applicant, a 21 year old police cadet, was assaulted while off duty by two males parked at the rear of his residence. He received lacerations to his right ear and head and a black eye. One offender was convicted of assault causing bodily harm and sentenced to 30 days in jail plus a year probation. A juvenile was also convicted.

Award: \$398.80 (pain and suffering \$350.00)

200-4856 The applicant, a 27 year old driver, was stabbed in the back in a restaurant washroom. The attack was unprovoked. The offender was charged with attempted murder and found not guilty by reason of insanity. Award: \$2,074.40 (pain and suffering \$1,500.00)

200-4875 The applicant, a 31 year old clerk expediter, was assaulted by a young hockey player. As a referee, he had removed the offender from an on-ice altercation. The offender punched him in the face, bruising his eyes and fracturing his nose, and was subsequently convicted of common assault. He was fined \$150.00 or 30 days in jail.

200-4896 The applicant, a 35 year old bus driver, was beaten and dragged off the bus by a passenger who took offence when asked to stop smoking. He was treated for bruises on his right forearm, head and neck. The offender was not

apprehended.

Award: \$368.44 (pain and suffering \$250.00)

Award: \$1,119.73 (pain and suffering \$800.00)

200-4936 The applicant, a 34 year old high school principal, was stabbed twice in the chest after assisting to disarm a man under the influence of drugs who was threatening others with a rifle. The offender was convicted of assault causing bodily harm and of pointing a firearm and sentenced to two years less a day and two years probation.

Award: \$1,222.75 (pain and suffering \$1,000.00)

200-4448 The applicant, a 28 year old subway operator, witnessed a person jump in front of his train and die from the impact. He suffered severe nervous shock.

Award: \$1,877.55 (pain and suffering \$1,500.00)

200-4964 The applicant, a 21 year old student, suffered a fractured jaw when struck by her former boyfriend at her residence. The offender was convicted of assault causing bodily harm and fined \$300.00 or 30 days in jail. Award: \$886.13 (pain and suffering \$750.00)

200-4965 The applicant, a 67 year old pensioner, received facial cuts when someone threw an object at a streetcar, shattering a window. No offender was apprehended.

Award: \$350.00 (pain and suffering \$350.00)

200-4970 The applicant, a 28 year old child care worker, was attacked without

provocation by an assailant and severely beaten. She sustained facial bruises and lost her two front teeth. No offender was apprehended. Award: \$2,192.45 (pain and suffering \$900.00)

200-4979 The applicant, a 21 year old cadet, sustained a fractured left hand while attempting to subdue the offender at the police station. The offender was charged with common assault and received a suspended sentence plus two years probation.

Award: \$875.00 (pain and suffering \$850.00)

200-4981 The applicant, age 64, was assaulted without provocation, at the hotel where she and the offender resided. She sustained multiple bruises to the face, legs, and thigh. The offender was charged with assault causing bodily harm and is receiving psychiatric treatment.

Award: \$789.00 (pain and suffering \$750.00)

200-4984 The applicant, a 62 year old taxi driver, was assaulted by a male passenger who had refused to pay his fare. His face was bruised and lacerated in several places and he had a concussion. He also suffered extreme mental distress for several months. The offender was convicted of assault causing bodily harm and fined \$300.00 or 15 days in jail.

Award: \$2,500.00 (pain and suffering \$1,000.00)

200-5013 The applicant, age 64, while entering her home, was attacked by unknown assailants who were trying to rob her. She received facial cuts and bruises. The assailants were never apprehended.

Award: \$689.80 (pain and suffering \$500.00)

200-5026 The applicant, a 24 year old policeman, fractured his right finger during a struggle with an offender, who was subsequently convicted of being intoxicated in a public place and fined \$20.00 or two days in jail. Award: \$550.00 (pain and suffering \$500.00)

200-5029 The applicant, a 32 year old fleet inspector, was jostled while standing on a street corner. When he asked why, the offender punched him in the mouth knocking out his two front teeth. The offender was convicted of common assault and sentenced to 45 days in prison.

Award: \$861.25 (pain and suffering \$600.00)

200-5062 The victim, a 6 year old, was enticed into a garage where he was beaten with an empty bottle. There was also an attempted sexual assault. He sustained lacerations to his head, arm, and leg, and still has nightmares. The offender was charged with assault causing bodily harm and received a suspended sentence plus three years probation.

Award: \$1,080.00 (pain and suffering \$1,000.00)

200-5075 The applicant, a 64 year old pensioner, was assaulted and robbed on a street corner. He sustained a black eye, facial bruises, and nose, face, and

head lacerations. The four offenders were not apprehended. Award: \$715.00 (pain and suffering \$500.00)

200-5083 The applicant, a 57 year old chef, was assaulted and robbed on a Toronto street. He sustained black eyes, a laceration above the left eye and bruised ribs. The offender was convicted of robbery and sentenced to eight months in jail.

Award: \$250.00 (pain and suffering \$250.00)

200-5107 The applicant, age 45, was knocked down and kicked in the face by a friend he had refused to feed. His forehead was cut. The charge of assault causing bodily harm was withdrawn against the offender.

Award: \$175.00 (pain and suffering \$175.00)

200-5109 The applicant, a 36 year old police officer, was shot in the right leg while investigating a domestic problem. The offender was charged with dangerous use of firearms and received a suspended sentence plus two years probation.

Award: \$846.00 (pain and suffering \$800.00)

200-5174 The applicant, a 50 year old policeman, was assaulted by a man at a show cause hearing on a conspiracy charge, sustaining scalp lacerations and bruises, facial bruises, and headaches. The offender was convicted of assaulting a police officer and sentenced to six months in jail and three months probation.

Award: \$200.00 (pain and suffering \$200.00)

200-5183 The applicant, age 39, while trying to start her car in a parking lot, was stabbed by an unknown assailant. She was wounded in the face, neck, and anterior chest wall. No offender was apprehended.

Award: \$2,346.48 (pain and suffering \$2,000.00)

200-5213 The applicant, a 27 year old correctional officer, was assaulted while trying to restrain an inmate. She sustained a sprained left wrist and tenderness of the stomach and legs. The offender now is confined to a mental institution. Award: \$755.00 (pain and suffering \$500.00)

200-5238 The applicant, a 53 year old correctional officer, sustained a fractured nose, a cut eye, and a large haematoma of the right cheek in a struggle with an inmate. The inmate now is in a mental institution.

Award: \$1,035.50 (pain and suffering \$800.00)

200-5259 The applicant claimed expenses incurred on the death of her 11 year old son. He died as a result of a beating given by a 13 year old who was subsequently convicted of juvenile delinquency.

Award: \$1,217.35

200-5273 The applicant, a 43 year old real estate agent, was assaulted on a Toronto street by a man who kicked her in the right hip and right thigh. She sustained a large haematoma. The offender was charged with assault causing bodily harm and a warrant for his arrest is outstanding. Award: \$954.50 (pain and suffering \$500.00)

Award: \$8,131.68 plus \$192.35 per month (pain and suffering \$2,500.00)

200-3201 The applicant, a young girl was assaulted by a man who tried to rape her.

Award: \$1,077.80 (pain and suffering \$800.00)

200-3203 The applicant, a pensioner, was assaulted. Award: \$650.00 (pain and suffering \$500.00)

200-3326 The applicant, a young man, was wounded by a shotgun at his residence.

200-4637 The applicant, a young woman, was assaulted and raped. Award: \$1,802.00 (pain and suffering \$1,750.00)

200-4655 The applicant, a young woman, was raped. Award: \$7,025.00 (pain and suffering \$4,500.00)

200-4678 The applicant, a young woman, was raped. Award: \$2,110.00 (pain and suffering \$1,750.00)

200-4710 The applicant, an elderly man, was robbed and severely beaten. Award: \$3,125.40 (pain and suffering \$2,000.00)

200-4762 The applicant, a young man, was assaulted by three men. Award: \$708.00 (pain and suffering \$700.00)

SUMMARY OF DISALLOWED APPLICATIONS

200-441 The applicant, a 52 year old butcher, claimed he was struck from behind and knocked unconscious. He had been drinking. The Board concluded that there was no proof of assault and denied the application.

200-887 The applicant, age 25, was shot at his residence by a man who came to purchase marijuana. The offender was a previous customer. The Board found that it was the applicant's own activities which prevented him from seeking protection from the police against the offender and invoked Section 17(1) and 17(1a) of the Act to deny the award.

200-1955 The applicant and an employee were involved in a dispute at the place of business. The arguments erupted again later at a discotheque. The applicant struck the offender before he was hit with a broken glass. The applicant also refused to co-operate with police. The Board invoked Sections 17(1) and 17(1a) to deny the application.

200-2165 The applicant, age 56, was injured in a fistfight which erupted when she returned with her daughter and her husband, to her son-in-law's apartment to recover her daughter's possessions. The Board was not satisfied that the injuries were the result of an unprovoked crime of violence. The applicant was convicted of common assault. The application was denied.

200-2564 The applicant, claimed on behalf of her two sons. Her husband was shot and killed by a man subsequently convicted of manslaughter. Although the applicant had been receiving sporadic support payments from her husband, the Board found she was now receiving social welfare benefits in excess of that amount and denied the application.

200-2931 The applicant, age 28, was assaulted with a broken beer bottle by another man who was convicted of assault causing bodily harm and weapons dangerous. Both men had been drinking. The Board decided the applicant had wrongfully interfered with the offender who objected to being touched or hit by the applicant. The applicant was not completely co-operative with the police. Invoking Section 17(1) and 17(1a), the Board denied the application.

200-3176 The applicant, age 35, was assaulted while he was an inmate at the Don Jail. He refused to identify his assailant. The Board invoked Section 17(1a) of the Act to deny the application.

200-3231 The applicant, a 50 year old fashion designer, claimed she was pushed and punched in an elevator. The Board found that the incident resulted from a continuing neighbourhood quarrel in which the applicant was a partial participant. The application was denied.

200-3287 The applicant, age 22, was involved in a beverage room brawl with several others. Both the applicant and the offender were subsequently arrested. Evidence indicated that the participants were ready to fight for any reason. The Board invoked Section 17(1) and 17(1a) to deny the award.

200-3420 The applicant, age 48, claimed he was assaulted by two males when he refused to buy them a drink. The applicant had been evasive in court about identifying the offenders. Because there was a lack of credible evidence, the Board invoked Section 17 of the Act to deny the application.

200-3427 The applicant, age 31, was involved in a parking lot altercation with another man. The Board heard conflicting evidence as to the cause of the fight, and relying on the evidence in court transcripts, invoked Section 17(1) to deny the application.

200-3500 The applicant, age 64, made racial sturs to a black bus driver. A scuffle ensued with another black passenger. The applicant was the instigator. Medical evidence did not support her claims of injuries received. The Board invoked Section 17(1) of the Act to deny the application.

200-3503 The applicant claimed she was assaulted by the man with whom she lived on a platonic basis. Medical evidence revealed she told the hospital her injuries were caused by a fall. She did not report her injuries to police until eight months later. The Board found the applicant's evidence was not credible. Invoking Sections 17(1) and 17(1a) of the Act, it denied the application.

200-3515 The applicant, a 45 year old cab driver, was assaulted by two male passengers after ordering them from his cab because of their profane language. The Board found that the applicant had struck the first three blows and was the aggressor. Invoking Section 17(1) of the Act, it denied the application.

200-3528 The applicant, a 22 year old hotel houseman, was shot in the legs. The Board found that the shooting was probably retaliation by the offenders for a shooting two months earlier. The applicant refused to co-operate in identifying the assailants. The Board invoked Section 17(1) and 17(1a) to deny the application.

200-3562 The applicant, age 31, claimed he was assaulted by two men attempting to rob his landlady. The Board found, however, that the evidence indicated he was injured in a drunken brawl. The Board invoked Sections 17(1) and 17(1a) to deny the application.

200-3670 The applicant, age 22, and the offender argued and fought at a drive-in over damage to the applicant's car. Neither laid a private complaint although they both had cause, and the Board invoked Section 17(1) to deny the application.

200-3698 The victim, a 13 year old boy, was struck in the eye by a rock while playing with five boys who were throwing stones and sticks. It could not be ascertained who threw the stone. The Board found that the incident did not fall within the meaning of Section 5 of the Act and denied the application.

200-3761 The applicant, age 31, was approached by a stranger in a hotel and became involved in an altercation with him. He was assaulted again in the parking lot by the same man. The applicant had been drinking heavily and refused to co-operate with the police. The Board invoked Sections 17(1) and 17(1a) of the Act to deny the application.

200-3897 The applicant claimed her four year old son's eardrum was ruptured by the punch of an older child. Medical evidence indicated the child had a history of ear problems and that the rupture was a result of an infection. The application was denied.

200-3903 The applicant, administrator of the deceased's estate, claimed for

funeral expenses of the deceased who was murdered by her husband. The Board denied the application because the deceased left a large estate.

200-3991 The applicant, claimed funeral expenses incurred following the death of her daughter who was shot and killed by her husband. The Board was satisfied that the lifestyle of the victim contributed to the occurrence and, invoking section 17(1) of the Act, denied the application.

200-4085 The applicant, age 28, was badly burned in an explosion caused when sparks from loose tape deck wires hit gasoline fumes. She had been investigating a theft of several other items from the boat when the explosion occurred. The fire department ruled out arson as a cause. The Board found the explosion was not a result of an offence against the Criminal Code. The application was denied.

200-4299 The applicant, age 56, was robbed and assaulted by two men while lying in a laneway. He was very intoxicated. The Board invoked Section 17(1) of the Act to deny the application.
