#### I. INTRODUCTION

#### A. Background

In the Fall of 1976, the National Center for State Courts under a Law Enforcement Assistance Administration Technical Assistance request, conducted a statewide survey of juvenile programs in New Hampshire and compiled a resource inventory for District and Municipal Court judges. The purpose of/the inventory or manual was to provide the courts with an accurate lisiting of juvenile resources by program type and location. Given the high attrition rate of juvenile programs, large staff turnover and frequent programmatic change, such a manual was considered essential to keep the courts apprised of existing juvenile resources. As juvenile caseloads continue to increase, the need for such a manual has grown, and as such, in May of 1978, the N.H. Judge's Association requested an update to the manual.

The following manual is intended to serve as a compendium of existing resources for juveniles brought to the attention of the court system. The manual is not and should not be considered an exhaustive listing of all programs which could be used by the courts; however, it provides an accurate listing and descripton of those programs known and thought to be a resource for the courts.

#### B. Considerations in Preparing the Resource Material

Preparation of a resource of this type requires several considerations. First, the document is designed for the court and as such lists resources generally utilized by the court. Recreation, or general interest groups (e.g., Boys Scouts, 4-H, or religious programs) are not included. The omission of these programs is not a comment as to their appropriateness of such programs, rather, these types of programs are not considered primary resources for the court.

Second, no attempt is made to evaluate the quality of the programs listed in the catalogue. The inclusion or omission of a project reflects neither a recommendation nor censure. All programs known to the compilers are included. Caution was exercised to minimize omissions.

A third consideration is the utility of the information. The programs are organized by county and functional categories. The information included under each program is limited to information considered essential to describe the type of service offered, program costs and restrictions. It is suggested that individuals interested in using a program listed contact the program prior to disposition to ascertain the appropriateness of the program. The catalogue serves a dual purpose. The primary function of the document is to provide a resource listing. A secondary purpose is the creation of a planning and management tool which provides a geographic and programmatic summary of juvenile services. Using the catalogue as a guide, project deficiencies from a geographic and/or programmatic basis can be isolated. While this second function is a by-product of completing a catalogue, it should not be overlooked.

### C. Organization of the Manual

As noted earlier, the program sheets are organized by county and functional categories. The five functional categories used are: diversion programs, diagnostic services, residential alternatives, non-residential alternatives and short term crisis shelters.

A summary listing of programs by functional category and county starts on page 5. Following the last county section, a state service section is presented to provide a summary of services and list of local and state offices for various state programs. A list of in-state nonpublic elementary and secondary schools which may accept referrals from the court is also included in this section.

- 1. Functional categories
  - a. Diversion programs

The category "diversion programs" includes projects primarily established to serve as alternatives to judicial processing. Most programs in this category provide counseling and referral services as well as educational, recreational and vocational components. In this respect, the programs have a multi-service charter and work with juveniles referred for a broad range of reasons.

b. Diagnostic services

"Diagnostic services" include projects which offer psychological and/or psychiatric evaluations as well as family and individual assessments. Programs included within this category provide written evaluations upon request by the court and undertake formal testing as required to develop a treatment plan.

c, Non-residential alternatives

"Non-residential alternatives" refer to projects that accept court referral of juveniles found to be delinquent or in need of supervision (PINS). These programs offer a variety of individual, vocational and educational counseling, supervision, and family therapy services. The specific services provided by the project are described on the program sheets. None of the projects in this category provides residential service directly. Most of the project staffs are knowledgeable concerning local foster homes, crisis homes, and group homes and have an accurate knowledge of the availability of such resources.

#### d. Residential alternatives

"Residential alternatives" include both group homes caring for a maximum of 12 youths, and institutions which can accommodate more than that number. All of the residential programs contacted provide varying amounts of counseling and most have a family counseling component. The cost and criteria for admittance to the residential programs vary greatly; therefore, it is important to review the "requirement" section for each program.

While foster homes are not included in the program sheets, they should certainly be considered as alternatives to residential programs. The rationale for their exclusion is the relatively small number that are currently available. The local welfare office should be consulted concerning the availability of foster homes.

#### e. Short term cris'is shelters

"Short term crisis shelters" are homes or facilities which provide residential services for up to one month. These programs frequently have limited counseling or treatment resources and are considered helpful as transitional residences prior to acceptance into a long term program or return to a family residence.

#### 2. Program sheets

The program sheets are designed to provide a basic review of the program rather than a complete discussion of the services offered. The intent of the sheet is to provide sufficient information for the user to make a determination as to whether the service is generally applicable. Prior to making a referral, the project staff should be contacted to insure that the services meets the specific client needs.<sup>1</sup>

Each program description includes the name and address, service, fee, requirements, contact person, and collection date.

Name and Address. The current title and address of the program are listed. In most instances, the mailing and business address are the same; all exceptions are noted.

<sup>1</sup>Several programs indicated that while participation in the programs was available to anyone, each referral was screened to insure the appropriateness of the referral.

Service. The description of the program service(s) is purposely brief; however, each major type of activity is noted as are the types of referral sources from which clients are accepted.

Fee. All costs for program services are listed when available. Due to the general policy of using a sliding scale, based on the individual's "ability to pay," fixed costs cannot be stated for some programs. The amount cited should be considered a guide and checked each time a referral is made.

Requirements. All requirements for or restrictions on referrals to the program are reflected in this section. Limitations as to age, referral source, residence, etc. are specified. <u>Note</u>: Unless reference is made to limitations on PINS, the reader should assume that they are accepted by the program. As with the fee for service, double checking participation of PINS is advisable prior to referral.

Contact Person. The name and phone number of a contact person for each program is provided. Due to the high staff turnover rate in juvenile programs, the contact person may frequently change. However, most projects have two or three staff members who can accept referrals and are able to answer questions concerning the program.

Date. The date the program sheet was completed is included on the lower right hand corner of each sheet. All updated sheets should include a date to inform the reader as to the age of the information being reviewed.

#### D. Procedured Used to Update the Manual (1978)

The procedure used to update the manual was similar to that followed in preparing the original manual. The major state and private agencies which service juveniles were contacted and asked to provide a listing of existing juvenile programs of the types mentioned in section C. A composite list was prepared and cross-checked with programs listed in the 1976 manual to create a master list of programs.

Programs that were included in the 1976 manual were sent a latter and a copy of their 1976 programs sheet with a request that they update the information. New program listings were sent a similar letter and explanation of the information requested with a sample program sheet. Those programs that didn't respond to the mailing (about 50%) were contacted by telephone for the information needed to complete the program sheets. Those contacted were also asked about other youth services in the area, specifically, programs to which referrals were made. This information served as the basis for expanding the master list. Additional programs were added to the master list if they could be categorized into one of the five groups defined above in section C.

A. VOCATIONAL REHABILITATION SERVICES: Peter S.B. Clark, Deputy Chief, Comprehensive services are provided as necessary, to identify vocationally handicapped disabled persons, to determine their rehabilitation potential and to develop a plan of rehabilitation services to be carried to completion by the counselor and client. More specifically, these services are:

- 1. Medical
  - a. General medical examination
- b. Specialists examination
- 2. Counseling and guidance
- 3. Psychological evaluation
- 4. Vocational evaluation
- 5. Training
  - a. Academic
    - b. On-the-job training

- 6. Physical restoration
- 7. Maintenance and
  - transportation
- 8. Job Placement
- 9. Follow-up
- 10. Post-employment services

<u>Eligibility</u>: 1. The presence of a physical or mental disability which constitutes a substantial handicap to employment; and
2. A reasonable expectation that vocational rehabilitation services may render the individual fit to engage in a gainful occupation.
<u>How to Apply</u>: Personal contact or through referral of physician, lawyer, clergyman, or neighbor to Central Office at 105 Loudon Road, Concord, NH or any field-unit office.

- B. <u>BLIND SERVICES SECTION</u>: Gerard DeAngelis, Program Director, Central Office Tel: 271-3537. This Unit is responsible for providing comprehensive Vocational Rehabilitation services to visually handicapped persons; administration of a Vending Stands Program; financial support and coordination of education programs for visually handicapped children;
- p psychological testing. The Unit provides educational aids and appliances and counseling services as necessary to blind children and their parents; maintains a Register of the Blind; directs distribution of Talking Book Machines and provides instruction in communication skills and activities of daily living. This Unit administers a Workshop and Home Work Program for the multiple handicapped blind and visually handicapped.
- C. <u>SPECIAL EDUCATION SECTION</u>: Robert T. Kennedy, Program Director, Special Education, Central Office, Tel: 271-3741. This Unit is responsible for all State and Federal Special Education programs for handicapped children. Programs include training of professional personnel in the education of handicapped children and material for blind children quota account. State aid programs for handicapped include: (1) reimbursement for programs for retarded children, disturbed children and neurologically impaired children; (2) tuition support for deaf, emotionally disturbed, retarded and physically handicapped children in need of residential placement; and (3) reimbursement for home instruction of handicapped children.
- D. <u>DISABILITY DETERMINATION SECTION</u>: Philip J. Donovan, Program Director, 105 Loudon Road, Bldg. #4, Tel: 271-3341. This Unit reviews the claims of persons alleging inability to perform gainful employment and seeking Disability Insurance and Supplemental Security Income benefits under the Social Security Act, to determine eligibility for benefits. Joint screening of applicants by Vocational Rehabilitation personnel enhances development of vocational planning for the applicant regardless of eligibility for Disability Insurance Benefits or Social Security Insurance.
- E. <u>VOCATIONAL EVALUATION UNIT</u>: Joseph C. Leddy, Program Director, 130 Silver Street, Manchester, NH, Tel: 627-4612. This Unit provides Vocational Evaluation services to all appropriate active clients of the Vocational Rehabilitation Division who are referred by the VR Counselor for one or more of the following reasons:
  - 1) To assist in the determination of eligibility for the Vocational Rehabilitation services.
  - 2) To explore and identify feasible vocational objectives for eligible clients.
  - 3) To increase client awareness of assets, limitations, and vocational alternatives.

The Vocational Evaluation process uses work, either real or simulated, as the focal point for assessment and vocational exploration. Medical, psychological, social, educational, cultural and economic data is incorporated in the total vocational evaluation process which serves as the basis for the client's vocational rehabilitation plan.
