ABSTRACT

This report examines and provides a profile of those residents released from drug contract houses during 1977 and 1978.

There were a total of 33 individuals released in 1977 and 55 released in 1978. In 1977, 10 individuals or 30% of the total releasee population escaped from these houses compared to 19 individuals or 35% in 1978. The completion rate for the 1977 sample was 45% and for the 1978 sample, the completion rate was 49%. If those individuals who voluntarily returned to their sending institutions are included in the totals for computing the completion rates, there would be a completion rate of 44% for the 1977 sample and 42% for the 1978 completion rate.

INTRODUCTION

In June of 1972, the Massachusetts State Legislature passed the "Correctional Reform Act" authorizing the establishment of different correctional programs that were to be outside of the walled institutions. In these programs, individuals who were within eighteen months of their parole eligibility date were authorized to be placed in small residential centers to complete the remainder of their sentences.

In June of 1977, the Massachusetts Department of Correction began sending individuals to drug contract houses. These programs were established because of the concern about drug abusers in the system and the unique problems that they have as they attempt to get reintegrated into the community. Some of these programs attempt to assist in the rehabilitation of drug-dependent individuals through creating a therapeutic environment that will make an individual receptive to change. They also generally utilize group meetings, encounter meetings, or community meetings where individuals are encouraged to share the problems that they are currently experiencing in order to prevent their return to drug dependency.

This present study is the first component in a three-part evaluation of residents released from a drug contract house in 1977 and 1978, the first two years of their operation. This report includes information on the movement of the population in and out of the drug houses, program termination data, and a statistical breakdown of background characteristics of program participants according to their classification as program completers or non-completers. The second component of the evaluation will be a comparison of commitment, background and criminal history variables between individuals of the drug contract houses who are program completers and program non-completers.

The final component of the evaluation will be a one year recidivism follow-up for the 1977 and 1978 releasee sample.

SAMPLES

During 1977, there were 34 residents released from drug houses and there were 65 released in 1978. Of the 1977 sample, one individual voluntarily returned to higher security and was excluded from the sample population, giving a final total of 33 residents released in 1977. Of the 1978 sample, 9 individuals voluntarily returned to higher security rather than remain in the programs and were excluded from the sample. One individual was transferred to a hospital and was also excluded from the sample giving a final 1978 releasee sample of 55.

The breakdown of releases in 1977 and 1978 by individual facilities is as follows:

For comparative purposes, the total sample for each year was divided into two groups - program completers and program non-completers. A program completer was defined as any resident who successfully completed his stay at one of the drug houses and was released to the street either by permit of the Parole Board or by a certificate of discharge. Also, individuals who received a lateral transfer to a similar security institution are included as program completers. A program non-completer was defined as any resident who escaped or who did not complete his stay in the program but was instead returned to his sending institution. Also individuals who voluntarily returned to their sending institutions are excluded from the non-completion sample. When the total sample for each year was so divided, the results were as follows: for 1977 - 15 residents were program completers (completion rate 45%) and 18 residents were program non-completers (non-completion rate 55%); for 1978 - 27 residents were program completers (completion rate 49%) and 28 were program non-completers (non-completion rate 51%). When individuals who voluntarily returned are added to the totals, the results are as follows: for 1977 - 15 residents were program completers (completion rate 44%) and 19 residents were program non-completers (non-completion rate 56%); for 1978 - 27 residents were program completers (completion rate 42%) and 37 were program non-completers (non-completion rate 58%).

There were several different reasons for a return to a higher security institution. Some examples are as follows: violation of house or department rules, inability to adjust to program, attempted or actual escape, or being a major disciplinary problem while at the facility. The specific reasons for a return to a higher security institution in 1977 and 1978 are summarized in Tables IV and V.

DATA COLLECTION

Data collected for both sample years consisted of commitment, social background and criminal history variables. Data was derived from the computerized data base developed by the Correction and Parole Management Information System (CAPMIS) and was produced on the Massachusetts State College Computer Network (MSCCN).

A complete statistical breakdown by variable for each sample year is documented in Table VII.

SUMMARY

Several variables appear to distinguish between program completers and program non-completers based on this profile. Some variables that seem to be relevant to examine include: Number of Furloughs, Last Grade Completed, Number of Court Appearances, Number of Juvenile Incarcerations and Age at Pre-Release Placement. These variables appear to be significant from examining the percentages in each year. The next component of the evaluation of the drug contract houses will deal with the specific examination of the variables that distinguish between program completers and program non-completers for this sample and to distinguish where the significant differences lie.

It is also significant to note that of the individuals who were released from drug contract houses, only 4 residents (or 12%) of the 1977 sample and 6 residents (or 11%) of the 1978 sample were committed for drug offenses. This percentage is the same as for the overall population and seems to indicate that the population in the drug contract houses is not very different from the population in other facilities.
