F O R E W O R D

The statistical summary which follows provides an overview of the Juvenile Court operations in Pennsylvania. It is limited to Juvenile Court delinquency and dependency cases originating in County Juvenile Probation Offices. Please note that the majority of dependency cases originate in the County Child Welfare Agency. This report contains data on the limited number of dependency cases that originated in county probation offices.

The report contains data on selected juvenile characteristics and methods by which children were handled by each Court. Although the report is general in nature, it should be used by each county to identify areas of court management that may need further evaluation or monitoring. More detailed data that is beyond the scope of this report is available in our Statistical Office data files. The Office will be glad to discuss any specific data requirements with each county court.

The Commission intends to produce a mid-year follow up report. This report will be limited to analytical data. It will be available for distribution during July of this year.

I wish to thank the Juvenile Court Judges and the Chief Juvenile Probation Officers and their staff, for without their cooperation, it would be impossible to complete this report.

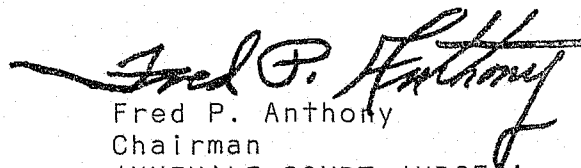

SUMMARY OF JUVENILE COURT DISPOSITIONS, 1978

REASON FOR REFERRAL

There were 40,529 juveniles processed in Pennsylvania Juvenile Courts during 1978. Cases involving acts of delinquency (including traffic) accounted for 36,981 or 91.2% of the total. Dependency cases accounted for 3,548 or 8.8%. (Dependent cases include all deprived cases as well as ungovernable behavior cases which were classified as dependent cases after August 3, 1977.)

MANNER OF HANDLING

21,902 or 54.0% of the juveniles processed were handled by an adjudication hearing. 12,953 or 32.0% of the cases were handled informally, and 5,674 or 14.0% were handled by a consent decree.

DETENTION

Of the 40,529 juveniles processed, there were a total of 10,051 pre-disposition detention experiences and 1,084 detentions after disposition. These detention incidents do not represent the number of juveniles detained since one child may be counted more than once whenever he enters different facilities. The majority of these detentions, 87.1%, were in detention homes while 8.3% were in shelter facilities. Jail, foster homes, and other each accounted for less than 2% of total detentions.

DISPOSITION

35,534 or 87.7% of the total cases processed were disposed of with no legal transfer of custody. Dismissals accounted for the major part of these dispositions with 11,110 cases or 27.4% followed by probation with 7,412 cases or 18.3%. Informal Adjustments accounted for 5,813 or 14.3% of the cases. Of the total cases where the final disposition involved a legal transfer of custody, 3,017 were placed in either a public or private institution for delinquency, and 1,978 cases received other court ordered care or commitment. A summary of all dispositions is shown in Table A.

There is a 2.4% reduction in referrals from 1977 to 1978. This continues the decrease of 8.8% noted between 1976 and 1977 data. Philadelphia's referrals increased 4.5% in 1978 after having a 22.5% reduction in 1977. Allegheny county continued its 10.1% referral decline of 1977 with a further decrease of 15.9% for 1978. Statewide referrals are down nearly 1/6 since 1975 with Philadelphia and Allegheny counties responsible for offsetting a slight increase in the totals for the other 65 counties of Pennsylvania.

During 1978 delinquency referrals increased 11.3% with Philadelphia, Allegheny, and the remaining counties all increasing their respective 1977 totals. Philadelphia and Allegheny counties accounted for 49.6% of the State delinquency cases in 1978, up only marginally from their 49.0% share in 1977 and down from their 1976 figure of 56.5%.

The most significant statistic in this area is the change in the percentage of delinquency referrals. There was a 57% decrease in the percentage of non-delinquent referrals (dependency) and delinquency referrals rose from 80.0 to 91.2 percent of all referrals. Statewide delinquency referrals minus Philadelphia and Allegheny counties constituted 94.4% of total referrals.

There was a 32.1% increase in the rate at which delinquency referrals are being placed in private institutions for delinquency during 1978. At the same time, there was a 13.5% decrease in the rate of placements to public institutions for delinquency. The overall rate of placement for delinquency cases is almost unchanged (2.8%) between 1977 and 1978.

This table reflects significant changes in the placement of juveniles into delinquency institutions. The Philadelphia, Central, and Southwest Regions are moving from 1977 positions of least utilization of private institutions to their 1978 positions which are nearer the state average.

These regions correspond to the Pennsylvania Commission on Crime and Delinquency Planning Areas.

TIME LAPSE DATA FOR THE JUVENILE COURT PROCESS

The time lapse from referral to disposition for the average case in the juvenile court system is 67.64 days. This is an increase of 9.17 days or 15.7% above the 1977 figure. This increase may largely represent the impact of Philadelphia data which was not included in 1977 statistics.

ATTORNEY REPRESENTATION

The following information is based on 13,151 cases where attorney representation was known. Attorney representation is divided into four (4) categories: court appointed, private, public defender and cases where the juvenile waived his right to an attorney. No statewide county breakdown is available in the detail tables.

The mean time lapse from referral to disposition where the attorney was "Court Appointed" was 50.94 days. 50% of all referrals received dispositions by the 35th day when court appointed attorneys were used. Both the mean and median were 16% lower than the same figures for 1977. Total cases in this category were down 48%.

The average time lapse from referral to disposition where the attorney was "private" was 81.84 days. 50% of all referrals having private attorneys received dispositions by the 65th day. Mean time lapse for private attorneys increased 6.5% over 1977 and now is 60.7% longer than the time lapse for court appointed attorneys.

The average time lapse from referral to disposition where the attorney was "Public Defender" was 66.36 days. 50% of the juveniles in this category had disposition of their cases within 46 days. These figures are virtually unchanged from the 1977 statistics.

The average time lapse from referral to disposition when the attorney was waived was 55 days. 50% of all juveniles in this group received dispositions within 36 days. This is only 55% as long as the time taken when a private attorney was used.
