





## Introduction

## Introduction

Crime is a major concern for the citizens of the Atlanta Region. It affects the lives of each and every person within the seven-county area. Some people become victims of crime or see loved ones fall victim to crime. Others live in fear of crime and change their life-styles and activities because of this fear. Everyone pays for crime -- through higher taxes to pay for law enforcement, through higher prices because of shoplifting and expensive security precautions, or through their own personal investment in security devices.

The Atlanta Regional Commission's Crime Analysis for the Atlanta Region covers data reported for calendar year 1978. The Crime Analysis Report only examines Part I offenses or "Index Crimes" which consist of homicide, forcible rape, robbery, aggravated assault (violent crimes), and burglary, larceny, and motor vehicle theft (property crimes) in the seven jurisdictions: Clayton, Cobb, DeKalb, Douglas, Fulton, Gwinnett,

and Rockdale County. This analysis has two goals. The first is to keep citizens informed and aware of the extent of crime in the region and in their community. The second is to provide information to criminal justice officials for planning purposes.

The information for this report was derived from three sources. The crime information was obtained by means of a survey form sent out to all of the 49 Atlanta Region law enforcement agencies. The questionnaire requested information on Part I offenses concerning the number of offenses committed and those cleared by arrest. It must be remembered that reported crimes are only a sample of the actual crime picture. There may be as much as 50 percent of all crimes which go unreported every year.

The population figures were extracted from the 1978 Population and Housing report of the Atlanta Regional Commission. The labor force

information came from the 1978 Civilian Labor Force Estimates prepared by the Georgia Department of Labor.

This is a purely descriptive analysis. It is not an attempt to evaluate the effectiveness of any law enforcement agency nor is it an attempt to identify the cause of crime in a given area. The population and employment figures are used to provide the reader with a partial demographic profile of each area. They are not used as correlates of crime in a given area. There are many social and economic factors which contribute to the impact of the crime problem.

Population size and density.

Population composition by age, sex, and race.

Population stability including the numbers of visitors and commuters.

Population composition as to education levels.


Opportunities within the community for recreation at differing economic and social levels.

Relationship of the local law enforcement agency with its community and the resultant attitudes of the citizenry.

Crime prevention efforts by the police and citizenry.

Policies and procedures of local prosecutors, judges and correctional managers.

However, these factors will not be dealt with in this report. A detailed breakdown of crimes for each jurisdiction is contained at the end of this report.



**Clayton County**

## Demographic Features

Clayton County had an estimated 1978 population of 142,300. Individuals in incorporated areas numbered 44,321 or 31.1 percent of the total population. The population density of the county is 1.31 persons per acre.

The labor force in Clayton County is comprised of 67,159 people with 63,698 employed and 3,461 unemployed. Based upon these figures, the unemployment rate was 5.2 percent for 1978.

## Crime Analysis

The crime rate based on offenses per 1,000 population was 54.62 for Clayton County in 1978. The number of index crimes in Clayton County increased 18.9 percent. The total number of Part I offenses reported within the county was 7,773. Of these, 7,336 were classified as property crimes (an increase of 18.2 percent) and 437 were classified as violent crimes (an increase of 34.0 percent). Larceny was the most reported property crime with a total of 3,941 incidents. Of



violent crimes, assault was the most reported with 243 incidents.

Of the total number of crimes reported, 60.9 percent were cleared. In addition, 61 percent of all property crimes and 57 percent of all violent crimes were cleared.

In Clayton County, Forest Park had the highest crime rate with 86.5 index crimes per 1,000 persons. Jonesboro had the lowest crime rate with 21.5 index crimes per 1,000 persons.



**Cobb County**

## Demographic Features

Cobb County had an estimated 1978 population of 278,800. Individuals in incorporated areas numbered 69,282 or 24.9 percent of the total population. The population density of the county was 1.25 persons per acre.

The labor force in Cobb County was comprised of 122,376 people with 116,394 employed and 5,982 unemployed. This yields an unemployment rate of 5.2 for 1978.

## Crime Analysis

The crime rate based on offenses per 1,000 population was 45.32 for Cobb County in 1978. The number of index crimes in Cobb County had an insignificant rate of increase in 1978 (.8 percent). The total number of Part I offenses reported within the county was 12,636. Of these, 11,730 were classified as property crimes (.6 percent) and 906 were classified as violent crimes (an increase of 3.5 percent). Larceny was the most reported property



crime with a total of 6,904 incidents. Of violent crimes, assault was the most reported with 545 incidents.

Of the total number of crimes reported, 27.4 percent were cleared. In addition, 26.1 percent of all property crimes and 43.4 percent of all violent crimes were cleared.

In Cobb County, Marietta had the highest crime rate with 101.1 index crimes per 1,000 persons. Acworth had the lowest crime rate with 26.3 index crimes per 1,000 persons.



**DeKalb County**

## Demographic Features

DeKalb County had an estimated 1978 population of 474,200. Individuals in incorporated areas numbered 92,423 or 19.5 percent of the total population. The population density of the county was 2.76 persons per acre.

The labor force in DeKalb County was comprised of 227,530 people with 216,142 employed and 11,388 unemployed. This means a 1978 unemployment rate of 5.0.

The data presented in this section do not include that portion of the City of Atlanta that is within DeKalb County since that breakdown was not available.

## Crime Analysis

The crime rate based on offenses per 1,000 population was 45.25 for DeKalb County in 1978. Index crimes in DeKalb County increased 1.5 percent in 1978. The total number of Part I offenses



reported within the county was 20,984. Of these, 19,771 were classified as property crimes (an increase of 0.9 percent) and 1,213 were classified as violent crimes (an increase of 11.9 percent). Larceny was the most reported property crime with a total of 10,253 incidents. Of violent crimes, robbery was the most reported with 595 incidents.

Of the total number of crimes reported, 34.9 percent were cleared. In addition, 32.7 of all property crimes and 71.7 percent of all violent crimes were cleared.

In DeKalb County, including the unincorporated area, Chamblee had the highest crime rate with 90.2 index crimes per 1,000 persons. Stone Mountain had the lowest crime rate with 16.8 index crimes per 1,000 persons.



crimes in Douglas County in 1978 decreased 8.4 percent from the 1977 total. The total Part I offenses reported within the county was 1,195. Of these, 1,099 were classified as property crimes (a decrease of 9.6 percent) and 96 were classified as violent crimes (an increase of 6.6 percent). Larceny was the most reported property crime with a total of 500 incidents. Of violent crimes, assault was the most reported with 59 incidents.

Of the total number of violent crimes reported, 2.0 percent were cleared.



## Demographic Features

Fulton County had an estimated 1978 population of 615,800. Individuals in the incorporated areas numbered 519,883 or 84.4 of the total population. The population density of the county was 1.83 persons per acre.

The labor force in Fulton County was comprised of 291,303 people with 272,613 employed and 18,690 unemployed. This means a 1978 unemployment rate of 6.4.

## Crime Analysis

The crime rate for Fulton County including the City of Atlanta was 107.46 in 1978. The number of index crimes in Fulton County excluding the City of Atlanta increased 19.3 percent in 1978. The total number of Part I offenses reported within the county was 12,312. Of these, 11,158 were classified as property crimes (an increase of 18.0 percent) and 1,154 were classified as violent

crimes (an increase of 34.5 percent). Larceny was the most reported property crime with a total of 6,602 incidents. Of violent crimes, assault was the most reported with 669 incidents.

Of the total number of crimes reported, 18.1 percent were cleared. In addition, 17.3 percent of all property crimes and 25.6 percent of all violent crimes were cleared.

Of the municipalities in Fulton County other than Atlanta, East Point had the highest crime rate with 87.2 index crimes per 1,000 persons. Palmetto had the lowest crime rate with 29.5 index crimes per 1,000 persons.

#### CITY OF ATLANTA

The crime rate for the City of Atlanta was 118.12 in 1978. This may be somewhat misleading as Atlanta's daily commuter population is approximately double its residential population and that the computed crime rates contained in this report are

based on residential populations.


The City of Atlanta reported 53,865 Part I offenses in 1978, an increase of 18.0 percent. Of these, 45,018 were classified as property crimes (an increase of 18.5 percent) and 8,847 were classified as violent crimes (an increase of 15.9 percent). Larceny was the most reported property crime with a total of 25,874 incidents.

Of violent crimes, robbery was the most reported with 4,119 incidents.

Of the total number of crimes reported, 22.0 percent were cleared. In addition, 16.0 percent of all property crimes and 52.0 of all violent crimes were cleared.

**Gwinnett County**

## Demographic Features

Gwinnett County had an estimated 1978 population of 137,200. Individuals in incorporated areas numbered 34,108 or 24.9 percent of the total population. The population density of the county was 0.49 persons per acre.

The labor force in Gwinnett County was comprised of 59,487 people with 57,077 employed and 2,410 unemployed. This means an unemployment rate of 4.1 for 1978.

## Crime Analysis

The crime rate for Gwinnett County was 38.23 in 1978. The number of index crimes in Gwinnett County increased 9.0 percent in 1978. The total number of Part I offenses reported within the county was 5,246. Of these, 4,978 were classified as property crimes (an increase of 9.7 percent) and 268 were classified as violent crimes (a decrease of 1.46 percent).

Larceny was the most reported property crime with a total



of 2,887 incidents. Of violent crimes, assault was the most reported with 155 incidents.

Of the total number of crimes reported, 17.6 percent were cleared. In addition, 15.5 percent of all property and 56.3 percent of all violent crimes were cleared.

In Gwinnett County, Norcross had the highest crime rate with 40.9 index crimes per 1,000 persons. Lawrenceville had the lowest crime rate with 21.7 index crimes per 1,000 persons.



**Rockdale County**

## **Demographic Features**

Rockdale County had an estimated population of 32,100. Individuals in incorporated areas numbered 6,252 or 19.5 percent of the total population. The population density of the county was 0.39 persons per acre.

The labor force in Rockdale County was comprised of 14,407 people with 13,854 employed and 556 unemployed. This means an unemployment rate of 3.9 for 1978.

## **Crime Analysis**

The crime rate for Rockdale County was 36.51 in 1978. The number of index crimes in Rockdale County increased 74.4 percent in 1978. The total number of Part I offenses reported within the county was 1,172. Of these, 969 were classified as property crimes (an increase of 54.0 percent) and 203 were classified as violent crimes (an increase of 372.0 percent). Larceny was the most reported



property crime with a total of 541 incidents. Of violent crimes, assault was the most reported with 180 incidents.

Of the total number of crimes reported, 29.7 percent were cleared. In addition, 18.7 percent of all property crimes and 89.6 percent of all violent crimes were cleared.

In Rockdale County, Conyers had 52.9 index crimes per 1,000 persons.



**Summary**

## **Summary**

Index crime in the Atlanta Region increased in 1978. There was a 11.2 percent increase in the total number of reported index crimes between 1977 and 1978.

Property crimes increased by 10.5 percent while violent crimes also increased by 17.3 percent.

It seems that an upward trend in crime is establishing itself except for 1977 where a decrease occurred. There were a total of 114,005 index crimes for 1978, an increase of 11.2 percent.

In 1978 index crimes in five out of the seven counties showed increases. Only Douglas County showed a decrease in reported index crimes by a decrease of 8.7 percent while Cobb County showed an insignificant rate of change.

The five cities with the highest crime rate were:

Atlanta 118.1 crimes per 1,000.

Marietta 101.1 crimes per 1,000.

Chamblee 90.2 crimes per 1,000.

East Point 87.2 crimes per 1,000.

Forest Park 86.5 crimes per 1,000.

The five cities with the lowest crime rates were:

Stone Mountain 16.8 crimes per 1,000.

Jonesboro 21.5 crimes per 1,000.


Lawrenceville 21.7 crimes per 1,000.

Riverdale 24.7 crimes per 1,000.

Snellville 25.9 crimes per 1,000.
