INTRODUCTION

At the Federal-Provincial conference of Deputy Ministers responsible for criminal justice, held in Ottawa on June 23, 1980, the report and recommendations of the National Project on Resource Coordination for Justice Statistics and Information (NPRC)* were discussed. Several important decisions with respect to the future of national justice statistics and information were made at that time.

The Deputy Ministers approved in principle the major organizational recommendation of the NPRC that a "Satellite" of Statistics Canada should be created to act as the central national justice statistics agency. As of its proposed starting date of April 1, 1981 it will incorporate the functions now carried out by the Justice Division of Statistics Canada, the National Work Group, and the National Task Force.

The organizational framework for the direction of efforts to produce national justice statistics was also revised as a result of the Deputy Minister's conference. A Justice Information Council has been constituted, comprised of all Deputy Ministers responsible for criminal justice, as well as the Chief Statistician of Canada. An Executive Committee of this Council has been formed to more actively direct future development. As well, an Implementation Work Group now exists to prepare the groundwork for the transition on behalf of the Executive Committee of Deputies. Finally, first-order liaison contacts have been appointed to coordinate Provincial/Territorial contributions to National statistical efforts.

CONSEIL SUR L'INFORMATION JUDICIAIRE (CIJ)

INTRODUCTION

Les sous-ministres responsables de la justice criminelle ont examiné le rapport et les recommandations du groupe chargé du projet national de coordination des ressources pour la statistique et l'information judiciaires (PNCR)* au cours de la conférence fédérale-provinciale tenue à Ottawa le 23 juin 1980. Ils ont alors pris plusieurs décisions importantes concernant l'avenir de la statistique et de l'information judiciaires à l'échelle nationale.

Les sous-ministres ont approuvé en principe la principale recommandation du groupe du PNCR, à savoir la création d'un organisme "satellite" de Statistique Canada faisant office de centre de la statistique judiciaire nationale. Dès le 1er avril 1981, date proposée pour son entrée en fonction, le centre remplira les fonctions qu'assument actuellement la Division de la statistique judiciaire, le Groupe national de travail et le Groupe de travail national.

Par suite de la conférence des sous-ministres, le cadre organisationnel servant à produire des statistiques judiciaires nationales a également fait l'objet d'un examen. Un Conseil sur l'information judiciaire composé de tous les sous-ministres responsables de la justice criminelle et du statisticien en chef du Canada a été constitué. Un sous-comité de ce Conseil a été chargé de diriger plus activement les travaux futurs. En outre, un groupe chargé de la mise en œuvre de la statistique judiciaire a été créé dont le mandat est d'effectuer, au nom du sous-comité de sous-ministres, le travail de base en vue de la transition.
