

Explanation of Workload Statistics

The data in this statistical report reflect the workload of the juvenile court service units and the adult probation and parole offices. The workload of these units does not only include the caseload of persons under supervision but also measures the other services delivered by the units to their clients.


It is not appropriate to draw comparisons between the individual districts within the juvenile or adult systems or to compare the juvenile workload to the adult workload.

The services provided by the court service units and the probation/parole offices are impacted by the needs of their locality. The workload cannot be considered comparable between the localities because of the divergent demands of the individual communities. The variation in workload is affected by the level and type of requests received from the court, the geography and size of the district, and by the levels of supervision required by the individual clients. The standards, definitions, and reporting procedures are also not the same for court service units and for the probation/parole offices.

JUDICIAL DISTRICTS, BY REGION**



As of June 30, 1980 there were 567 authorized Juvenile Counselors in 37 Juvenile Court Service Units within 32 Juvenile and Domestic Relations Judicial Districts. Of the 37 Court Service Units, 25 are state operated and 12 are locally operated. The 12 locally operated Court Service Units are physically located within 9 of the districts.

- * Locally operated Court Service Units.
- (a) In District 23 there are 3 locally operated Court Service Units, each having the following number of authorized Juvenile Counselors: Roanoke City - 16; Roanoke County - 7; and Salem City - 2.
- (b) In District 22 there are 2 Court Service Units; one is locally operated (Danville - 3 Counselors) and the other (Rocky Mount - 7 Counselors) is state operated.
- (c) In District 19 there are 2 locally operated Court Service Units, each having the following number of authorized Juvenile Counselors: Fairfax County - 47; and Falls Church - 1.
- (d) In District 20 there are 2 Court Service Units; one is locally operated (Loudoun - 4 Counselors) and the other (Warrenton - 2 Counselors) is state operated.

Children and Families Under Supervision of Virginia Court Service Units Fiscal Year Ending June 30, 1980

This report represents the Juvenile Court Service Workload for the Commonwealth of Virginia in fiscal year 1980 (July 1, 1979 through June 30, 1980). The map on page 4 shows the 32 Judicial Districts in which the 37 Juvenile Court Service Units are located. There are 25 state operated and 12 locally operated Juvenile Court Service Units.

INTAKE

During fiscal year 1980 there were 106,333 Intake Cases referred to Court Service Units. Intake Cases accounted for 73.7 percent of the 144,296 total services completed in fiscal 1980.

In examining regional totals, Region III (Northern) received the greatest number of Intake Referrals, accounting for 32,066 intakes or 30.2 percent of all Intake Referrals for fiscal 1980. Region V (Southeast) was second in Intake Referrals, accounting for 30,286 or 28.5 percent of all such referrals. Region I (Western) was third in Intake Referrals with 16,916, while Region II (Central) had the fewest referrals, accounting for only 13,276 intakes or 12.5 percent of the total intake workload.

TRANSFER REPORTS

Transfer Reports are ordered on individuals fifteen years of age or older who have been charged with certain felonies. The report is used to determine if an individual should be transferred to Circuit Court for trial as an adult.

There were 1,753 Transfer Reports completed in fiscal 1980. These reports represent 8.7 percent of the 20,143 reports (Social History, Transfer, Addendum, and Foster Care) completed by the Court Service Units.

In examining regional totals, Region V (Southeast) completed the most Transfer Reports in fiscal 1980, accounting for 617 reports or 35.2 percent of all such reports. Region IV (East Central) had the second largest number of Transfer Report completions with 535 or 30.5 percent of all such reports. Region I (Western) had the fewest number of Transfer Reports with only 160 or 9.1 percent of the total Transfer Reports completed.

SOCIAL HISTORY REPORTS

When requested by the judge prior to court disposition, a comprehensive study of the child's social history and environment is made. The Court Service Unit, according to Standards adopted by the State Board of Corrections, must complete a Social History Report on any child placed under supervision. As a result, the number of Social History Reports represents all children receiving supervision for a period of over three months.

Social History Reports accounted for 60.1 percent of all reports completed by Court Service Units in fiscal 1980. There were 12,113 Social History Reports completed in this fiscal year.

In examining regional totals, Region V (Southeast) completed the largest number of Social History Reports, accounting for 3,964 or 32.7 percent of all Social History Report completions. Region III (Northern) was second in completions, accounting for 2,966 Social History Report completions or 24.5 percent of all Social History Reports. Region II (Central) had the fewest completions of Social History Reports, with 1,367 reports.

ADDENDUM REPORTS

Addendum Reports are short reports sent to the court concerning Social History updates, or any other short report or progress report made for the court's use.

In fiscal 1980 there were 4,822 Addendum Reports submitted to the courts. The above figure represents 23.9 percent of all reports completed by the Court Service Units during the fiscal year.

In examining regional totals, Region V (Southeast) completed the largest number of Addendum Reports in fiscal 1980, accounting for 1,662 reports. Region IV (East Central) was second in reporting, with 1,256 Addendum Reports.

FOSTER CARE REPORTS

Section 16.1-282 of the Code of Virginia requires a yearly court review of each child who is in a foster care placement. When upon order of the judge, the Court Service Units assist in this review, they report and receive credit for this service.

There were 1,455 Foster Care Reports submitted to the courts in fiscal 1980. The above figure represents only 7.2 percent of all reports completed by the Court Service Units during the fiscal year.

In the regional analysis, Region V (Southeast) had the largest number of Foster Care Reports submitted to the courts, accounting for 473 reports or 32.5 percent of all Foster Care Reports completed during the fiscal year. Region III (Northern) was second in reporting with 396 Foster Care Reports.

PROBATION/SUPERVISION CASES

Juvenile Probation/Supervision comprised 12,183 cases or 92.4 percent of all Probation/Supervision cases completed in fiscal 1980. Adult Probation/Supervision accounted for the remaining 1,006 cases completed or 7.6 percent of all Probation/Supervision cases completed. The combined totals of Juvenile and Adult Probation/Supervision cases completed comprised 13,189 or 9.1 percent of the total workload of 144,296 cases, intakes and reports completed in fiscal year 1980.

Official Juvenile Probation cases completed in fiscal 1980 accounted for 7,357 cases or 60.4 percent of all juvenile cases, while the remaining 4,826 juvenile cases completed had been under Unofficial Supervision. Official Adult Probation cases completed accounted for 595 cases or 59.1 percent of the total Adult Probation cases completed, while Unofficial Adult Supervision accounted for 411 cases or 40.9 percent of all Adult Probation/Supervision cases completed. There were 5,971 Official and 1,221 Unofficial Juvenile cases carried over to fiscal 1981 and only 184 Official and 74 Unofficial Adult cases carried over.

In examining regional totals, Region V (Southeast) accounted for the largest number of completions, with 4,540 Juvenile Probation/Supervision cases and 591 Adult Probation/Supervision cases. Southeast's Juvenile and Adult completions combined represented 38.9 percent of all Probation/Supervision cases completed in fiscal 1980. Southeast also accounted for the largest number of cases carried over, with 2,223 Juvenile and 151 Adult Probation/Supervision cases. Region III (Northern) had the second largest number of cases completed with 2,639 Juvenile and 138 Adult Probation/Supervision cases completed and 2,075 Juvenile and 55 Adult Probation/Supervision cases carried over to fiscal 1981.

AFTERCARE SUPERVISION IN DIRECT CARE

The Court Service Units provide services through visitation and contact with children in Direct Care. In fiscal 1980 there were 415 children in Direct Care released from Aftercare Supervision. The Court Service Units carried 1,121 Aftercare in Direct Care cases over into fiscal 1981.

Region III (Northern) accounted for the largest number of children (124) released from Direct State Care in fiscal 1980. Region IV (Southeast) accounted for the second largest number of children (99) released from Direct Care in fiscal 1980. Southeast also accounted for the largest number of children (395) in Direct State Care carried over into fiscal 1981.

FAMILY COUNSELING

All families of children in the direct care of the Department of Corrections are contacted and provided services if needed while their children are under State care. Family Counseling is also provided for families of children on Aftercare Supervision and is available for families of children on Probation or involved in other juvenile and domestic relations cases. During fiscal 1980 there were 3,411 families released from Family Counseling Services. There were 1,572 families carried over into fiscal 1981 for counseling services.

During fiscal year 1980, Region V (Southeast) released the largest number of families (1,241) from counseling services. Southeast also had the largest number of Family Counseling Cases carried over into fiscal 1981, carrying 595 cases. Region IV (East Central) had the second largest number of families released from counseling during the fiscal year, accounting for 933 releases. East Central was also second in Family Counseling Cases carried over into fiscal 1981, carrying 456 cases.

AFTERCARE SUPERVISION IN COMMUNITY

The Court Service Units discharged 805 juveniles from Aftercare Supervision in the Community in fiscal 1980. The Court Service Units carried 704 cases on Aftercare Supervision in the Community into fiscal 1981. The children discharged from Aftercare in the Community comprise only 0.6 percent of the total 144,296 supervision cases, intakes, and reports completed in fiscal year 1980.

In examining the regional totals, Region V (Southeast) accounted for the greatest number of discharges in fiscal 1980, with 203. Region III (Northern) was second in both discharges and in cases carried over, accounting for 183 discharges in fiscal 1980, and 176 cases carried over into fiscal 1981.

Fiscal Year Ending June 30, 1980**





CHART 2



Adults Under Supervision of the Division of Community and Prevention Services Fiscal Year Ending June 30, 1980

The data in this section of the report were submitted to the central office of the Division of Community and Prevention Services by each district office in Virginia. The map on page 78 shows the 39 adult probation and parole districts and the administrative regions in which they are located.

PROBATION CASELOADS

Probationers are received for supervision from courts of record (Circuit Courts) or courts not of record (General District Courts). Of the total clients served during fiscal year 1980 there were 16,759 from Circuit Courts and 2,170 from District Courts. At the end of the fiscal year there were 10,669 probationers remaining under supervision from Circuit Courts and 972 from District Courts. At the end of last fiscal year there were 10,151 probationers under supervision from courts of record and 1,103 from courts not of record. This is a 5.1 percent increase in the number of clients under supervision from Circuit Courts and an 11.9 percent decrease in clients from District Courts. Region I (Western) had the largest number of probationers under supervision on June 30, with 2,888. The region with the smallest caseload was Region IV (East Central) with 1,595 probationers under supervision.

PAROLE/PARDON CASELOADS

On July 1, 1979 the Code of Virginia was changed, instituting mandatory parole six months prior to discharge (§53-251.3). During fiscal year 1980 there were 5,276 discretionary parolees, 1,783 mandatory parolees and 10 pardonees who were served by the Division of Community and Prevention Services. On the last day of the fiscal year, there were 2,913 discretionary parolees, 653 mandatory parolees and 4 pardonees under supervision. Last fiscal year there were 3,135 discretionary parolees and 8 pardonees being supervised on June 30. This represents a 7.1 percent decrease in the number of discretionary parolees and a 50 percent decrease in the number of pardonees under supervision on June 30. When mandatory parolees are included with discretionary parolees, there is an overall increase of 13.7 percent in

the number of parolees under supervision. Region V (Southeast) had the highest number of parolees under supervision on June 30, with 938; Region IV (East Central) was second, with 874 parolees under supervision on June 30. Region I (Western) had the smallest caseload, with 489 parolees/pardonees under supervision.

CLIENT FLOW

Among the 7,675 probationers received for supervision during fiscal year 1980, 5,694 or 74.2 percent were new cases from court. This represents a 9.8 percent decrease over the 6,313 new cases from court received in fiscal year 1979. During fiscal year 1980 there were also 673 probationers or 8.8 percent transferred from other states, 387 or 5.0 percent restored to supervision and 89 or 1.2 percent Virginia cases returned from other states.

Of the 7,288 probationers removed from probation supervision during fiscal year 1980, 2,049 or 28.1 percent were removed due to the expiration of their term of probation. This represents a 2.9 percent increase over the 1,992 probationers removed by expiration of probation in fiscal year 1979. In addition, 1,881 probationers or 25.8 percent were removed from supervision by order of the court. Warrants were issued for 689 or 9.5 percent of the probationers who were discharged, 636 or 8.7 percent were probationers who had their probation revoked, and 533 or 7.3 percent were out-of-state probation cases that were terminated.


The majority of parolees/pardonees who were received came directly from Virginia institutions (3,229 or 82.2 percent). In addition, 10.2 percent of the clients were transferred from other districts and 6.0 percent were received from other states. Among those removed from supervision, 1,969 or 56.3 percent were discharged from parole, 715 or 20.4 percent were issued warrants and 413 or 11.8 percent were transferred to other districts. In addition, among parolees removed from supervision, 5.6 percent were out-of-state cases terminated and 4.2 percent were Virginia cases transferred to other states.


