





Explanation

This volume lists justice oriented programmes across Canada; federally, provincially and territorially; that are specially designed for or available to Native People.

Those programmes listed as federal are those that have been set up on a national basis by the federal government, and do not indicate the extent of total federal involvement in justice oriented programmes. In fact, many of the programmes listed under the various provinces and territories are partially funded by the federal government, but operate specifically for residents of the province or territory concerned.

In interviewing people concerned to elicit information on the various programmes, the following areas were particularly examined:

Purpose of the programme;

Authorization for the programme;

Administration of the programme;

Population at whom the programme is directed;

Duration of the programme;

Resources of the programme in terms of funds and manpower.

Further information on any of the programmes listed can be obtained by getting in touch with the contact person indicated at the end of the listing.

Justice programming for Native people is in a constant state of flux, as new ones are developed and old ones come to an end. Even now, programmes are coming into being that are not listed here, and some of the ones listed here might not receive funding in the next fiscal year.

This list of programmes is organized in the following manner: federal programmes, territorial programmes, then programmes by province from west to east. Sections and the names of programmes under each section or heading are arranged alphabetically.

Contracts are entered into by which the National Native Alcohol Abuse Programme agrees to fund projects, in whole or in part, on the basis of proposals submitted by Native communities or groups

The National Inventory of Diversion Projects is designed to reflect the state of the art in the area of diversion by listing diversion projects in Canada under the following headings:

Existent Diversion Projects in Canada - Juvenile

Existent Diversion Projects in Canada - Adult

Diversion Resource Programmes - Direct Service Resources

The Inventory identifies almost fifty diversion projects, some of which are specifically for juveniles or adults and some of which are for both juveniles and adults. The majority of these projects are not specifically designed for Native people, but four are; one in British Columbia, two in Manitoba and one in Ontario.

Each year the Department of Justice funds up to five Metis and non-status Indian students to attend a 2-month summer law programme given at the University of Saskatchewan in Saskatoon. If the students are successful in the summer programme and are accepted by a Canadian law school, the Department pays the student's tuition, book costs and a living allowance based on Manpower retraining rates. This funding continues as long as the student successfully remains in an LL.B. programme, but is not paid during articling nor bar admission course

Delivery of Services:

The summer programme is given each June and July at the Faculty of Law of the University of Saskatchewan in Saskatoon. Students in the summer programme are evaluated at the end of the programme, based on exam marks, moot court performance, teachers' observations, etc. Based on this evaluation, they are either recommended to attend law school or not, although the final decision in all cases is up to the law school to which the student has applied on whether or not to accept the student for formal legal studies
