

INTRODUCTION

The Offender-Based Transaction Statistics (OBTS) system was implemented in California to develop statistical data resulting from the progress of individuals through the various levels of the criminal justice system. This system includes adults, arrested on felony charges, who are disposed of at the law enforcement, prosecutor, lower court, and superior court levels.

This OBTS effort in California has been funded and supported through a combination of state funds and federal funds provided by the Law Enforcement Assistance Administration (LEAA) in the United States Department of Justice since July 1, 1974.

While the analysis and data in this publication deal with adult felony arrestees who received a final disposition in 1975, OBTS disposition data for 1976 have already been processed and will be available in June 1977. In the future, OBTS data will be reported in the following two major annual publications of the Bureau of Criminal Statistics:

- . Crime and Delinquency in California
- . Criminal Justice Profile

HIGHLIGHTS OF THE 1975 OBTS DATA

The highlights of the 1975 OBTS data as reported by criminal justice agencies in 56 counties (excluding Alameda and Santa Clara counties - see "Data Explanations and Limitations," p. 13) are as follows:

Dispositions

- . In 1975, over 900 agencies reported 174,069 dispositions of adult felony arrests.
- . Of the 174,069 persons disposed of following a felony arrest:
 - 8.5 percent were released at the law enforcement level
 - 13.5 percent were released at the prosecutor level
 - 56.0 percent were disposed of at the lower court level
 - 22.0 percent were disposed of at the superior court level
- . Nearly one out of two persons arrested on felony charges was convicted.
- . Of all court convictions, three out of four defendants received either a sentence of straight probation or probation and jail.
- . Of those convicted in superior court, 80 percent received a felony sentence and 20 percent were disposed of as misdemeanants.
- . Less than 3 percent of the original number of persons arrested for felony offenses received a prison commitment. It took an average of six months from the time of arrest until these defendants were sentenced to prison.

Offenses

- . Of the 174,069 dispositions, 19.4 percent originated with arrests for crimes against persons (homicide, forcible rape, robbery, and assault); 28.4 percent originated with crimes against property (burglary, theft, and motor vehicle theft); 39.0 percent originated with drug law violations; and "all other" felony offenses comprised 13.2 percent of the total number of arrest offenses.
- . Law enforcement agencies released a much smaller proportion of persons arrested for felony drug offenses than were arrested for either crimes against persons or property.

Race

- . Over half (56.0 percent) of the adult felony arrestees in 56 counties were white. Negroes accounted for 24.6 percent of the arrestees and Mexican-Americans comprised 15.6 percent of the felony arrest disposition population.
- . White arrestees were much more heavily involved in drug law violations than were any other racial group.

Sex

- . Males comprised 86.5 percent of the adult felony arrest dispositions and females comprised 13.4 percent.

Age

- . The majority of adults (60.5 percent) disposed of in 1975 were between 20 and 29 years of age at the time of their arrest. Three out of every four adults were under 30 years of age.
- . Older defendants have a higher proportion of court convictions than do younger defendants.

THE OBTS CONCEPT

Over the past several years, California has been developing a system of criminal transaction reporting which tracks adult felony arrestees from the point of arrest through the point of final disposition in criminal justice proceedings. The essential features of the OBTS system are:

- . Data for each offender are recorded separately (rather than in summary form).
- . The individual adult, arrested on felony charges, is the basic unit of count rather than counting multiple crimes, multiple cases, or multiple dispositions.
- . The events and decisions at each stage in the criminal justice process are noted in the individual's transaction record.

This is referred to as a "longitudinal" tracking process by those engaged in criminal research. The OBTS system provides a dynamic picture of the criminal justice system; one that shows the progress of the offender through the various steps of the criminal justice process. It identifies bottlenecks and pinpoints interrelationships. It incorporates the concept of time. It shows what decisions are being made, where those decisions are made, and permits the consideration of decisions at one level in light of decisions made at other levels.

Traditionally, data have been collected independently from each of the four levels in the criminal justice system. While this was adequate to describe in isolation what happened at each individual level, it was impossible to look at the criminal justice system as an overall "system" per se; that is, as an integrated process of interrelated decision points. For example, data were not readily accessible to describe what happened to persons who were arrested for robbery unless a special study was undertaken. However, with the OBTS system, it not only becomes possible to do this, but the final disposition may be evaluated in light of such demographic factors as age, race, sex, criminal status at the time of arrest, and prior criminal record. By tracking individual adult offenders arrested on felony charges through each step in the California criminal justice system to the point where a final disposition occurs, persons interested in the administration of criminal justice can obtain a much broader perspective of the overall effectiveness, or ineffectiveness, of the system and its various components.

THE HISTORICAL DEVELOPMENT OF OBTS IN CALIFORNIA

The need for offender-based data has long been recognized. Several comprehensive studies were conducted in the 1920's and early 1930's following such an approach. However, these studies focused on particular locations over limited periods of time and predated the systemized collection of data on a statewide or national level.

In 1931, the National Commission on the Observation of Law Enforcement (Wickersham Commission) called for the establishment of state systems to collect offender-based criminal justice data as well as a national center to coordinate the states' efforts and present a national picture. This call for offender-based reporting has been repeated in a number of studies, most recently in one conducted by the National Advisory Commission on Criminal Justice Standards and Goals. In the volume entitled Criminal Justice System, the commission stated:

"... the OBTS system has been developed and is recommended for use in all states and localities...When operative, the OBTS system will be as informative about the criminal justice system as the NCIC is about crimes, and the CCH is about criminals."

Prior to 1966, the Department of Justice collected individual offender information at several levels. Felony arrest data, the first step in the tracking process, were then reported only in summary form by police agencies. This prevented identifying and matching subsequent disposition activity with the individual arrestees. The district attorneys reported to the Bureau of Criminal Statistics (BCS) on all felony complaints disposed of in lower courts as well as felony filings and disposition data on persons disposed of in superior courts. Separate reports were received for persons placed on probation and for those committed to state correctional institutions.

The first serious effort toward the development of an offender-based criminal justice statistical reporting system in California was made in 1966. At that time, as part of a pilot study, BCS established an individual reporting system based upon a line-item register that was completed monthly for felony arrests made by 20 law enforcement agencies in three counties. For one year, the transaction reporting from all sources within these three counties was integrated to form a comprehensive offender-based transaction reporting system. The development of the SEARCH (System Electronic Automatic Retrieval Criminal Histories) program by LEAA on a national level gave emphasis to the creation of an offender-based transaction statistical system. It was only natural that California, the only state that had already undertaken the development of such a system, became a part of the SEARCH project in 1968, and received financial support from the project to expand the individualized accounting system already started.

In 1969, 77 law enforcement agencies in 12 counties became active in the Project SEARCH OBTS system of reporting criminal justice data. This 12-county study reaffirmed the soundness of the OBTS concept. It also demonstrated the need for certain changes in the method of data collection. The separate reporting systems for felony arrests and court dispositions proved extremely difficult to coordinate and resulted in numerous omissions, as well as errors, in the data. It was evident that a single consolidated reporting form was needed in order to provide continuity in the transactions reported as the adult felony arrestee proceeded from his arrest to the ultimate disposition of his case.

To meet the need for a consolidated reporting form, the "Disposition of Arrest and Court Action" form (JUS 8715) was developed after experimental use in San Diego County during 1971 and 1972. This single reporting form was tested and proved to be workable. With minor modifications, the JUS 8715 form was finalized and is now used statewide. (See Appendix 1.) This single-page, four-part form replaced several other reporting documents which were formerly submitted to the Department of Justice.

On January 1, 1973 Los Angeles, Orange, and San Bernardino counties, together with San Diego County, began reporting dispositions of adult felony arrests on the JUS 8715 form. Imperial and Riverside counties were added on July 1, 1973. On December 1, 1973 the use of the JUS 8715 reporting form was expanded statewide. However, since LEAA funding for the OBTS project was not received until mid-1974, it was not possible to hire and train personnel to process the total volume of 1973 JUS 8715 disposition documents received by BCS.

Consequently, for the 1973 data year, BCS coded a 25 percent random sample of the JUS 8715 forms received from Los Angeles, San Diego, Orange, and San Bernardino counties. The sample included those persons arrested on felony charges after January 1, 1973 who had a final disposition recorded between July 1, 1973 and December 31, 1973. This sample was somewhat weighted in favor of those dispositions that occurred at the law enforcement level, rather than at the court level, since many of the court dispositions were not completed until after the December 31 date for the sample group. An initial OBTS data base containing 11,076 dispositions was established from these four southern California counties for 1973. These data represent a six-month, 25 percent sample of felony arrest dispositions.

BCS hired and trained personnel to code all of the 1974 JUS 8715 disposition documents received from the above four original OBTS counties. A data base of 107,578 felony arrest dispositions was established for 1974. The 1974 four-county OBTS effort was documented in the report A Comparison of Offender-Based Transaction Statistics (OBTS) in Four Southern California Counties, 1974.

The 1975 OBTS data base, containing 174,069 felony arrest dispositions received from 56 counties, is discussed in greater detail later in this report. In 1976, 157,537 dispositions were reported to BCS by criminal justice agencies in 57 counties (excluding Santa Clara County). These 1976 data will be available by mid-1977.

THE FLOW OF TRANSACTION STATISTICS REPORTING

In the California OBTS system, each agency which makes decisions affecting an offender is responsible for reporting those actions on a consolidated arrest and disposition report, the "Disposition of Arrest and Court Action" form (JUS 8715). Agencies are also responsible for forwarding that report to the next level in the criminal justice system in a timely manner. For example, the arresting police agency usually initiates the report at the time the adult felony arrestee is booked. Unless the offender is released by the arresting agency, the report is forwarded to the prosecuting agency, normally the district attorney in the case of felony charges. Unless the charges are rejected, the JUS 8715 form, together with the case file, proceeds to the lower court level where the complaint is filed.

The JUS 8715 form remains with the defendant's case file in the court records. If the disposition terminates at the lower court level, the court clerk is responsible for entering the appropriate disposition information on the JUS 8715 form.

Municipal and justice courts (i.e., lower courts in California) are limited by statute to try only those defendants charged with criminal offenses which carry a jail sentence upon conviction. Only the superior courts of the state may try defendants on criminal charges which carry a prison sentence. The superior court is the final level in the California OBTS reporting system. The county clerk's office, as the record keeper for the superior courts, is responsible for entering final disposition information on the arrest and disposition report. These data include information on all defendants bound over from lower court preliminary hearings for trial, or who plead guilty to felony charges and appear in superior court for sentencing, or who appear in superior court as the result of a grand jury indictment.

Wherever the final disposition occurs, that agency is responsible for completing the JUS 8715 form and distributing the various copies of the four-part form to the appropriate agencies. The first and second copies of the form (white and green) are detached and forwarded to a central unit in the California Department of Justice, Division of Law Enforcement. These copies are reviewed for completeness, correctness, and legibility and then forwarded to BCS for statistical reporting purposes and to the Bureau of Identification (BID) for updating of the criminal history ("rap sheet") information. The third copy of the form (yellow) is returned to the local law enforcement agency which made the arrest and initiated the JUS 8715. The fourth copy (blue) is forwarded to the Federal Bureau of Investigation (FBI) in Washington, D.C.

The "Disposition of Arrest and Court Action" form thus serves a multiple purpose of providing individual arrestee/defendant transaction statistics as well as providing information used to update or create criminal history files at the local, state, and national levels.

THE 1975 OBTS DATA BASE

Currently, over 900 California criminal justice agencies report dispositions of adult felony arrests by means of the JUS 8715 form. Data are gathered, processed, verified, stored, and used to produce summary statistics that describe the outcome of adult felony arrests at specific levels of the California criminal justice system.

The Bureau of Criminal Statistics processed all JUS 8715 disposition documents received from criminal justice agencies in 56 counties for adult felony arrests which occurred in 1975 or in previous years. A data base of 174,069 arrest disposition records has been established by BCS. OBTS data for 1975 for Alameda and Santa Clara counties are not available since agencies in those two counties did not report dispositions on the JUS 8715 during 1975.

These 1975 data are contained in Charts 1-3 and Tables 1-22 for the following jurisdictional areas:

- . Statewide (i.e., 56-county total, excluding Alameda and Santa Clara counties)
- . Los Angeles County
- . Statewide (i.e., 55-county total, excluding Alameda, Los Angeles, and Santa Clara counties)

For each of the above jurisdictional areas, data are displayed by arrest offenses grouped into the following categories: homicide, forcible rape, robbery, assault, burglary, theft, motor vehicle theft, drug law violations, and "all other" felony offenses. Data also are shown by race, sex, and age for each of the above jurisdictions. In addition, Tables 3, 4, 7, 8, 11, and 12 show the commitments of lower and superior court defendants by convicted offense.

DATA EXPLANATIONS AND LIMITATIONS

In using these data to evaluate the role of statewide criminal justice agencies, there are several limitations and instructions which should be explained if the data are to be correctly interpreted. These include:

1. All data pertain to adult arrests for felony offenses. These felony-level arrest offenses are defined in the Criminal Justice Glossary.
2. Dispositions from Alameda and Santa Clara counties for 1975 are not included in this report since the JUS 8715 form was not used by these counties as the reporting document. Consequently, all "statewide" data include only those disposition documents received from 56 of the 58 California counties.
3. The data in this report reflect dispositions that occurred in 1975 as a result of adult felony arrests which were made in 1975 or in previous years.
4. Comparisons should not be made between felony arrest dispositions reported on the JUS 8715 and felony arrests reported to BCS on either the "Monthly Report - Adult Felony Arrests" form (JUS 703) or the "Monthly Arrest and Citation Register" form (JUS 750). OBTS data are based upon the year of disposition regardless of when the arrest occurred. Arrest data are based upon the year in which the arrest took place.
5. The data in this report are not represented as reflecting the total number of adult felony arrests or the total number of dispositions made at any particular level of the criminal justice system. These data do indicate how the adult felony arrestees, whose report of disposition was completed, received, and processed by BCS, filtered out in the California criminal justice process. The number of arrests and dispositions shown on the following charts and tables includes only those data reported to BCS on the JUS 8715 form.
6. The elapsed time data at the prosecutor level appear to be inflated in some reports and should be interpreted with care. The footnotes on Charts 1D, 2D, and 3D document the possible reasons for this distortion of elapsed time data. All elapsed time data indicate the number of days from the point of arrest to the point of final disposition.
7. The total number of felony offense dispositions reported by some sparsely populated counties (e.g., Alpine, 3; Amador, 66; Plumas, 78; Sierra, 40; etc.) and shown in Tables 21-22, are so low that they may invalidate any proportionate comparisons that may be made.
8. It may not be advisable to make statistical comparisons between 1975 OBTS data and the data in "Felony Complaints Terminated in California Lower Courts" and "Felony Defendants Disposed of in California Superior Courts" as previously published by BCS from 1969 through 1974.

Court disposition data from 1969 through 1974 were collected from the previous superior court reporting system. These data described lower and superior court dispositions of felony defendants as reported on the "Report of Criminal Proceeding" form (JUS 700) and the "Report of Felony Complaints" form (JUS 745). The 1975 OBTS data describe police, prosecutor, lower court, and superior court dispositions of adult felony arrests as reported on the "Disposition of Arrest and Court Action" form. Consequently, the data received and reported from these two different reporting systems may not be fully comparable.

9. During the transition from the previous system of reporting dispositions at the superior court level to the new OBTS system of reporting dispositions at all four levels, the 1975 data from several counties appear to be underreported. Like any newly implemented statistical reporting system, data are often incomplete during the developmental years.

10. Data in the lower and superior court "dismissed" category reflect the impact of the drug diversion program under Penal Code Section 1000.2. Basically there are two court actions in drug diversion situations. These are:

- a. The defendant is placed off-calendar upon entering a six-month to two-year drug diversion program. In lower court (Chart 1B), these defendants are included in the "dismissed" categories under both misdemeanor complaint actions and felony complaint actions.

In superior court (Chart 1C), these defendants are included in the "other" category of those defendants who are not convicted.

- b. If the defendant successfully completes the drug diversion program into which he was placed by the court, he returns to the court where the original charges against him are usually dismissed. In lower court (Chart 1B), these defendants are included in the "dismissed" categories under both misdemeanor complaint actions and felony complaint actions.

In superior court (Chart 1C), these defendants are included in the "dismissed" category.

Lower court defendants in these two categories accounted for 45.3 percent of the total lower court dismissals. Superior court defendants in these two categories accounted for 22.5 percent of the total number of superior court dismissal and "other" nonconviction actions.

THE DISPOSITION TREE FORMAT

The OBTS concept of tracking individual adult felony arrestees from the point of arrest to the point of final disposition stimulated the development of the disposition tree format. This type of data display shows the level and reason why each arrestee/defendant filtered out of the California criminal justice system. This type of format indicates the actions which were taken at the major decision points as the arrestee/defendant progressed through the state's criminal justice process.

Since 1975 is the first year that OBTS data have become available for most California counties (1974 OBTS data are available from BCS for Los Angeles, San Diego, Orange, and San Bernardino counties), it is appropriate to comment briefly on the general content and layout of this type of report in order to assist those new counties which have not previously been exposed to data in the OBTS disposition tree format.

Felony Disposition Summary

The first three pages in each six-page disposition tree report contain a Felony Disposition Summary for the police and prosecutor (Charts 1A, 2A, 3A), lower court (Charts 1B, 2B, 3B), and superior court (Charts 1C, 2C, 3C). Both numeric totals and percent calculations are indicated at each level shown. These data enable the user to see the number and proportion of the dispositions which have occurred at each level of the criminal justice system.

Elapsed Time Reports

In addition to displaying numeric and percent data, a series of elapsed time reports is also a standard part of the disposition tree report. These elapsed time data appear as the last three pages in each six-page disposition tree. These reports show the average elapsed time in days from the date of felony arrest to the date of the final disposition, regardless of whether that disposition takes place at the police or prosecutor (Charts 1D, 2D, 3D), lower court (Charts 1E, 2E, 3E), or superior court (Charts 1F, 2F, 3F) level.

The user will note that the general format of both the Felony Disposition Summary (pages A, B, C) and the Elapsed Time Report (pages D, E, F) is identical; the only difference being that numeric and proportional data are shown on the former, while elapsed time data in days are shown on the latter. Elapsed time data are computed automatically and are based upon the dates which are reported on the JUS 8715 form by local agencies as the individual progresses through the various levels of the criminal justice system.

The six-page disposition tree format, just described, is illustrated in Charts 1, 2, and 3 towards the end of this report. These charts contain disposition data on adult felony arrests made in the following jurisdictional areas:

- Chart 1 - Dispositions of Adult Felony Arrests in 56 Counties (Excluding Alameda and Santa Clara Counties)
- Chart 2 - Dispositions of Adult Felony Arrests in Los Angeles County
- Chart 3 - Dispositions of Adult Felony Arrests in 55 Counties (Excluding Alameda, Los Angeles, and Santa Clara Counties)

Disposition Data by Specific Offense, Race, Sex, Age, and County

In addition to data displayed in the disposition tree format, this report contains tabular displays of 1975 statewide (i.e., 56-county) OBTS data by arrest offense, race, sex, age, and county as well as by convicted offense and sentence.

The major arrest offense categories selected are: homicide, forcible rape, robbery, assault, burglary, theft, motor vehicle theft, and drug law violations (Tables 1, 2, 5, 6, 9, and 10). The various code sections which are grouped into each felony arrest offense category can be found in the glossary. Convicted offense data are contained in Tables 3, 4, 7, 8, 11, and 12. The racial categories selected include white, Mexican-American, Negro, and all other races (Tables 13-15). Data on the type of dispositions received by male and female arrestees/defendants are shown in Tables 16-17. Disposition data by age at the time of the felony arrest are reported in the following increments: 19 and under, 20-29, 30-39, and 40 and over (Tables 18-20). The dispositions of all adults arrested on felony charges and reported to BCS on the JUS 8715 form for each of the 56 counties participating in the OBTS system are reported in Tables 21 and 22.

Space limitations prohibited including a six-page disposition tree in this report for all of these data elements and jurisdictions; therefore, the data from the Felony Disposition Summary (pages A, B, C) section of approximately 125 disposition trees have been summarized in tabular format. Elapsed time data (pages D, E, F) have been omitted from Tables 1-22 because of space restrictions. The corresponding six-page disposition trees are available from BCS upon request by any contributing agency.

Types of Disposition Tree Reports

The 1975 OBTS disposition data are available in the following report formats:

- . 56 counties (excluding Alameda and Santa Clara counties - see Chart 1).
- . 55 counties (excluding Alameda, Los Angeles, and Santa Clara counties - see Chart 3).
- . Individual county reports based on county of arrest. This is restricted to 56 counties in 1975. (See Chart 2 for Los Angeles County report.)
- . Any selected arresting agency within the 56 counties.
- . Any selected statewide arrest offense.
- . Any selected filed offense in either municipal or superior court, or both, for the 56-county group.
- . Any selected convicted offense in either municipal or superior court, or both, for the 56-county group.
- . Any of the 56 counties in which a final court disposition occurs.
- . Any selected judicial district.

AN ANALYSIS OF THE CRIMINAL JUSTICE SCREENING PROCESS

The Offender-Based Transaction Statistics system traces adults, who are arrested on felony charges, from the point of arrest to the point of final disposition. A final disposition may occur at the law enforcement, prosecutor, lower court, or superior court level of the California criminal justice process. At each level, a screening process invariably takes place which results in a termination of the justice process for some persons, and the continuation of the justice process for other persons. Any number of variables can affect this screening process. These variables include such factors as the conditions of the arrest; the availability of witnesses; the type of complaint filed; the type of plea entered; the age, race, sex, or prior record of the defendant; the evidence presented; the sentencing options available to the judiciary; and other variables. Any or several of these factors may enter into the screening processes that take place following an adult arrest for a felony offense.¹

In 1975, there were 174,069 dispositions of adult felony arrests reported by local agencies in 56 counties (Alameda and Santa Clara counties were excluded). These dispositions were for adult felony arrests which were made in 1975 or in previous years. One out of two persons arrested on felony charges eventually left the criminal justice process without being convicted (Table 1). In analyzing the criminal justice screening process, the dispositions of these 174,069 adult felony arrestees are examined to see exactly where they filtered out of the criminal justice system.

Of the 174,069 persons arrested on felony charges¹ in 1975, only 4,561 (2.6 percent) were sentenced to state prison (Chart 1C, Tables 1-2). The judicial process required to obtain these felony convictions and prison commitments took an average of six months following the original arrest (Chart 1F).

Somewhere in the criminal justice process, the other 97.4 percent of felony arrestees received a disposition other than a prison commitment. Chart 1 shows the level of final 1975 dispositions for all 174,069 adults arrested on felony charges.

Law enforcement releases accounted for 8.5 percent of the adults originally arrested for felony offenses. The majority of these arrestees were released for insufficient evidence, followed by releases to other law enforcement agencies as in the case of persons arrested on out-of-jurisdiction warrants.

The screening process that took place at the prosecutor level resulted in another 13.5 percent of the original arrest group being released because the complaint was denied. Over half of these rejected complaints were due to "lack of probable cause" (Chart 1A).

The next screening took place at the lower court level (Chart 1B). Of the 134,725 complaints filed in lower courts, 33.1 percent of the defendants were not convicted, 39.4 percent were convicted as misdemeanants, and 27.6 percent were bound over to superior court for trial or sentencing. The reader should note that the proportion of lower court dismissals for all offenses (25.0 percent) appears to be inflated because of the extremely high proportion of felony drug offense arrests which was dismissed at the lower court level (41.7 percent).

Under provision 1000.2 P.C., defendants arrested for certain drug offenses may be placed into a drug diversion program and are subsequently diverted from the criminal justice process. Those defendants who successfully complete the terms agreed to in a six-month to two-year drug diversion program return to the criminal justice system where the original charges against them are dismissed. Nearly all drug diversions occur during the lower court arraignment proceedings. Both types of defendants (i.e., those entering drug diversion programs under 1000.2 P.C. and those successfully completing drug diversion programs) are statistically recorded as dismissals because the persons are diverted from the criminal justice system. This accounts for the disproportionate number (41.7 percent) of drug offense arrestees who were dismissed at the lower court level (Tables 1 and 2). A more detailed explanation of how drug diversion court actions are recorded statistically is contained in "Data Explanations and Limitations," item 10.

Of the 53,060 defendants convicted as misdemeanants and sentenced in lower courts, three out of four (74.5 percent) received sentences of either straight probation or probation and jail. Most of the remaining 25 percent were sentenced to county jail or fined.

The final screening in the criminal justice process takes place at the superior court level. Only 22.0 percent of the original number of adults arrested on felony charges appeared in superior court (Chart 1C). Of the 38,230 superior court defendants, 18.2 percent were not convicted and 81.8 percent were convicted. Approximately three out of five defendants (60.4 percent) were convicted after changing an initial plea of not guilty to a plea of guilty. Less than 8 percent of the convictions resulted from a jury trial.

Of those 31,263 defendants who were convicted in California superior courts in 1975, slightly more than seven out of ten defendants (71.0 percent) received commitments of probation and jail (49.5 percent) or straight probation (21.5 percent). These defendants comprised 12.8 percent of the original 174,069 persons who were arrested on felony charges. Of those who were convicted and sentenced, 14.6 percent received either death or a prison sentence. Those defendants who received the maximum possible sentence for the commission of a felony offense represented less than 3 percent of the original arrest group.

The level of conviction of these 31,263 superior court defendants may indicate the "seriousness" of the offenses for which they were convicted:

24,828	were convicted of a felony offense and received a felony sentence (79.4 percent).
5,019	were convicted of a felony offense and received a misdemeanor sentence (16.1 percent).
<u>1,416</u>	were convicted of a misdemeanor offense (4.5 percent).
31,263	Total 1975 superior court convictions in 56 counties.

ARREST DISPOSITIONS BY OFFENSE: DATA ANALYSIS

56-County Total

The data in Tables 1 and 2 show the 1975 dispositions of adult felony arrests made by criminal justice agencies in 56 counties for eight major offense categories.

The data are self-explanatory as presented; however, many other combinations of the data are possible. For example, the disposition process as applied to arrestees charged with crimes against persons (homicide, forcible rape, robbery, and assault) may be compared to the disposition process for individuals arrested for crimes against property (burglary, theft, and motor vehicle theft).

In addition, the dispositions of either or both of these offense-type categories may be compared to drug law violation dispositions to illustrate that persons arrested for drug offenses are handled differently in the California criminal justice system than are other felony arrestees. For example, law enforcement agencies released a considerably smaller proportion (3.7 percent) of felony drug law violators than individuals arrested for either crimes against persons (10.6 percent) or crimes against property (12.7 percent).

Prosecutors tended to file criminal complaints proportionately more often on persons arrested for drug law violations (78.6 percent) than on those arrested for crimes against persons (67.2 percent) or property crimes (65.5 percent). On the other hand, a much larger proportion of drug law violation defendants (68.8 percent) was disposed of in lower court than were persons involved in arrests for crimes against persons (43.1 percent) or against property (48.0 percent). However, due to the large number of drug law violation dismissals in lower court (41.7 percent), the conviction rate per arrest for drug offenses at the lower court level was slightly lower (26.7 percent) than the conviction rate for crimes against persons (27.9 percent) or crimes against property (34.1 percent).

Of the 33,720 arrestees for crimes against persons, only 29.9 percent were bound over to superior court where 24.7 percent were convicted. A prison sentence was received by 7.0 percent of those originally arrested for homicide, rape, robbery, or assault. Of the defendants who appeared in superior court for property crimes, 22.3 percent of the arrestees were convicted and 2.2 percent were sentenced to prison. Felony arrests for drug law violations resulted in a superior court conviction rate of 9.9 percent, with less than 1 percent of the defendants who were arrested for drug law violations receiving prison sentences. Statistical data on commitments by convicted offense, rather than by arrest offense, are shown in Tables 3 and 4.

A Comparison of Los Angeles County with the Other 55 Counties

Of the 56 counties participating in the OBTS reporting system in 1975, Los Angeles County accounted for 41.0 percent of the total number of adult felony arrest dispositions. Tables 5 and 6 show Los Angeles County data for the same eight major offense categories as shown in Tables 1 and 2. The 55-county data (excluding Alameda, Los Angeles, and Santa Clara counties) are shown in Tables 9 and 10.

Since Los Angeles County contributed 41 percent of the total felony arrest dispositions in the 56 counties, it seems appropriate to evaluate that county's criminal justice process separately from the data provided by the remaining 55 counties which contributed 59 percent of the total felony arrest dispositions. Generally speaking, the screening process that took place at the earlier stages of the criminal proceedings in Los Angeles County (law enforcement and prosecutor levels) reduced the proportion of felony arrestees which was handled by the courts. The highlights of such a comparison are:

- . In Los Angeles County, there was a higher proportion of arrests for crimes against persons (21.4 percent) than in the other 55 counties (17.9 percent).
- . Los Angeles County law enforcement agencies released a higher proportion of adult felony arrestees (10.1 percent) than did police agencies in the other 55 counties (7.4 percent).
- . Complaints were denied about twice as often in Los Angeles County (19.0 percent) as in the other 55 counties (9.6 percent).
- . Dispositions at the lower court level constituted a considerably lower proportion of the total dispositions in Los Angeles County (44.5 percent) than in the other 55 counties (64.1 percent).
- . The proportion of dispositions at the superior court level were somewhat higher in Los Angeles County (26.4 percent) than in the rest of the counties (18.9 percent).
- . The superior court conviction rate was also slightly higher in Los Angeles County (20.6 percent) than in the other 55 counties (16.1 percent).
- . Data from the 55 counties indicate that the proportion of defendants convicted in superior court who received prison sentences (2.7 percent) was about the same as those defendants convicted in Los Angeles County superior courts (2.5 percent).

Statistical data on commitments by convicted offense, rather than by arrest offense, are shown in Tables 7 and 8 for Los Angeles County and in Tables 11 and 12 for the 55 counties.

ARREST DISPOSITIONS BY RACE: DATA ANALYSIS

Tables 13-15 show data on the racial composition of adults arrested on felony charges and the level where a final disposition occurred. The overall distribution of the racial composition of adults arrested on felony charges and disposed of in 1975 is as follows:

The preceding summary table indicates a substantial difference in the level at which persons of various races received a final disposition in the 56 counties. A greater proportion of whites (62.9 percent) was disposed of at the lower court level than Mexican-Americans (54.0 percent) or Negroes (41.3 percent). In contrast, a greater proportion of Negroes (31.6 percent) and Mexican-Americans (24.9 percent) was either released by law enforcement agencies or prosecutors than whites (17.4 percent). There was also a considerable difference in the proportion of whites (19.7 percent), Mexican-Americans (21.2 percent), and Negroes (27.1 percent) disposed of at the superior court level.

The relative differences in the final level of disposition among the reported races were due, in part, to the types of felony offenses for which persons of each race were arrested. For example, there were 69,813 adults arrested for felony drug law violations in California in 1975.¹ Nearly 60 percent of the drug offense arrestees were white, 23 percent were Negro, and 17 percent were Mexican-American.

As mentioned earlier in this report, the provisions of Penal Code Section 1000.2 permit defendants appearing in court on drug charges to be placed in drug diversion programs. Since the proportion of whites arrested for drug law violations was almost 60 percent, and proportionately much greater than any other reported race, there was a larger proportion of white defendants diverted from the criminal justice system to drug diversion programs than defendants of other races. Most of these diversions took place at the lower court level. Therefore, drug diversion cases accounted, in part, for the racial variances shown in the proportions in the above summary table.

ARREST DISPOSITIONS BY SEX: DATA ANALYSIS

Data on the disposition of adult felony arrestees by sex in 56 counties, Los Angeles County, and in 55 counties are shown in Tables 16 and 17. Because there appears to be little difference between the 56-county, Los Angeles County, or 55-county data, the following analysis is based upon data from the 56-county total.

Males comprised 86.5 percent of the 174,069 adult felony arrest dispositions reported by the 56 counties for 1975. Females comprised 13.4 percent of the total, and the gender of the remaining 0.1 percent of the arrestees was not identified.

Proportionately, fewer females (6.9 percent) were released at the law enforcement level than males (8.8 percent). There are two reasons which may be responsible for this fact. First, data in Table 2 indicate that law enforcement agencies generally released proportionately fewer persons who were arrested for homicide, theft, and drug offenses. Second, the proportion of females arrested for these three felony offenses exceeded the average 13.5 percent shown for females arrested for all offenses.¹ Therefore, proportionately fewer females were released by law enforcement agencies.

A larger proportion of female defendants were disposed of at the lower court level (60.4 percent) than were male defendants (55.4 percent). Sentencing patterns differed between male and female defendants in lower court in that females received a larger proportion of straight probation sentences (15.8 percent) than did males (11.9 percent). All other lower court sentences showed a divergence of 1.6 percent or less between convicted males and females.

At the superior court level, proportionately more female defendants (5.6 percent) were granted straight probation commitments than were male defendants (3.6 percent). Males received prison commitments nearly three times more often (2.9 percent) than females (1.1 percent). Both males and females showed identical proportions for those who were fined and for those who were committed to the California Rehabilitation Center (CRC).

ARREST DISPOSITIONS BY AGE: DATA ANALYSIS

The age groupings of persons disposed of following an arrest on felony charges by law enforcement agencies in 56 counties appear in Tables 18, 19, and 20. For the purposes of this analysis, adults are defined as persons 18 years of age and older. Data on adult population were obtained from the California Department of Finance.

56-County Total

The total number of persons reported to have been disposed of in 1975, following a felony arrest, comprised slightly more than 1 percent of the total 1975 adult population (13,180,560) in the 56 counties. The majority of adults disposed of were between 20 and 29 years of age. This group accounted for 60.5 percent of the dispositions while the same age group comprised 25.5 percent of the total 1975 adult population in the 56 counties.

The data in Table 18 also indicate that three out of every four adults disposed of in 1975 were under 30 years of age. Those adult felony arrestees between 30 and 40 years of age accounted for just under 15 percent of the dispositions and those in the 40 and older category accounted for less than 9 percent of the dispositions.

A Comparison of Los Angeles County with the Other 55 Counties

While over half of the 1975 felony arrest dispositions in both Los Angeles County and the other 55 counties were for persons under the age of 30, those persons who received dispositions in Los Angeles County tended to be a little older than those persons who received dispositions in the other counties. In Los Angeles County, 72.1 percent of the dispositions were for the under 30 age group, while in the other counties 78.3 percent of the dispositions were for the under 30 age group. The under 30 adult population in both Los Angeles County and the other 55 counties was almost 31 percent of the 1975 adult population.

Another difference is that for each reported age group, a greater proportion of superior court dispositions occurred in Los Angeles County (26.4 percent) than in the other 55 counties (18.9 percent). Conversely, a greater proportion of lower court dispositions occurred for each reported age group in the 55 counties (64.1 percent) than in Los Angeles County (44.5 percent).

One possible reason for this may be attributed to local procedures for screening the adult felony arrestee at various levels in the criminal justice system. It appears that lower courts in the 55 counties were called upon to screen out proportionately more adult felony arrestees than were Los Angeles County lower courts. In Los Angeles County, 29.1 percent of the total arrestees were screened out at the police or prosecutor level, while in the other 55 counties, the police or prosecutor eliminated 17.0 percent of the arrestees from the criminal justice system, thereby placing a greater screening load upon the courts.

Summary of Age Analysis

Three general observations can be made about the 1975 age disposition data:

- . The under 30 age group accounted for slightly over three-fourths (75.7 percent) of all dispositions of felony arrests in the 56 counties.
- . Felony arrestees disposed of in Los Angeles County appeared to be older than in the other 55 counties. The 30 and over age group in Los Angeles County accounted for 27.2 percent of the total dispositions as compared to 20.9 percent for this age group in the other 55 counties.
- . Age appears to be directly related to court convictions. The older the age group, the higher the proportion of court convictions within that age group. One reason for this trend is that older defendants have a greater history of prior criminal activity. Consequently, defendants with heavier prior records are more likely to be convicted than those with no or minor criminal histories. This is apparent in the table below:







- Following a bail or an O/R (Own Recognizance) release, additional time may be required to secure sufficient evidence to prosecute the case. If no rebooking takes place when the individual is rearrested (and a new "Disposition of Arrest and Court Action," form JUS 8715, is initiated) the district attorney date (i.e., DAD) is computed from the original arrest date thereby inflating the elapsed time at this level.



















LOWER COURT COMPLAINTS





CRIMINAL JUSTICE GLOSSARY

The glossary contains the definitions of general terms used in this publication. The terminology relates to the Offender-Based Transaction Statistics (OBTS) system and the disposition trees shown in Charts 1-3.

ACQUITTAL: a judgment of a court, based either on the verdict of a jury or a judicial officer, that the defendant is not guilty of the offense(s) for which he has been tried.

ADULT: a person 18 years of age or older.

ARRAIGNMENT: the appearance of an accused person before a court in order that the court may inform him of the formal accusation(s) against him and hear his plea.

ARREST: "taking a person into custody, in a case and in the manner authorized by law. An arrest may be made by a peace officer or by a private person." (California Penal Code, Section 834)

ARREST WARRANT: a written document signed and issued by a magistrate and directed to a specifically named person, ordering that person to arrest another specifically named person who is accused of a specific offense.

BENCH WARRANT: a warrant issued by a court of record authorizing the arrest of an accused person.

BOOKING: a police administrative action officially recording an arrest and identifying the person, the place, the time, arresting authority, and the reason for the arrest.

CALIFORNIA REHABILITATION CENTER (CRC): a state institution operated by the State Department of Corrections which is designated for the treatment of persons addicted to narcotics or in imminent danger of addiction. Commitment to the facility is by civil procedure only.

CALIFORNIA YOUTH AUTHORITY (CYA): the state agency which has jurisdiction over and maintains institutions as correctional schools for the reception of wards of the juvenile court and other persons committed from justice, municipal, and superior courts.

CERTIFICATION: a type of filing used when the defendant has pled guilty to a felony charge at the preliminary hearing in lower court. The defendant is certified (referred) to superior court for sentencing and final disposition.

CERTIFIED GUILTY PLEA: a certified statement to superior court that the defendant has pled guilty to a felony charge in the lower court.

CHARGE: a formal allegation that a specific person has committed a specific offense. In the OBTS system the offense for which the person was arrested is the "charged" offense.

CIVIL COMMITMENT: type of commitment in which criminal proceedings are suspended while a defendant undergoes treatment at the California Rehabilitation Center (CRC) as a narcotic addict, or in a state hospital under the Department of Health as a mentally disordered sex offender or as a person declared insane.

COMPLAINT: a verified written accusation, filed with a local criminal court, which charges one or more persons with the commission of one or more offenses (see **FELONY COMPLAINT** and **MISDEMEANOR COMPLAINT**).

COMPLAINT DENIED: the decision by a prosecutor not to file a complaint against a specific person for a specific offense.

COMPLAINT GRANTED: the decision by a prosecutor to file a complaint against a specific person for a specific offense.

COMPLAINT REQUESTED: a request by a law enforcement agency that the prosecutor file a complaint against a specific person for a specific offense.

CONTINUANCE: the postponement of the trial of a specific defendant granted by the court before which the case is to be tried.

CONVICTION: a judgment, based either on the verdict of a jury or a judicial officer or on the guilty plea of the defendant, that the defendant is guilty of the offense(s) for which he was tried.

COUNT: each charge listed in an indictment, information, or complaint.

COURT: an agency of the judicial branch of government, authorized or established by statute or constitution, and consisting of one or more judicial officers, which has the authority to decide upon controversies in law and disputed matters of fact brought before it.

CRIME: "an act committed or omitted in violation of law forbidding or commanding it..." (California Penal Code, Section 15)

DEATH PENALTY: the most severe penalty that can be imposed following a conviction for selected offenses.

DEFENDANT: a person against whom a criminal proceeding is pending.

DISMISSAL: a decision by a judicial officer to terminate a case without a determination of guilt or innocence.

DISPOSITION - COURT: an action taken as the result of an appearance in court by a defendant. Examples would be: dismissed, acquitted, or convicted.

DISPOSITION OF ARREST AND COURT ACTION: a reporting form (JUS 8715) used to collect disposition information from police, prosecutors, and courts on adults arrested on felony charges. All information is based upon the year in which the final disposition occurred.

DISPOSITION - POLICE: a final disposition at the police level following a felony arrest. Arrestees may be released under California Penal Code Section 849b(1) for the following reasons: exoneration, further investigation necessary, insufficient evidence, complainant refuses to prosecute, released to another agency as in the case of an out-of-jurisdiction warrant, etc.

DISPOSITION - PROSECUTOR: an action taken as the result of complaints which were requested by the arresting agency. Dispositions include granting a misdemeanor or a felony complaint or denying a complaint for such reasons as lack of corpus, lack of probable cause, interest of justice, victim declines to prosecute, witnesses unavailable, illegal search and seizure, combined with other counts, etc.

DISPOSITION TREE: a report format which shows the number of defendants, percent, and the level (i.e., police, prosecutor, lower court, or superior court) where a final disposition takes place.

DRUG DIVERSION: per California Penal Code, Section 1000, criminal proceedings are suspended for selected first-time drug offenders while they are participating in a community-based treatment program. Following successful completion of the program, the original charges against the drug offender may be dismissed.

DRUGS: (a) a substance officially recognized as such; (b) intended for medical use; (c) a non-food, used to change the structure or function of the body and; (d) substances intended for use as a component in (a) through (c) above.

ELAPSED TIME: a report showing the average (mean) elapsed time in days from the point of arrest on felony charges to the point of final disposition.

EXISTING CRIMINAL STATUS: type of correctional supervision at the time of the arrest which led to the disposition of the defendant in superior court. Categories include:

None: not under commitment.

Probation: on probation with California, federal, or other state agencies.

Parole: on parole with California, federal, or other state agencies.

Institution: confined in California, federal, or other state penal institution.

EXONERATED: the act of freeing a person from an accusation or charge.

FELONY: "a crime which is punishable with death or by imprisonment in the state prison." (California Penal Code, Section 17)

FELONY ARRESTS: a term used on the OBTS disposition reports to describe adults arrested on felony charges whose disposition (i.e., not arrest) occurred in the year reported. Arrests may have occurred in the same year as the final disposition or in previous years.

FELONY COMPLAINT: a verified written accusation, filed with a local criminal court, which charges one or more persons with the commission of one or more felonies.

FILING: a document filed with the municipal court clerk or county clerk by a prosecuting attorney alleging or accusing a person of committing or attempting to commit a crime.

FINE: the penalty imposed upon a convicted person by a court requiring that he pay a specified sum of money.

GRAND JURY: a sworn body of persons authorized by law to evaluate evidence and issues of fact supporting accusations against suspects in order to determine whether or not an indictment should be returned.

GUILTY: a court finding that a defendant should be held responsible for the criminal offense with which he is charged in the finding.

GUILTY PLEA: a defendant's formal answer in open court to the charges in the indictment or information, stating that the charges are true and that he has committed the offense as charged.

HELD TO ANSWER: following a preliminary hearing in the lower court, the defendant is bound over to the superior court to be arraigned and tried on felony charges.

INDICTMENT: a formal written accusation charging one or more persons with the commission of a crime, presented by a grand jury to the superior court when the jury has found, after examining the evidence presented, that there is a valid case.

INFORMATION: an information filing is a formal accusation of crime(s) differing from an indictment only in that it is presented by a prosecuting attorney instead of a grand jury. Information filings are used when the lower court determines, at the preliminary hearing, that there is sufficient evidence to hold the defendant for a felony trial and prosecution at the superior court level.

JAIL: a county or city facility for incarceration of sentenced or unsentenced persons.

LACK OF CORPUS: a lack of proof that all of the essential elements of a crime have been committed.

LAW ENFORCEMENT AGENCY: a federal, state, or local criminal justice agency of which the principal functions are the prevention, detection, investigation of crime, and the apprehension of alleged offenders.

LOWER COURT WARRANT: a lower court process directing a peace officer to arrest a defendant and bring him before the court.

LOWER COURTS: the municipal and justice courts.

MENTALLY DISORDERED SEX OFFENDER (MDSO): "...any person who, by reason of mental defect, disease, or disorder, is predisposed to the commission of sexual offenses to such a degree that he is dangerous to the health and safety of others." (California Welfare and Institutions Code, Section 6300)

MISDEMEANOR: a crime punishable by imprisonment in the county jail, by a fine, or by both. Under certain conditions defined by Section 17 of the Penal Code, a felony crime can be treated as a misdemeanor.

MISDEMEANOR COMPLAINT: a verified written accusation by a person, filed with a local criminal court, which charges one or more persons with a commission of one or more offenses, at least one of which is a misdemeanor and none of which is a felony.

MONTHLY ARREST AND CITATION REGISTER: a reporting system used to collect information on all adult and juvenile arrests. The Arrest Register reports detailed data which identifies individual age, sex, and race characteristics and creates a link to subsequent court activity. All information is based upon the year in which the arrest occurred.

MUNICIPAL OR JUSTICE COURT: the court of original or trial jurisdiction for adults being prosecuted for misdemeanors and those certain felonies which may be tried as misdemeanors. Also, municipal and justice courts conduct probable cause preliminary hearings for those felonies which are subject to jurisdiction of superior courts - the felony trial court.

NOLO CONTENDERE: a defendant's formal answer in court to the charges in a complaint, information, or indictment, in which he states that he does not contest the charges, and which, while not an actual admission of guilt, subjects the defendant to the same legal consequences as a plea of guilty.

OBTS: an abbreviation for the Offender-Based Transaction Statistics system.

OFFENSE: a charged offense is the offense for which the defendant was arrested. A convicted offense is the offense which the defendant was convicted of or pled guilty to in court.

PAROLE: the supervision of adults in the community after an early release from a county jail or state prison.

PLEA: the defendant's formal answer in open court to the charges in a complaint, an indictment, or an information.

PLEA OF NOT GUILTY: a plea entered by the defendant denying guilt for the offense charged and thereby putting the state to the proof of all of the material elements of the charged offense(s).

PRIOR CRIMINAL RECORD: the criminal record prior to the arrest which led to the disposition of the defendant in superior court. Categories include:

None: no arrests.

Minor: one or more convictions with sentences of less than 90 days jail or fine, or probation of less than two years.

Major: any number of convictions with sentences of 90 days or more jail, or probation of two years or more.

Prison: any number of prison commitments.

PRISON: a state facility where adults are confined following conviction of a felony offense.

PROBATION (SENTENCE): a court requirement that a convicted person fulfill certain conditions of behavior and accept the supervision of a probation agency, usually in lieu of a sentence of confinement.

PROBATION WITH JAIL: a type of disposition rendered upon conviction which imposes a jail term as a condition of probation status.

PROSECUTOR: an attorney employed by a governmental agency whose official duty is to initiate and maintain criminal proceedings on behalf of the government against persons accused of committing criminal offenses.

PUNISHMENT: the minimum sentence for a felony conviction is six months in state prison, maximum is death. Misdemeanor convictions are punishable by imprisonment in the county jail for one day to one year, or by a fine, or both.

RELEASED ON OWN RECOGNIZANCE (O/R): a procedure of guaranteeing the appearance of an alleged offender at a court proceeding by requiring him to sign an agreement to appear as required. The defendant is allowed to be at liberty pending further action and agrees to return to court when so instructed.

SENTENCE: see PUNISHMENT.

SENTENCE SUSPENDED: the court decision postponing the pronouncing of sentence upon a convicted person, or postponing the execution of a sentence that has been pronounced by the court.

STRAIGHT PROBATION: probation granted to adults with no condition or stipulation that the defendant serve time in jail as a condition of probation.

SUPERIOR COURT: the court of original or trial jurisdiction for felony cases and all juvenile hearings. Also, the first court of appeals for municipal or justice court cases.

SUPERIOR COURT WARRANT: a superior court process directing a peace officer to arrest a defendant and to bring him before the court.

TRIAL: a formal examination of the facts of a case by a court of law to decide the validity of a charge. There are three types of trials:

Court - the decision is rendered by the judge.

Jury - the decision is rendered by a 12-member panel of the defendant's peers.

Transcript - the decision is rendered by the court on the basis of the testimony contained in the transcript of the preliminary hearing held in lower court.
