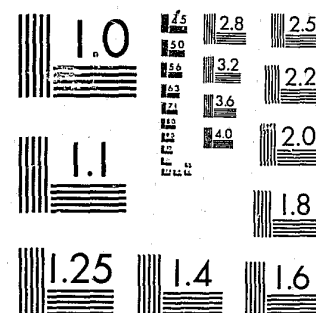

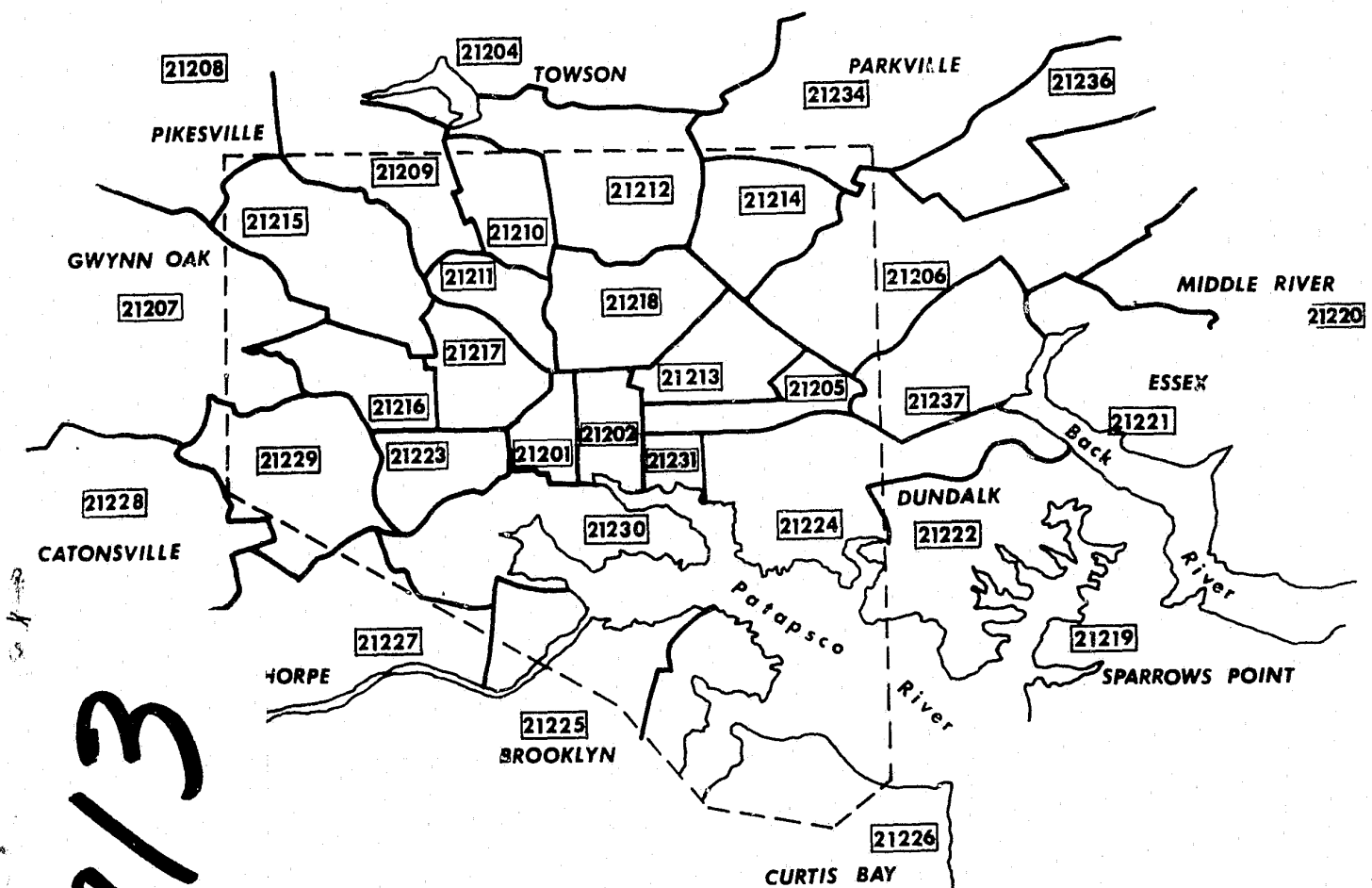

Introduction

This publication is the third in a series of demographic presentations identifying juvenile offender activity by ZIP CODE throughout the State of Maryland. Two earlier editions, "Juvenile Cases by Zip Code 1968-1969" and "Juvenile Cases by Zip Code 1968-1971" similarly identify juvenile offender activity by political subdivision and zip code areas within each political subdivision. Because the boundaries of some zip code areas overlap political subdivision boundaries, the post office zip code is identified as the focal point of juvenile activity in each zip code area.

The statistics in the publication are primarily concerned with those cases in which the juvenile resides in the same political subdivision in which the offense or referral occurred and over which the respective juvenile court has jurisdiction. Juvenile cases in which the juvenile resides outside the political subdivision in which the offense or referral occurred are included in summary form only. This was done in order to maintain primary perspective on the problem as it relates to jurisdictional responsibility of resident cases within the various political subdivisions.

Types of Data

In addition to political subdivision and zip code area, juvenile cases are further broken down by the age of juveniles, the types of cases, and the manner of handling cases. The types of cases are classified as either delinquent, Children in Need of Supervision (CINS), or non-delinquent including neglect/dependency cases or special proceedings. The manner of handling is classified as either formal, informal, or disapproved/closed at intake. Formal cases are those cases which are

placed on the official court docket for adjudication by a judge or designate through the filing of a petition. Informal cases are those cases which are not placed on the official docket, but are adjusted by a judge, designate, probation officer or other officer of the court. Disapproved cases are those rejected due to legal insufficiency while closed at intake cases are those which were resolved with only minimal involvement of juvenile authorities.

Zip Code Areas

Zip code post office areas were used instead of census tracts to identify geographic areas because of their greater familiarity to both the general public and to the personnel preparing the court records in the various counties. In addition, zip codes provide a more detailed breakdown of data in some counties where census tracts are larger.

It should be noted that in the larger metropolitan areas of Baltimore and the District of Columbia, zip code areas often overlap partially into the adjacent political subdivision. In these cases, the same zip code post office number and name will appear in each of the subdivisions into which it overlaps along with that proportion of cases which reside in each respective subdivision. These zip code post office designations are followed by the term "part" along with the number of cases which resided in each respective "part". A complete total of these "parts" is shown in a map of the total Baltimore metropolitan areas showing the boundary lines which overlap into the adjacent subdivisions.

Changes in Format

Due to the prolonged period since the last edition of the series, the current publication has extended the time period to include data covering the period from 1970-1980. The years selected are typically representative of this period and are intended to provide the viewer with a better perspective of the juvenile problem during the entire decade. During this period, the volume of juvenile offender activity increased statewide from 26,236 referrals in 1970 to 46,845 referrals in 1980, an increase of more than 77%. However, this increase is not as dramatic as it might seem since the peak number of juvenile referrals was reached in 1976 when the total number of referrals was 58,044. Since 1976 the number of referrals has declined steadily to its present number and while the declining trend appears to be leveling off, no dramatic increases in referrals is anticipated in the immediate future.

Another important change occurred in the processing of juvenile cases since the last publication of the series. The manner of handling cases, which formerly were either formal (official) or informal (unofficial) has been extended to include two additional categories, "disapproved" and "closed at intake." Disapproved cases are those which have been rejected in the intake screening process because of legal insufficiency. Closed at intake cases are those which are resolved satisfactorily with only a minimum of involvement on the part of the complainant, juvenile authorities and the juvenile charged. These two groups are treated collectively as one in the publication since they usually involve the least serious of complaints.

In resuming publication of this series, it is intended to provide the public with the means for a more current assessment of the juvenile

problems not only at the state and county levels but also at local community levels which can identify with specific zip codes. The increasingly numerous individual requests for zip code data from public, private, and individual sources attests to a substantive need for this type of information on a more frequent, regular basis.

Highlights

Urban Oriented Problem

The problem of juvenile crime in Maryland continues to be primarily an urban one. Five political subdivisions with 1980 populations of 250,000 or more each, Baltimore City, Montgomery, Prince George's, Baltimore and Anne Arundel Counties, collectively accounted for three of every four juvenile cases (79%) in 1980. This reflects a decrease from almost 81% in 1970, suggesting that while juvenile crime is still a major urban problem, the less urban oriented areas are beginning to experience more juvenile crime proportionately than in previous years.

Number of Zip Code Areas

A total of 459 zip code areas of a total of approximately 500 areas in the 24 political subdivisions in the state reported juvenile cases in 1980. This compared with 372 in 1970, an increase of 23%. This indicated that while there are still some areas in the state where there are no juvenile problems, the number of such areas is steadily decreasing, as evidenced by the increasing number of zip code areas reporting juvenile cases.

Non-Resident Cases

The increased mobility of today's youth has resulted with increasing frequency in offenses being committed outside the political subdivision in which the juvenile resides. Of the juvenile cases disposed of in 1980, 12.0% involved non-residents of the political subdivision in which the offense or referral occurred.

County With Most Reporting Zip Codes

The political subdivision with the largest number of reporting zip code areas was Baltimore County with 48. This county with a 1980

population of 655,615 reported 6,554 juvenile cases, a rate of 99 cases per 10,000 general population.

County With Least Reporting Zip Codes

Caroline County was the subdivision reporting cases from the fewest zip code areas, eight (8). With its 1980 population of 23,143, the county rate was 98 cases per 10,000 general population. Caroline County replaced Garrett County as the jurisdiction showing fewest reporting zip codes.

Baltimore City Rate

Baltimore City with 31 zip code areas reporting juvenile cases counted the largest number of cases for any single political subdivision, 14,644. With its 1980 population of 786,775, the rate of juvenile cases was second highest, 186 cases per 10,000 general population, almost twice as high as for Baltimore County.

Ocean City Impact

Worcester County which reported 848 cases, had the highest juvenile case rate of any of the 24 political subdivisions, 274 cases per 10,000 general population, based on the 1980 county population figure of 30,889. However, this high rate is due primarily to the summer influx of visitors to Ocean City. The majority (79.0%) of the cases disposed of in 1980, as in previous years, involved juvenile residing in areas located outside the county.

Juvenile Court Cases by Age of Juvenile

A majority of the juvenile cases referred to the juvenile courts were between 15 and 17 years old (62.8%) in 1980. Juveniles under 11 years of age comprised only 4.5% of the cases referred while 29.8% were between 11 and 15 years of age. Significantly, the proportion of juveniles under 11 years decreased almost 8% since 1971 while 16 year

olds replaced the 17 year old group as the largest single age group with almost 22% of all the cases.

Manner of Handling

In 1980, 31.3% of the cases were handled formally, while 17.1% were handled as informal cases. Cases closed at intake accounted for 45.3% while disapproved cases involved 6.3% of the referrals.

Type of Cases Handled

A majority (87.5%) of the 1980 cases involved delinquency complaints while 9.0% involved Children in Need of Supervision and 3.5% involved non-delinquency complaints. Comparable statistics in the last publication in 1971 revealed that 71.4% involved delinquency, 18.1% CINS, and 10.5% CINA. This represents a significant change in the type of cases handled, with the percentage of the latter two groups decreasing substantially. (CINA cases are Children in Need of Assistance, i.e., dependency and neglect cases.)

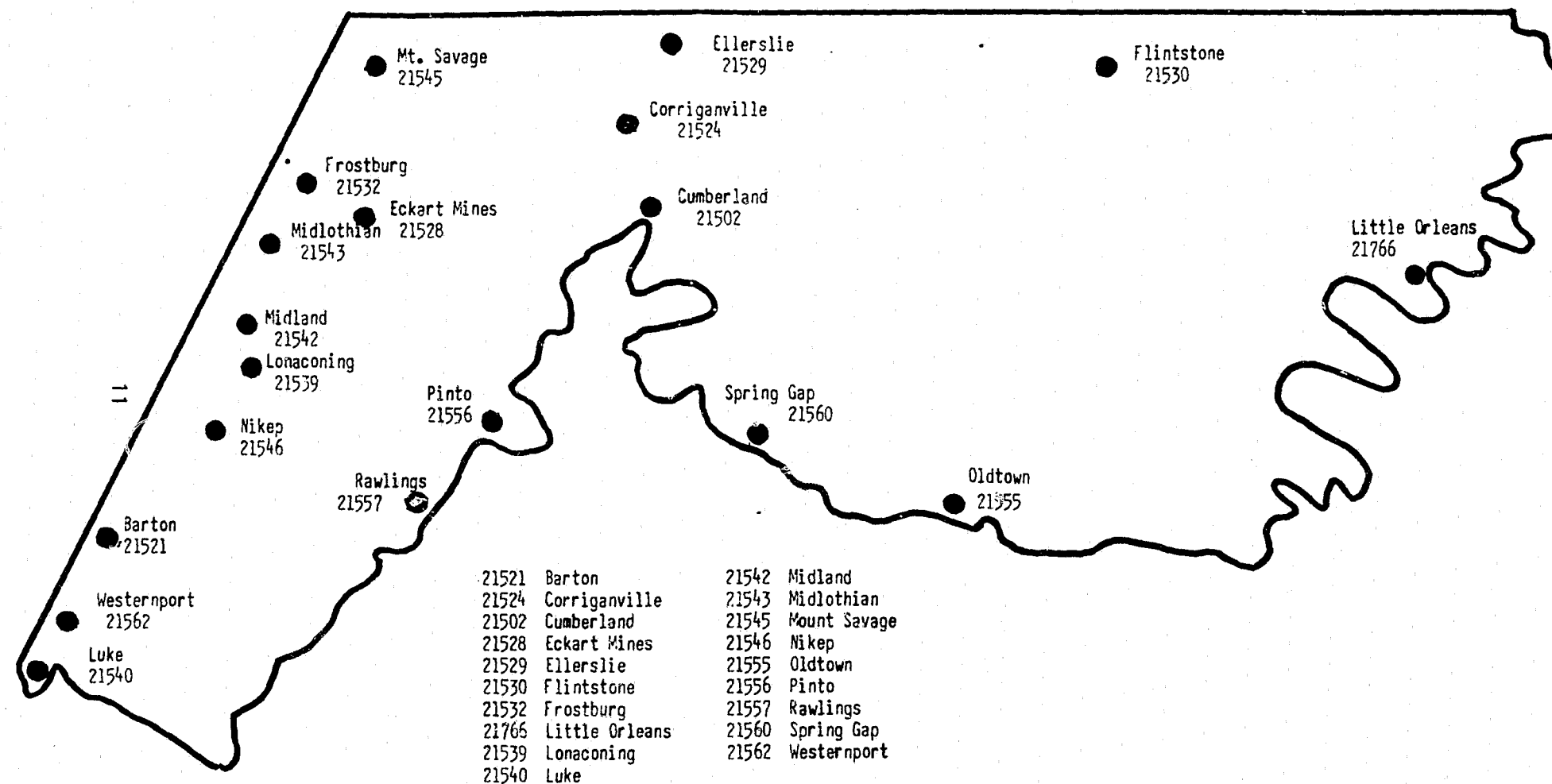
Juvenile Referrals
Allegany County
Fiscal 1980

The total number of juvenile cases handled in Allegany County in 1980 was 452, an increase of 4.1 percent of the number handled in 1978. Cases involving county residents accounted for 76.1% of the total number of cases. This represented a decrease of 5.8% of the in-county cases since 1978. Cases involving out-of-county residents increased by 56.5% compared to 1978. Four county zip code areas reflected an increase in the number of cases, eleven areas showed a decrease and four remained the same.

The area served by the Cumberland Post Office, the largest urban area in the county, was responsible for 79.9% of the juvenile cases involving residents in 1980. This was followed by Frostburg with 11.9% of the resident cases.

Of the total number of juvenile cases handled in 1980 that involved county residents, 23.8% involved juveniles under fourteen years of age and 14.2% involved fourteen year olds, 20.1% involved fifteen year olds, 17.4% involved sixteen year olds, and 22.1% involved seventeen year olds. Of the resident cases, 77.9% were for delinquency referrals, 13.3% involved Children in Need of Supervision (CINS), and 8.7% were for referrals of Children in Need of Assistance (CINA) or special proceedings.

While 79.4 of the cases involving county residents were handled formally, only 0.3% were handled informally. Of the formal resident cases, 72.9% involved delinquency cases, 16.1% involved CINS, and 11.7% involved CINA or special proceedings.

Fiscal 1980

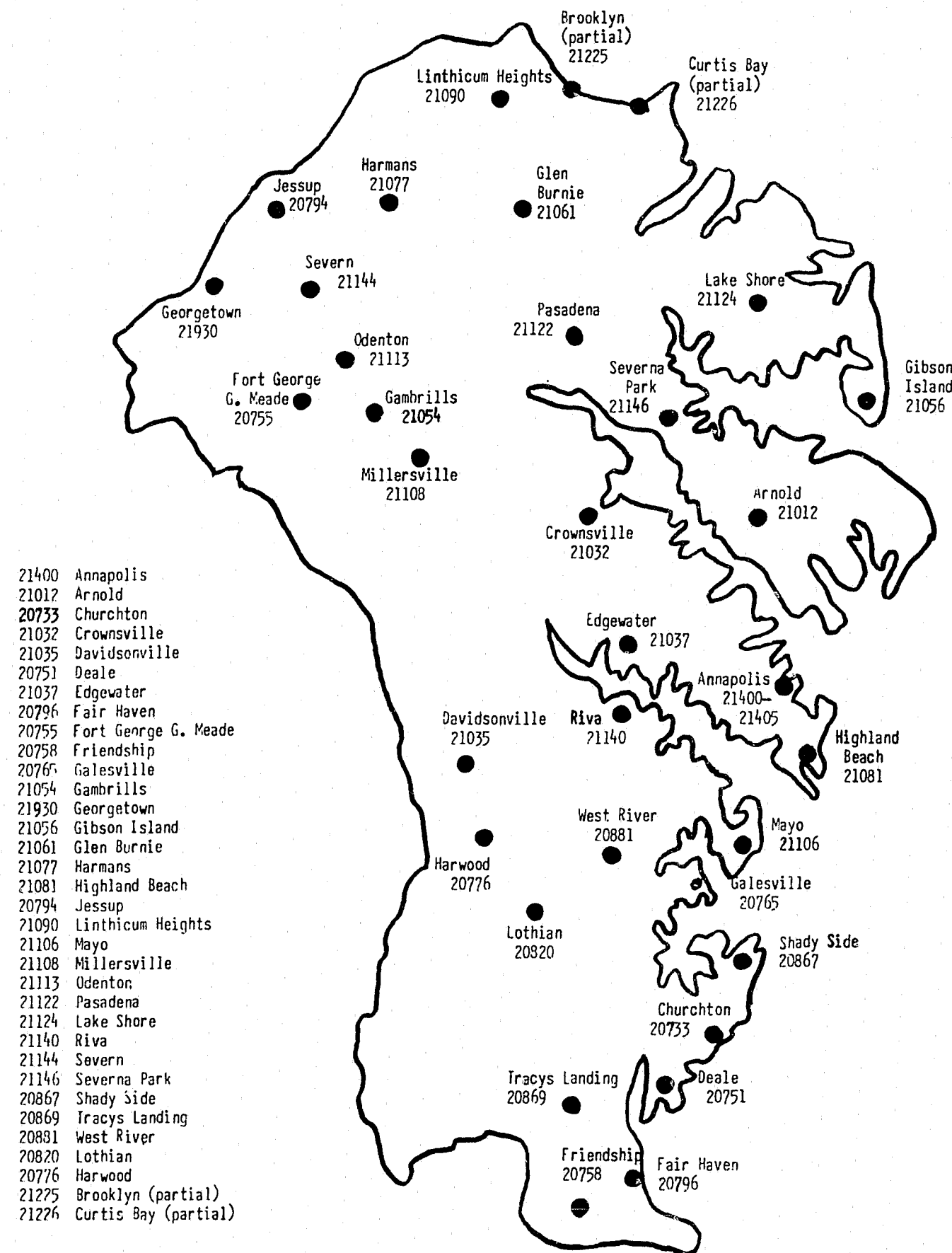
The Juvenile Services Administration in Anne Arundel County handled 3,820 cases during fiscal 1980, a 22.8% decrease from the number of cases in 1978. Cases involving county residents, which accounted for 90.3% of the total cases, decreased 23.3%. Non-resident cases decreased 18.1% during 1980.

The Annapolis area, represented by eight different zip codes, reported the largest number of resident cases with 21.3% of the resident cases, a 7.0% decrease compared with 1978. The Glen Burnie area reported 20.1% of the resident cases. Cases were reported by 37 zip code areas during fiscal 1980; twelve reported increases; decreases were reported in 24 areas while one remained the same.

Of the cases involving county residents during 1980, 34.9% involved juveniles under fifteen years of age, juveniles fifteen years of age accounted for 20.8% of the cases, sixteen year olds accounted for 22.8% of the cases, seventeen year olds accounted for 19.7%.

The cases involving county residents were handled as follows: 27.7% were formalized, while 27.3% were put on informal supervision, and 44.9% were disapproved or closed at intake.

Of the 957 formal resident cases, 82.2% were for delinquency referrals, 1.1% were for CINS referrals, and 16.6% were for CINA or special proceeding referrals.

Juvenile Referrals
Baltimore County
Fiscal 1980

The Baltimore County Juvenile Court reported an increase of 29.3% in the total number of juvenile cases handled, from 5,068 in 1978 to 6,554 cases in 1980. Of the 57 zip code areas in the county, 38 showed an increase in referrals, 10 showed a decrease, and 9 remained unchanged. The number of cases involving county residents increased 26.5% and the cases involving juveniles residing in zip code areas outside the county increased by 49.7% during the same period.

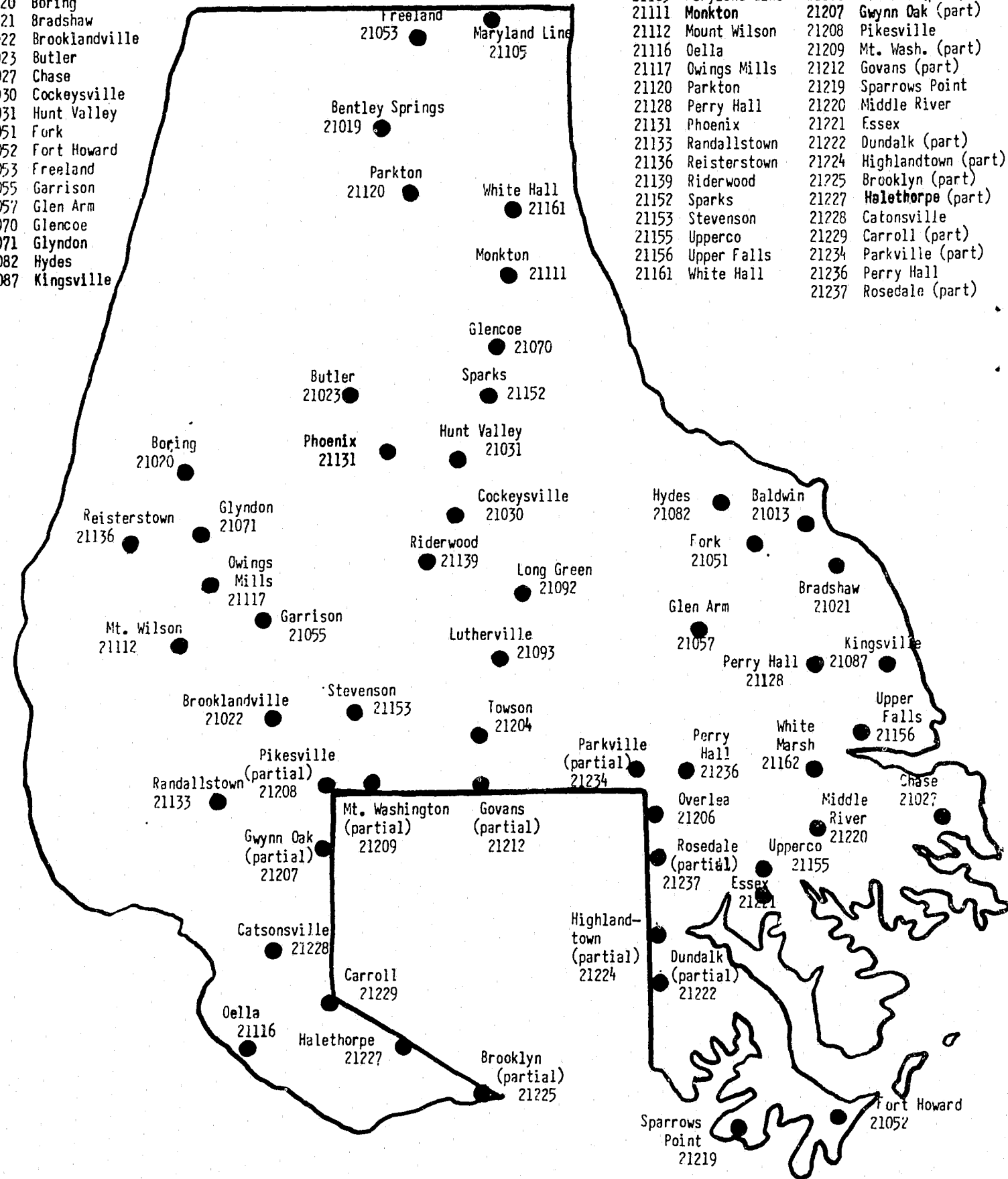
It should be noted that a number of zip code areas served by the Baltimore City Post Office overlap into Baltimore County while others are entirely in that county. Cases involving juveniles in these areas are reported by the respective subdivision having legal jurisdiction over the area in which the offense or referral occurred.

Of the 5,623 resident cases handled in fiscal 1980, a majority (82.9%) involved juveniles fourteen years of age or older. The largest percentage of the cases involved juveniles sixteen years old (23.6%) or seventeen years old (22.1%).

The breakdown of resident cases by manner of handling for formal, informal, and closed cases was 30.0%, 20.2%, and 49.8% respectively. Of the formal resident cases, most were for delinquency referrals followed by CINA or special proceedings and CINS cases. 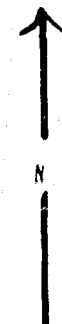

The total number of cases that were handled by the Juvenile Services Administration in Calvert County increased 44.7% from fiscal 1978 to fiscal 1980. Cases involving county residents accounted for 86.7% of the total cases handled and increased 40.3% from fiscal 1978. Out-of-county cases increased 82.2% during the same period.

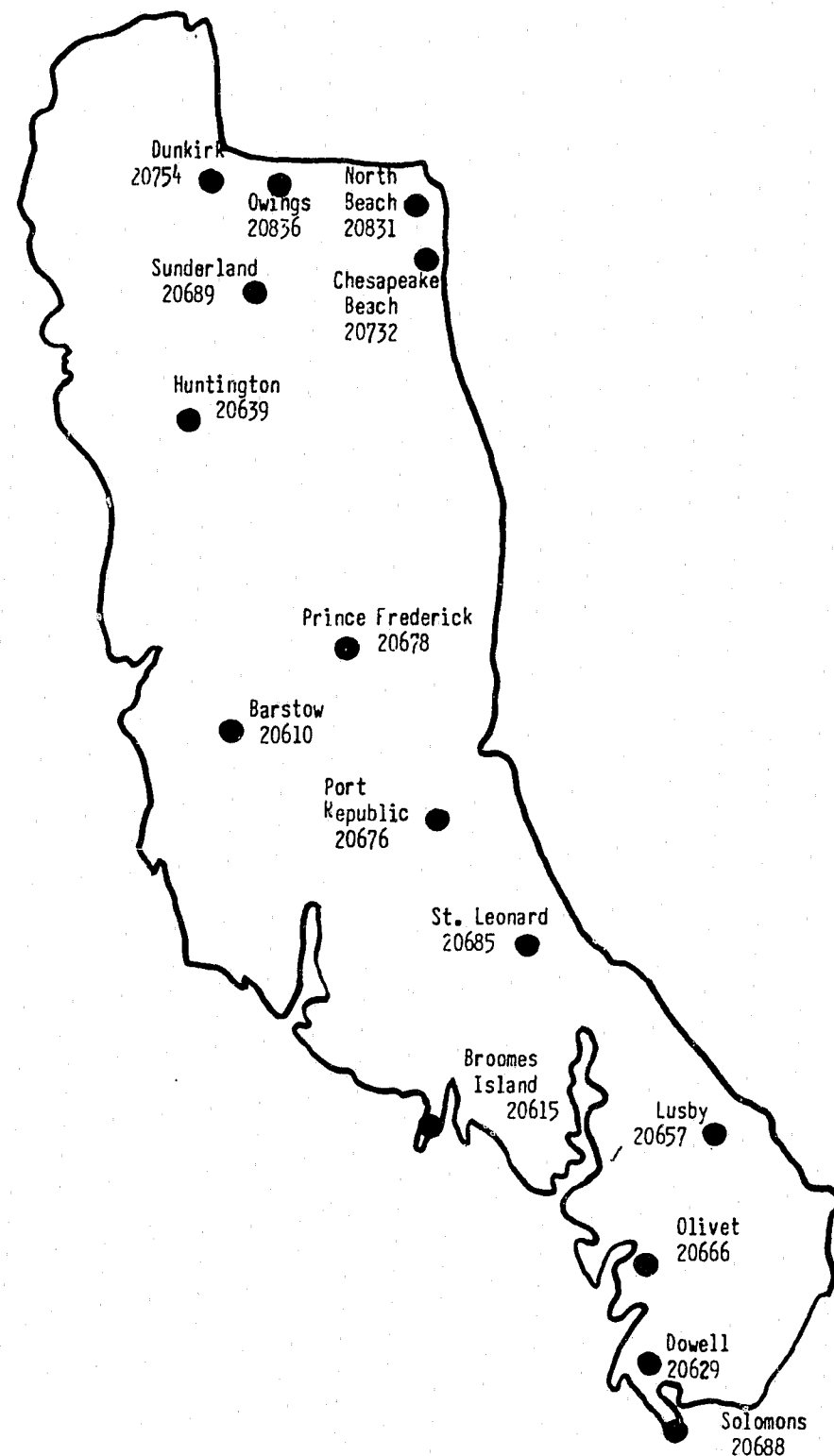
The 533 cases handled during 1980 that involved county residents represented fourteen different zip code areas. Of these areas, ten reflected an increase in the number of cases while four reflected a decrease.

Of the resident cases handled during fiscal 1980, almost half (47.3%) involved juveniles under fifteen years of age. Juveniles fifteen years old accounted for 22.3%, sixteen year olds accounted for 16.1%, and 14.3% involved juveniles seventeen years of age or older.

The distribution of resident cases was as follows: 37.1% were referred to court, 35.3% were put on informal supervision, while 27.6% were disapproved or closed at intake. Of the 198 cases involving county residents that were handled formally, 81.8% involved delinquency cases, 2.0% involved Children in Need of Supervision, and 16.2% involved Children in Need of Assistance and special proceedings. Of those cases handled informally, 73.9% involved delinquency cases, 25.0% involved CINS cases, and 1.1% involved CINA or special proceedings cases.

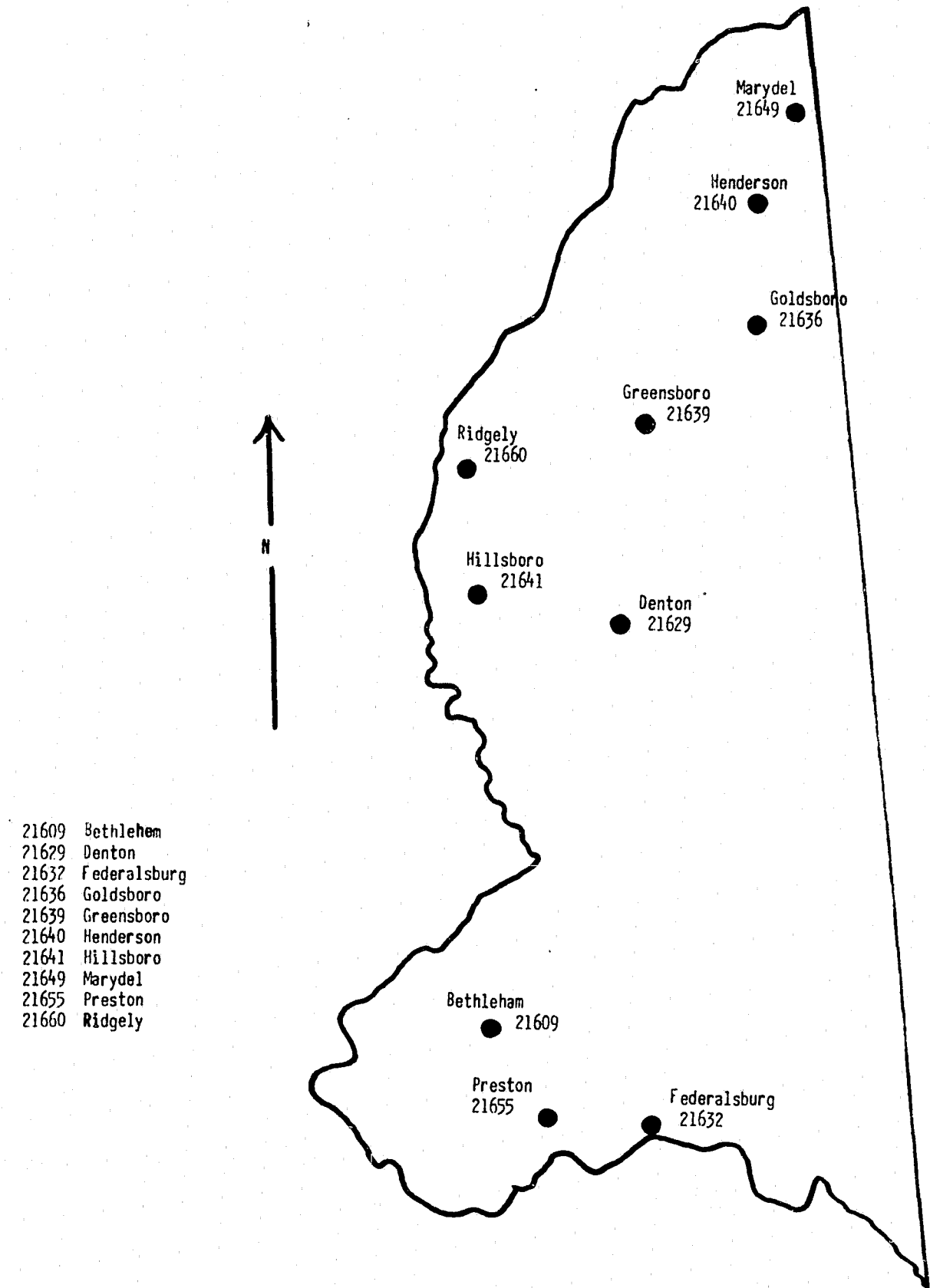

The total number of cases handled by the Juvenile Services Administration in Caroline County increased by 37.1% from 167 cases in fiscal 1978 to 229 cases in fiscal 1980. Cases involving county residents accounted for 87.8% of the total cases and increased 42.6% over 1978. The number of cases involving out-of-county residents increased by 7.7%.

The 201 cases involving county residents represent eight different zip code areas. Of these, seven reported an increase in the number of cases and one reported a decrease.

Juveniles fifteen years of age and younger accounted for 52.2% of the resident cases handled during fiscal 1980. Sixteen year old juveniles accounted for 22.9%, and seventeen year old juveniles accounted for 22.4% of the cases.

The largest percentage of cases involving county residents were disapproved or closed at intake (42.3%), 28.4% were handled formally and 29.4% were handled informally. Of the formalized resident cases, 84.2% were for delinquency referrals and about an equal number of cases were for CINS and CINA or special proceeding referrals, 8.8% and 7.0% respectively. The proportion of delinquency referrals which were put on informal supervision is similar (86.4%).

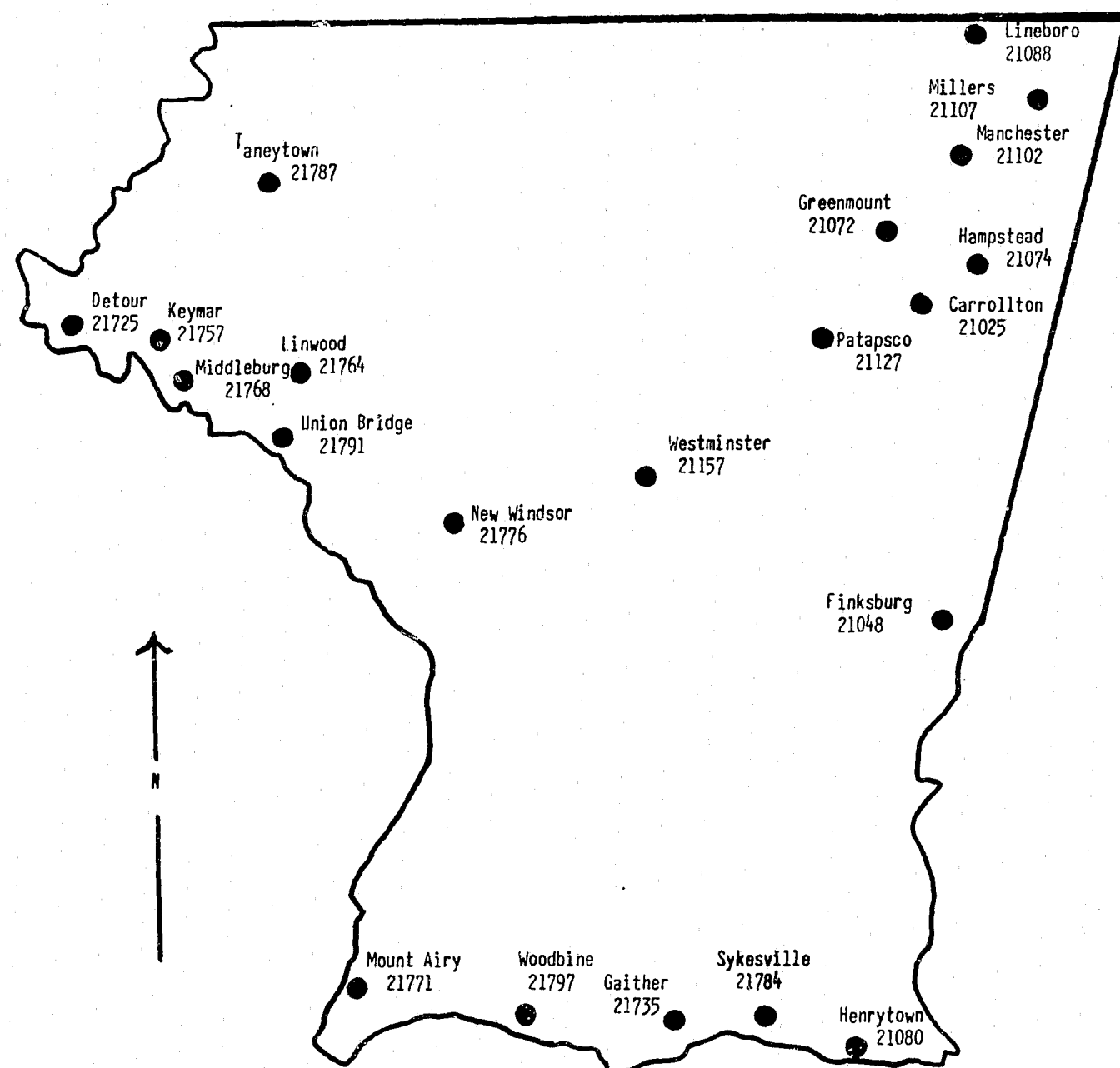

The Juvenile Services Administration in Carroll County handled 696 cases during fiscal 1980, an increase of 9.4% over fiscal 1978. Cases involving county residents increased 11.2% and accounted for 92.7% of the total cases. Out-of-county resident cases decreased by 8.9% and accounted for 7.3% of the total cases.

Fourteen zip code areas reported cases during fiscal 1980. Seven of these reported an increase in the number of cases, six reported a decrease in the number of cases, and one reported no change. Seven zip code areas reported no cases during fiscal 1980. The Westminster area reported the largest number of resident cases (48.8%) and also reported the largest increase in the number of cases, from 234 in 1978 to 315 in 1980 (35%).

A majority of the resident cases that were handled during fiscal 1980 involved juveniles between the ages of fifteen and seventeen (63.7%) while juveniles under fifteen years accounted for 34.4% of the number of resident cases.

Approximately one-half of the resident cases were disapproved or closed at intake (50.8%) and 47.9% were handled formally. Few (1.2%) were put on informal supervision. Of those cases that were handled formally 83.8% involved delinquent offenses. Children in Need of Assistance or special proceedings accounted for 15.5% of the formal cases and Children in Need of Supervision accounted for 0.6%. Delinquent offenses accounted for 87.5% of the disapproved or closed at intake cases. Children in Need of Supervision were involved in 12.2% of the disapproved or closed at intake cases.

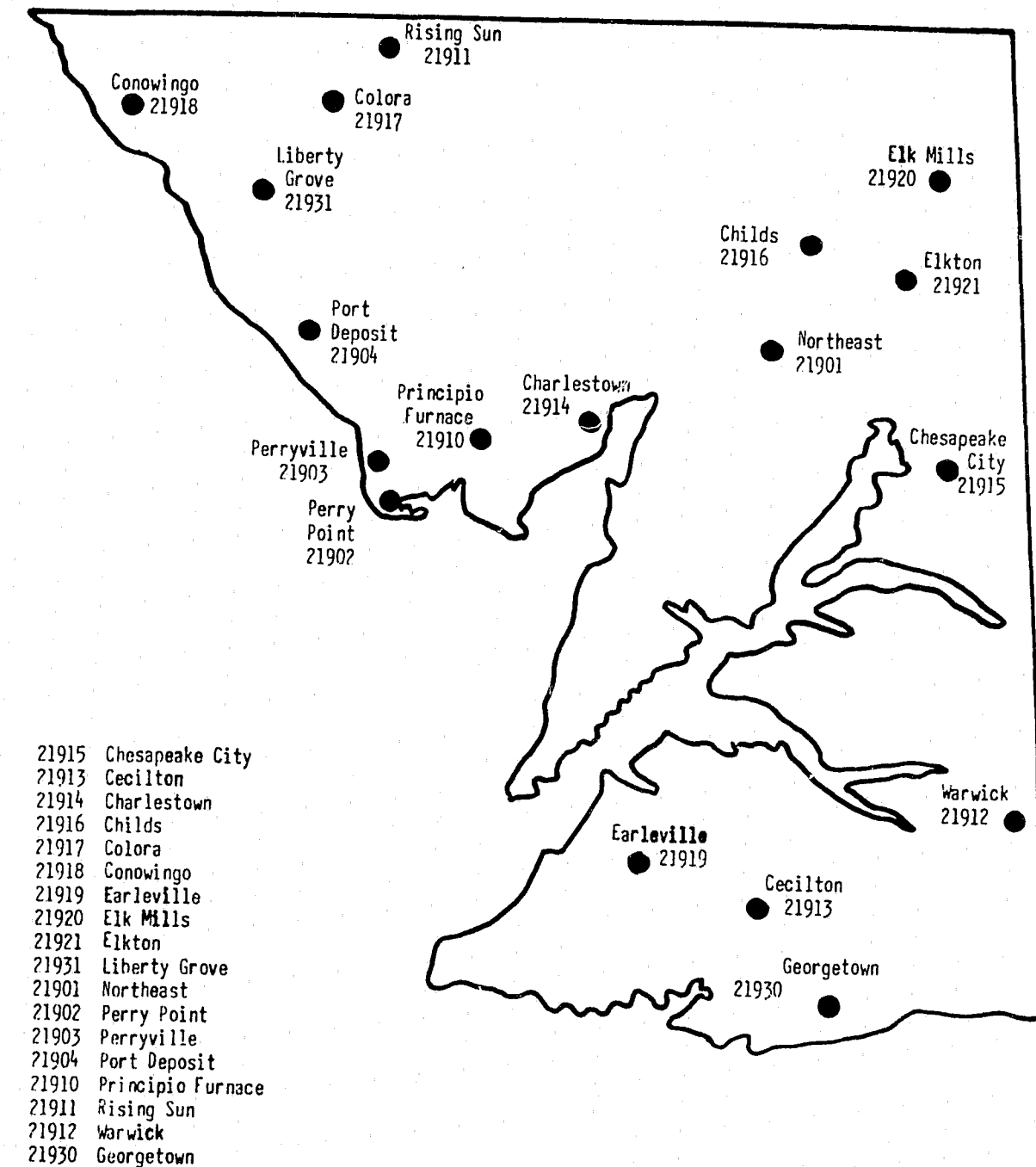

During fiscal 1980 the number of cases that were handled by the Juvenile Services Administration in Cecil County increased by 54.4%, from 482 cases in 1978 to 744 cases. The number of cases involving county residents, which accounted for 85.1% of the total number of cases, increased 46.9%. The cases involving out-of-county residents increased 117.6% from 51 cases to 111.

Fifteen different zip code areas reported cases during fiscal 1980. Of these areas, eleven areas reported an increase in the number of cases, two reported a decrease in cases, and two reported no change. Three zip code areas reported no cases during the year.

Juveniles under sixteen years of age accounted for 55.0% of the total number of resident cases handled during fiscal 1980. Sixteen year olds accounted for 19.6% of the cases, and seventeen year olds accounted for 21.3%.

A majority of the cases involving county residents were disapproved or closed at intake (70.0%) while 24.0% were handled formally and 6.0% were handled informally. Of those cases that were handled formally, 97.4% involved delinquent offenses, and 2.0% involved CINS referrals. There was only one CINA or special proceeding case. Delinquent cases accounted for 92.1% of the informal cases and 97.5% of the disapproved or closed at intake cases.

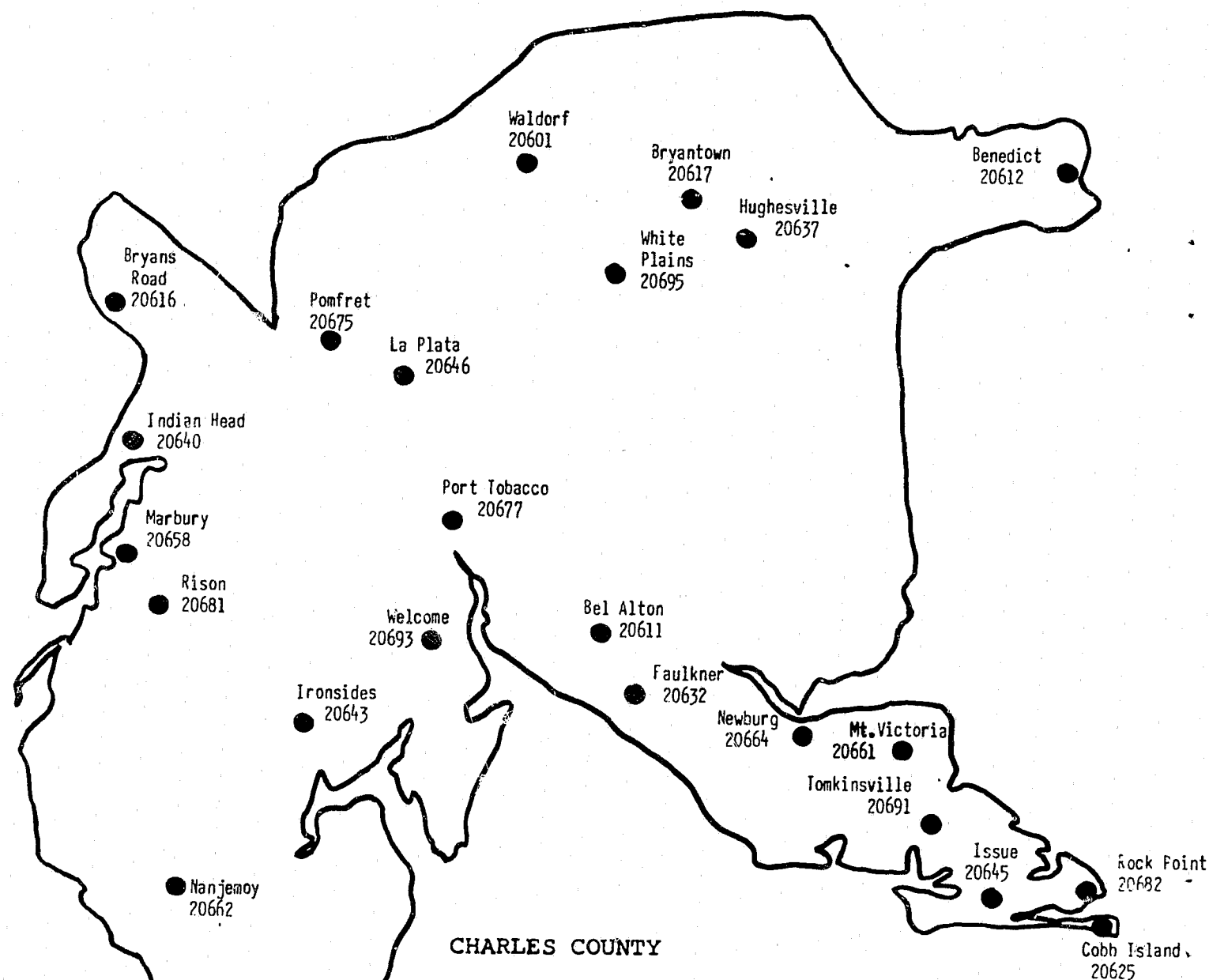

The 1,134 cases reported by the Juvenile Services Administration in Charles County during fiscal 1980 represent an increase of 4.1% over the number of cases reported in fiscal 1978. Cases involving county residents, which accounted 86.1% of the total cases, increased 1.0%. Cases involving out-of-county residents increased 28.5%.

Twenty different zip code areas reported cases during fiscal 1980. Nine of these areas reported an increase in cases, ten reported a decrease and one reported no change. The Waldorf area reported the largest number of county resident cases (45.9%) and increased 18.8% over the number of cases in 1978.

Juveniles under the age of fifteen accounted for 36.8% of the resident cases. Fifteen year olds accounted for 20.0%, sixteen year olds accounted for 21.2%, and seventeen year olds accounted for 20.8% of the resident cases.

Of the resident cases, 42.0% were formalized. Of these cases 95.1% involved delinquent offenses, 0.5% involved CINS referrals, and 4.4% involved Children in Need of Assistance or special proceedings. Of the resident cases which were disapproved or closed at intake, 65.0% involved delinquent offenses, 33.3% involved CINS, and 1.7% involved CINA or special proceedings.

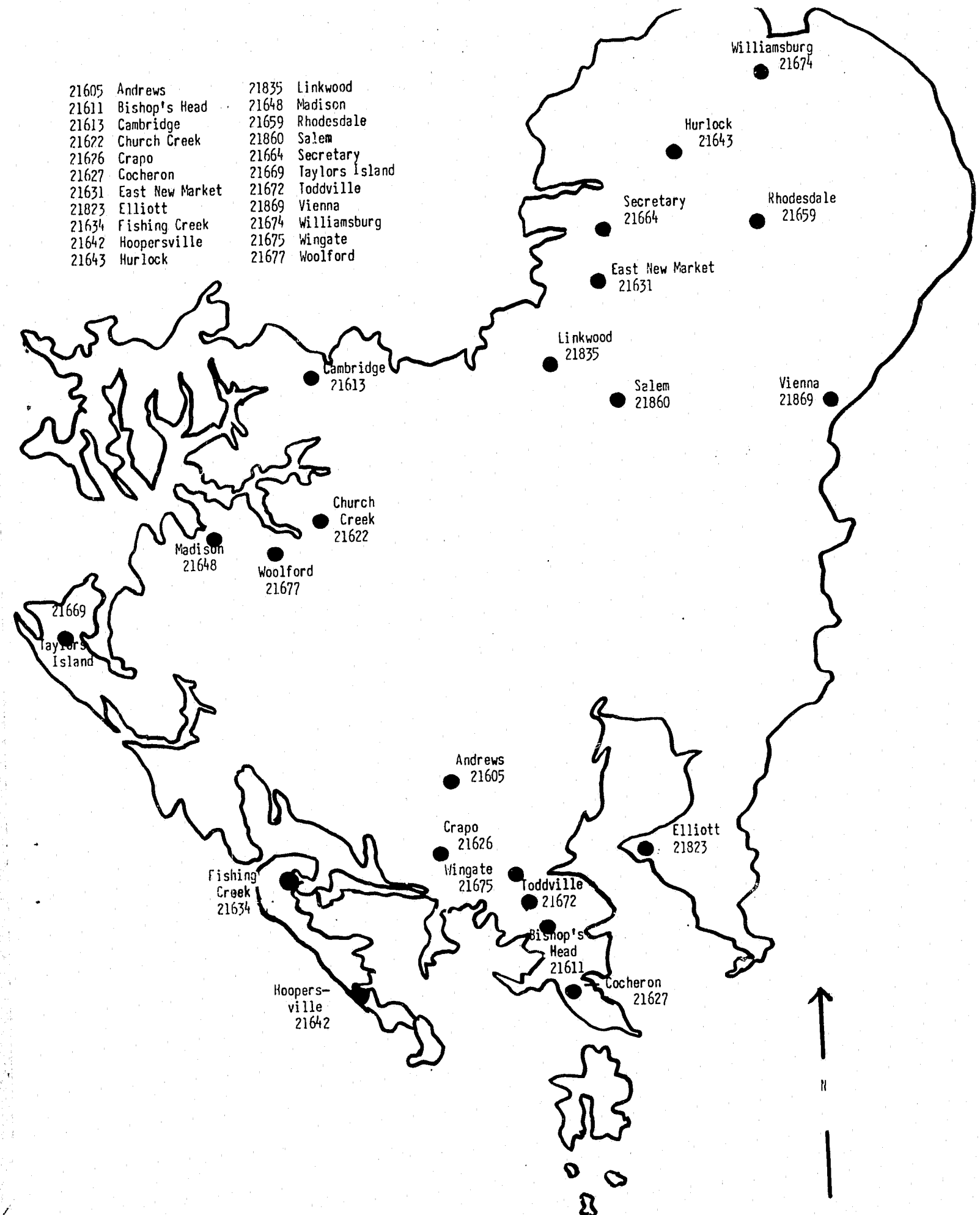

The Juvenile Services Administration in Dorchester County handled 284 cases during fiscal 1980, an increase of 31.5% over fiscal 1978. Cases involving county residents accounted for 90.5% of the cases and increased 31.1% over 1978. Cases involving out-of-county residents accounted for 9.5% of the cases and increased 35.0%.

Eleven zip code areas reported cases during fiscal 1980. Nine of these areas reported increases in the number of cases, one reported a decrease and one reported no change. The Cambridge area reported 72.4% of the resident cases and reported an increase of 20.8% over the number of cases handled in 1978.

Of the 257 juvenile cases involving county residents that were handled in 1980, 42.4% involved juveniles under fifteen years of age. Juveniles fifteen years of age accounted for 18.3%, sixteen year olds accounted for 17.1%, and 22.2% were seventeen year olds.

A majority of the cases involving county residents were disapproved or closed at intake (58.0%). Of these 83.9% involved delinquent offenses, 14.8% involved Children in Need of Supervision, and 1.3% involved Children in Need of Assistance or special proceedings. Among the formal cases 62.6% involved delinquent offenses, 2.0% were CINS referrals, and 35.4% were CINA or special proceedings referrals.

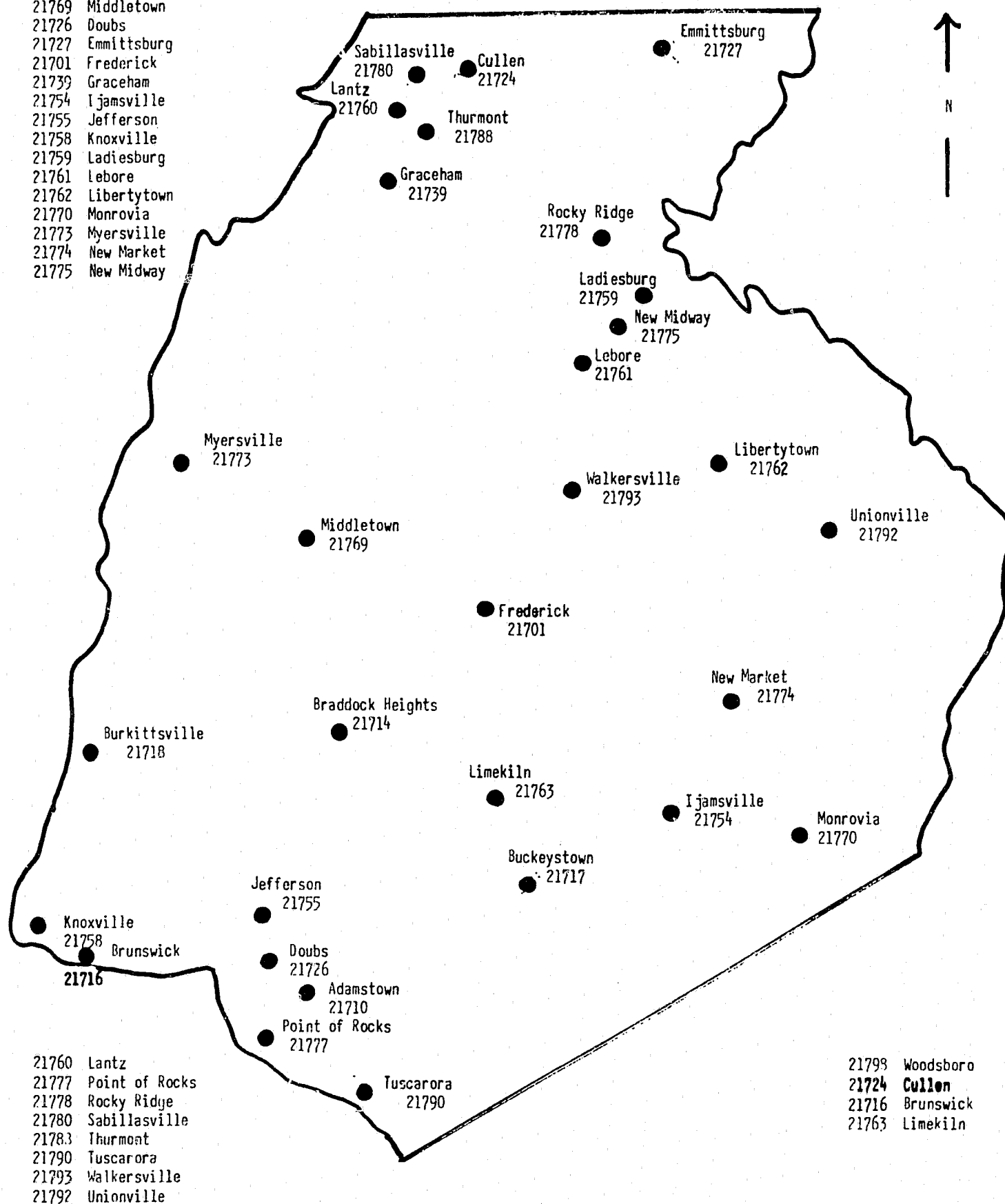
The number of cases that were handled by the Juvenile Services Administration in Frederick County during fiscal 1980 increased 4.8% over the number in 1978. Cases involving county residents accounted for 84.2% of the total cases and increased 4.9%. Cases involving out-of-county residents accounted for 15.8% of the cases and increased 4.3%.

Resident cases handled during fiscal 1980 involved juveniles from 22 different zip code areas. Of these areas, 14 reported an increase in the number of cases and 8 decreased. Nine zip code areas reported no cases during fiscal 1980. The area served by Frederick post office reported 56.6% of the resident cases and decreased by 7.4% between 1978 and 1980.

Juveniles under fifteen years of age accounted for 39.8% of the resident cases handled during fiscal 1980. Fifteen year olds accounted for 18.3%, sixteen year olds 20.4%, and seventeen year olds represented 20.3% of the resident cases.

A majority of the cases involving county residents were disapproved or closed at intake (71.4%). Of these cases 93.7% involved delinquent offenses and 6.3% involved Children in Need of Supervision. Formal cases accounted for 24.4% of the cases. Among the formal cases 86.2% involved delinquent offenses, 1.1% involved CINS, and 12.7% involved CINA or special proceedings.

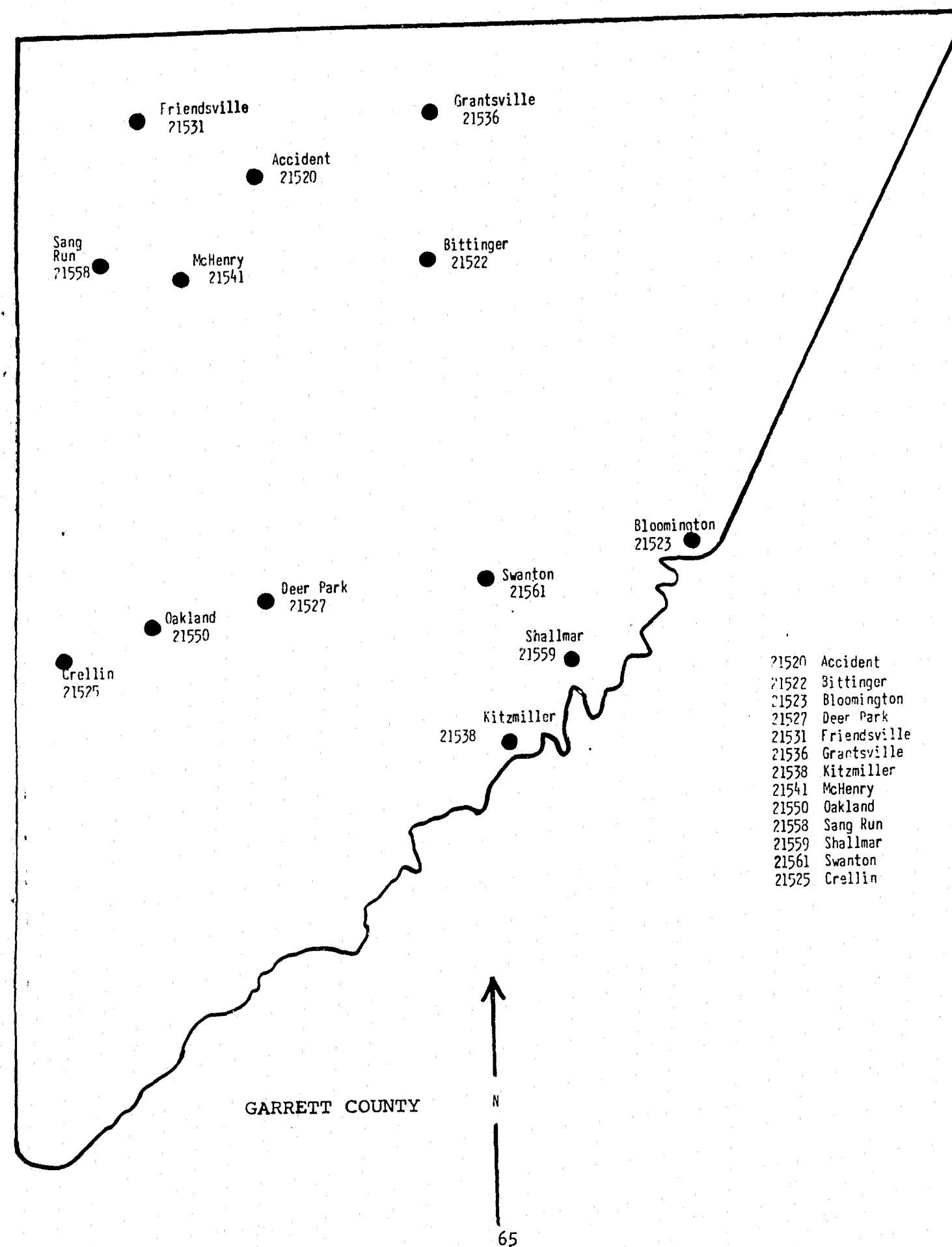

The 213 cases that were handled by the Juvenile Services Administration in Garrett County during fiscal 1980 represent an increase of 53.2% over the cases in 1978. The number of cases involving county residents accounted for 83.1% of the total cases and increased 90.3% over 1978. The number of cases involving out-of-county residents decreased 21.7% from 1978 and represents 16.9% of the total cases.

Nine zip code areas reported cases during 1980; all of these reported an increase. The Oakland area reported 53.7% of the cases, an increase of 21.8% over the 1978 cases.

Of the cases involving county residents, 67.2% involved juveniles under the age of sixteen. Sixteen year olds accounted for 11.3% of the cases, and seventeen year olds accounted for 19.8% of the resident cases.

Of the 177 resident cases, 48.0% were handled formally, 35.6% informally, and 16.4% were disapproved or closed at intake. Of the formal cases, 64.7% involved delinquency referrals, 3.5% CINS referrals, and 31.8% involved CINA or special proceedings.

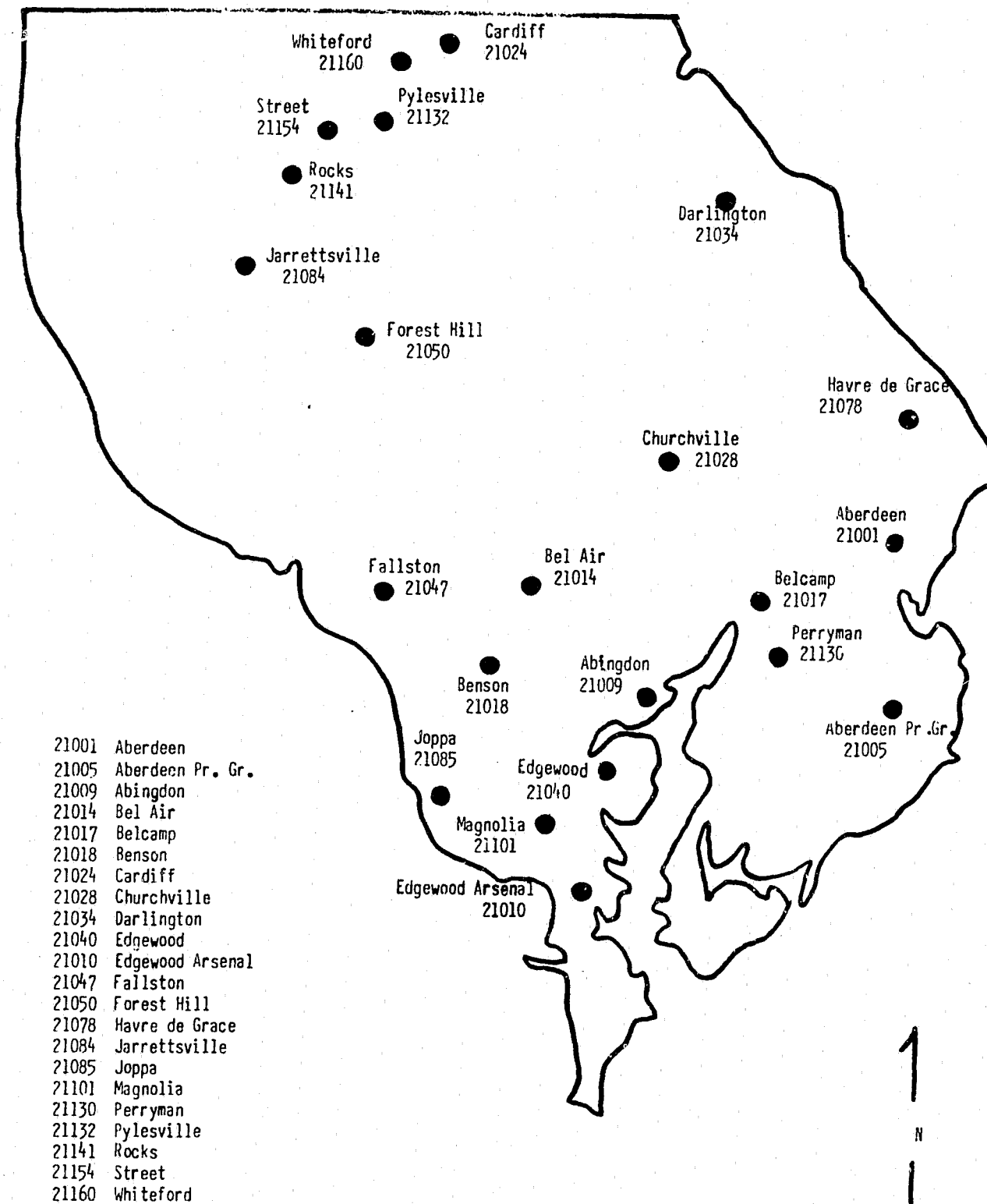

The 1,419 cases that were handled by the Juvenile Services Administration in Harford County during fiscal 1980 represent an increase of 18.9% over the number of cases handled during fiscal 1978. Resident cases increased 15.7% during this period while non-resident cases increased 77.8%.

The resident cases involved juveniles from 19 different zip code areas of the county. Of these, 11 reported an increase in the number of cases, 5 reported a decrease, and 3 reported no change. The Edgewood area reported the largest number of cases for any one zip code area with 20.4% of the resident cases and an increase of 4.7% over 1978.

Juveniles under the age of fifteen accounted for 34.3% of the resident cases. Fifteen year olds were involved in 20.4% of the cases, 19.2% involved sixteen year olds, and 22.2% involved seventeen year olds.

Of the 1,307 cases involving county residents, most (60.4%) were disapproved or closed at intake, 32.1% were handled formally, and 7.5% were handled informally. Among those cases that were disapproved or closed at intake, 93.2% involved delinquent offenses and 6.8% involved Children in Need of Supervision.

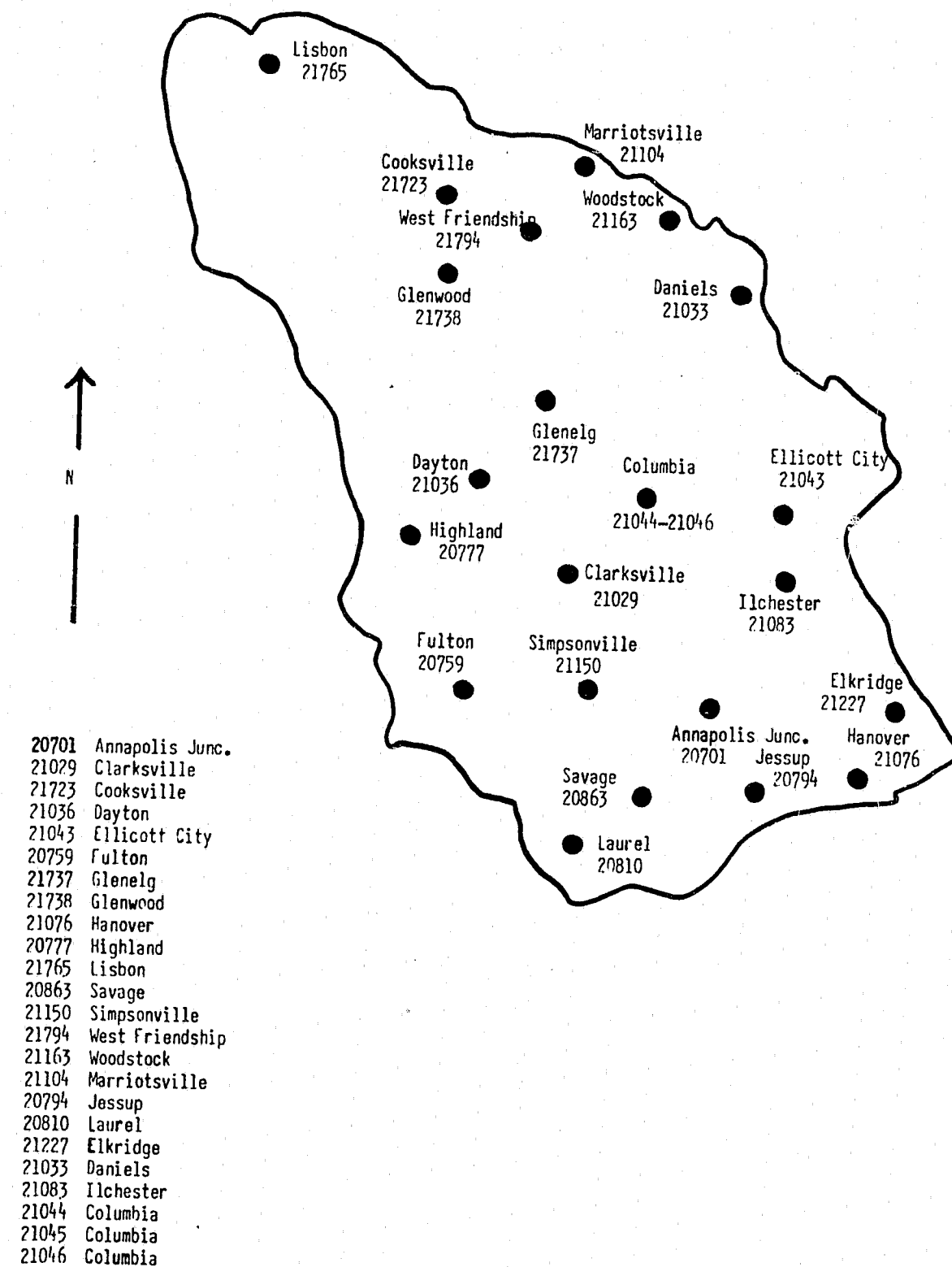

During fiscal 1980, 923 cases were handled by the Juvenile Services Administration in Howard County. This represents an increase of 5.2% over the number of cases handled during fiscal 1978. County residents accounted for 78.8% of the cases, and increased 1.3% over 1978. Cases involving out-of-county residents accounted for 21.2% of the total cases, and increased 23.3% since 1978.

Nineteen different zip code areas reported cases during fiscal 1980. Eight of these areas reported an increase in the number of cases, eight reported a decrease, and three had no change. The Columbia area, comprised of three zip codes, accounted for 46.2% of the county resident cases.

Of those resident cases that were handled during fiscal 1980, 26.0% involved juveniles under fifteen years of age, fifteen year olds accounted for 18.3% of the cases, 24.5% involved sixteen year olds, and 28.6% involved seventeen year olds.

Among the 727 cases involving county residents, the majority (67.7%) were disapproved or closed at intake, 27.4% were handled formally, and 5.0% were handled informally. Among the cases disapproved or closed at intake, 95.3% involved delinquent offenses and 4.7% were for CINS referrals. Among the cases handled formally, 97.0% involved delinquency offenses, 2.5% CINS, and 0.5% involved Children in Need of Assistance or special proceedings.

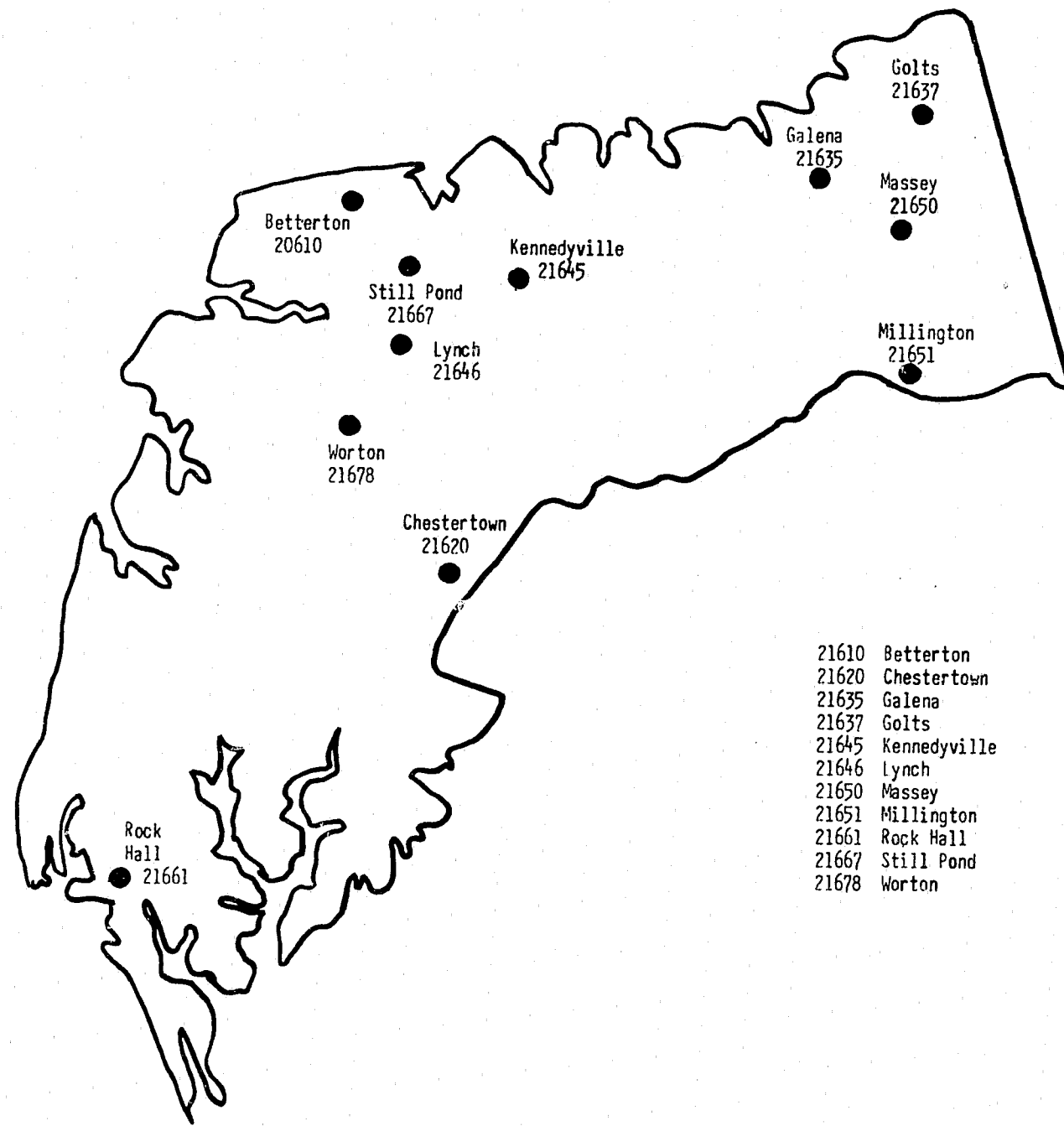

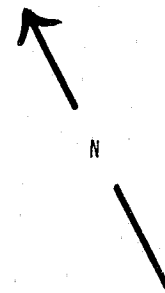

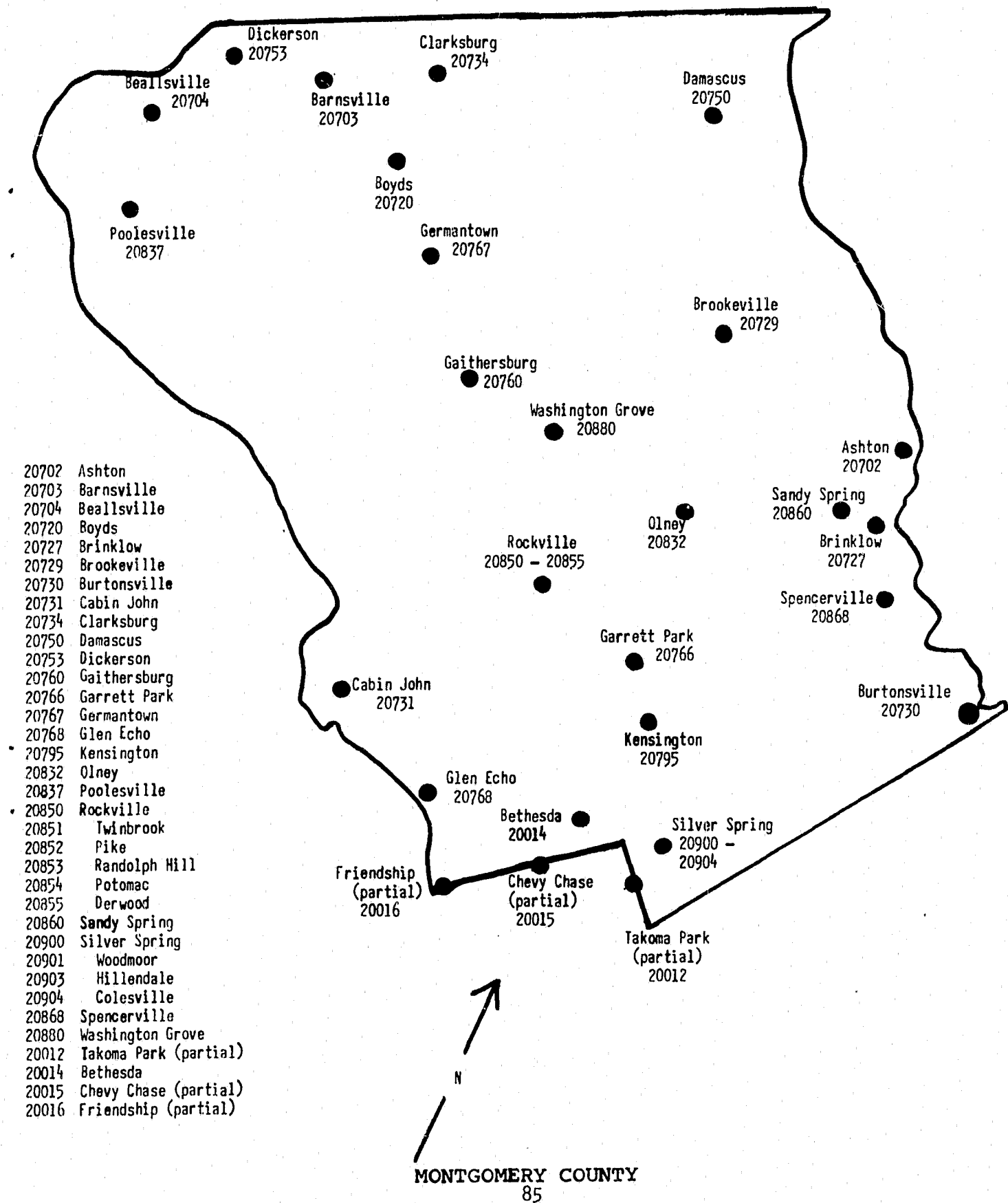

The Juvenile Services Administration in Montgomery County handled 2,157 cases during fiscal 1980, a decrease of 21.9% from the cases handled in fiscal 1978. Resident cases which accounted for 81.2% of the total cases handled decreased 22.8%. Out-of-county resident cases decreased 18.1%.

During fiscal 1980, thirty-eight different zip code areas reported cases. The largest concentration of resident cases was reported from the area of Silver Spring which included eleven zip code areas and accounted for 39.1% of the total resident cases.

Of the 1,751 cases involving county residents that were handled during fiscal 1980, the largest percentage of cases involved juveniles seventeen years of age (23.6%). Juveniles less than fifteen years old accounted for 30.0% of the total cases, fifteen year olds accounted for 20.0%, and sixteen year olds accounted for 23.1% of the total resident cases.

A majority of the cases involving county residents were disapproved or closed at intake (57.1%). Of those 97.9% involved delinquent offenses and 2.1% involved Children in Need of Supervision. Among the 542 resident cases that were handled formally, all but one were for delinquency referrals. The other case was for a CINS referral. The informal cases were composed of 95.7% delinquent offenses and 4.3% Children in Need of Supervision cases.

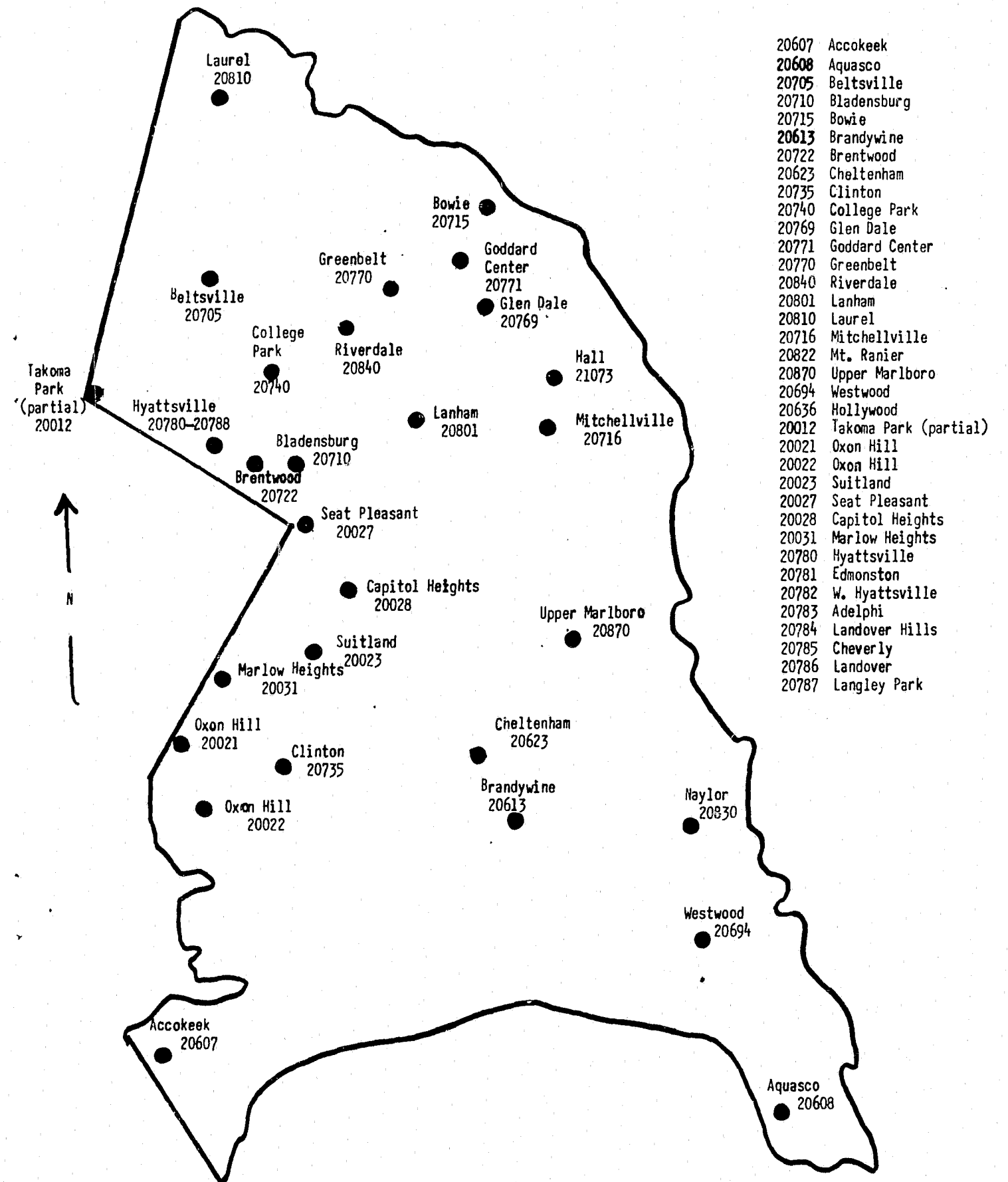

The 8,789 cases that were handled by the Juvenile Services Administration in Prince George's County during fiscal 1980 represent an increase of 5.2% over the number of cases handled in fiscal 1978. The resident cases accounted for 81.7% of the total cases and increased 4.5%. Cases involving out-of-county residents accounted for 18.3% of the cases and increased 8.6%.

Among the 39 zip code areas, thirty-five reported cases. Twenty-two zip code areas reported increases, ten reported decreases, and three reported no change in the number of cases from 1978.

The age group with the most resident cases was fifteen year olds (20.8%). Juveniles less than fifteen accounted for 39.4% of the resident cases, and those who were sixteen years old accounted for 20.2%.

Of the resident cases, 31.7% were handled formally, 25.1% were handled informally, and 43.2% were either disapproved or closed at intake. Of the formal cases, 77.5% were for delinquency referrals, 3.2% were for CINS, and 19.3% were for CINA or special proceedings. Among the cases handled informally, 95.4% were for delinquency referrals, 4.2% were for CINS, and 0.4% were for CINA or special proceedings.

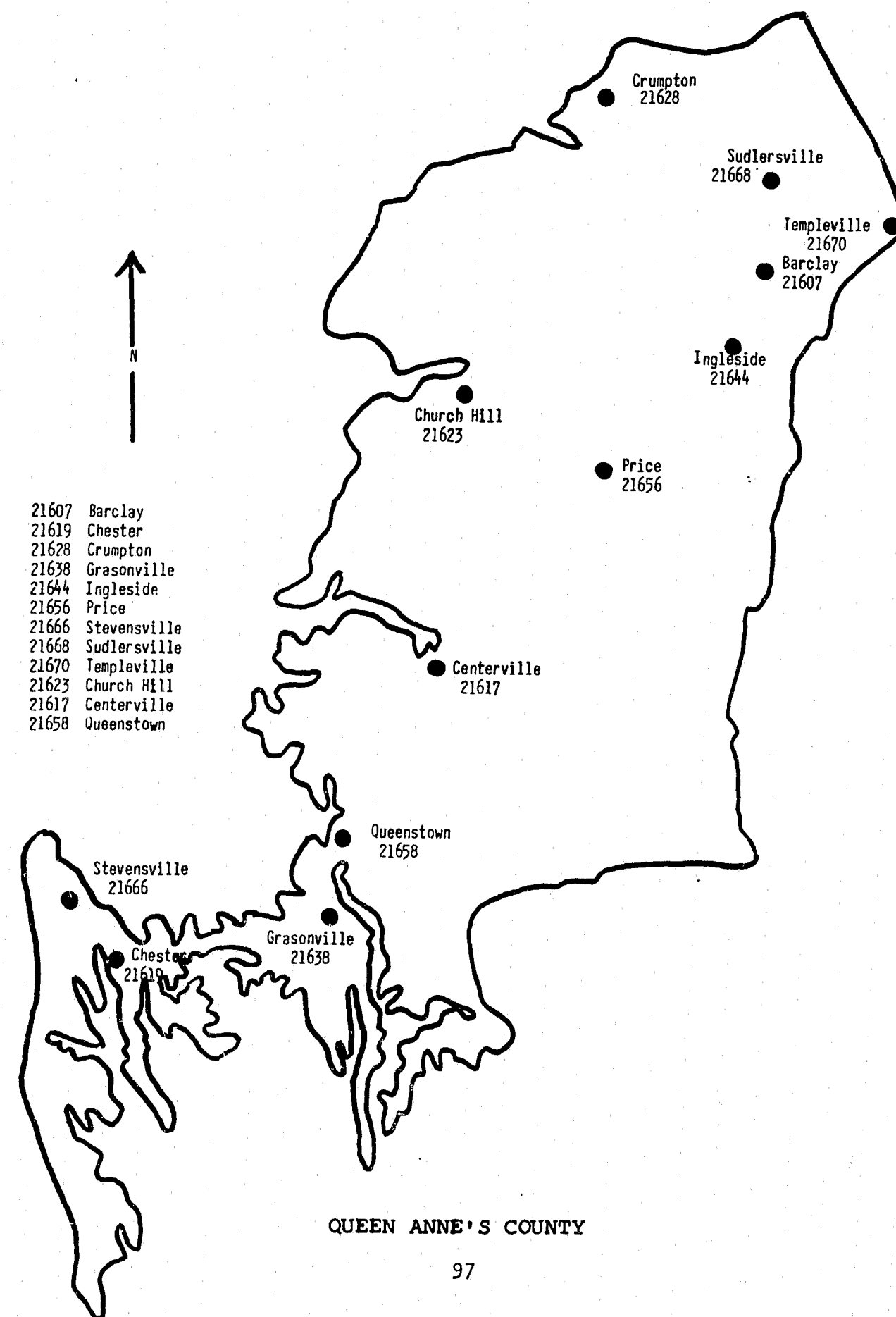

The 180 cases that were handled by the Juvenile Services Administration in Queen Anne's County during fiscal 1980 represent an increase of 41.7% over the number handled in 1978. The 121 county resident cases represented 67.2% of the total cases and increased 39.1% over 1978. Out-of-county residents accounted for 32.8% of the cases and increased 47.5%.

Nine zip code areas reported cases during fiscal 1980, six increased and three decreased. The majority (74.4%) of the resident cases came from Centerville, Grasonville, and Stevensville.

Among the resident cases, juveniles less than fifteen years old represented 35.5% of the cases. Fifteen year olds accounted for 28.1%, sixteen year olds represented 12.4%, and seventeen year olds accounted for 23.1% of the cases.

Of the cases involving county residents, 65.3% were disapproved or closed at intake, 25.6% were handled formally, and 9.1% were handled informally. Delinquent offense cases comprised 88.6% of the closed or disapproved at intake cases and 11.4% of these cases involved Children in Need of Supervision. Of the cases handled formally, most (87.1%) were delinquency cases.

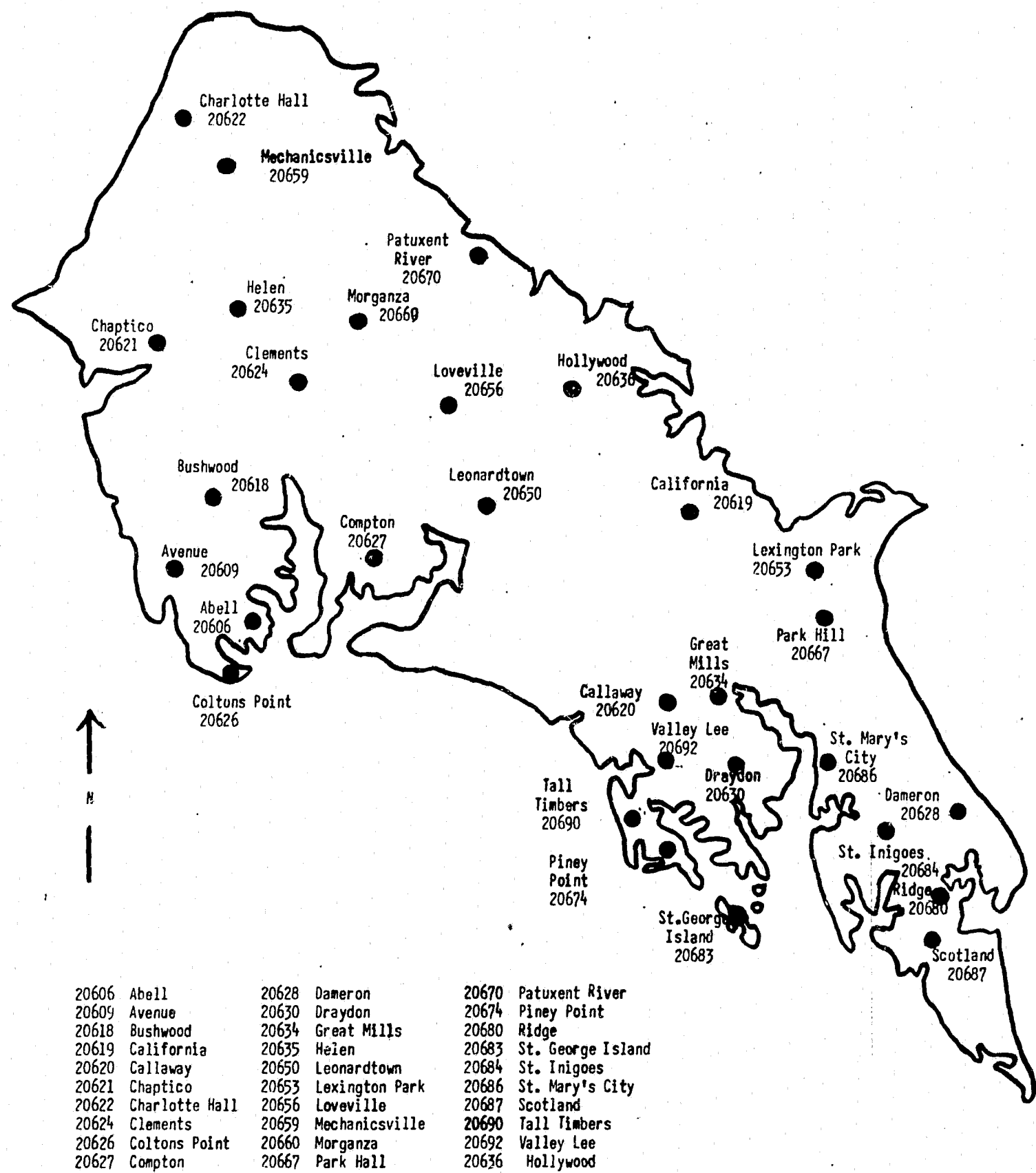

The Juvenile Services Administration in St. Mary's County handled 585 cases during fiscal 1980. This represents a decrease of 15.6% from the number handled during fiscal 1978. Cases involving county residents accounted for 94.7% of the cases and decreased 16.3%. Out-of-county residents accounted for 5.3% of the cases. The number of cases involving out-of-county residents remained the same as 1978.

Among the resident cases twenty-nine zip code areas were represented. Of these thirteen reported increases in the number of cases, fifteen reported decreases, and one remained the same. The Lexington Park area reported 28.0% of the resident cases and the Mechanicsville area reported 13.9% of the county resident cases.

Among the 554 cases involving county residents, the largest percentage of cases involved juveniles seventeen years of age (24.4%). Juveniles less than fifteen years old accounted for 32.5% of the cases, those fifteen years old accounted for 17.9% of the cases, and those sixteen years old accounted for 22.4% of the county cases.

The distribution of cases involving county residents was 35.0% formal, 48.2% informal, and 16.8% disapproved or closed at intake. Among the cases handled formally, 90.7% were for delinquent offenses, 3.1% involved Children in need of Supervision, and 6.2% involved Children in Need of Assistance or special proceedings. Among the cases handled informally, 86.9% were for delinquent offenses and 13.1% were for CINS referrals.

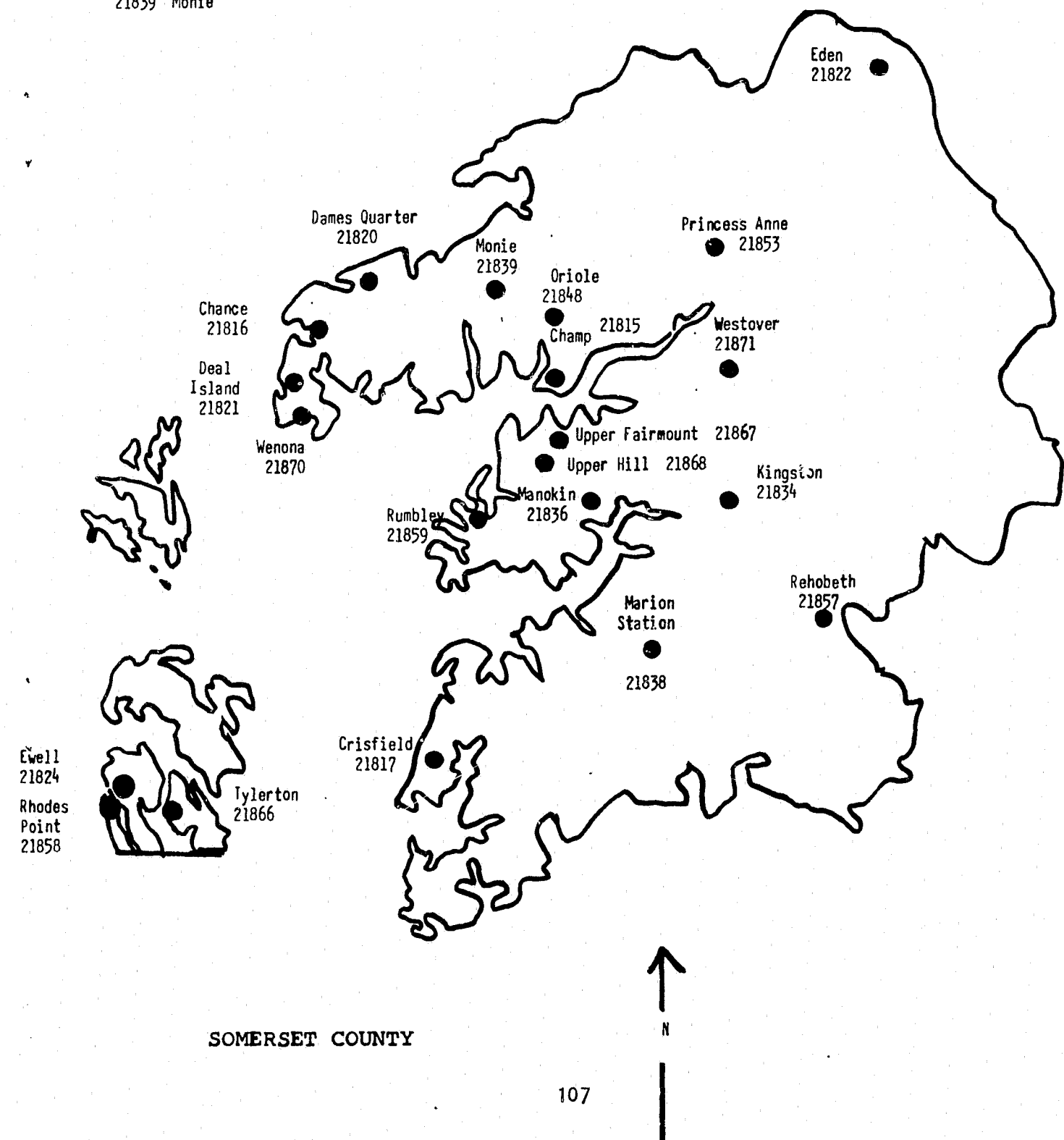
The total number of cases handled by the Juvenile Services Administration in Somerset County during fiscal 1980 increased 33.0% over the number handled during fiscal 1978. County resident cases comprised 95.9% of the cases and increased 34.9%. The number of out-of-county cases remained the same as 1978.

Among the resident cases, twelve zip code areas were reported. Nine areas reported an increase in cases, one reported a decrease and two remained the same. Crisfield and Princess Anne were ranked first and second in the number of resident cases.

Over half of the resident cases that were handled during fiscal 1980 involved juveniles fifteen years old or younger (55.2%). Juveniles sixteen years old accounted for 23.3% and seventeen year olds accounted for 19.8% of the resident cases.

A majority of the county resident cases were handled formally (62.1%). Of these cases 97.2% involved delinquency offenses and 2.8% involved CINS. Disapproved/Closed at Intake comprised almost 39% of the cases.

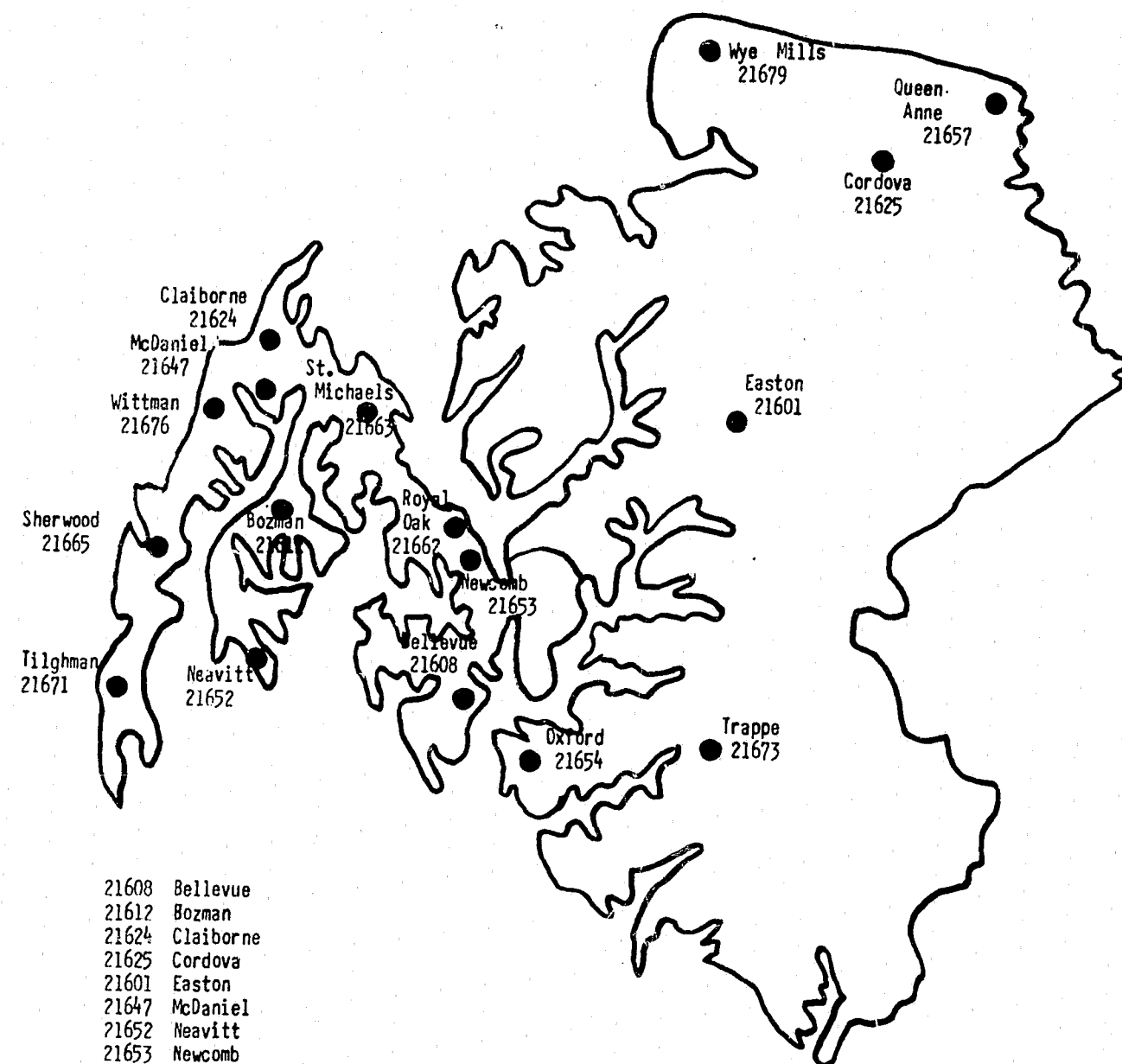

The number of cases handled by the Juvenile Services Administration in Talbot County increased 23.2% from 220 in 1978 to 271 in 1980. County resident cases accounted for 74.5% of the total cases and increased 11.6%. Out-of-county resident cases accounted for 25.5% of the total cases and increased 76.9%.

Among the resident cases, thirteen zip code areas were reported. Of these areas, eight increased in number of cases and five decreased.

Of those cases involving county residents, a majority (68.3%) of the cases involved juveniles fifteen years or older. Juveniles less than fifteen years old accounted for 31.7% of the cases.

Cases were handled formally in 41.6% of the county resident cases, informally 43.6%, and disapproved or closed at intake 14.9%. Of the formal cases, 88.1% involved delinquent offenses and 11.9% involved CINS. Among the informal cases, 97.7% involved delinquent offenses and 2.3% involved CINS.

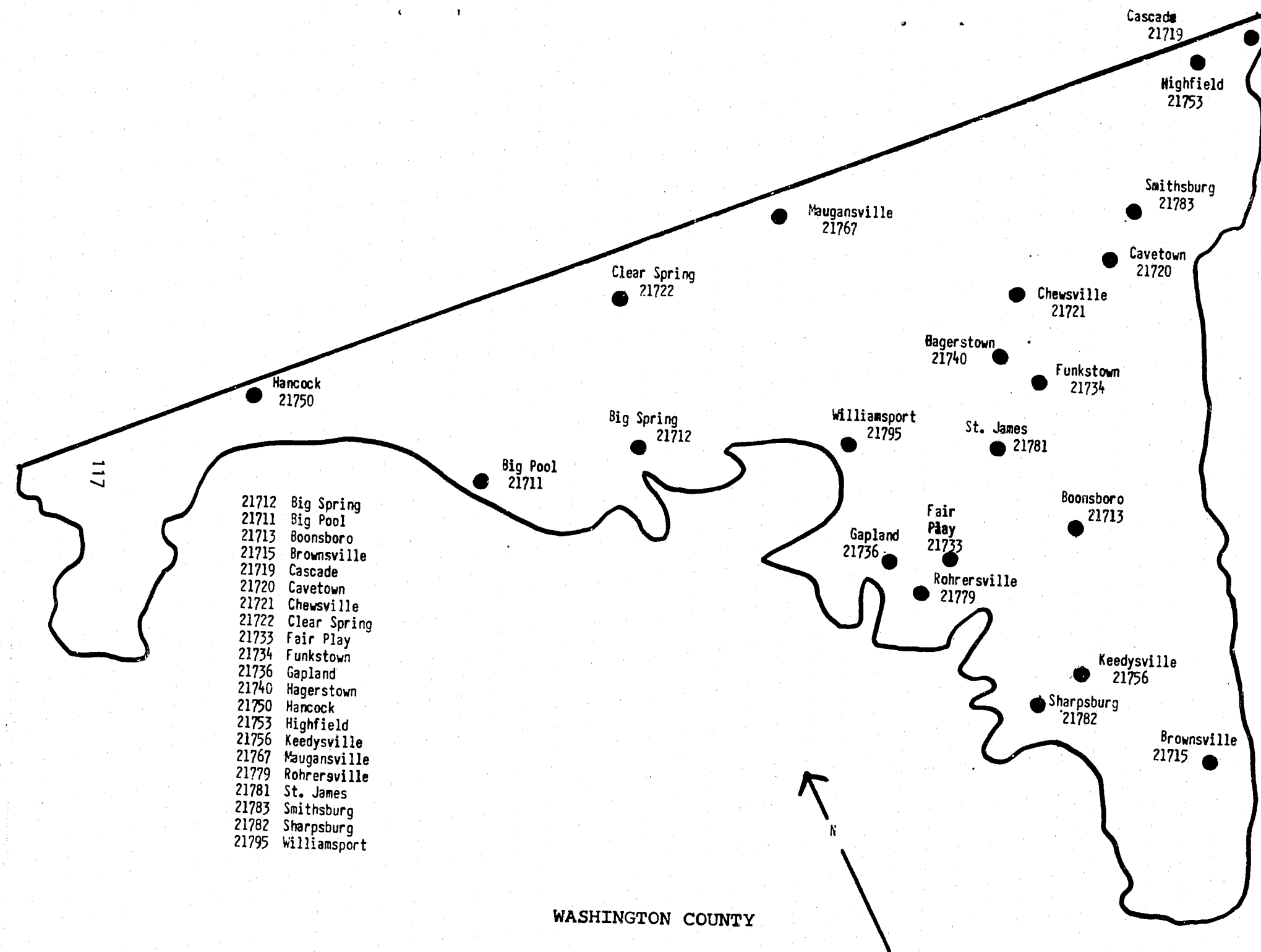

The 650 cases handled during 1980 in Washington County by the Juvenile Services Administration represented a decrease of 14.9% from the number handled in 1978. The county resident cases accounted for 86.3% of the total cases and decreased 17.6%. Out-of-county resident cases accounted for 13.7% of the cases and increased 72.%.

Fifteen zip code areas reported cases involving county residents. Five of these areas reported an increase in the number of cases, nine of these areas reported a decrease, and one remained the same. The Hagerstown area reported the largest number of cases and represented 80.4% of the county resident cases.

The largest percentage of resident cases for any one age involved juveniles sixteen years of age (23.5%). Juveniles seventeen years of age reported 19.8% of the cases, those fifteen years old reported 20.7% of the cases, and juveniles less than fifteen years old reported 35.3% of the cases.

More than half (61.3%) of the resident cases were handled formally, 28.5% were disapproved or closed at intake, and 10.2% were handled informally. Among those handled formally, 82.3% involved delinquent offenses, 3.5% involved CINS offenses, and 14.2% involved CINA or special proceedings. Among the cases disapproved or closed at intake, 83.1% involved delinquent offenses, 15.0% involved CINS, and 1.9% involved CINA or special proceedings.

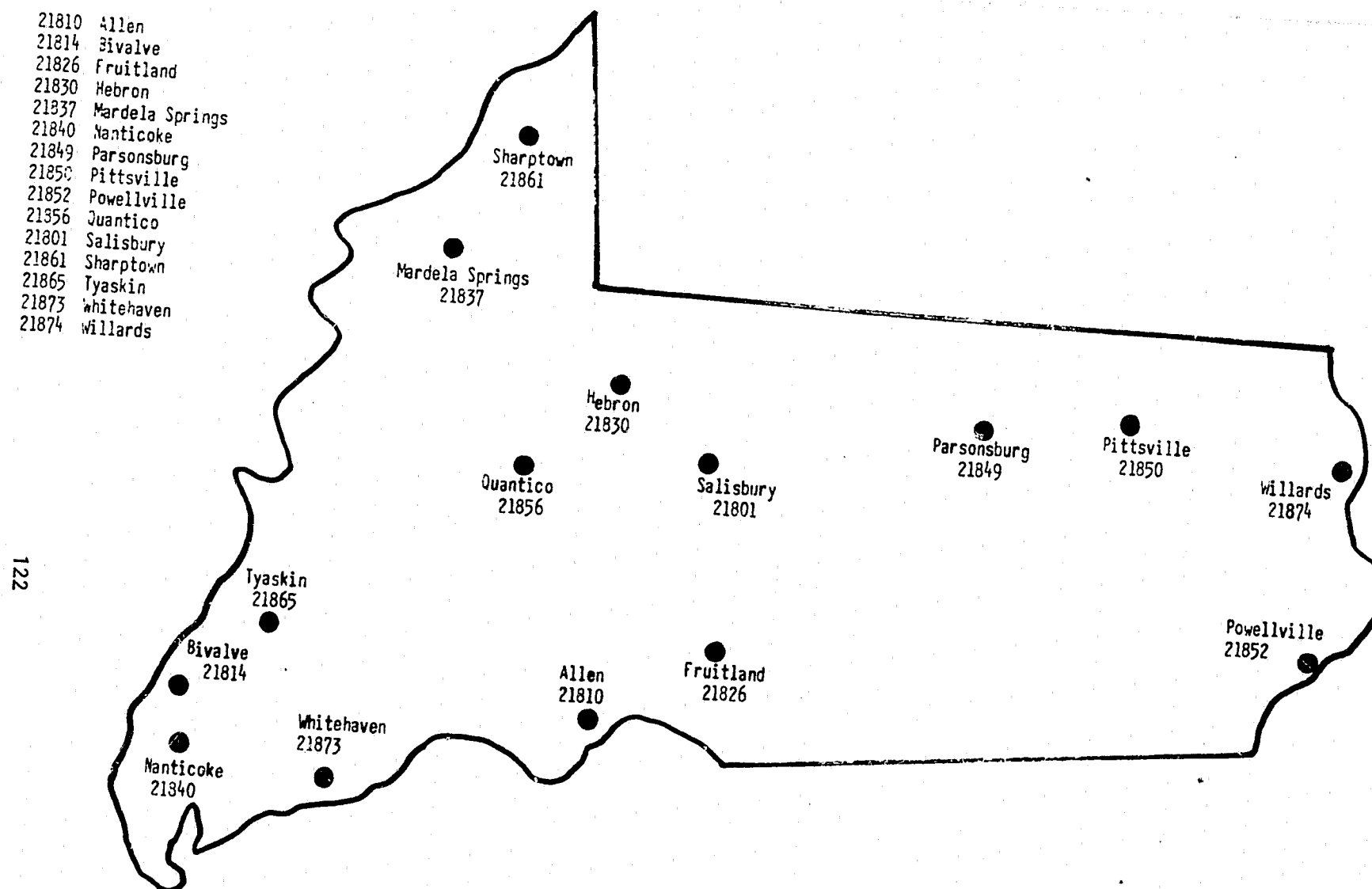
The 434 cases handled by the Juvenile Services Administration in Wicomico County during fiscal 1980 represent an increase of 128.4% over the number of cases in 1978. County resident cases accounted for 85.7% of the cases and increased 116.3% over 1978. Out-of-county residents accounted for 14.3% of the cases and the number of those cases increased 244.4% over the number handled in 1978.

Eleven different zip code areas were represented in the 372 county resident cases. Nine areas reported an increase in cases, one remained unchanged, and one reported a decrease in the number of cases from 1978. Salisbury reported the largest percent of the resident cases (82.0%).

Among the county resident cases, 53.2% involved juveniles under sixteen years old. Juveniles sixteen years old accounted for 21.0% of the cases and those seventeen years old reported 23.1% of the cases.

A majority of the resident cases were either disapproved or closed at Intake (72.6%). Of the formal cases (27.4% of the resident cases), 95.1% involved delinquent offenses, 1.0% involved CINS, and 3.9% involved CINA or special proceedings. There were no cases handled informally.

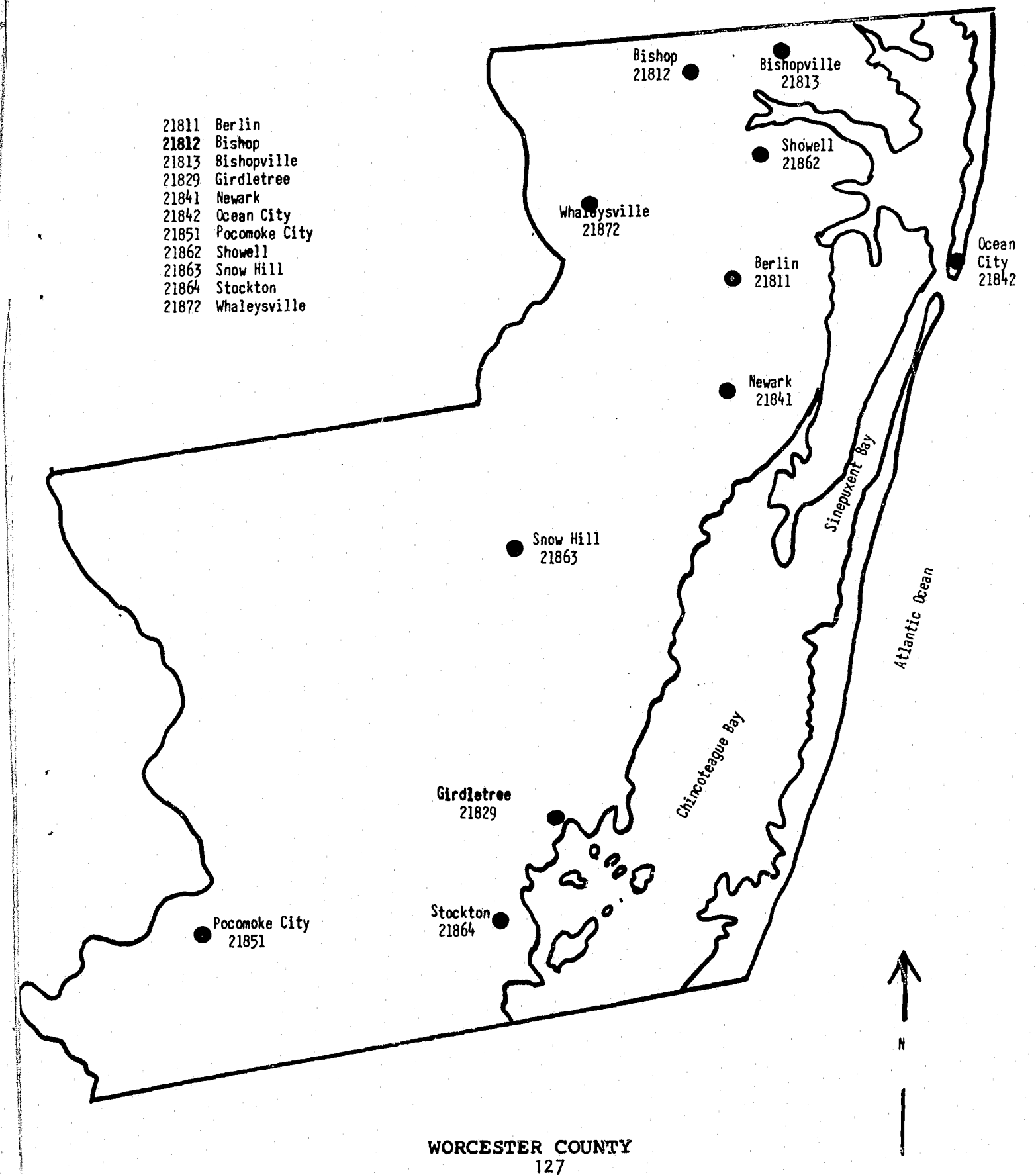

The number of cases handled by the Juvenile Services Administration in Worcester County during fiscal 1980 increased 36.3% over the number of cases in 1978. The county resident cases accounted for 21.0% of the cases and increased 19.5% over the number of cases handled in 1978. Out-of-county cases accounted for 79.0% of the cases and increased 41.6%. The large percentage of out-of-county residents was primarily due to the summer influx of visitors to Ocean City.

Nine zip code areas reported juvenile cases in fiscal 1980. Among the areas, four reported an increase and five reported a decrease. The top three areas, ranked in order, with the most resident cases were Ocean City, Berlin, and Pocomoke. Together they accounted for 81.5% of the resident cases.

Among the county resident cases, 34.8% involved juveniles under fifteen years of age. Juveniles fifteen years of age accounted for 20.8% of the cases, sixteen and seventeen year olds accounted for 21.9% each.

A majority of the resident cases were disapproved or closed at intake (68.5%). Formal cases accounted for 31.5% of the cases. There were no resident cases handled informally. Among the disapproved or closed at intake cases, 91.0% involved delinquent offenses and 9.0% involved CINS. Delinquent offenses accounted for 85.7% of the formal cases, one case (1.8%) involved CINS and 12.5% involved CINA or special proceedings.

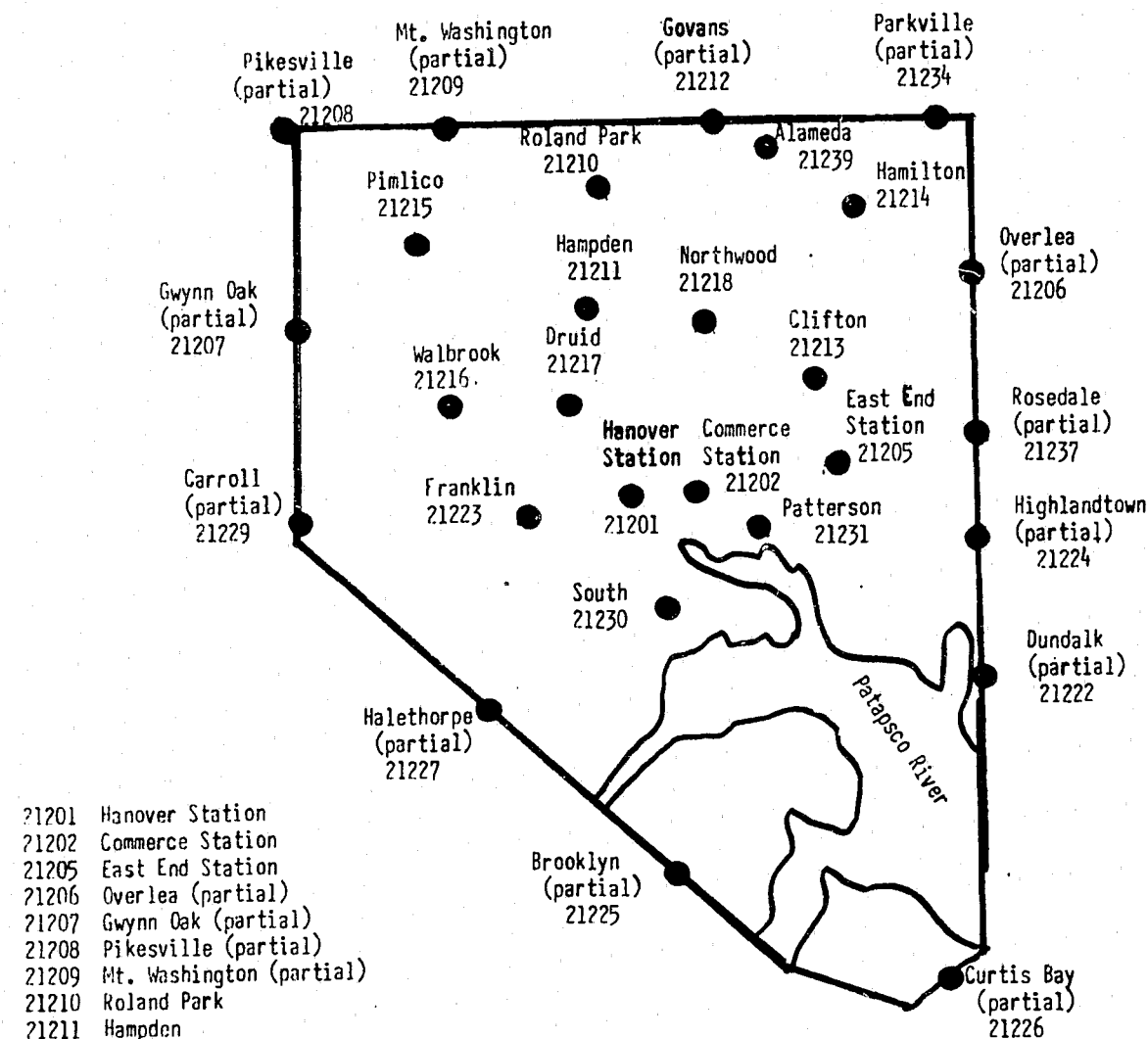
In Baltimore City during fiscal 1980, the Juvenile Services Administration handled 14,644 cases, a decrease of 12.7% from the number in 1978. Cases involving city residents accounted for 98.6% of the cases and decreased 12.4% from 1978. Out-of-city residents accounted for 1.4% of the cases and decreased 29.5% from the number of cases handled during fiscal 1978.

Thirty-one zip code areas reported cases during fiscal 1980. Among these areas, three reported an increase in the number of cases; the others reported a decrease.

The zip code areas designated as "part" are those that overlap the city-county boundary. Juvenile cases in these areas are reported by the subdivision having legal jurisdiction over the area in which the offense occurred.

Among the city resident cases, 37.5% involved juveniles under fifteen years of age, 20.1% involved fifteen year olds, 20.8% involved sixteen year olds, and 18.1% involved seventeen year olds.

Disapproved or closed at intake cases accounted for 54.1% of the resident cases. Among these cases, 88.8% involved delinquent offenses, 10.6% involved CINS, and 0.6% involved CINA or special proceedings. Formal cases accounted for 30.2% of the resident cases. Among the formal cases, 91.2% involved delinquent offenses, 2.0% involved CINS, and 6.8% involved CINA or special proceedings. Informal cases represent 15.7% of the total resident cases. Of these, 70.5% involved delinquency referrals, 29.3% involved CINS, and 0.2% involved CINA or special proceedings.

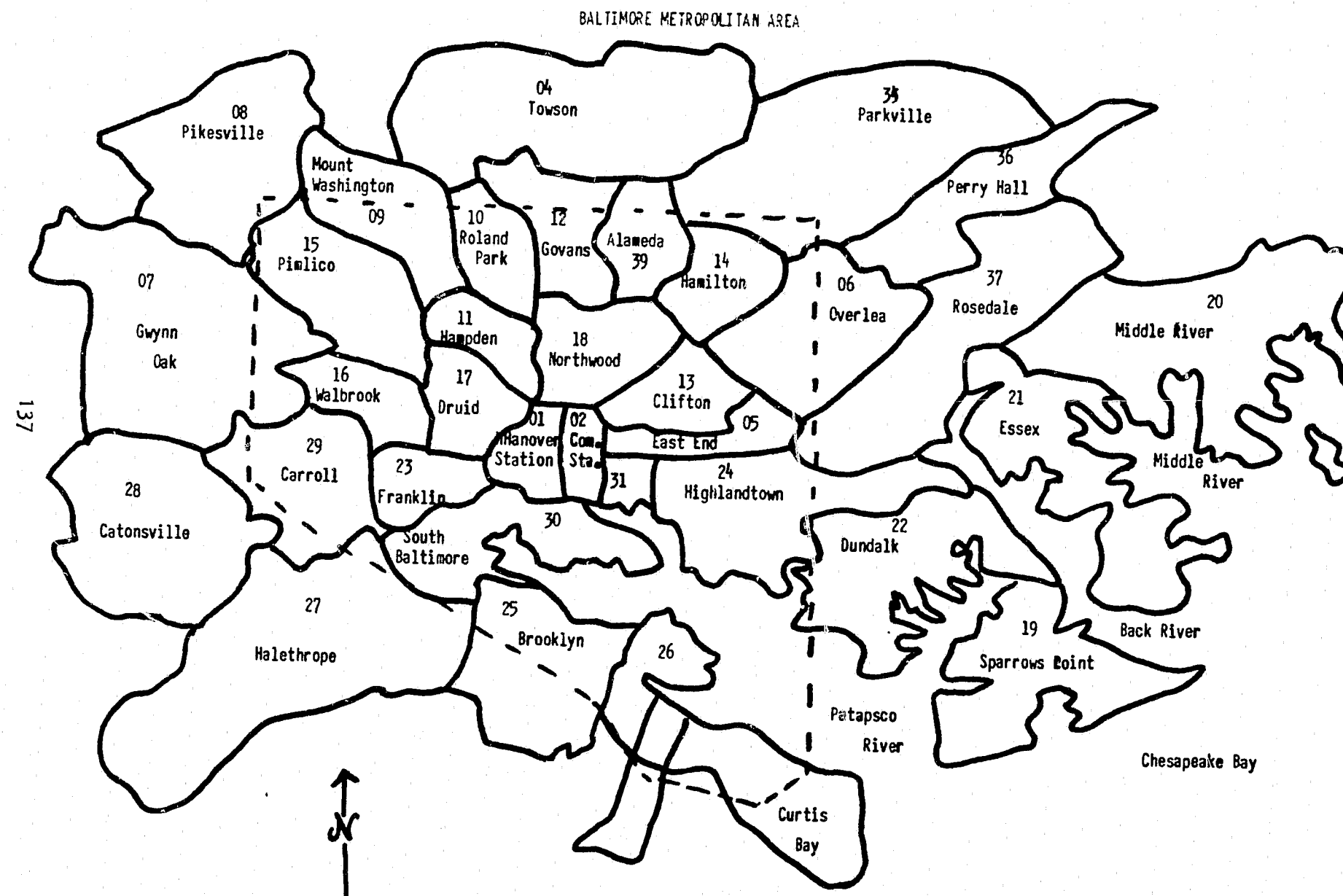

The number of juvenile cases for the Baltimore Metropolitan Area includes all referrals involving youths residing in the zip code areas served by the Baltimore City Post Office. This combines the Baltimore City resident caseload with those cases bordering the city area marked "part" on the Baltimore County and Anne Arundel County tables.

The 1980 total of 20,322 cases from the Baltimore Metropolitan Area represented a 4.7% decrease from the 1978 total of 21,319 cases. It should be noted, however, that this total does not include cases of residents from those zip code areas who may have been involved in cases handled in jurisdictions other than Baltimore City, Baltimore County, or Anne Arundel County.

The largest percentage of cases from the Baltimore Metropolitan Area involved juveniles sixteen years of age (21.8%). Less than a fifth of the cases (15.1%) involved juveniles fourteen years of age, 20.3% involved juveniles fifteen years old, and 19.3% involved seventeen year olds. Among the Baltimore Metropolitan Area cases, 52.8% were disapproved or closed at intake, 30.2% were handled formally, and 17.0% were handled informally. Of the 6,143 cases that were handled formally, 90.4% involved delinquent offenses, 1.7% involved CINS, and 7.8% involved CINA or special proceedings. Among the disapproved or closed at intake cases, 88.7% involved delinquent offenses, 10.2% involved CINS, and 1.1% involved CINA or special proceedings.
