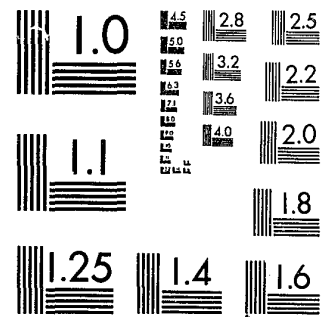

INTRODUCTION

This report is a description of population movements into, among, and out of the Massachusetts Correctional Institutions during the year 1976. This is the last in a series of four annual statistical reports prepared by the Research Unit of the Massachusetts Department of Corrections.¹ The tables contained in this report were derived from the data base developed by the Correction and Parole Management Information System (CAPMIS) and produced on the Massachusetts State College Computer Network (MSCCN).

Table I describes the types of admissions into the Massachusetts Correctional Institutions. Table II describes the types of releases out of the institutions. Table IIIA and IIIB details the institutional transfers among the Departments' institutions. Table IV documents returns from houses of correction to the prisons. Table V characterizes inmates received from county facilities to the state institutions for the first time. Table VI describes transfers from MCI's to county facilities. Transfers to a house of correction on a from and after sentence are characterized in Table VII. These include both paroles and good conduct discharges to from and after sentences. Table VIII includes both transfers to and transfers from other states. These include temporary transfers (i.e., parole hearings, awaiting trial, etc.) as well as commitments, releases by authority of other states, and paroles and discharges to other state authorities. Tables IX and X describe returns from and releases to hospitals, respectively.

¹ Unlike the 1976 commitment report and the 1976 releases report, data for individuals with two or more commitments or releases during the year, have been included in these tables.
