INTRODUCTION

The following Directory of Criminal Justice Journals was compiled by the Information Center of the National Council on Crime and Delinquency, from journals received by the NCCD Library. The annotated listing includes journals published by and for various groups with an interest in the criminal justice system. The journals included in general deal exclusively or predominantly with criminal justice issues and many focus on one specific aspect of the criminal justice system, such as correction or the police. The majority of the journals listed are U.S. publications. Included are selected foreign journals that are most likely to be of interest to an American audience.

Entries have been divided on the basis of subject matter emphasis:

- (1) abstracting services--journals abstracting world-wide literature on all or selected criminal justice issues
- (2) criminology and criminal justice journals--journals that cover the spectrum of criminal justice issues
- (3) law journals--journals that focus on criminal law and its application
- (4) university law reviews--journals published by law schools that generally treat all legal issues
- (5) law enforcement and police journals--journals concentrating on law enforcement issues and activities
- (6) correctional journals--journals addressed to various aspects of the correctional system
- (7) journals on juvenile delinquency and the juvenile--journals on criminal justice issues affecting juveniles and on the causes and treatment of delinquency
- (8) journals on victimology--journals emphasizing the victim and his place in the criminal justice system
- (9) behavioral journals--journals emphasizing sociology, social work, psychiatry, psychology, and medicine that frequently contain information pertinent to the criminal justice system
- (10) journals on related social issues--journals concentrating on alcoholism, drug abuse, homosexuality and suicide.

Each bibliographic citation contains the journal title, Publisher and address, frequency of publication and subscription information, and a brief annotation. The annotation describes the issues emphasized by each journal, mentions items of special interest, and includes topics of recent articles to indicate the scope of the publication. The following abbreviations have been used to indicate frequency of publication: A-annual, B-every two months, M-monthly, Q-quarterly, and T-three times per year.

An international abstracting service emphasizing European literature on the etiology of crime and delinquency, the control and treatment of offenders, criminal procedure, and the administration of justice. Each issue is indexed by author and subject. Annual cumulated indexes and a list of journals regularly abstracted appear in the final issue of each year.

Abstracts on Police Science. B; fl. 144.25 (\$55/US) Kluwer B.V. Box 23, Deventer, The Netherlands

An international abstracting service emphasizing European literature on police science, the forensic sciences, and forensic medicine. Each issue is indexed by subject and author. Annual cumulated indexes and a list of journals regularly abstracted appear in the final issue of each year.

An international abstracting service emphasizing current U.S. literature on law and the courts, law enforcement and the police, juvenile delinquency and the delinquent, crime and the offender, correction, drug abuse, and related social issues. In addition to abstracts, contains a section highlighting new research findings and unusual and imaginative programs; literature reviews on specific subjects, such as hidden crime, victimless crime, diversion, and depopulating the jails; and questions and answers on inquiries of wide interest. Detailed subject index in each issue, cumulated annually.

CRIMINOLOGY AND CRIMINAL JUSTICE JOURNALS

Acta Criminologica. A; \$5. University of Montreal Press, Case Postale 6128, Montreal 101, Quebec

An annual bilingual (English/French) review of anti-social behavior. Each issue contains a monograph, two to three theoretical or empirical articles, and a critical examination of the Canadian justice system in the judicial, police, and correction sectors. An article on comparative criminological research analyzes pertinent research projects. Summaries appear in English, French, Spanish, German, and Russian. Recent issues have concentrated on robbery and violence and middle class delinquency.

Acta Criminologiae et Medicinae Legalis Japonica. Japanese Association of Criminology, Tokyo Medical and Dental University, 1-Chome, Yushima, Bunkyo-Ku, Tokyo, Japan

Articles and research studies on criminology and the forensic sciences. The emphasis is on Japanese studies; included are English, French, and German articles.

Australian and New Zealand Journal of Criminology. Q; \$A9/nonmembers. Southdown Press, 32 Walsh Street, Melbourne, Victoria, 3001, Australia

General criminological journal containing original papers and book reviews. Emphasis is on criminology in Australia and New Zealand. Indexed annually. Recent topics have included patterns of criminality in New South Wales, recidivist youth, the deterrent effect of fines and probation, international terrorism, and the possible criminal use of atomic or biochemical materials.

Emphasizes delinquency and deviant social behavior. Contains articles, notes, and extensive reviews of new publications. A reference section lists new periodical citations in criminology, penology and social work, psychiatry, psychology, and sociology, as well as official (Her Majesty's Stationery Office) publications. Annual index. Recent topics have included British areal studies of crime, a follow-up study of bright delinquents, juvenile delinquency among Asians and half-Asians, and becoming prostituted.

California Youth Authority Quarterly. Q; \$3. California Youth Authority, 714 "P" Street, Sacramento, Calif. 95814

Articles on all aspects of criminal justice, recently including lie detection, women in correction, the dilemma of security, youth center research problems, and a Los Angeles police department diversion program. Not necessarily restricted to California although many articles discuss California projects and programs.

Canadian Journal of Criminology and Corrections (formerly Canadian Journal of Corrections). Q; \$10, \$7/students. Canadian Criminology and Corrections Association, 55 Parkdale Avenue, Ottawa K1Y 1E5, Ontario, Canada

Containing both theoretical and practical articles, this journal is an information source for criminological work and thinking in Canada. Contains book reviews and the working papers of the Law Reform Commission of Canada. Bilingual (English/French). Indexed annually. Recent articles have been on confidentiality in correctional institutions, mentally abnormal offenders in a Toronto jail, probation effectiveness in Alberta, a classification of the asocial personality, and American military deserters in Canada.

Crime and Delinquency. Q; \$25. National Council on Crime and Delinquency, Continental Plaza, 411 Hackensack Avenue, Hackensack, N.J. 07601

Information on all aspects of the criminal justice system, including juvenile, family, and criminal courts; law enforcement; and correctional institutions. Articles with abstracts, book reviews, a listing of books received, and news briefs and notes. Publishes NCCD policy statements and resolutions. Annual index. Representative articles have discussed imprisonment for the nondangerous offender, the death penalty, correctional study in higher education, the medical model of delinquency, pre-arrest diversion, and racial discrimination in urban police departments. Annual article on legislation and court decisions.

Crime and Social Justice: A Journal of Radical Criminology. Twice yearly; \$10/institutions, \$6/individuals. 101 Haviland Hall, University of California, Berkeley, Calif. 94720

The only radical journal of criminology in the U.S., committed to a search for socialist solutions to the crime problem. Articles on topics such as the repression of criminology, prospects for a radical criminology in the United States, and LEAA--a case study in the development of an industrial complex. Includes book reviews, lists publications received, and publishes course outlines accompanied by an extensive survey of the literature or an annotated bibliography.

Crime Punishment and Correction (Misdaad Straf en Hervorming). T; R.2 (\$4.50/US) National Institute for Crime Prevention and Rehabilitation of Offenders, P.O. Box 10005, Cape Town 7905, South Africa

Bilingual (English/Afrikaans) international criminology journal. Articles and book reviews. Recent topics: sentencing--the training of judicial officers, investigation and prosecution of crime, corporal punishment and juvenile justice, victimology, crime and the African prison reform in Sweden and Denmark, and a symposium on the cause of crime in urban society.

Criminologie. Annual or semi-annual; \$8. Les Presses de l'Université de Montréal, Case Postale 6128, Montreal 101, Quebec, Canada

A theme-oriented review emphasizing different criminal justice issues. The most recent concentrates on juvenile delinquency in Quebec.

Criminologist. Q; £ 3 (\$8/US); by subscription only to official or professional organizations in law enforcement, criminology, law, forensic science, and medicine; not sold or distributed to the general public. Forensic Publishing Co., 9 Old Bailey, London EC99 1AA, England

Authoritative views on all matters related to crime and criminology, emphasizing the police, law, forensic science, and criminology. Articles, brief book reviews, and case notes. Recent articles: post-mortem identification, forensic pathology, assessment of a doctor as a forensic witness, an analysis of child murderers, and the pathologist and sexual crime.

Criminology: An Interdisciplinary Journal (formerly Criminologica). Q; \$20/institutions, \$15/individuals. Sage Publications, Inc., 275 South Beverly Drive, Beverly Hills, Calif. 90212

The official publication of the American Society of Criminology, this journal is interdisciplinary in nature and is devoted to crime and deviant behavior as found in sociology, psychology, psychiatry, law, and social work, as well as urban design, systems analysis, and decision theory. The emphasis is on empirical research and scientific methodology. Also included are articles which review the literature or deal with theoretical issues. Contains articles with abstracts and short research notes. Recent articles: the female homicide victim, behavioral approaches to treatment in crime and delinquency, prisonization as an inhibitor of effective resocialization, and a static-descriptive model of field supervision.

Federal Probation. Q; free. Administrative Office of the United States Courts, Supreme Court Building, Washington, D.C. 20544

All phases of preventive and correctional activities in delinquency and crime. Regular sections review legislation, contain abstracts of professional periodicals, and give personnel and conference news. Extensive book reviews. Recent articles: the mentally retarded probationer, the federal probation system, an inmate grievance mechanism, and education for correctional careers.

Indian Journal of Criminology. Twice yearly; \$6. 5, Valliammal Street, Madras 600 010, India

The official publication of the Indian Society of Criminology, this journal publishes articles on all aspects of criminology, the criminological sciences (criminal biology, psychology, sociology, and penology), and the subsidiary sciences (forensic science, forensic medicine, and judicial psychology). The majority of articles concentrate on India. Recent topics: ethics of licensing brothels, diagnosis and correctional services in crime, legal aid, personality patterns among delinquents, and the functions of the juvenile court in India.

International Annals of Criminology (Annales Internationales de Criminologie/Anales Internacionales de Criminologia). Twice yearly; with membership. International Society of Criminology, 4, rue de Mondovi, 75001 Paris, France. In U.S.: c/o Marvin Wolfgang, Center for Studies in Criminology and Criminal Law, University of Pennsylvania, Philadelphia, Pa. 19104

A compendium of writings, with text in English, French, and Spanish, on all aspects of criminology, such as clinical and therapeutic applications, legislation, statistics, education, and prevention. Book reviews.

International Journal of Criminology and Penology. Q; £8.60, (\$23.50/US) Academic Press Limited, 24-28 Oval Road, London NW1, England. In U.S.: Academic Press, Inc., 111 Fifth Avenue, New York, N.Y. 10003

Articles on all aspects of criminology and penology. Book reviews. Recent topics: racial-ethnic identification in prisons, work release in Belgium, the homosexual as a crime victim, the delinquent label and its effect on future behavior, and white-collar crime.

International Review of Criminal Policy. Irregular; \$6. United Nations, Department of Social Affairs, New York, N.Y. 10017

Discusses applied criminological sciences, in English, French, or Spanish. A recent issue was devoted to human resources in the policy of the prevention and control of crime and treatment of offenders, including research and utilization of manpower in social defense, major nongovernmental organizations working in social defense, and recent international meetings dealing with criminal policy.

Issues in Criminology. Twice yearly; \$8/libraries and institutions, \$6/individuals. University of California School of Criminology, 101 Haviland Hall, Berkeley, Calif. 94720

A social science journal in the area of criminology and correction, with articles and book reviews. Recent topics have included channeling lawyers--the careers of public defenders; gang youth and hustling--the psychology of survival; racism; prisoners' rights; and the eugenics movement--some insights into the institutionalization of racism.

Journal of Criminal Justice. Q; \$25/individuals, \$10/students. Pergamon Press, Inc., Maxwell House, Fairview Park, Elmsford, N.Y. 10523

An international journal for the dissemination of new information, ideas, and methods to criminal justice academicians and practitioners. Covers all aspects of the criminal justice system, emphasizing integrating the functioning of the individual elements of the system. Of special interest are papers reflecting the application of new disciplines or analytic methodologies to criminal justice problems. Contains articles with abstracts, book reviews, notes, current publications abstracts, a list of publications received, and Academy of Criminal Justice Sciences news and notes. Recent topics: measurement problems in official and survey crime rates, effects of increased security on prison violence, and a statistical analysis of urban homicide.

Journal of Criminal Law and Criminology. Q; \$18.50/institutions, \$15/individuals, \$9/law students. Williams and Wilkins Co., 428 East Preston Street, Baltimore, Md. 21202

Comprehensive, in-depth coverage of criminology and criminal justice topics. (1) A criminal law section analyzes all issues in this area with articles by authorities as well as student comments. Recent analyses have included procedural safeguards for involuntary civil commitments of the mentally ill and the exclusion of young adults from juries. Included in this section are a review of recent trends in criminal law and an annual Supreme Court review. (2) A criminology section emphasizes reports of original research. Recent papers have discussed the research and policy implications of general prevention, the effect of incarcerating juvenile offenders on reducing crime, self-reported delinquency--a comparison of structured interviews and self-administered checklists, and an assessment of work furlough as an alternative to incarceration. Included in this section are occasional symposia such as one recently published on the measurement of delinquency. (3) A section of brief research notes is intended to provide as much exposure as possible to the results of current research in criminology, criminal law, and related fields. Notes have reported research examining the effect of institutionalization on a delinquent's self-concept and public opinions toward legal sanctions for violent crime. (4) A book review section contains both article-length and shorter reviews.

Recent topics: the impact of behavior modification and transactional analysis on institution social climate, female delinquency--an application of self and opportunity theories, application of crime seriousness information in police departments, and social relations among inmate addicts.

Original research of interest to justice planners and administrators. Reviews empirical research and evaluates policy innovations. Articles, book reviews, and case comments. The journal of the Scandinavian Association of Criminalists. Emphasizes criminology and criminal justice issues in the Scandinavian countries. Text in Danish, Norwegian, and Swedish.

Prison Journal. Twice yearly; \$2. Pennsylvania Prison Society, Social Building, Room 302, 311 South Juniper Street, Philadelphia, Pa. 19107

Each issue focuses on and critically examines one aspect of criminology or penology, such as the death penalty, prison education, preventive detention and bail, and key issues in correction--behavior modification, parole, alternatives to traditional institutions. Book reviews. Annual index.

Discusses criminological problems and the administration of prisons. Articles are in Italian, with summaries in Italian, English, French, German, and Spanish. A summary of each volume is issued annually in Chinese. Recent articles have discussed cross-sectional surveys of student drug use in Toronto; attitudes toward drug users and the use of alcohol, tobacco, and cannabis on the campus of a provincial university; and drug abuse and its prevention as seen by the international legal profession.
