P R E F A C E

The information in this publication was compiled by the Research and Reporting Unit, Division of Program Development and Evaluation. The report was prepared by Zona G. Jackson, Statistician. Typesetting and graphics were done by Sharon S. O'Keefe, Graphic Artist Illustrator. Coordination and review were done by Helen S. Hinshaw, Reporting Supervisor.

This report covers commitments to county and city jails and city jail farms; it should be noted that this confinement in jail does not reflect whether a person has been judged innocent or guilty. A separate commitment is reported each time a person is confined in jail on a charge of having violated a law or an ordinance, for being inebriated or insane, as a material witness in a criminal case, for investigation, for protection, or for any other reason. The confinement may be before or after adjudication of the case in which the prisoner is involved. A person who is recommitted after being released on bond or otherwise released is reported each time he is placed in jail.

The statistics in this report were obtained from the forms DC-J6—Record of Prisoners Confined. These forms are submitted monthly by the individual jails and jail farms to the Virginia Department of Corrections, Division of Finance, Jails Reimbursement Unit. The primary purpose of these documents is to serve as a basis for determining costs of operation and the amount of State reimbursement to local jails and city jail farms. To serve the secondary function, that of providing statistical data, the forms are then transferred to the Electronic Data Processing Unit for editing and computer processing.

Data from similar annual jail reports are available back to 1943 and copies of more recent annual jail reports are available for fiscal years 1970 through 1980. All questions, remarks or requests relating to the report should be directed to the following agency:


**Commitments to County and City Jails and City Jail Farms  
Fiscal Year Ending June 30, 1981**

*During fiscal year 1981 there were 189,056 commitments to county and city jails and city jail farms. This represents a 4.2% increase over commitments during 1980 (181,454).*


**RACE AND SEX**

Among the jail commitments, 65.8% were white and 34.2% were nonwhite. The number of males received was 170,997 or 90.4%. The number of females was 18,059 or 9.6%. This has not changed from last fiscal year when females comprised 9.6% of the commitments.

**MALES**




**FEMALES**



#### AGE

Last fiscal year there were 3,975 persons committed who were under age eighteen. During fiscal year 1981, 1.9% of the commitments (3,654) were in this category, which represents an 8.1% percent decrease since last year.





#### OFFENSE

An analysis of the offenses for fiscal 1981 shows that Offenses Against Decency, Peace and Good Order were the most frequent (59,717 or 31.6%); traffic offenses ranked second, with 40,114 or 21.2%.


Specifically, the most common offenses were Drunkenness/Drunk and Disorderly, which represented approximately one quarter of all commitments (26.3%). The second most frequent offense was Driving Under the Influence of Intoxicants (13.8%).

Incarceration for violations of the narcotic laws accounted for only 6,636 commitments or 3.5%. This represents a slight decrease from last fiscal year, when 3.6% of the commitments were in this category.




#### TYPE OF OFFENSE

Of the total commitments, more than half were charged with misdemeanors (110,959 or 58.7%), which is an increase from last year when 55.0% were committed for misdemeanors. The persons committed on local ordinances ("other offenses") numbered 39,223 (20.7%) while 38,874 persons (20.6%) were charged with felony offenses.



#### PLACE COMMITTED FROM

Virginia counties accounted for 52.0% of the jail commitments and the cities accounted for 48.0% of the commitments. Of the 98,241 commitments from the counties, Fairfax had by far the greatest share, with 13,486, Arlington committed 5,407 and Prince William committed 5,334 prisoners. Of the 90,815 city commitments, Richmond had 16,092, Norfolk had 14,246, and Newport News had 10,311.



#### CAPACITY AND POPULATION ANALYSIS

The average of the rated capacities for all of the jails in Virginia is 56 beds. The total rated capacity for all of the jail facilities was 5,387 on June 30, 1981. In comparison, the average daily population for a Virginia jail facility was slightly more than this average rated capacity. During fiscal year 1981 the average population was 60.0 persons, which is an increase from fiscal 1980 when the average population was 50.0 persons.

The average number of commitments during fiscal year 1981 for the 97 jail facilities was 1,949, which is an increase over the 1980 average of 1,871 commitments. The average prisoner days in 1981 was 21,771 days as compared to 18,319 days for fiscal year 1980. The average number of commitments is rising and the average length of confinement per prisoner increased slightly during fiscal year 1981. The average length of stay per commitment during fiscal 1981 was 11.2 days. Last fiscal year the average length of stay was 9.8 days.

There were 46 jails that recorded more total prisoner days than capacity days available. There were 320 days during fiscal year 1981 when the total number of inmates for all Virginia jails exceeded the total State capacity.




Figure 1: Jail Commitments - Ten Year Comparison




Figure 2: Prisoner Days - Ten Year Comparison

**DESCRIPTION**

*Rated Capacity* is extracted from the Population Survey of Local Correctional Institutions. It is the design capacity of each jail and does not necessarily represent the number of beds in the jail.

*Maximum* is the highest recorded population for each jail during the fiscal year.

$$40 \times 365 = 14,600$$

*Capacity Days* are determined by multiplying the rated capacity of each jail by 365 days.

*Actual Prisoner Days* are the total number of prisoner days recorded by each jail for the entire fiscal year.

$$14,600 - 12,699 = 1,901$$

*Net Difference* is recorded as positive when the rated capacity is greater than the total prisoner days. Jails with negative numbers are therefore overcrowded.

$$1,901 \div 14,600 = 13.0\%$$

*Percentage Difference* is the net difference divided by the capacity days.

*Days Above Rated Capacity* are the number of days during the fiscal year that the number of prisoners being held exceeded the rated capacity.

$$90 \div 365 = 24.7\%$$

*Percent of Year Over Capacity* is the number of days over capacity divided by 365, the total days in a year.

*Average Daily Population* is actual prisoner days divided by 365 days.

$$\frac{34.8 \times 100,000}{31,700} = 109.8$$

*Rate of Incarceration* is expressed as average daily population divided by the county/city population. The rate is expressed per 100,000 residents.

$$\frac{40 \times 100,000}{31,700} = 126.2$$

*Capacity/Population Ratio* is the rated capacity of the jail divided by the population of the areas served.
