

The National Offender Services Coordination Program is funded by the U.S. Department of Labor, Employment and Training Administration, and sponsored by the American Bar Association, Commission on Correctional Facilities and Services. NOSCP is a technical assistance effort to stimulate new and accelerated offender services through prime sponsor agencies designated under the Comprehensive Employment and Training Act of 1973, as amended.

NOSCP is an umbrella program with three functional units: the Clearinghouse on Offender Employment Restrictions, the Female Offender Resource Center, and the Pretrial Intervention Service Center. The programs address such subjects as the disabilities of conviction and incarceration, employer attitudes and perceptions, different treatment of male and female offenders, and alternatives to incarceration. In addition, NOSCP maintains a clearinghouse information exchange to compile data on all existing offender service programs.

Most authorities agree that the lack of meaningful employment opportunities for former offenders has been a major contributing cause to the rising crime rate and the high rate of recidivism, and, in turn, to the increasing cost of crime. Unless assimilation into communities is facilitated by the availability of suitable jobs, corrections will continue to be a wasteful and high cost "revolving door" system under which non-dangerous offenders serve what is virtually a life sentence on the installment plan—largely because of the obstacles in the way of stable, worthwhile employment.

One of the many obstacles to offender employment is the scant information available on the community organizations that offenders can turn to for assistance in their job search. Corrections officials and manpower program operators are also often unaware of the offender job development resources available in their states or communities to whom they can refer their job-ready clients.

This directory is intended to help fill this void. It lists by state those programs and organizations, of which the Clearinghouse is aware, that have indicated their interest in helping the ex-offender—or special groups of former offenders—find meaningful employment. The directory does not, however, attempt to list those programs providing services other than job assistance, nor does a listing herein intend to confirm the effectiveness of an organization's job development or placement activity.

The directory was prepared by the Clearinghouse on Offender Employment Restrictions as a resource for job leads for the ex-offender and for those agencies and programs providing job preparation and support services to the former offender.

Another resource that should not be overlooked in a job search is the local office of a state's department of employment security. These offices, which are listed in a telephone directory, can be the source for many job leads.
