

INTRODUCTION

Decisions effecting the State's criminal justice process are made on many levels many times each day. Executive policy makers determine agency direction or goals; administrators organize methods to meet their agencies' responsibilities; supervisors select work assignments; even line personnel utilize discretion in completing their day-to-day tasks.

While most of these determinations are made without issue, criminal justice decision-makers on all levels have identified problems and concerns related to their agencies' role within the criminal justice process. These identified issues--as well as others not yet identified--impede or otherwise delimit agencies' services, administration, or operational effectiveness. Such problems pose a particular dilemma to Florida's system of criminal justice administration as the majority of these individual agencies do not have the resources--either manpower or monetary--to individually address or adequately resolve many of these issues.

Historically, the State's Bureau of Criminal Justice Assistance has provided limited help to many of these agencies by providing technical assistance and by the administration of flow-through federal funds to support individual activities addressing identified problems. However such assistance is limited to the extent of the Bureau's personnel resources and the limited and currently decreasing availability of federal funding support.

The results of limited agency internal resources and external state and federal assistance are clear. Many criminal justice decision-makers face policy and procedural issues on a daily basis with less than adequate

information upon which to base their actions--actions which nonetheless must be taken.

It must also be noted that many of these issues are not unique to a single agency or even discrete to one criminal justice subsystem. In such instances, even if one agency's resources do allow them to address an identified problem, they may be the exclusive beneficiary of the research effort, though development and utilization of their findings might significantly benefit other agencies with similar problems.

At the same time but from a different direction, some of these issues, concerns and problems facing criminal justice decision-makers have also been identified and/or addressed by academic resources of Florida's public universities. These resources include not only the recognized criminal justice or criminology programs found at each of Florida's nine public universities, but also resources from other academic disciplines with speciality areas in or applications to the criminal justice field, such as psychology, social work, public administration, computer/information systems, or management. In such coincident cases, however, while the resultant findings have been occasionally utilized by practitioners, due to the lack of systematic articulation between the state's criminal justice agencies and universities, many of these efforts result in little more than reported findings collecting dust on some university or agency bookshelf.

Acknowledging decision-maker needs, the National Advisory Commission's Task Force on Criminal Justice Research and Development (1976) noted that the main role of research and development in criminal justice is to "generate and apply new knowledge to criminal justice practice." To a large degree then, such efforts--both practitioner and academic--to provide decision-makers with information to allow them to make more informed choices,

comprise activities subsumed under the general heading of applied research.

Such activities likewise fall within the recognized scope of the research and service components of educational outreach as identified by Florida's system of public higher education. As Florida's Commission on Educational Outreach and Service's report, Access to Knowledge (1976), clearly indicates, applied research is "needed to construct new approaches to social and technical problems." This commission also recommended the initiation of service mechanisms to apply and use knowledge so generated.

What clearly emerges is a need for criminal justice decision-makers to have available more and better information. This need can be addressed, in part, by developing and coordinating available, yet under-utilized, academic and agency resources to provide all criminal justice agencies better access to assistance, information, and activities in applied research directed toward addressing pragmatic issues.

This SOURCEBOOK has been organized in two parts to assist criminal justice agencies address this need. First, by briefly examining and assessing educational resources of the state's public universities (which may be engaged to assist in the resolution of practitioner identified research issues, and making comments and recommendations on strategies which serve to more successfully integrate the science and practice of criminal justice in Florida. Secondly, by identifying existing Florida-related research and informational resources currently available to practitioners to support their agencies' research and development needs.

Part I identifies the academic resources of the State University System which may be cooperatively developed by criminal justice practitioner agencies. Such potential resources are not limited to university faculty and staff--both graduate and undergraduate students represent significant

manpower reserves which may be utilized in addressing agency identified problems. This section also comments on the formal and non-formal activities which currently link academic resources of the State University System and Florida's criminal justice agencies. In addition, recommendations to assist agencies in developing educational research support are provided and possible strategies identified.

Part II indexes publications, documents, research findings, and other materials which have been identified as addressing problems and issues of specific interest to Florida's criminal justice practitioners. These include articles and published research findings of state university criminal justice faculty as well as faculty of other disciplines addressing criminal justice related topics, selected criminology/criminal justice graduate theses and dissertations in the area of applied research, and other miscellaneous publications. This latter category consists of numerous reports sponsored by individual state agencies, state-wide assessments, nationally sponsored program reports and articles focusing on components of Florida's criminal justice process, and applied research studies undertaken by other state agencies and educational institutions.

PART I. EDUCATIONAL RESOURCES

For the state's nine public universities, general responsibilities for research and service activities are clearly defined by current Board of Regents' general policy guidelines (1978). In considering the research function of the universities, these guidelines view applied research programs as an integral component within the total scope of university research efforts and specifically note that "some applied research at each university will be directed at the problems of its particular service area."

Even more succinct is general policy addressing public service: "to offer the citizens of Florida access to the expertise of its faculty and to its unique educational resources" including "the synthesis and dissemination of research results and knowledge and other information that will assist in improving social, economic, political and cultural conditions."

This section identifies academic resources of interest to criminal justice agencies which may be developed within these policy guidelines to provide research or service support in addressing practitioner identified issues and problems. As discussed throughout this section, the State University System of Florida is comprised of nine institutions which are identified in figure 1.

Criminal Justice Resources

All of the nine state universities have identified criminal justice academic degree programs, though these programs are quite diverse in size and scope. They range from more than 700 undergraduate majors (mostly

full-time, pre-service students) and graduate programs supported by over 17 full-time faculty, to programs with less than 100 majors (mostly part-time, inservice students) with 3 or 4 faculty who may be shared with other academic units. This diversity is also reflected in their individual program emphasis--some with clearly identified career preparation structure, others toward a more traditional liberal education/inter-disciplinary social science orientation. A capsule description of the criminal justice programs at each state university, indicating the location of this academic unit within the institution, the degree(s) offered, size of faculty, and program emphasis, is provided in table 1.

Fifty-eight faculty representing these nine criminal justice programs have been identified and the research and service interests and previous criminal justice practitioner experience of each assessed. An index of these interest areas and faculty is listed in table 2.

For more detailed information about an individual faculty resource, the interest index is immediately followed by table 3 which provides a brief profile for each faculty member including his or her current position and institution, academic degree(s), research and service interests, and any previous criminal justice related experience.

These fifty-eight faculty unquestionably represent a most valuable reservoir of knowledge and research skills, however, the impact of any one faculty--regardless of individual commitment to practitioner agency support through applied research and service--is bounded by the time each has available for such efforts beyond required academic assignments. Given this reality and the hundreds of practitioner agencies and institutions comprising Florida's criminal justice system in potential competition for such fixed resources, it is clear that development and impact of such faculty resources is limited.

While criminal justice faculty have unique qualifications and expertise which may be cooperatively developed to address practitioner identified issues and problems, surprisingly such sophisticated technical competencies are often not required. In many instances, agency decision-makers face issues that are quite pragmatic, their resolution identified yet unresolved, with the singular impediment a lack of resources (manpower or monetary). If practitioners facing such problems agree that voluntary assistance from other resources familiar with the criminal justice process who possess rudimentary research skills could reasonably address many such practical issues, an additional manpower reserve of considerable depth becomes available--undergraduate and graduate criminal justice students.

Criminal justice students--the primary product of the state universities' criminal justice programs--can provide much needed research and service support to Florida's operating criminal justice process. At the undergraduate level, these "research resources" can be developed through existing programs for student field placements, practicums, or internships found at each institution. Each academic year, more than 500 undergraduate students from the nine criminal justice programs participate in such structured field placements within Florida's criminal justice process. While such internships were originally conceived to allow student placements with agencies to closely examine operating components of the criminal justice system and the application of criminological theory to criminal justice practice, the student's role in such programs is not necessarily limited to passive observation.

Most field placement coordinators enthusiastically welcome new placement opportunities that will not only allow student participants to observe, but also interact with agencies through meaningful activities. Agencies are

encouraged to initiate contact with these faculty coordinators (see table 4) to discuss the development of student resources.

At the graduate level, the number of students is quite small and field placements with criminal justice agencies a rare occurrence. However, in the Master's programs at Florida International University (Miami) and the University of South Florida (Tampa), and both the Master's and doctoral programs at Florida State University (Tallahassee), students are increasingly interested in doing required research related to the needs of the operating criminal justice system which may have application and utility. Clearly the development of such interests towards addressing practical system needs could be most beneficial to an agency. Development of such graduate student resources is best initiated through faculty who have a related interest and may chair or serve on the graduate supervisory committees of such potential student resources.

Other University System Resources

It is clear that academic resources of interest to criminal justice decision-makers which may assist them in addressing identified issues or problems are not limited to criminal justice faculty and students. Problems facing administrators of criminal justice agencies may be more appropriately addressed by university resources representing academic programs in management, public administration, urban and regional planning, information systems/computer sciences, or the large human service area including components of psychology, social work, counseling, etc. In addition to the faculty resources

which may be developed, many of these programs--particularly public administration, urban and regional planning and human services--also provide students with field experiences through structured placements or internships.

Community Colleges and Private Institutions

Throughout Florida, all of the state's public community and junior colleges--with the single exception of North Florida Junior College at Madison--have identified criminal justice academic programs. These twenty-seven programs are quite diverse in size and scope though the majority are directed primarily toward career preparation and development of pre-service and inservice criminal justice personnel.

In addition, seven private colleges and universities in Florida also have recognized criminal justice academic programs. Undergraduate programs in criminal justice are offered at Bethune-Cookman College, Biscayne College, St. Leo College, and the University of Tampa. External degree/off-campus programs in criminal justice are offered at both the baccalaureate and Masters level by Nova University and Rollins College. Finally, a public administration graduate program leading to the MPA degree with concentrations in criminal justice and correctional management is offered by the University of Miami.

PART TWO. RESEARCH INDEX

While this index focuses on Florida-specific research, there is another excellent and ready resource for topic-related support for practitioner agencies at the national level--the National Criminal Justice Reference Service (NCJRS). Sponsored by the National Institute of Law Enforcement and Criminal Justice, this clearinghouse collects documents and materials from a wide variety of national and international sources. As all of its citations and descriptive abstracts are collected in a computerized data-base, in response to practitioner demand NCJRS has initiated a series of quite useful topical bibliographies addressing specific areas of interest.

A listing of currently available NCJRS SELECTED BIBLIOGRAPHIES follows, however it should be noted that new bibliographies are continually compiled based on practitioner needs.

PART II. RESEARCH INDEX

This section provides criminal justice practitioners a topical index for seeking information on problems and issues specifically related to Florida's criminal justice process or related research conducted by state university faculty and students. The index is divided into four major components: (1) Police Services, (2) Courts, (3) Correctional Services, and (4) Other Criminal Justice Topics. These first three areas, of course, directly correspond to the three major criminal justice subsystems of law enforcement, courts, and corrections (or rehabilitation). The "other criminal justice topics" category was established to catalog those resources with system-wide impact or interest (for example, Planning or Technology), or special areas which have been long recognized as requiring unique consideration (for example, Juvenile Justice or Substance Abuse).

Accordingly, within each of these four major components, publications, documents, research reports and findings, as well as other materials which have been identified as relevant to Florida's criminal justice efforts, are collected by identified sub-topic areas. Each entry is listed alphabetically by KEY-DESCRIPTOR within each sub-topic area. While it was not possible to cross-index these materials, each sub-topic area can be easily examined to determine the appropriateness of identified resources.

Police Services

The major category of Police Services contains research and publications related to the management, organization, and operations of law enforcement

agencies and activities including sub-topic areas related to (a) Administration, Organization and Operations, (b) Criminalistics and Forensics, (c) Investigations, (d) Offenses, (e) Patrol, and (f) Recruitment, Training, and Staff Development.

Courts

The major category of Courts identifies research and publications related to the organization and operation of the state's judicial process including sub-topic areas related to (a) Bail and Bond, (b) Defense, (c) Diversion Alternatives, (d) Management and Operations, (f) Prosecution, and (6) Trial Courts Structure and Procedures.

Correctional Services

The major category of Correctional Services lists research and publications related to the organization and operation of both adult and juvenile institutional and non-institutional correctional programs and activities including the sub-topic areas of (a) Alternatives to Institutionalization [Adult], (b) Alternatives to Institutionalization [Juvenile], (c) Classification, (e) Institutions [Adult], (f) Institutions [Juvenile], (g) Jails, (h) Management, (i) Probation and Parole [Adult], (j) Probation and Parole [Juvenile], (k) Recruitment, Training and Staff Development, and (l) Rehabilitation and Treatment.

Other Criminal Justice Topics

The major category of Other Criminal Justice Topics catalogs research and publications of a system-wide nature or impact, or which have been acknowledged as requiring individual consideration including sub-topic areas related to (a) Crime Deterrence, Prevention and Public Involvement, (b) Criminology, (c) Juvenile Justice and Juvenile Delinquency, (d) Planning, Evaluation and

Policy, (e) Reference and Statistics, (f) Substance Abuse, and (g) Technology, Research and Development.

Index Format

Within each of the sub-topic areas, the format used for each entry is headed by a KEY-DESCRIPTOR, followed by the TITLE or SUBJECT, AUTHOR/RESEARCHER, PUBLICATION/PUBLISHER or SPONSORING AGENCY, and, if available, a DESCRIPTIVE STATEMENT.


