

H I G H L I G H T S

- * Admissions to state juvenile correctional institutions during calendar year 1980 totaled 901 (815 males and 86 females) as compared with 1,030 (938 males and 92 females) in 1979. This is a 12.5 percent decrease from 1979 admission levels and continues a trend which began in 1979 following the adoption of Wisconsin's new Children's Code. The new code provides for community-based treatment of juvenile offenders except those found to be a danger to themselves or the public and in need of restrictive or custodial treatment.
- * A total of 815 boys were admitted to Wisconsin juvenile correctional institutions during calendar year 1980; 541 new admissions (including 12 state probation violators), 156 returns from aftercare, 114 returns from aftercare pending revocation hearing, 3 temporary admissions from probation pending revocation hearing, and 1 return from aftercare for replacement planning. The breakdown for the 86 girls admitted during the same time period is 59 new admissions, 15 returns from aftercare, 11 returns from aftercare pending revocation hearing, and 1 temporary admission from probation pending revocation hearing. (Tables 1 and 1-A)
- * Slightly over one-half (53 percent) of the juveniles admitted in 1980 came from the seven counties which make up the Milwaukee and Southeastern Regions. The Milwaukee Region accounted for one-third (33 percent) of all admissions, while one-fifth (20 percent) of all admissions were from the Southeastern Region which is made up of Kenosha, Ozaukee, Racine, Walworth, Washington, and Waukesha Counties. (Table 3)
- * The median age reported for all boys admitted during 1980 was 16.4 years as compared with 16.5 years in 1979. The median age for girls decreased to 16.1 years from 16.2 years in 1979. (Table 4)

- * Boys newly-admitted in 1980 had a median age of 16.3 years as compared with 16.2 years in 1979. The median age for newly-admitted girls remained at 15.9 years. (Table 5)
- * The median age of boys readmitted in 1980 was 16.7 years as compared with 16.9 years in 1979. The median age of readmitted girls also decreased from 16.8 years in 1979 to 16.4 years in 1980. (Table 6)
- * Slightly more than two-thirds, 68 percent of the boys and 67 percent of the girls, admitted during calendar year 1980 were white. One-fourth of the boys and slightly less than one-fourth (24 percent) of the girls admitted during the same period were black. (Table 7)
- * The most common offenses in which newly-admitted boys were involved prior to admission were burglary (36 percent), auto theft (21 percent), and other theft (14 percent). Theft (31 percent) and auto theft (17 percent) were the most common offenses in which newly-admitted girls were reported to be involved prior to commitment. (Table 10)
- * Two-thirds (67 percent) of the boys returned to the institutions from aftercare were reported to have been involved in law violations. This was true for slightly less than one-half (47 percent) of the girls returned from aftercare supervision. (Table 11)
- * It was reported that 34 percent of the newly-admitted boys as contrasted with 51 percent of the girls had acted alone when involved in delinquent behavior. (Table 12)
- * Slightly more than one-tenth (13 percent) of the boys and girls newly-admitted during 1980 had no record of prior official probation experience. Three-fifths of the boys (60 percent) and slightly over one-half (51 percent) of the girls had been supervised by county social service agencies prior to institutionalization. (Table 13)
- * Somewhat over three-fifths (63 percent) of the newly-admitted boys and a little more than four-fifths (81 percent) of the girls were reported to have had involvement with guidance clinics or other child-caring agencies prior to commitment to a correctional institution. (Table 14)

- * Two out of 10 newly-admitted boys and 3 out of 10 newly-admitted girls came from families receiving some form of public assistance. (Table 15)
- * Slightly more than two-fifths (43 percent) of the newly-admitted boys and about three-fifths (59 percent) of the newly-admitted girls had completed eight or less grades of school prior to commitment. (Table 16)
- * Achievement test scores were available for only three boys newly-admitted during 1980 while no scores were available for juvenile girls. (Table 17)
- * Six out of 10 (59 percent) of the newly-admitted boys for whom information was available were reported to have been functioning at normal or better than normal intelligence level upon admission. The same was true for 7 out of 10 (69 percent) of the newly-admitted girls for whom data were available. (Table 18)
- * Almost three-fourths (71 percent) of all boys and girls received as new admissions during 1980 were from 10 of Wisconsin's counties. About one-third (34 percent of the boys; 32 percent of the girls) were from Milwaukee County. Characteristics of juveniles newly-admitted from the 10 counties (Milwaukee, Kenosha, Racine, Rock, Dane, Brown, Waukesha, LaCrosse, Outagamie, and Winnebago) are shown in Appendix Table B.
- * The number of juveniles returned from aftercare or temporarily admitted to juvenile institutions from probation for replacement planning continues to be virtually non-existent. Department of Health and Social Services policy precludes admissions of this type. (Appendix C)
- * A comparison of admissions to juvenile institutions in 1979 and 1980 by sex and region can be found in Appendix D.
- * Milwaukee County's proportion of all types of juvenile admission for the period 1976 through 1980 can be found in Appendix E.
