H I G H L I G H T S

- * Admissions to state juvenile correctional institutions during calendar year 1981 totaled 806 (741 males and 65 females) as compared with 901 (815 males and 86 females) in 1980. This is a 10.5 percent decrease from 1980 admission levels and continues a trend which began in 1979 following the adoption of Wisconsin's new Children's Code. The new code provides for community-based treatment of juvenile offenders except those found to be a danger to themselves or the public and in need of restrictive or custodial treatment.
- * A total of 741 boys were admitted to Wisconsin juvenile correctional institutions during calendar year 1981; 556 new admissions, 91 returns from aftercare, 92 returns from aftercare pending revocation hearing, and 2 admissions without a Wisconsin disposition. The breakdown for the 65 girls admitted during the same time period is 53 new admissions, 5 returns from aftercare, and 7 returns from aftercare pending revocation hearing. (Tables 1 and 1-A)
- * Slightly over one-half (57 percent) of the juveniles admitted in 1981 came from the seven counties which make up the Milwaukee and Southeastern Regions. The Milwaukee Region accounted for one-third (35.4 percent) of all admissions, while one-fifth (21.5 percent) of all admissions were from the Southeastern Region which is made up of Kenosha, Ozaukee, Racine, Walworth, Washington, and Waukesha Counties. (Table 3)
- * The median age reported for all boys admitted during 1981 was 16.4 years, the same as in 1980. The median age for girls remained the same at 16.1 years. (Table 4)

* Boys newly-admitted in 1981 had a median age of 16.3 years, which was the same as in 1980. The median age for newly-admitted girls increased to 16.1 years from 15.9 in 1980. (Table 5)

* The median age of boys readmitted in 1981 was 16.7 years, the same as in 1980. The median age of readmitted girls decreased from 16.4 years in 1980 to 16.3 years in 1981. (Table 6)

* Approximately two-thirds, (69.8 percent) of the boys and 66.2 percent of the girls, admitted during calendar year 1981 were white. About one-fourth (24.1 percent) of the boys and one-fourth (24.6 percent) of the girls admitted during the same period were black. (Table 7)

* The most common offenses in which newly-admitted boys were involved prior to admission were burglary (45.7 percent), auto theft (14.9 percent), and other theft (12.9 percent). Theft (34.0 percent) and auto theft (15.1 percent) were the most common offenses in which newly-admitted girls were reported to be involved prior to commitment. (Table 10)

* About three-fifths (58.2 percent) of the boys returned to the institutions from aftercare were reported to have been involved in law violations. This was true for four-fifths (80.0 percent) of the girls returned from aftercare supervision. (Table 11)

* It was reported that 32.2 percent of the newly-admitted boys and 30.2 percent of the girls had acted alone when involved in delinquent behavior. (Table 12)

* Slightly more than one-tenth (11.1 percent) of the boys and about a twenty-fifth (3.8 percent) of girls newly-admitted during 1981 had no record of prior official probation experience. About one-half of the boys (46.4 percent) and slightly over seven-tenths (71.7 percent) of the girls had been supervised by county social service agencies prior to institutionalization. (Table 13)

* Nearly two-thirds (66.2 percent) of the newly-admitted boys and more than nine-tenths (94.3 percent) of the girls were reported to have had involvement with guidance clinics or other child-caring agencies prior to commitment to a correctional institution. (Table 14)

* Two out of 10 newly-admitted boys and about .2 out of 10 newly-admitted girls came from families receiving some form of public assistance. (Table 15)

* Almost one-half (48.2 percent) of the newly-admitted boys and slightly more than one-half (52.9 percent) of the newly-admitted girls had completed eight or less grades of school prior to commitment. (Table 16)

* Achievement test scores were available for only eight boys newly-admitted during 1981, while no scores were available for juvenile girls. (Table 17)

* One out of 2 (54.3 percent) of the newly-admitted boys for whom information was available were reported to have been functioning at normal or better than normal intelligence level upon admission. The same was true for 6 out of 10 (59.1 percent) of the newly-admitted girls for whom data were available. (Table 18)

* Almost three-fourths (72.9 percent) of all boys and girls received as new admissions during 1981 were from 10 of Wisconsin's counties. About one-third (35.9 percent) of the boys and less than one-fifth (17.0 percent) of the girls were from Milwaukee County. Characteristics of juveniles newly-admitted from the 10 counties (Milwaukee, Kenosha, Racine, Rock, Dane, Brown, Waukesha, LaCrosse, Outagamie, and Winnebago) are shown in Appendix Table B.

* The number of juveniles returned from aftercare or temporarily admitted to juvenile institutions from probation for replacement planning was non-existent. Department of Health and Social Services policy precludes admissions of this type. (Appendix C)

* A comparison of admissions to juvenile institutions in 1980 and 1981 by sex and region can be found in Appendix D.

* Milwaukee County's proportion of all types of juvenile admissions for the period of 1977 through 1981 can be found in Appendix E.
