

INTRODUCTION

When the Missouri Juvenile Justice Association asked Patricia Dudley to compile a 1982 update of her SURVEY OF MISSOURI'S 1980 DETENTION PRACTICES, the question arose as to whether or not there had occurred enough changes to warrant a new survey. Since the 1980 Survey had been put to such good use around the state, it was decided that a 1982 revision was in order.

In 1980, Missouri had 14 Detention Centers. By June of 1982, Missouri had 22 Detention Centers in operation, and one more scheduled to open very soon. That totaled to nine new Detention Centers in two years time.

In 1980, 25 Judicial Circuits stated they used county or municipal jails, at least part of the time, for detention of juveniles. In 1982, only 13 Judicial Circuits answered that they detain in jail facilities. * That is a decrease of almost half.

Of those Judicial Circuits not having their own Detention Centers, at least eight Circuits stated they were now contracting with other Circuits for Detention Services. The Circuits having Detention Centers stated they were presently contracting with 17 Circuits (some circuits listed more than once) to provide them with Detention Services.

These changes were overwhelming. It seems Missouri's Detention Practices had changed drastically.

In 1980, Missouri's Detention Centers had the capacity for detaining 476-478 juveniles. By 1982, Missouri's Detention Centers had a capacity for detaining 571 juveniles.

In 1980, there were 163 full-time and 86 part-time Supervisory and Child Care Staff employed in Missouri's Detention Centers. By 1982, there were 203 full-time and 101 part-time (or equivalent) Detention Child Care Staff employed in Missouri.

The reader is encouraged to compare the 1980 and 1982 Surveys. It makes one very proud of Missouri's progress, and the work done by the judicial circuits around the state to improve Missouri's Detention Practices.

* No response was received from the 3rd Judicial Circuit.

SUMMARY INFORMATION

MISSOURI'S DETENTION INFORMATION

There are 23 judicial circuits, in the state of Missouri that have some form of a Detention Center. They are:

7th, 10th, 12th, 13th, 15th, 16th, 17th, 18th, 19th, 20th, 21st, 22nd, 23rd, 24th, 25th, 26th, 29th, 31st, 32nd, 33rd, 37th, 42nd, 43rd.

Twenty judicial circuits in the state of Missouri do not have their own Detention Centers. They are:

1st, 2nd, 4th, 5th, 6th, 8th, 9th, 11th, 14th, 27th, 28th, 30th, 34th, 35th, 36th, 38th, 39th, 40th, 41st, 44th.

(No response was received from the 3rd judicial circuit)

Of those Circuits not having their own Detention Center, 12 answered that they detained in jail facilities, and 8 answered that they contract with other circuits for Detention Services. Some do both. (See each Circuit's listing for individual circuit's Detention Practices.)


