# Report of Felon Escapes

## During the Fiscal Year Ended June 30, 1982

*The data compiled in this statistical report of escapes occurring in fiscal year 1982 were extracted from the felon files maintained by the Virginia Department of Corrections, Division of Adult Services, Classification and Records Unit. Statistics are not tabulated for felons whose escape charges were dismissed or not-prossed in court.*

### NUMBER AND RATE OF ESCAPES

There were 123 felon escapes from the Virginia Correctional System during the fiscal year ended June 30, 1982. While there was no increase in the number of escapes from fiscal year 1981 to 1982, there was a decrease from 14.8 to 13.9 in the rate of escapes per thousand confined population. The average number of escapes per year during the past ten years is 203. The proportion of the confined population to the total escapees has remained relatively constant. From fiscal years 1978 to 1981, it has ranged from 1.0% to 1.4% and in fiscal year 1982 it was 1.3%.

### RACE AND SEX

Of the 123 escapees, 91 or 74.0% were white males, 28 or 22.8% were nonwhite males, 1 or 0.8% was a white female, and 3 or 2.4% were nonwhite females. This compares to the total felon population on June 30, 1982, of 39.7% white males, 56.7% nonwhite males, 1.5% white females, and 2.1% nonwhite females. An analysis of the last ten years revealed that a majority of the escapees have been white males.

### MONTH ESCAPED, TIME OF DAY, AND ASSIGNMENT

The largest number of escapes during fiscal year 1982 occurred during the month of July, with 19 occurrences or 15.5%. There has been a consistent pattern during the past ten year period that most of the escapes occurred May through August, the warm weather months. As in the last six years, more than half of the escapes (71 or 57.7%) occurred between the hours of 9:00 a.m. and 5:00 p.m. From 1973 to 1980, the largest number of escapes occurred while inmates were working on the highway. During fiscal year 1981, the largest number of escapes (33 or 26.8%) occurred from correctional field units or major institutions, but escapes while working on the highway was a close second, accounting for 30 or 24.4%. During fiscal year 1982, there was a return to the previous trend of most escapes occurring while inmates were working on the highway (40 escapes or 32.5%). Escapes from the institutions was second with 34 occurrences or 27.6%. Escapes occurring by inmates on furlough accounted for 7 or 5.7% of all escapes. This represents a substantial decrease from fiscal year 1981 when 16 or 13.0% of escapes occurred while inmates were on furlough.

### PAROLE STATUS

Of the 123 escapees, 50 or 40.8% were not eligible for parole at the time of the escape. There were 34 or 27.6% who had been denied parole prior to their escape. Of these, 21 or 61.8% had been denied three or more months prior to the escape. Thirty-one or 25.2% of the escapees were parole violators, while during fiscal year 1981, 14 or 11.4% of the escapees were parole violators.

### **LENGTH OF SENTENCE**

During fiscal year 1982, the largest number of escapees were serving sentences of 6 years to 9 years 11 months, accounting for 29 or 23.7% of all escapes. This continues the trend started in fiscal year 1973. Escapees with sentences of 6 years to 14 years, 11 months accounted for almost half (53 or 43.1%) of all fiscal year 1982 escapes. In the total felon population, 1,491 felons or 16.2% were serving sentences between 6 years and 9 years, 11 months, while 2,969 or 32.3% were serving sentences between 6 years and 14 years, 11 months.

### **TIME SERVED PRIOR TO ESCAPE**

Of the 123 escapes, 48 or 39.0% occurred during the first and second years of confinement. As in the last ten years, over half of the fiscal year 1982 escapes (67 or 54.5%) occurred during the first three years of confinement.

### **TIME LEFT TO SERVE AT TIME OF ESCAPE**

At the time of escape, 66 or 53.7% of the escapees had less than 5 years remaining to serve. Of these, 9 or 13.6% had less than one year to serve, and 25 or 37.9% had less than two years to serve. There were 18 escapees (14.6%) who had detainers or were to be tried for other offenses.

### **AGE OF ESCAPEES**

As in fiscal years 1973 - 1981, this year the largest proportion of all escapes (44 or 35.9%) occurred in the age group of 20 to 24 years. There were 89 (72.4%) escapees who were under the age of 30. There has not been an escapee over the age of 49 since fiscal year 1979.

### **PREVIOUS RECORD**

Prior felony and/or misdemeanor sentences had been served by 61 escapees (49.6%). There were 38 or 30.9% who had an adult record but had not previously served a felony or misdemeanor sentence in a state correctional institution. Escapees with a juvenile record comprised 86 or 69.9% of the total, while 9 or 7.3% had no prior record of any kind. This year's statistics on previous felony and/or misdemeanor sentences and juvenile records continues the trend started in fiscal year 1973. Comparison to the total felon population shows that 3,890 felons or 42.3% had served prior felony sentences. Among the felon population, 474 felons or 5.2% had served prior misdemeanor sentences but had no prior felony record, and 4,973 felons or 54.1% had juvenile records.

### **PRIOR ESCAPES**

More than one third (42 or 34.2%) of all escapees in fiscal year 1982 had a history of one or more prior escapes. This year's 34.2% of escapees with a history of prior escapes, is the highest in ten years. Fiscal year 1973 had the second highest with 32.0%, while fiscal year 1979 had the lowest with 23.3%. There was one (0.8%) escapee who had escaped six times prior to the current escape.

## **OFFENSE**

At the time of escape, 49 escapees or 39.8% were serving sentences for Offenses Against Persons, while 61 or 49.6% were serving sentences for Offenses Against Property. The most frequent offense category among the total felon population on June 30, 1982 was Offenses Against Persons, representing 50.9% of the total confined population.

## **MARITAL STATUS**

As in the past ten years, over half (76 or 61.8%) of the fiscal year 1982 escapees were single. There were 21 or 71.1% escapees who were married. This compares with the total felon population on June 30, 1982 in which 61.8% were single and 16.2% were married.

## **MILITARY SERVICE AND AWOL RECORD**

There were 18 escapees (14.6%) who were known to have served in the military. Of these, 8 or 44.4% had a history of being AWOL one or more times.

## **CUSTODY STATUS**

Over half (67 or 54.5%) of the escapes were committed by inmates in under gun status. This has been a continuing trend since fiscal year 1977.

## **EDUCATION AND INTELLIGENCE**

Educational level of fifth grade or higher was reported for 83 or 81.4% of the 102 escapees who had been tested. An I.Q. of 90 (normal) or above was reported for 75 or 61.5% of the 122 who were tested. In comparison, 52.0% of the total felon population of June 30, 1982 who had been tested were fifth grade level or higher and 44.6% tested an I.Q. of 90 (normal) or above.

## **INSTITUTION**

Inmates assigned to correctional field units at the time of their escape accounted for a majority (89 or 72.5%) of all felon escapes. Statistically, for every 100 inmates assigned to correctional field units, 3.1 escaped. Among the major institutions, Powhatan Complex experienced the largest number of escapes (8 or 6.6%), but the Women's Halfway House accounted for the greatest rate (11.8) of escapes per 100 confined inmates. During fiscal year 1981, Southampton Complex had the highest number and rate of escapes (11 or 8.9% and 1.3 per 100 inmates) of all the major institutions.

## **TIME ESCAPEE REMAINED FREE**

Within 24 hours, 54 or 43.9% of the escapees were captured or had surrendered. Within 29 days, an additional 32 escapees or 26.0% were taken back into custody, resulting in 86 or 69.9% being captured or surrendering within 30 days. On an average, over the last ten years, 65.7% of all escapees were back in custody within 30 days.

## **CRIMES COMMITTED WHILE AT LARGE**

Fourteen or 11.4% of all escapees were known to have committed crimes while on escape. Auto Theft was the most prevalent crime committed, accounting for four occurrences.

### STATUS OF PARENTS

The parents of 34 or 27.6% of the escapees were married and living together. Forty-six or 37.4% came from homes where the parents were divorced, separated, or never married. There were 35 or 28.5% from homes where one parent had died. *It should be noted that all of these categories reflect parental status at the time the escapee was originally committed and not the status at the time of the escape.*

### SUBSTANCE ABUSE HISTORY

There were 87 escapees (70.7%) who had a history of liquor habits and drug use. Twenty-eight or 22.8% had been addicted to drugs, while 14 or 11.4% were heavy drinkers. There was only one escapee (0.8%) who had no record of drug or liquor use.

### EMPLOYMENT HISTORY

Prior to confinement for their current felony offense(s), 12 escapees or 9.8% had been steady workers, whereas 57 or 46.4% had only worked intermittently (less than 6 months employment in the 12 months prior to arrest). There were 26 or 21.1% who had only held odd jobs. There has been a decrease each year in the percentage of escapees who were steady workers. The percentage dropped from 75.5% in fiscal 1977 to the current level of 9.8%, a 65.7% decrease.

### PROFILE OF FISCAL YEAR 1982 ESCAPEES

The escapees for fiscal year 1982 were predominantly white males, 20 to 24 years of age, with a normal intelligence level (I.Q. 90 - 109), single, had a history of liquor habits and drug use, and had an intermediate educational level (5.0 to 8.9). Most escaped on Mondays between the hours of 9:00 a.m. and 5:00 p.m., during the month of July, while working on the highway and assigned to a correctional field unit. A larger portion of the escapees were recidivists with juvenile records, serving sentences of 6 to 9 years for Offenses Against Property, were not yet eligible for parole at the time of the escape and had escaped during the first two years of confinement. Most escapees had escaped at least once previously, were in under gun custody status, committed no known offense while on escape, and were recaptured or surrendered within 24 hours.




Figure 1: Comparison of Felon Escapes During the Past Ten Years, Fiscal Years Ended June 30, 1973 - 1982




Figure 2: Comparison of Felon Population on June 30, Fiscal Years 1973 - 1982
