P R E F A C E

The information in this publication was compiled by the Research and Reporting Unit, Division of Program Development and Evaluation. The report was prepared by Marilyn P. Davis, Statistician. Typesetting and graphics were done by Sharon S. O'Keefe, Graphic Artist. Coordination and review were provided by Helen S. Hinshaw, Reporting Supervisor.

This report, in previous years, covered only commitments to county and city jails and city jail farms during the fiscal year of the report. Since requests are received from some users of this report for statistics for all persons confined in these facilities regardless of when commitment occurred, the fiscal year 1982 report has been expanded to include a separate section depicting all confined during the fiscal year.

It should be noted that commitment to jail does not reflect whether a person has been judged innocent or guilty. A separate commitment is reported each time a person is confined in jail for any cause, such as: charged with violation of a law or an ordinance, being inebriated, material witness in a criminal case, held for investigation or protection, or held for a State hospital or other authority. Confinement may be before or after adjudication of the case in which the prisoner is involved. A person who is recommitted, after being released for any reason, is reported as a commitment each time confinement in jail occurs.

The statistics in this report were obtained from forms DC-J6, Record of Prisoners Confined, that were submitted monthly by the individual jails and jail farms to the Virginia Department of Corrections, Division of Finance, Jails Reimbursement Unit. The primary purpose of these documents was to determine a per diem cost of operation and an amount of State reimbursement due local jails and jail farms. In accordance with revisions to the Code of Virginia effective July 1, 1982, block grant funding replaced the reimbursement method of State financial assistance for the operation of local jails. However, the DC-J6 forms served an important secondary function of providing statistical data. Therefore, these forms continue to be transmitted to the Electronic Data Processing Unit for editing and computer processing.

Commitment data from similar annual jail reports since 1943 are available and copies are available of more recent annual jail reports (fiscal years 1970 through 1981). All questions, remarks, or requests relating to this report should be directed to the following agency:

COMMITMENTS

Commitments to County and City Jails and City Jail Farms


Fiscal Year Ended June 30, 1982

During fiscal year 1982 there were 199,206 commitments to county and city jails and city jail farms. This represents a 5.4% increase over commitments during 1981 (189,056).


RACE AND SEX

Among the jail commitments, 65.4% were white and 34.6% were nonwhite. The number of males received was 180,131 or 90.4%. The number of females was 19,075 or 9.6%. This has not changed from the last two fiscal years when females also comprised 9.6% of the commitments.

MALES




FEMALES



AGE

Last fiscal year there were 3,654 persons committed who were under age eighteen. During fiscal year 1982, 1.8% of the commitments (3,523) were in this category, which represents a 3.6% decrease since last year.





OFFENSE

An analysis of offense groups for fiscal 1982 shows that Offenses Against Decency, Peace and Good Order were the most frequent (60,306 or 30.3%); Traffic Offenses ranked second, with 45,558 or 22.9% of the commitments.



Specifically, the most common offense was Drunkenness/Drunk and Disorderly, which comprised slightly more than one quarter of all commitments (25.2%). The second most frequent offense was Driving Under the Influence of Intoxicants (15.1% or 30,099 commitments). Drunk driving commitments increased 15.4% over the 26,077 commitments in fiscal year 1981 for this offense.

Incarceration for Violations of the Narcotic Laws accounted for 7,330 commitments or 3.7%. This represents an increase over last fiscal year, when 3.5% of the commitments were in this category.



TYPE OF OFFENSE

Misdemeanants accounted for well over half of the total commitments again this year. Percentage breakdowns by type of offense are: misdemeanors—58.4% or 116,394; felonies—20.8% or 41,401, and "other offenses"—20.8% or 41,411. The number of commitments by type of offense increased proportionately to total commitments; therefore, there were no significant percentage changes from the previous fiscal year.



PLACE COMMITTED FROM

Virginia counties accounted for 49.2% of the jail commitments and the cities accounted for 50.8%. Of the 98,109 county commitments, Fairfax had by far the greatest share, with 12,955; Arlington committed 6,368 persons and Prince William committed 6,084. Of the 101,097 city commitments, Norfolk committed 14,989, closely followed by Richmond, with 14,260, while Newport News had the third largest number of commitments among cities, with 11,486.

AVERAGE CAPACITY AND NEW COMMITMENT ANALYSIS

The total rated capacity for all jail facilities in Virginia increased from 5,387 on June 30, 1981 to 5,634 on June 30, 1982. This was due to the reopening of Bland County and Pittsylvania County Jails in September, 1981 and the expansion of several local facilities during the fiscal year.

Rated capacity for the 99 jail facilities now averages 57 beds per jail, compared to the fiscal year 1981 average for 97 facilities of 56 beds per jail.

The average number of commitments per jail was 2,012, which is a 3.2% increase over last year's average of 1,949 commitments. New commitments to all Virginia jails averaged 546 persons per day or 5.5 persons per day, per jail.




Figure 1: Commitments by Month




Figure 2: Commitments – Ten Year Comparison


Confinements in County and City Jails and City Jail Farms Fiscal Year Ended June 30, 1982

During fiscal year 1982, there were 205,280 persons confined in Virginia jails. This is a 5.7% increase over the 194,182 confinements in fiscal year 1981.


RACE AND SEX

Of the total persons confined, 64.9% were white and 35.1% were nonwhite. There were 185,888 (90.6%) males and 19,392 (9.4%) females. The percentage of females has increased slightly from the 9.1% confined in the previous year.

MALES




FEMALES



AGE

The number of persons confined in jail who were under age eighteen was 3,747 or 1.8% of the total confinements. This represents a 3.2% decrease in the number in this age category since last fiscal year when 3,869 confined persons were under eighteen.

As expected, the age percentage distribution for persons confined was the same as for persons committed. The average age of persons confined during fiscal year 1982 was 31 years, which is the same as the average age last fiscal year.





OFFENSE

Of all those confined in fiscal year 1982, 60,707 or 29.6% were committed for Offenses Against Decency, Peace and Good Order; Traffic Offenses ranked second, with 45,886 or 22.4%.



Drunkenness/Drunk and Disorderly was the most frequent offense, comprising nearly one quarter of all confinements (24.5% or 50,241). Driving Under the Influence of Intoxicants was the second most common offense, accounting for 14.7% or 30,188 confinements. The number of people confined for driving while intoxicated increased 15.3% over the 26,174 confined in fiscal year 1981 for this offense.

An increase of 11.3% occurred in incarcerations for Violations of the Narcotic Laws. There were 7,747 confinements or 3.8% of the total, compared with 6,961 or 3.6% for this category last year.



TYPE OF OFFENSE

The number of persons confined by offense type increased proportionately compared to the total number of confinements. Therefore, misdemeanants again comprised more than half of the total confined population—57.4% or 117,936, a slight decrease from the 57.9% for fiscal year 1981. Accordingly, felony confinements increased slightly to 45,748 or 22.3% in fiscal 1982 from 21.8% in fiscal 1981. The percentage for "other offenses" remained constant at 20.3% or 41,596 persons.



PLACE COMMITTED FROM

Of the 205,280 persons confined in Virginia jails during fiscal year 1982, 49.2% or 100,963 were committed from counties and 50.8% or 104,317 were committed from cities. The county committing the greatest number of persons confined during the year was Fairfax, with 13,296. This exceeded the combined number of confined persons committed by Arlington (6,561) and Prince William (6,181), which ranked second and third, respectively. Among the cities, Norfolk committed 15,460 of the persons confined, closely followed by Richmond, with 14,988, while Newport News' commitments accounted for 11,708 of the persons confined.

CAPACITY AND CONFINED POPULATION ANALYSIS

The number of persons confined daily in a Virginia jail facility averaged 69.7 persons or 22.3% more than the average rated capacity (57 beds) for the current fiscal year. By comparison, there was a daily average of 60.0 persons in fiscal year 1981 and 50.0 persons in fiscal year 1980 confined in jail. In the two year period since fiscal year 1980, there has been a significant increase (39.4%) in the average daily population.

Prisoner days in the 99 facilities totaled 2,519,841. Average prisoner days per jail grew to 25,453, as compared to 21,771 days for fiscal year 1981. This 16.9% increase was a result of the longer average length of confinement per prisoner (which extended to 12.3 days from the average length during fiscal year 1981 of 10.9 days) combined with a moderate 3.2% increase in the number of new commitments.

There were 61 jails that recorded more total prisoner days than rated capacity days available for the year. Daily State jail population exceeded the 5,634 rated capacity and averaged 6,904 persons.




Figure 3: Confinements – Five Year Comparison




Figure 4: Prisoner Days – Ten Year Comparison




Figure 5: Confinements – First Tuesday of Each Month

DESCRIPTION

Total Confined is the number of persons who were confined in each jail during the fiscal year, regardless of when they were committed.

Rated Capacity is extracted from the Population Survey of Local Correctional Institutions. It is the design capacity of each jail and does not necessarily represent the number of beds in the jail.

Maximum is the highest recorded population for each jail during the fiscal year.

Capacity Days are determined by multiplying the rated capacity of each jail by 365, the total days in a year.

Actual Prisoner Days are the total number of prisoner days recorded by each jail for the entire fiscal year.

Net Difference is recorded as positive when the rated capacity is greater than the total prisoner days. Jails with negative numbers are, therefore, overcrowded.

Percentage Difference is the net difference divided by the capacity days.

Days Above Rated Capacity are the number of days during the fiscal year that the number of prisoners being held exceeded the rated capacity.

Percent of Year Over Capacity is the number of days over capacity divided by 365 days.

DESCRIPTION

Average Daily Population is actual prisoner days divided by 365 days.

1980 County/City Population is the figure published in Virginia Population Projections 2000, issued by the Department of Planning and Budget, January, 1983. Where more than one county or city use the same jail, their populations are combined.

Rate of Incarceration is expressed as average daily population divided by the county/city population. The rate is expressed per 100,000 residents.
