



Data Collection Description

The data available here were originally collected by Isaac Ehrlich for a study of the economics of crime. They concern crimes committed in 1960 in 47 states of the United States (New Jersey, Alaska, and Hawaii were excluded). For each state the reported crime rate was determined for each of the Federal Bureau of Investigation's seven index crimes: murder, rape, assault, larceny, robbery, burglary, and auto theft. Of these crimes, murder, rape, and assault are considered violent crimes while the remaining four, robbery, burglary, larceny, and auto theft, are considered property crimes. In addition, the probability of prison commitment and the average time served when sentenced were determined and are reported for each of the index crimes. Eleven variables of socioeconomic status are included: family income, income distribution, unemployment rate for urban males in the age groups 14-24 and 35-39, labor force participation rate, educational level, percentage of young males and percentage non-white in the population, percentage of population in Standard Metropolitan Statistical Areas, sex ratio, and place of occurrence. In addition, per capita police expenditures for 1959 and 1960 are reported in the data.

The crime rate is defined as the number of offenses known to the police per 100,000 of population in 1960. Probability of imprisonment is the ratio of commitments to state (and in the case of auto theft, also federal) prisons in a given year to the number of offenses known to have occurred in that same year. The data on the number of prison commitments are obtained from the NATIONAL PRISONER STATISTICS bulletins of the Federal Bureau of Prisons and refer to prisoners received from court by state institutions for adult felony offenders during the calendar year of 1960. Also, the data on rape relates to sexual offenses in general. Time served is the average time served by offenders in state prisons before their first release.

File Structure

The data collection is available from the ICPSR in two formats: card-image and OSIRIS. The card-image file contains several decks per case in a format based on 80 column punched cards. The data are sorted by case with all decks for a case together in ascending order.

The OSIRIS dictionary gives the format and other information for each variable in the OSIRIS data file. The dictionary or dictionary-codebook file is used in conjunction with the OSIRIS software package. The OSIRIS data file is constructed with a single logical record of 437 for each case. There are 66 variables for 47 cases.

The OSIRIS data file can be accessed directly through software packages or programs which do not use the OSIRIS dictionary by specifying the tape locations of desired variables. These tape locations are given in the OSIRIS dictionary-codebook.

ICPSR Processing Information

The study was processed according to standard ICPSR processing procedures. The data were checked for illegal or inconsistent code values which, when found, were recoded to OSIRIS missing data values. Consistency checks were not performed. Statements bracketed in "<" and ">" signs in the body of the codebook were added by the processors for explanatory purposes.

The example below is a reproduction of information appearing in the machine-readable codebook for a typical variable. The numbers in brackets do not appear in the actual codebook but are references to the descriptions which follow this example.

[1] Indicates the variable and reference numbers. A variable number and a reference number are assigned to each variable in the data collection. In the present codebook which documents the archived data collection these numbers are identical. Should the data be subsetted or rearranged by an OSIRIS program (e.g., MMP to intersperse data from another source, or TCOT to produce an analysis deck), the variable numbers would change to reflect the order of the new data collection, while the reference number would remain unchanged to reflect the variable number in the codebook describing the archived data collection.

[2] Indicates the abbreviated variable name (maximum of 24 characters) used in the OSIRIS system to identify the variable for the user. An expanded version of the variable name can be found in the variable description list.

- [3] Indicates the code values of missing data. In this example there are no missing data values (NO MISSING DATA). Alternative statements for other variables are "MD=0," "MD GE 9," or "MD=-1." Some analysis software packages (including the OSIRIS software package) require that certain types of data which the user desires to be excluded from analysis be designated as "MISSING DATA," e.g., inappropriate, unascertained, unascertainable, or ambiguous data categories. Although these codes are defined as missing data categories, this does mean that the user should not or cannot use them in a substantive role if so desired.
- [4] Indicates the starting location and width of this variable when the data are stored on a magnetic tape in the OSIRIS format. If the variable is of a multiple-response type, the width referenced is that of a single response. In this example the variable named "PLACE OF OCCURRENCE" is 1 column(s) wide and is located in the 9th column within the record.
- [5] Indicates the location by deck and column(s) of this variable when the data are stored on cards or in card-image format (80-column format).
- [6] A variable containing data with implied decimals is denoted by the message "IMP DEC= d," where d is the number of decimal places implied in the variable.
- [7] This is the full text (question) supplied by the investigator to describe the variable. The question text and the numbers and letters that may appear reflect the original wording of the questionnaire item.
- [8] Indicates an additional comment or explanation appended to the variable description.
- [9] A variable which has a footnote associated with it is denoted by the message, "SEE NOTE(S) n" where n is the number of the footnote referenced.
- [10] "Actual number is coded" appears in the codebook to indicate that the variable has been declared continuous.
- [11] Indicates the code values occurring in the data for this variable.
- [12] Indicates the textual definitions of the codes. Abbreviations commonly used in the code definitions are "DK" (Do Not Know), "NA" (Not Ascertained), and "INAP" (Inappropriate).

CLASSIFICATION OF CRIME INDEX OFFENSES
Definitions of Crime Classifications

Taken from: U.S. Department of Justice, Federal Bureau of Investigation, CRIME IN THE UNITED STATES: UNIFORM CRIME REPORT, 1970, p.61.

1. MURDER (Criminal homicide): Murder and non-negligent manslaughter: All willful felonious homicides as distinguished from deaths caused by negligence. Excludes attempts to kill, assaults to kill, suicides, accidental deaths, and justifiable homicides. Justifiable homicides are limited to: (a) the killing of a person by a peace officer; and (b) the killing by a private citizen of a person in the act of committing a felony.
2. RAPE (Forcible rape): Rape by force, assault to rape, and attempted rape. Excludes statutory offenses (no force used - victim under age of consent).
3. ROBBERY: Stealing or taking anything of value from the care, custody, or control of a person by force or violence or by putting that person in fear, such as strong-arm, robbery, stickups, armed robbery, assault to rob, and attempts to rob.
4. ASSAULT (Aggravated assault): Assault with intent to kill or for the purpose of inflicting severe bodily injury by shooting, cutting, stabbing, maiming, poisoning scalding or by the use of acids, explosives, or other means. Excludes simple assault, assault and battery, fighting, etc.
5. BURGLARY (Breaking or entering): Burglary, house-breaking, safe-cracking, or any breaking or unlawful entry of a structure with the intent to commit a felony or a theft. Includes attempts.
6. LARCENY Theft (except auto theft): Fifty dollars and over in value; thefts of bicycles, automobile accessories, shop-lifting, pocket-picking, or any stealing of property or article of value that is not taken by force and violence or fraud. Excludes embezzlement, "con" games, forgery, worthless checks, etc.

7. AUTO THEFT: Stealing or driving away and abandoning a motor vehicle. Excludes taking for temporary or unauthorized use by those having lawfull access to the vehicle.
