This edition of this periodic report is the first to combine both death sentencing information and current death row occupancy information concerning crimes committed by female offenders. Both the female death sentencing rate and the female death row population remain very small in comparison to that for adults, each being around 1% to 4% of the totals. However, the annual death sentencing rate has doubled beginning in 1989, and the population of female death row inmates is growing.

My research continues on the imposition of death sentences and the actual execution of female offenders throughout American history. Preliminary findings indicate that actual execution of female offenders is quite rare, with only 398 documented instances beginning with the first one in 1632. And the incidence of execution of females has declined considerably in the twentieth century as compared to earlier centuries. The last female offender executed was Velma Barfield in North Carolina on November 2, 1984. FEMALE DEATH SENTENCES IMPOSED:

The current American death penalty system began when new death penalty statutes were passed beginning in the Fall of 1972. These statutes followed the United States Supreme Court's decision in <u>Furman v. Georgia</u>, 408 U.S. 238, on June 29, 1972, which in effect struck down all then existing death penalty statutes. Sentencing began under the new statutes in 1973 and continues through today. While some of these post-<u>Furman</u> statutes have undergone minor and sometimes major challenges, most have endured relatively unchanged, making them and the sentences under them the legal structure for our current death penalty system.

While some uncertainty exists as to the precise number of death sentences imposed in the early years of this period, Table 1 on the next page lists the sentences imposed each year according to the Bureau of Justice Statistics and to my research. A total of 83 female death sentences have been imposed, only 1.9% of the total of 4,329 death sentences for all offenders. Despite some fluctuations particularly in the early years of this period, the death sentencing rate for female offenders was typically about 5 per year beginning in the early 1980s. However, beginning in 1989 this annual death sentencing rate doubled and has remained at this new, higher rate since that time. Research continues to discover the reasons for this dramatic jump in the female death sentencing rate.

Appendix A to this report (pp. 4-7) provides a more detailed listing of name, age, race, gender, state, and current status for each case. While the sources of this information are many, the major sources are the outstanding research effort of the NAACP Legal Defense and Educational Fund, Inc. (particularly their newsletter, <u>Death Row, U.S.A.</u>) and the equally fine monitoring effort of the National Coalition for the Abolition of the Death Penalty. However, the data from 1973 through the early 1980s may not be as complete as those for more recent years. This data compilation effort has always been and it appears will always be "research in progress," so recipients of this report are asked to complement this research with any corrections, additions, and deletions which they might be able to provide.

## CURRENT FEMALE DEATH ROW INMATES:

Of the 83 death sentences imposed upon female offenders since 1973, only 33 female offenders remain on the death rows of 16 states. Three-quarters of the offenders are white and an even greater portion of their victims were white. Their present ages range from 21 to 69, and they have been on death row from 1 week to nearly 9 years.

Appendix B to this report (pp. 8-11) sets forth the names of these offenders and some brief details about their crimes and sentences. Multiple sentencing dates mean that the earlier death sentence was reversed but then a new death sentence was imposed.

Neelley, Judith Ann: White; age 18 at time of crime and now age 26 (DOB 6-7-64); kidnapping and murder of white female age 13 in DeKalb County on 9-28-82; sentenced on 4-18-83.

<u>Walker, Maxine Altione</u>: White; age 43 at crime and now age 46 (DOB 9-10-44); murder of white male boyfriend (hired nephews to commit killing) in Talladega County on 3-31-88; sentenced on 12-15-88.

Cox, Donna Sue: White; age 27 at crime and now age 31 (DOB 4-6-59); murder of white male adult (her boyfriend) in Parkton (Robeson County) on 7-12-86; sentenced on 10-30-87.

<u>Jennings</u>, <u>Patricia</u> <u>JoAnn</u> [Wells]: White; age 47 at crime and now age 48 (DOB: 8-24-42); murder of elderly white male adult (her husband) in Wilson County on 9-19-89; sentenced on 11-5-90.

Mahaley, Marilyn [Rudd]: White; age 34 at crime and now age 35 (DOB: 9-3-55); murder of white male (her husband) in Alamance County on 3-20-90; sentenced on 12-17-90.

Moore, Blanche [Taylor]: White; age 56 at crime and now age 57 (DOB: 6-?-33); murder of white male adult (her boyfriend) in Alamance County in late 1989; sentenced on 11-16-90.

Stager, Barbara Terry: White; age 39 at crime and now age 42 (DOB 10-30-48); murder of her husband in Durham (Durham County) on 2-1-88; sentenced on 5-19-89.

Allen, Wanda Jean: Black; age 29 at crime and now age 31 (DOB 8-17-59); murder of female adult in Oklahoma County in December 1988; sentenced on 4-26-89.

<u>Jones, Patricia</u>: White; age 36 at crime and now age 39; murder in Oklahoma County in April, 1988; sentenced on 12-7-89.

<u>Plantz, Marilyn Kay:</u> White; age 27 at crime and now age 30 (DOB 10-19-60); murder of white male adult (her husband) in Oklahoma County in August, 1988; sentenced on 3-31-89.

<u>Smith, Lois Nadean</u>: White; age 41 at crime and now age 50 (DOB 9-12-40); murder of white female adult in Gans (Sequoia County) on 7-4-82; sentenced 12-29-82.

Rivers, Delores: Black; age 34 at crime and now age 37 (DOB 12-25-53); murder in Philadelphia in February (?) 1988; sentenced on 3-16-89.

Smith, Rebecca: White; age 39 at crime and now age 41; murder of white male age 49 (her husband) in North Myrtle Beach on 7-17-89; sentenced on 12-10-90.

#### TENNESSEE

Owens, Gaille Kirksey: White; age 32 at crime and now age 38 (DOB 9-22-52); murder of husband (had someone commit killing) in Shelby County on 2-17-85; sentenced on 1-15-86.

### **TEXAS**

Beets, Betty Lou: White; age 46 at crime and now age 53 (DOB 3-12-37); murder of husband in Athens (Henderson County) on 8-6-83; sentenced on 10-14-85.

Newton, Francis Elaine: Black; age 21 at crime and now age 25 (DOB 4-12-65); murder of husband (black male age 23), son (black male age 7), and daughter (black female age 1) in Houston on 4-7-87; sentenced on 11-17-88.

<u>Perillo, Pamela Lynn:</u> White; age 24 at crime and now age 35 (DOB 12-3-55); robbery and murder of white (?) male age 26 in Houston on 2-24-80; sentenced on 9-2-80 and 11-13-84.

Tucker, Karla Faye: White; age 23 at crime and now age 31 (DOB 11-18-59); murder of white female age 32 and white male age 27 in Houston on 6-13-83; sentenced on 4-25-84.
