### CRIMINAL INJURIES COMPENSATION BOARD FIFTH REPORT TO THE ATTORNEY GENERAL APRIL 1ST, 1973 – MARCH 31ST, 1974

## THE LEGISLATION

The original legislation under which the Board functioned was The Law Enforcement Compensation Act, 1967. The Board was then known as the Law Enforcement Compensation Board.

The scope of that legislation, to provide compensation in respect of injuries sustained or death occasioned in or resulting directly from assisting a peace officer in making an arrest or preserving the peace, was extended retroactively at the session of 1968-69 to include injury or death occurring in or resulting from an offence against a statute of Canada or Ontario, not including an offence involving the use or operation of a motor vehicle other than assault by means of a motor vehicle. The extended scope also comprehended injury or death occurring in or resulting directly from making an arrest or preventing a crime as well as an attempt to make an arrest or prevent a crime.

The legislation was re-enacted in 1971 on the lines of the model Act prepared by the Conference of Commissioners on the Uniformity of Legislation in Canada with the elimination of reference to offences against provincial statutes and an upward revision in the basic award limitation, of from \$10,000 to \$15,000, as well as a more generous overall limitation in respect of a single occurrence, of \$100,000 in the case of lump sum payments and \$175,000 in respect of periodic payments. The basic limitation for periodic payments remains at \$500 per month. In 1973 three minor amendments were made to the Act.

## THE AGREEMENT

In line with the agreement with the Government of Canada which provides for payment of .05 cents per capita of the population of the province, or 90% of the actual amount paid by the province, whichever is the lesser, as a contribution toward the cost of the compensation, the Board provides copies of its decisions (other than those which because of their nature are not distributed on a public basis) to the daily press and others requiring the service. In addition, a brochure will shortly be published and distributed with a view to publicizing the type of compensation which is available to victims of crime and others falling within the scope of the Act.

Under the agreement the province is entitled to recover from the federal authorities \$396,950 of the \$722,637 paid out under the Act during the last fiscal year. As the reimbursement provisions of the agreement came into force on January 1st, 1973, this is the first full fiscal year of their application.

## VOLUME OF WORK

The increase in the work of the Board is reflected in the number of applications received during the recently completed fiscal year, as against the previous fiscal year:

The smaller number of applications heard in the latter period is accounted for by the fact that during the 1972-73 period, extra sittings of the Board were held to overcome a threatened backlog. Presently, each application is placed on the list for hearing as soon as the material is complete.

## SITTINGS

The seven members of the Board, of whom six are on a part-time basis, usually sit in panels of two. It is rarely that a decision is reserved and it is customary for the award to be paid within two weeks of the hearing. It is planned to hold sittings throughout the province in the interest of the convenience of applicants.

### STAFF

The staff of the Board comprises a Registrar, Deputy Registrar and Investigator in addition to a clerical, stenographic and secretarial staff of six. As has been observed in previous reports of the Board, the present arrangement for the investigation of applications for compensation is quite inadequate. While there is no backlog of applications awaiting hearing at this time, a backlog is inevitable unless the investigation staff is increased, for the responsibility for the dispensing of public funds requires appropriate information upon each application pending before an award is made.

### PROCEDURES

The Board does not have the advantage offered by the adversary system which ensures the presentation of both sides of any matter brought before a court or other tribunal. However, since the Act requires the Board to find the commission of a crime (in the principal class of application coming before it) before being qualified to make an award, there must be adequate and reliable evidence in this regard.

In addition, the Board is required to consider all relevant circumstances before making an award, and is also permitted by the legislation to inquire into the reporting of the offence and the cooperation afforded to law enforcement agencies. All this adds up to the need for an adequate investigational staff. Their services are also required for regular checks of situations where periodic payments are being made, as well as with respect to possible recovery from offenders, through the Board's rights of subrogation, of sums paid out.

### SUBROGATION

During the fiscal year 1973-74, 10 applications were referred to counsel in the Ministry of the Attorney General for consideration as to recovery proceedings against the offender in accordance with our subrogation rights. This addition to the 11 cases previously referred to the law officers of the Crown results in a total of 21 cases being explored in relation to recovery.

Recovery was successfully effected in six of these cases. Total recovery was made in relation to two awards, partial recovery with respect to one award, and monthly payments are being received with regard to three others, which may eventually result in total recovery. The total amount recovered during the fiscal year was \$4,969.44.

### APPEALS

Case A — The Divisional Court quashed the Board's decision and referred the matter back for further consideration. A new hearing was conducted by a different panel of the Board. The Board denied the application for reasons other than those of the original Board. Advice has been received from the solicitor for the applicant that the Board's second decision would be accepted and appeal proceedings will not be commenced.

Case  $B - \ln 1972$ , the Court of Appeal quashed the Board's decision denying an award and referred the matter back for further consideration. In July, 1973, the application was re-heard by a different panel of the Board who found the applicant to be compensable and granted an award approaching the maximum permitted under the Act.

Case C – The Board rendered its decision in January, 1973 deny-

ing compensation to the applicant and six other applicants resulting from injuries sustained in a riot at Kingston Penitentiary. One of these applicants was a guard. Counsel appealed the Board's decision to the Divisional Court. The Board's decision was quashed and returned to us for further consideration. The Board has taken the matter to the Court of Appeal which has reserved judgment. This decision, when rendered, will be useful as a precedent in pending and future matters.

During the period covered by this report, the Board has been served with motions to appeal with respect to two applications with no further action having been commenced.

### ACKNOWLEDGEMENTS

The Board cortinues to be grateful to those whose assistance is essential to its efficient functioning which includes the members of the legal, medical and dental professions, the police forces of the province, staffs of the various hospitals and members of the press. We express our gratitude to the law officers of the Crown for their competent guidance and assistance and are fully appreciative of the conscientious and capable manner in which the staff of the Board carry out their respective functions.

### THE BOARD

Following the authorization for enlarging the membership of the Board to seven, by the 1971 legislation, Mr. Shaun MacGrath was appointed to part-time membership, effective July 1st, 1973. Mrs. Anne Austin's appointment as a part-time member as of November 1st, 1973, brought the membership to its statutory maximum. Mr. V. K. McEwan, a part-time member, was appointed Vice-Chairman, effective November 7th, 1973. Mr. A. A. Wishart, who resigned the chairmanship as of December 31st, 1973, continued as a part-time member for the completion of certain pending matters. He was replaced as Chairman by Mr. Eric Silk. Mr. Fred Deacon resigned from the Board as of December 31st, 1973.

The splendid contribution of Mr. Wishart, who became Chairman of the Board on January 1st, 1972, is gratefully acknowledged, as is the fine legacy of Mr. Deacon who served as a member of the Board from its establishment.

While both appointments took place just after the close of the period of this report, it is appropriate to "round out the picture" by stating that part-time member, Mr. R. C. Rutherford has been appointed a Vice-Chairman and Mr. J. W. Wakelin became a part-time member as of April 1st, 1974.

### SUMMARY OF DECISIONS April 1, 1973 to March 31, 1974

The number 100 preceding an application number denotes that the occurrence took place before September 1, 1971 and therefore the application was dealt with under the terms of The Law Enforcement Compensation Act, 1967.

Where the application number is preceded by the number 200, the occurrence took place on or after September 1, 1971, and the application was dealt with under the terms of The Compensation for Victims of Crime Act, 1971.

### SUMMARY WHERE AWARDS ORDERED

100-29-1 The victim, an 18 year old Toronto youth, was struck on the forehead by a bottle deliberately thrown by another youth. He was not rendered unconscious but subsequently complained of headaches. No charge was laid against the alleged offender.

Award: \$50.00 (p & s \$50.00).

100-247 The applicant, age 27, was shot during the attempted hold-up of a Windsor Brewers Retail store. He sustained serious wounds of both the stomach and right arm which resulted in extensive surgical repair. The offender has never been apprehended.

Award: \$1,502.00 and continuing monthly payments in the amount of \$200.00 (p & s \$200.00 per month).

100-265 The victim, who was 12 years old at the time of this occurrence, sustained extensive burns to her face and arms as a result of a fire which was lit by a boy also 12 years old in Agincourt, Ontario. The Board had previously granted an Interim Award of \$558.20 for out-of-pocket expenses and has now made a Final Award.

Award: \$5,220.00 (p & s \$5,000.00).

100-298 The applicant, a 27 year old man, was shot in the upper abdomen while visiting a girl friend in the City of Niagara Falls. The offender pleaded guilty to wounding with intent and was sentenced to two years and nine months in prison.

Award. \$1,604.50 (p & s \$500.00).

100-323 The applicant, age 43, while at a Massey, Ontario service station was struck in the right leg by a .22 calibre bullet. Three juveniles, who had been firing from a distance at the service station sign, were convicted of dangerous use of a firearm and placed on 12 months' probation.

Award: \$1,137.75 (p & s \$300.00).

100-429 The applicant, age 57, was a passenger on a train bound for Sarnia, Ontario. It was derailed near Malton, Ontario, as a result of sabotage. Minor injuries were sustained by the applicant, to nis right shoulder. The Board has previously dealt with applications of other passengers who were injured in the same occurrence. The offender has never been identified.

Award: \$441.80 (p & s \$250.00). (Same occurrence as 100-70, 100-120, 100-375, 100-479, 100-480, 100-759, 100-965, 100-966).

100-442 The victim, age 49, was viciously assaulted in his Toronto rooming house. He remained in a comatose state in a Toronto nursing home for a lengthy period. Recently he died as a result of these injuries. The offender was convicted

of assault causing bodily harm and sentenced to two years. A sister of the victim applied for reimbursement of funeral expenses. Award: \$869.74

100-454 The victim, an 18 year old girl, while walking in Chesley, Ontario, was struck in the left eye with a stone propelled from a sling shot. The boys who were playing with sling shots were not charged as the police were never notified. The victim sustained a serious eye injury which has permanently affected her vision.

Award: \$1,294.40 (p & s \$750.00).

100-476 The victim, a 38 year old part-time waitress, went to her place of employment, a Toronto tavern, to collect her wages. While drinking beer in the tavern she became aware that a floorman employee had become involved in an altercation with some customers. She went to his aid and was struck on the head with a chair. The offender was charged with wounding and subsequently acquitted.

Award: \$732.70 (p & s \$400.00).

100-478 The applicant, whose husband had been murdered, had been granted a periodic award in the amount of \$250.00 per month. Investigation by this Board reveals that the pecuniary loss as previously established no longer exists as a result of the re-marriage of the applicant. The award was discontinued.

100-512 The applicant was granted a monthly award in the amount of \$150.00 for pecuniary loss sustained as a result of the death of his wife. This amount was to cover the cost of the service of a housekeeper to care for his three minor children. It has been ascertained that the applicant has re-married thus eliminating this expense. The periodic award was discontinued.

100-518 The applicant, age 49, was assaulted by her common-law husband in their Toronto home. She sustained multiple bruises. The offender was convicted of assault causing bodily harm and was fined \$400.00. In making its award, the Board was bound by Section 4(2) of The Law Enforcement Compensation Act, 1967 and was prohibited from compensating for pain and suffering. Award: \$78.10.

100-535 The victim, a 37 year old Toronto school teacher, was employed during the spring school break as a taxi driver. In the course of his employment he was assaulted by another taxi driver sustaining a fractured nose. The offender was convicted of assault causing bodily harm and fined \$100.00 or ten days. Award: \$250.00 (p & s \$150.00).

100-582 The applicant, now 27, a harvester operator, was beaten by an unknown assailant outside the Mariaggi Hotel in Thunder Bay. He has suffered some permanent loss of vision in his right eye. Award: \$2,456.05 (p & s \$1,000.00).

100-596 The victim, a 65 year old Peterborough housewife, upon answering a knock at her door, was struck in the face by an unknown assailant. She sustained a laceration to her upper lip requiring five stitches, damage to her teeth, and a bruise on her left leg.

Award: \$383.00 (p & s \$200.00).

100-605 The victim, age 47, was struck on the back of the head by an unknown person as he walked home from his travel agency in Toronto. He sustained a compound compressed fracture of the skull. The identity of the assailant still remains unknown.

Award: \$2,170.00 (p & s \$1,500.00).

100-620 The victim, a member of the Metropolitan Toronto Police Force, was on plain-clothes duty in the Yorkville area. He was approached by a man who wanted to know if he wanted the services of a girl. While arresting this man, the applicant was assaulted and sustained dental damage and facial lacerations in addition to numerous bruises. The offender was convicted on a charge of assaulting a peace officer and received four years to run consecutive to a sentence of 11 years in respect to several other hold-up charges.

Award: \$834.25 (p & s \$700.00).

100-641 The victim, age 45, was returning to his Toronto apartment with his wife and children when he was struck in the face by a stranger. As a result of this unprovoked assault, he sustained severe damage to his right eye. The offender was convicted of common assault and was fined \$100.00 or, in default, two months' imprisonment.

Award: \$2,263.00 (p & s \$1,500.00).

100-654 The victim, a 50 year old male, was pistol-whipped in his Windsor home during a robbery, sustaining severe lacerations. An Interim Award was granted in the amount of \$3,592.68. Details can be found in the Third Annual Report.

Award: \$476.80 (p & s NIL).

100-658 The 35 year old husband of the applicant was fatally shot by an offender in Toronto. The offender was convicted of manslaughter and sentenced to eight years in penitentiary.

Award: \$3,854.00 and continuing monthly payments of \$265.00.

100-659 Upon leaving the Parkview Hotel in Chatham, the applicant, age 63, was assaulted by two young men. He sustained a concussion, fractured jaw and lacerations to his scalp. Both offenders were charged with assault causing bodily harm and one offender was sentenced to two months in prison. The other offender was acquitted.

Award: \$693.00 (p & s \$500.00).

100-661 The victim, age 21, was walking home from school in Toronto when he felt a severe pain in his left thigh, having been struck by a .22 calibre bullet. Although this offence was fully investigated by the police, the offender has never been identified.

Award: \$383.00 (p & s \$300.00).

100-691 The victim, age 20, of Port Colborne, was assaulted without provocation by a male acquaintance. He sustained stab wounds to his left shoulder and right arm. The offender was convicted of wounding with intent to maim and was sentenced to four years in penitentiary.

Award: \$1,816.00 (p & s \$500.00).

100-704 The applicant, age 35, a part-time taxi driver, was the victim of an unprovoked assault while a patron in the York Town Tavern, Toronto. He sustained a fractured nose and cheek-bone. The offenders were not apprehended. Award: \$495.00 (p & s \$300.00).

100-708 The victim, a 31 year old Toronto taxi driver, was viciously attacked by an unknown assailant as he called for a fare at a local apartment building. He sustained lacerations to his scalp and experienced dizziness over a period of time. Award: \$475.00 (p & s \$200.00).

100-745 The victim, age 22, was shot during a quarrel with two other patrons in a Niagara Falls hotel. He sustained severe wounds to his left leg which required extensive surgical repairs. The offender was convicted of criminal negligence causing bodily harm and sentenced to one year in gaol. Award: 1019.47 (p & s 750.00).

100-751 The victim, a 17 year old female, was a passenger on a snowmobile being driven by a male friend. Another snowmobile, being operated in a reckless manner, struck their snowmobile. She sustained a compound fracture of her left tibia. The driver of the offending snowmobile has never been identified. The Board established that he was clearly guilty of criminal negligence. Award: 1,240.00 (p & s 1,000.00).

100-759 The applicant, a 55 year old train engineer, was driving the Toronto to Sarnia train when it was derailed at Malton. He sustained extensive damage to his right lung and clavicle. Two persons were killed and numerous were injured in this same occurrence. The Board has previously granted awards to applicants as a result of this occurrence. A very extensive police investigation established that the derailment was the result of sabotage caused by an unknown person cutting a steel padlock with a hack-saw and opening the switch.

Award: \$4,056.41 (p & s \$2,500.00). (Same occurrence as 100-70, 100-120, 100-375, 100-429, 100-479, 100-480, 100-965, 100-966).

100-762 The victim, a 54 year old widow, was attacked by her landlord in her Ottawa apartment. She sustained facial lacerations and numerous body bruises. The offender was convicted of common assault and fined 50.00. Award: 250.00 (p & s 200.00).

100-767 The applicant, age 50, was attacked at the entrance of the Waverly Hotel in Thunder Bay. He sustained deep lacerations to his forehead and upper facial area. The offender was convicted on a charge of wounding and sentenced to four months definite and three months indefinite.

Award: \$1,221.00 (p & s \$350.00). (Same occurrence as 100-768).

100-768 The applicant, age 60, was attacked in front of the Waverly Hotel in Thunder Bay. He was kicked in the face by his assailant and sustained severe facial injuries. The offender was convicted of wounding and was sentenced to four months definite and three months indefinite.

Award: \$1,656.50 (p & s \$500.00). (Same occurrence as 100-767).

100-771 The victim, a 16 year old Ottawa student, was struck a heavy blow to the head by a fellow student with whom he had been scuffling. He sustained severe head injury requiring extensive surgery. The offender was conviced of assault causing bodily harm, thereby committing an offence of delinquency contrary to the Juvenile Delinquents Act. Award: 2,008.12 (p & s 1,000.00).

100-781 The victim, a pharmacist, 48 years of age, was attacked by a man as he and a companion strolled through the Fairview Mall in Toronto. He sustained injuries to his left foot and face. The offender was convicted of assault causing bodily harm and sentenced to 30 days in gaol, in addition to a \$200.00 fine. Award: \$510.00 (p & s \$300.00). (Same occurrence as 100-610).

100-787 The applicant, now 33, was assaulted without provocation by a total

stranger. He was treated at the Sarnia General Hospital for a fractured cheekbone. The offender pleaded guilty to assault causing bodily harm and was fined \$100.00.

Award: \$883.00 (p & s \$500.00).

100-789 The victim, a 63 year old male, was assaulted in his Toronto rooming house during a political argument. He sustained two black eyes, swollen lips and a fracture of the left malar bone. The offender was convicted of assault causing bodily harm and was sentenced to 15 months definite and three months indefinite.

Award: \$354.50 (p & s \$200.00).

100-795 The victim, a 74 year old night clerk, was shot during the hold-up of an Ottawa hotel. He sustained severe wounds to the abdomen and pelvis. The offenders were never apprehended.

Award: \$3,985.00 (p & s \$3,500.00).

100-802 The victim, age 46, a clerk for the City of Welland, was assaulted by two men in the Atlas Hotel in Welland. He sustained two fractured ribs in addition to injuries to his face and right arm. His assailants were convicted of assault causing bodily harm and were sentenced to six months and five months in gaol respectively.

Award: \$983.40 (p & s \$750.00).

100-806 The victim, a 40 year old commercial photographer, was assaulted without provocation in the New Dundee Hotel in New Dundee. He sustained multiple contusions, four fractured ribs and the partial loss of the sight of his right eye. Each of the two offenders was convicted of assault causing bodily harm and sentenced to one year in gaol. Award: \$7,103.62 (p & s \$2,500.00).

100-820 The applicant, age 30, and her husband, an Ontario Provincial Police constable, were awakened by the sounds of an intruder in their home in Maidstone Township. The husband, armed with his service revolver, fired two warning shots and then wounded the intruder in the leg with a third shot. The applicant was close to her husband throughout and was terrified because of threats of violence to herself and her small children. Since the incident she has been extremely nervous and has been taking prescribed tranquilizers. The charge of break and enter with intent against the offender was dismissed as the court was of the opinion that he was under the influence of a drug and therefore incapable of forming intent.

Award: \$547.00 (p & s \$300.00).

100-842 The applicant, age 57, is the wife of the victim in file 100-843. During the robbery of her Toronto home, she was knocked to the floor by unknown assailants. She sustained a laceration to her scalp and since has experienced frequent headaches and dizzy spells. Award: \$650.00 (p & s \$500.00).

100-843 The victim, age 56, residing in Toronto, answered his doorbell and was confronted by three armed men. As he attempted to prevent their entry, he was struck on the head and shot in the chest. The applicant and his wife were tied and confined to a bedroom. The three men fled after having stolen a large sum of money and have never been apprehended.

Award: \$2,250.00 (p & s \$2,000). (Same occurrence as 100-842).

100-859 The applicant, age 35, a veteran officer with the London Police Force,

sustained a fractured and dislocated left arm while arresting the offender. He now experiences permanent partial paralysis of his left elbow joint. The offender was sentenced to 30 days in gaol on a charge of assaulting a peace officer. Award: 2,333.75 (p & s 2,000.00).

100-860 The victim, age 30, a lift truck operator, was assaulted in the men's washroom of the Knob Hill Hotel, Toronto. He sustained a displaced fracture of the right cheek-bone. There is a warrant outstanding for the arrest of the alleged offender.

Award: \$805.00 (p & s \$350.00).

100-863 The applicant, age 28, was assaulted by three customers at the Toronto gas station where he was employed part time. He sustained lacerations and contusions of the face. The offenders remain unknown. Award: 319.75 (p & s 200.00).

100-866 The victim, age 38, while in his Toronto apartment, was confronted by a man who demanded money. He was held captive for two and one-half hours and during this period was beaten. He eventually jumped out of a third-storey window to escape his assailant and sustained fractures of the wrist and left foot in addition to severe back injuries. The offender was never apprehended. Award: 9,310.05 (p & s 2,500.00).

100-870 The applicant, 32 years old, is employed as a spray painter. He was viciously assaulted at the Highland House Hotel in Scarborough and sustained multiple injuries including both a fractured jaw and fractured nose. The offender was convicted on a charge of common assault and was fined \$200.00. Award: \$2,368.84 (p & s \$1,000.00).

100-883 The applicant, age 46, observed three men stealing an air conditioning unit from the Toronto furniture store in which he worked. He attempted to prevent them from leaving and received a beating for his effort. He sustained head injuries and even now experiences dizziness. The three offenders were apprehended and charged. Charges against two were dismissed. The third was convicted of assault causing bodily harm and fined \$100.00 or 30 days in gaol. Award: \$1, 367.24 (p & s \$500.00).

100-884 The victim, a 29 year old man, while trying to act as a peacemaker during a fight in a Toronto tavern, was struck in the face by a beer glass. He sustained a severe facial laceration and injury to five teeth. The offender was found guilty of assault with intent to injure and was sentenced to 18 months in gaol.

Award: \$1,086.00 (p & s \$350.00).

100-887 A supplementary award of \$360.00 was ordered covering the payment of dental work not completed at the time of the original hearing. Details in Third Report.

Award: \$360.00.

100-888 The applicant, a 32 year old constable of the Waterloo City Police Force, responded to a call concerning a domestic dispute. The estranged husband, on refusing to leave the premises, assaulted the applicant causing injury to the cervical spine. The offender on being convicted of assaulting a peace officer was fined \$200.00 or 30 days in gaol. Award: \$1,030.00 (p & s \$1,000.00).

100-908 The applicant, now 22 years of age, was walking along a St. Catharines street accompanied by his sister and another young lady. He was assaulted by

three young men who had made obscene remarks to the two young ladies. The victim sustained a fractured nose and abrasions to his back. Bench warrants are outstanding for the alleged offenders. Award: \$303.00 (p & s \$200.00).

100-917 The victim, a 41 year old Toronto welder, was assaulted for no apparent reason as he sat talking to his wife in their parked car. The offender opened the driver's door and punched the applicant repeatedly. The applicant sustained fractures of the nose and cheek-bone plus multiple lacerations of his face. The offender was convicted of assault and given a suspended sentence with probation for one year.

Award: \$1,959.30 (p & s \$1,000.00).

100-927 The applicant, now 30 years of age, became involved in an altercation with two men while swimming at a Port Colborne quarry. He was kicked on the head and sustained a concussion. One offender was convicted of assault causing bodily harm and was fined \$250.00 or 30 days. Award: \$706.69 (p & s \$350.00).

100-933 The victim, age 44, was beaten and robbed as he was leaving the Royal Hotel in Hamilton, Ontario, He sustained a compound fracture of his jaw and experiences continuing numbness in his face. A charge of robbery against an alleged offender was dismissed for lack of positive identification. Award: \$1,516.20 (p & s \$750.00).

100-940 The applicant, a 29 year old Toronto Transit Commission bus driver, stopped his bus to allow passengers to get off. Without provocation, he was assaulted by the offender, sustaining a fractured malar bone and facial injuries. The assailant, upon being convicted of assault causing bodily harm, was sentenced to three months in gaol.

Award: \$285.55 (p & s \$200.00).

100-943 The applicant, age 39, was assaulted by an opposing player after a soccer game in Brantford. He sustained extensive dental damage and suffers occasional dizzy spells. The offender was convicted of assault and fined \$50.00 with the alternative of five days in gaol. Award: \$1,766.41 (p & s \$400.00).

100-945 The 31 year old victim, husband of the applicant, was fatally shot in Halton County, by the offender who was convicted of manslaughter. He was sentenced to seven years in prison.

Award: \$1,767.00 and continuing payments of \$52.00 per month.

100-948 The victim, now 25 years of age, was viciously assaulted by two unknown assailants, as he was returning to his home after having entertained a business acquaintance in downtown Toronto. He sustained dental damage in addition to fractures of his jaw and cheek-bone. Award: \$2,147.00 (p & s \$1,750.00).

100-949 The victim, age 39, was assaulted when returning to his Windsor home after having spent the evening at a nearby hotel. He sustained dental damage plus minor facial lacerations. The offender was convicted of common assault and fined \$50.00 or 10 days in gaol and placed on probation for 12 months. Award: \$316.15 (p & s \$300.00).

100-951 The victim, a 44 year old Toronto man, was stabbed after requesting that the offender return some money owing to him. He sustained deep wounds to his chest and abdomen. The offender was convicted of wounding and placed on probation for two years.

Award: \$2,914.40 (p & s \$500.00).

100-953 The applicant, now 23, a Humber College student, was employed part time as an usher at a Toronto drive-in theatre. He was in the theatre front office, with the assistant manager, preparing to take the night deposit bag to the bank when two masked men seized the bag containing \$4,800.00 and shot the applicant in the right forearm. The injury has left him with permanent residual incapacity as far as sustained or fine movements of his right hand are concerned. The two offenders have never been apprehended. Award: \$2,525.00 (p & s \$2,500.00).

100-954 The victim, age 65, was on duty when two youths attempted to hold up the Fort Erie service station where he worked. He was struck on the back of the skull and sustained severe head injuries. The offenders were not apprehended.

Award: \$6,397.50 (p & s \$6,000.00).

100-956 This applicant, a 47 year old Toronto fruit store owner, was assaulted by several teenagers who were stealing fruit from his store. He sustained multiple bruises in addition to a fractured knee-cap. The offenders were not apprehended. Award: \$1,360.00 (p & s \$700.00).

100-957 The victim, age 29, was assaulted without provocation by a stranger while walking along a Toronto street. He sustained minor facial lacerations. A week later, on recognizing his assailant standing in front of the Ford Hotel, he called the police. The assailant was convicted of assault causing bodily harm and given a three month sentence. Award: \$150.00 (p & s \$150.00).

100-961 The victim, age 36, a tenant in a Toronto apartment house, complained to the building superintendent about conditions in his apartment and requested certain repairs. The superintendent struck him with his fist causing facial lacerations which required suturing. The offender was convicted of assault causing bodily harm and sentenced to five days in gaol plus a fine of \$100.00. Award: \$393.40 (p & s \$200.00).

100-962 The victim, now 18, had entered the Toronto apartment building where she lived with her mother when she was attacked by a young man wielding a knife. She sustained stab wounds to her neck, arm, a finger, both breasts and abdomen. The offender was convicted of wounding and was sentenced to 14 years' imprisonment.

Award: \$4,425.00 (p & s \$4,000.00).

100-965 The applicant, age 72, was a passenger on a train which had left Toronto and was bound for Sarnia. As a result of sabotage, the train was derailed at Malton and he sustained bruised ribs and accompanying chest pains. The saboteur has never been identified.

Award: \$160.00 (p & s \$100.00). (Same occurrence as 100-70, 100-120, 100-375, 100-429, 100-479, 100-480, 100-759, 100-966).

100-966 The victim, age 66, was a passenger on a train which had left Toronto and was bound for Sarnia. The train was derailed at Malton as a result of sabotage and she sustained a fracture of her right ring finger plus severe bruising of her left leg. Despite very thorough investigation by the police, the saboteur has never been apprehended.

Award: \$310.00 (p & s \$250.00). (Same occurrence as 100-70, 100-120, 100-375, 100-429, 100-479, 100-480, 100-759, 100-965).

200-4 The victim, age 50, was assaulted in his Toronto home by a tenant who had been requested to leave. The victim sustained lacerations of the face and right hand. The offender was convicted of assault causing bodily harm and fined \$50.00 or five days in gaol.

Award: \$567.00 (p & s \$300.00). (Same occurrence as 200-5).

200-5 The victim, a 44 year old Toronto woman, on coming to the assistance of her husband, who was being assaulted by a tenant, sustained injuries to her left hand. The offender was convicted of assault causing bodily harm and fined \$50.00 or five days in gaol.

Award: \$75.00 (p & s \$75.00). (Same occurrence as 200-4).

200-19 The victim, a 73 year old lady, was tripped by one of two youths in the course of a purse snatch on a Kitchener street. The police were notified, but the offenders were never apprehended. She sustained a fracture of her left hip, which required the insertion of three pins.

Award: \$2,052.23 (p & s \$1,500.00).

200-20 An intruder entered an apartment in Port Credit, bent upon robbery. The 26 year old applicant and her two infant children were there at the time. The intruder ransacked the premises, threatened the applicant with a butcher knife and inflicted minor lacerations to her chest. She was terrorized and developed an anxiety reaction which resulted in the loss of her hair. The offender has not been apprehended.

Award: \$360.00 (p & s \$250.00).

200-33 The victim, a 65 year old Toronto taxi driver, was murdered by two people who had been picked up as passengers. Both offenders were found guilty of non-capital murder and sentenced to life imprisonment.

Award: \$3,426.70 and continuing payments of \$87.00 per month to the applicant, wife of the victim.

200-52 The victim, a 46 year old male, was shot when mistaken for a bear or a moose, while hunting in the North Bay area. The gunshot injury to his right thigh was described as a superficial through and through wound involving no vital structures. The offender pleaded guilty to a careless hunting charge, under The Game and Fisheries Act and was fined \$100.00 and costs. Award: \$988.98 (p & s \$400.00).

200-59 The applicant, now 25, a carpenter by occupation, was proceeding to his job in Ottawa when a bullet from an unknown source penetrated his vehicle and struck him in the right arm. As a result, his arm was amputated above his left elbow. The offender has never been identified.

Award: \$9,028.10 and continuing payments of \$225.00 per month. (p & s \$5,000.00).

200-68 The applicant, age 42, was assaulted in front of his home in Welland. He sustained lacerations and bruises to his face and chest. The offender was placed on probation for six months as a result of being convicted of assault. Award: 703.40 (p & s 350.00).

200-76 The victim, an 18 year old student and part-time employee of the Club Jamaica in Toronto, was stabbed in the abdomen by a patron of the club. He had accused this patron of striking his sister previously. The offender was

convicted of assault causing bodily harm and sentenced to 10 days in gaol. Award: \$1,125.00 (p & s \$1,125.00).

200-84 The applicant, age 44, was assaulted and robbed of \$500.00 by three unknown men as he walked along a Toronto street. He sustained dental damage and facial bruises. His assailants have never been identified. Award: \$697.72 (p & s \$100.00).

200-100 The applicant, a 25 year old self-employed truck driver was attending a private party at the Flying Dutchman Motor Hotel. On leaving the party he attempted to pass through a doorway. A man blocking the door had apparently had a quarrel with his girl friend and gave vent to his anger by assaulting the applicant with his fists. The victim suffered severe and extensive dental damage. The assailant fled from the premises and has never been identified. Award: \$928.00 (p & s \$500.00).

200-108 The applicant, age 62, while walking along a Toronto street was pushed to the ground by two youths who made off with her purse. She sustained a fractured right hip. The offenders remain unknown. Award: \$2,198.00 (p & s \$750.00).

200-115 The victim, age 32, was requested to leave the Embassy Hotel in Windsor after he had become unruly. The hotel employee who ejected the applicant used excessive force. The applicant sustained minor facial injuries plus a fractured nose. The offender was convicted of assault and was fined \$50.00 When arriving at its decision, the Board had regard to Section 17(1) of the Act. Award: 373.88 (p & s \$100.00).

200-116 The victim, age 50, was walking along a Toronto street in company with a friend. For no obvious reason, a stranger punched her in the chest and knocked her to the ground. She sustained minor injuries to her body and right hand. A charge of common assault against the offender was withdrawn as he was committed to a mental health centre. Award: \$200.00 (p & s \$200.00).

200-121 The victim, a 15 year old male, was assaulted in front of a Rexdale theatre. He sustained the loss of three teeth and suffered mental anxiety as a result of subsequent threats by the offender. The offender was convicted of assault causing bodily harm and was fined \$200.00 and placed on probation for two years.

Award: \$661.44 (p & s \$500.00).

200-128 The applicant, age 55, was the victim of an unprovoked assault as he left his rooming house in Toronto. The offender, who was brandishing a piece of lumber, struck the victim in the left eye. The victim has completely lost the sight of the eye as a result. The offender was convicted of wounding and was sentenced to two years' imprisonment.

Award: \$6,977.40 (p & s \$5,000.00).

200-140 The applicant, age 20, was shot in an unprovoked attack as he left the Henley Hotel in St. Catharines. He received two wounds to his face as well as dental damage and a fractured jaw. The offender pleaded guilty to two charges of wounding and was sentenced to 14 years on these and other charges. Award: \$2,167.51 (p & s \$850.00).

200-142 The victim, a 51 year old machine operator, accompanied a strange woman to her Toronto apartment. A man was there and the three of them sat drinking beer provided by the applicant. The man, on being refused a demand

for money, commenced to assault the applicant with fists and with a shovel. The woman assisted in the assault. The victim received numerous severe injuries including head lacerations, fractured ribs and cerebral contusion. The assailant was convicted of assault causing bodily harm and was sentenced to one year's imprisonment.

Award: \$1,850.74 (p & s \$1,150.00).

200-143 The applicant, age 42, a Toronto building superintendent, was assaulted as he investigated a disturbance in one of the apartments. He sustained injuries to his head, chest and groin. The offender, having been convicted of assault causing bodily harm, was fined \$300.00 or three months in gaol. Award: \$940.00 (p & s \$750.00).

200-146 The victim, age 60, a retired painter, was assaulted when leaving the Vendome Hotel in Sarnia. He sustained multiple lacerations, damage to his left eye and profound deafness to his left ear. The alleged assailants were acquitted of a charge of robbery because of lack of identification. Award: 1,204.15 (p & s 1,000.00).

200-147 This 42 year old Toronto taxi driver was threatened with a knife by a passenger who refused to pay the fare. The applicant, while fleeing on foot, fell down a flight of steps and sustained a fractured right arm. He reported the matter to the police who apprehended the offender, in an intoxicated condition, asleep on the porch of a house. While no charges were laid the Board was satisfied that the applicant qualified as an innocent victim of a crime of violence. Award: 475.00 (p & s 250.00).

200-152 The applicant is a 31 year old waiter employed by the Ledo Hotel in Sudbury. While waiting for a taxi, after having completed his shift, he assisted a fellow employee to evict two men from the hotel as they had been creating a disturbance. One of the men returned and stabbed the applicant four times. The assailant was convicted of assault causing bodily harm and sentenced to six months' imprisonment.

Award: \$648.00 (p & s \$350.00).

200-156 The victim, a 19 year old meat packer, was assaulted by a fellow employee while on the job in Toronto. He sustained injuries to his testicles. The offender has not yet been apprehended having left the city. Award: 382.00 (p & s 300.00).

200-164 The victin, age 55, is a part-time farmer and part-time truck driver. When leaving the Legion Hall in Dundalk, he was punched in the left eye by an acquaintance. The blow broke the victim's glasses resulting in the loss of an eye. The offender was convicted of assault causing bodily harm and sentenced to five months' imprisonment.

Award: \$9,104.00 (p & s \$4,500.00).

200-166 The victim, now 58, was walking to catch a bus in Ottawa when two young men snatched her purse. The victim fell to the sidewalk fracturing her right patella and sustaining multiple abrasions. The offenders were never apprehended.

Award: \$608.40 (p & s \$500.00).

200-167 The victim, age 19, was stabbed during a scuffle in a Toronto apartment. He sustained a severed femoral artery and vein. The offender was charged with wounding and there is a bench warrant outstanding for his arrest. Award: \$2,332.00 (p & s \$1,250.00).

200-168 The applicant, a 40 year old Toronto man, was granted an Interim Award in September, 1972, having been assaulted, sustaining a severely fractured jaw and dental damage. At this writing, there is no mobility at the fracture site. The offender was convicted of assault causing bodily harm and was sentenced to three months in gaol.

Award: \$525.00 (p & s \$500.00).

200-169 The victim, age 21, a machinist by trade, was assaulted as he walked along a street in Toronto. As a result of this unprovoked incident, the victim sustained extensive dental damage. The offender was convicted of assault causing bodily harm and was given a suspended sentence plus probation for one month. Award: \$907.38 (p & s \$750.00).

200-171. The victim, now 39 years old, was attacked without provocation, by members of a motorcycle gang in the Parkdale Hotel in Toronto. He sustained lacerations to his head. The offenders were never apprehended. Award: \$670.00 (p & s \$500.00).

200-174 The applicant is a 32 year old maintenance worker employed by the Canadian National Institute for the Blind. He was assaulted and kicked in the head after leaving a dance in Kingston. He sustained fractures of the nose and jaw in addition to extensive dental damage. One of the offenders was convicted of common assault and fined \$100.00; the other was convicted of assault causing bodily harm and sentenced to three months in gaol. Award: 1,061.20 (p & s \$600.00).

200-178 The applicant received an Interim Award of \$5,837.00 which was reported in the Board's Fourth Report. A Final Award has now been ordered which relates to a further loss of wages only. Award: \$374.00.

200-181 The victim, now 21 years of age, was shot between the eyes while he was present at a gathering in Woodstock. The offender was sentenced to life imprisonment for the murder of another person who was shot during the same incident. In determining its Order, the Board had regard to the provisions of Section 17(1) of the Act.

Award: \$2,370.46 (p & s \$1,750.00).

200-183 The applicant, age 42, a Toronto police constable, sustained a fractured ankle while making an arrest. The offender was convicted of common assault and fined \$200.00 or 20 days in gaol. Award: \$950.00 (p & s \$950.00).

200-188 The victim, age 21, was assaulted by a group of youths as he walked along a Toronto street. He sustained cuts and abrasions to his head and chest. The three offenders were convicted of assault causing bodily harm and each was sentenced to two months in prison. Award: \$345.00 (p & s \$250,00).

200-189 The applicant, 37 years of age, was assaulted by an unknown assailant as he left the Silver Dollar Tavern in Toronto. He sustained a facial contusion and slight injury to his eye. Award: \$50,00 (n, k, a, 550,00)

Award: \$50.00 (p & s \$50.00).

200-190 The victim, a 20 year old man, was assaulted in the early evening on a Toronto street. He sustained multiple fractures of his jaw. The offender remains unknown.

Award: \$934.14 (p & s \$500.00).

200-191 The applicant, a 48 year old furniture finisher, was assaulted by four men as he walked along a Toronto street. He sustained a broken rib in addition to numerous bruises to his body. The offenders were not apprehended. Award: \$300.00 (p & s \$300.00).

200-194 The victim, a child 5 years of age, was shot in the right eye as he opened a window of his St. Catharines home. As a result of having been struck by a pellet from an air gun, he lost all sight of the eye. The juvenile offender was convicted of using a firearm in a manner dangerous to the public. Award: \$8,147.60 (p & s \$7,500.00).

200-196 The victim, a 31 year old Toronto security guard, was assaulted by several youths. He sustained a cerebral concussion and for several months experienced severe headaches and blackouts which required corrective surgery. One of these youths was convicted of assault causing bodily harm and was given a suspended sentence plus six months' probation.

Award: \$3,320.88 (p & s \$3,000.00).

200-204 The victim, age 33, was employed as a part-time taxi driver in the City of Toronto. He sustained facial lacerations as a result of being beaten by two men he had picked up as fares. One offender was acquitted; the other was fined \$50.00 or five days after being found guilty of common assault. Award: \$330.00 (p & s \$250.00).

200-208 The victim, age 43, was assaulted by an acquaintance whom he had admitted to his Toronto apartment. He sustained damage to his left eye, left ear and forehead. The offender was convicted on a charge of wounding and was sentenced to eight months indefinite.

Award: \$885.00 (p & s \$500.00).

200-209 The victim, a 59 year old crane operator, while walking along a Toronto street, was set upon, beaten and robbed by two men. He sustained lacerations to the scalp and numerous bruises. Both offenders were charged with, and convicted of, robbery. Each was sentenced to one year definite and one year less a day indefinite.

Award: \$205.00 (p & s \$200.00).

200-217 The applicant, a 75 year old night clerk at a Brockville hotel, was struck on the head by the assailant who also took money from the desk of the hotel. The victim sustained a depressed skull fracture necessitating surgery. The offender, who pleaded guilty to robbery with violence, was sentenced to two years in penitentiary.

Award: \$1,069.20 (p & s \$750.00).

200-223 The victim, age 20, was on duty in a Niagara Falls service station when the offender entered and demanded money. The victim refused the demands and was shot in the chest. The offender was convicted of armed robbery and wounding and sentenced to seven years in prison on each charge. Award: \$2,285.50 (p & s \$2,000.00).

200-228 The victim, now 11 years of age, was playing in a ravine in a Toronto suburb when another youth, 14 years of age, fired a pellet gun at him. The first shot missed but a second shot struck the victim in the left eye rendering him legally blind in that eye. The offender was adjudged to be a juvenile delinquent as a result of this occurrence and was placed on probation. The Board has recovered \$2,700.00 of its award under a Board of Education insurance policy. Award: \$7,810.00 (p & s \$7,500.00).

200-229 The victim, a 62 year old storekeeper, was walking in a Toronto park when he was set upon by three men. He was beaten into unconsciousness and sustained head injuries, bruises, contusions and eye damage. Eyesight in his left eye is almost completely lost. The offenders were not identified or apprehended. Award: \$4,565.00 (p & s \$4,000.00).

200-231 The applicant, whose 36 year old sister was murdered in the City of Toronto, was awarded \$626.50 for expenses incurred as a result of the death. The offender was found guilty of manslaughter and sentenced to life imprisonment.

#### Award: \$626.50.

200-233 The victim, a 26 year old Toronto mechanic was struck in the face by a beer bottle causing severe facial lacerations. The offender was convicted of assault and attempted wounding and sentenced to six months in gaol. Award: 1,203.35 (p & s 300.00).

200-234 The victim, a 69 year old watchman in Windsor, was struck in the face by the offender. He also sustained a laceration to his left wrist as a result of this assault. The offender was found guilty of common assault and was placed on probation for six months.

Award: \$603.16 (p & s \$100.00).

200-235 The victim, a 75 year old Toronto widow, sustained a comminuted fracture of her left ring finger while resisting four would-be purse snatchers. All youths concerned were charged with robbery, convicted as juveniles and placed on probation.

Award: \$335.00 (p & s \$250.00).

200-236 The applicant, 43 years of age, was set upon by two strangers in the parking lot of the St. Clair Hotel in Sarnia. He sustained multiple contusions in addition to injuries to his chest. The offenders have not been identified. Award: \$1,453.00 (p & s \$400.00).

200-240 The victim, a 33 year old unemployed Toronto painter was stabbed in the left chest without warning or provocation while visiting a friend's home. The offender was convicted of assault causing bodily harm and was sentenced to nine months' imprisonment.

Award: \$1,159.50 (p & s \$750.00).

200-241 The applicant, a 53 year old iron worker, was assaulted without provocation in a Toronto restaurant. He sustained a fracture of his left arm. The offender was not apprehended.

Award: \$2,224.00 (p & s \$300.00).

200-249 The applicant, a 39 year old housewife, was attacked and stabbed by a boarder in her Ottawa home. She sustained severe facial lacerations. The offender was sentenced to one year in prison, having been convicted of wounding. Award: 6,628.50 (p & s 4,000.00).

200-252 The victim, age 36, was assaulted and robbed in a Toronto subway station. He sustained a fractured jaw. The offender was convicted of robbery and sentenced to six years in gaol. The victim was not completely truthful with the Board as he withheld information regarding income received during his recovery and he attempted to inflate the cost of dental treatments. The Board invoked Section 17(1) of the Act and confined the award to out-of-pocket expenses only.

Award: \$681.85.

200-257 The victim, age 36, was assaulted by a fellow worker at a Toronto railway vard. He sustained a fractured jaw. The alleged offender left the country shortly after this incident and was therefore not prosecuted. Award: \$605.10 (p & s \$400.00).

200-266 The victim, age 24, was beaten in Thunder Bay when he attempted to break up a fight between one of his friends and eight other youths. As a result of having been viciously struck on the head with a club, the victim sustained a severe skull fracture and still has a mild speech defect. The offender was convicted of assault causing bodily harm and was fined \$300.00 or three months in gaol plus one year on probation. Award: \$7,490.57 (p & s \$5,000.00).

200-268 The victim, an 80 year old lady, was the victim of a purse snatch near her Toronto home. She sustained a dislocation of her right ring finger which eventually necessitated a surgical fusion. The offenders were not apprehended.

Award: \$400.00 (p & s \$300.00). 200-271 Following a heavy drinking session, in his Toronto apartment with

three male companions, the applicant, a 43 year old part-time taxi driver, was stabbed in the chest, back and side. The offender was convicted of wounding and was placed on 12 months' probation and fined \$150.00 or 60 days in gaol. In determining this award, the Board applied Section 17(1) of the Act and made no award for pain and suffering. Award: \$962.00.

200-272 The victim, a 52 year old widow, accepted a ride home following a dance at a Toronto social club. This previously unknown man drove to his own apartment and invited the applicant in to have a drink. She accepted and was subsequently assaulted for no apparent reason. She sustained a hairline fracture of the nose and facial lacerations. The offender was convicted of common assault and fined \$150.00 or 15 days in gaol. Award: \$902.11 (p & s \$500.00).

200-273 The applicant, a 42 year old physician and surgeon, was treating a patient in a Windsor hospital, who was suffering from an overdose of drugs and alcohol. The patient became violent and dangerous to the attending nurses. The doctor, in attempting to restrain the patient, was assaulted, receiving injuries to his forearm, face, eyes and inner ear. The assailant was convicted of assault and fined \$100.00 with the alternative of 30 days in gaol. Award: \$2,234.96 (p & s \$1,500.00).

200-274 The applicant is a 31 year old Hamilton truck driver. He is also a parttime waiter at the Exchange Hotel in Caledonia. While working at the hotel, he was assaulted for no apparent reason, sustaining a fractured jaw and dental damage. The offender was convicted of assault causing bodily harm and was sentenced to 60 days in gaol. Award: \$509.00 (p & s \$500.00).

200-275 The applicant, a 27 year old international exchange student, was attacked and robbed shortly after he left Diamond Jim's Tavern in Hamilton. He sustained stab wounds to his lower abdomen and right hand. The offenders have not been identified.

Award: \$509.00 (p & s \$500.00).

200-276 The victim, a 29 year old man, was assaulted by an intruder he surprised in a neighbour's yard in Willowdale. The victim could not identify his assailant and no arrest was made. He sustained a minor injury to his right wrist and superficial bruises. Award: \$75.00 (p & s \$50.00).

200-280 The applicant, a 55 year old automobile assembly line worker, was assaulted at his rooming house in Oshawa. The offender, who had cast a racial slur at the applicant, struck the applicant, causing cuts to the inside of his mouth. The offender was acquitted of common assault because of a lack of evidence. Award: \$222.10 (p & s \$100.00).

200-281 The victim, a 23 year old Toronto mother of two small boys, was attending a party at her brother's home. Some uninvited members of a motorcycle gang tried to crash the party and were refused admittance by the applicant's brother. Two of the gang members returned later with a shotgun. The applicant, her brother and another male guest received gunshot wounds. The brother and the guest subsequently died from their injuries. The offenders were convicted of non-capital murder and sentenced to life imprisonment.

Award: \$7,775.00 (p & s \$7,500.00). (Same occurrence as 200-258 and 200-487).

200-283 The applicant, age 24, attended a party in Thornhill and during the course of the evening four men, one being armed with a sawed-off .22 calibre rifle, entered and demanded that he give them his money. When he refused he was shot in the left upper thigh. Three of the four offenders were convicted on various charges as a result of this incident. Award: \$530.00 (p & s \$500.00).

200-284 The victim, a 19 year old man, was stabbed in the throat in a Windsor house after he had asked tenants in an upstairs apartment to be quiet. The offender pleaded guilty to a charge of assault causing bodily harm and was sentenced to one month in gaol and probation for one year. Award: \$1,442.67 (p & s \$750.00).

200-286 The applicant, 59 years old, is a steward at the Italian Canadian Club in Guelph. He was struck on the head as he left with the evening's receipts and sustained a linear fracture of the skull. The offender was convicted of assault with intent and sentenced to four years in prison. Award: \$943.00 (p & s \$750.00).

200-288 The victim, a 62 year old male, was injured in an unprovoked assault in a Palmerston hotel. He was struck in the right eye and as a result lost the sight of the eye. The offender was convicted of assault causing bodily harm and fined \$200.00, or in default, 40 days in gaol. Award: \$5,486.00 (p & s \$5,000.00).

200-290 The applicant, a 49 year old Guelph truck driver, became involved in an argument, in a parking lot, with a part-time taxi driver. He was physically assaulted by being knocked to the ground and kicked several times about the face and chest. He sustained multiple injuries to these areas. The offender was charged with assault but has not been apprehended. A bench warrant for his arrest is outstanding.

Award: \$967.00 (p & s \$350.00).

200-291 The victim, a 37 year old man, while proceeding to work at a bakery, was attacked by an unknown offender in the early morning hours in the City of Hamilton. He sustained a concussion causing frequent dizzy spells and scalp lacerations. The offender was never apprehended. Award: \$1,525.00 (p & s \$1,000.00).

200-292 The victim, age 47, was drinking beer in the Claremont Hotel, Toronto, when the female offender struck him with a glass. There was no apparent provocation. The victim lost the sight of his left eye as a result of this attack. The offender was convicted of assault causing bodily harm and fined \$300.00 or 30 days in gaol.

Award: \$3,150.28 (p & s \$2,000.00).

200-295 The victim, a 66 year old Toronto taxi driver, was struck in the face during a dispute concerning payment of a fare. He sustained a minor bruise on his chin and his dentures were broken. The offender was convicted of common assault and fined \$150.00 or 10 days.

Award: \$305.00 (p & s \$100.00).

200-296 The victim, a 51 year old Toronto woman, was stabbed in the eye by her common-law husband who had become extremely quarrelsome after having been drinking heavily. As a result of this wound, her right eye has been removed. The offender was sentenced to four years in penitentiary after being convicted of attempted murder.

Award: \$3,074.40 (p & s \$3,000.00).

200-298 The victim, a 36 year old man, was shot and killed in the village of Angus by his daughter's boy-friend. The offender was convicted of manslaughter and was sentenced to 15 years in gaol.

Award: \$1,670.00 and continuing payments of \$313.00 per month to the applicants, the wife and five children of the victim.

200-299 The applicant, age 25, while visiting his estranged wife at her Toronto residence, was assaulted by the alleged offender. The victim sustained a fractured jaw. Although the alleged offender was charged with assault causing bodily harm, the charge was withdrawn due to lack of evidence.

Award: \$650.00 (p & s \$500.00).

200-300 The applicant, age 44, was strolling along a Kingston street with his family when he came upon a group of youths who assailed them with obscene language. One of these youths punched the applicant in the face and kicked him twice in the groin. The offender, who was on parole, was returned to a training school.

Award: \$875.25 (p & s \$400.00).

200-301 The victim, age 32, was driving along a Toronto street when another car almost collided with him. The other driver stopped his vehicle, came over to the victim, and assaulted him. The victim sustained a fractured nose and dental damage. The offenders remain unknown.

Award: \$1,015.77 (p & s \$750.00).

200-303 The applicant, now 41, is a member of the Toronto Fire Department. He was attending a birthday party for a relative when two men knocked at the door. One of these men fired a rifle and the bullet struck the victim on the ring finger of his right hand. There is an outstanding warrant for one alleged offender; the other was convicted of common assault and fined \$150.00 or 15 days. Award: \$910.00 (p & s \$750.00).

200-304 The victim, a 36 year old Owen Sound labourer, lost the sight of his left eye when he was struck in the eye by a pellet from an air gun. The offender

was convicted of dangerous use of a firearm and received a suspended sentence plus probation for an 18 month period. Award: \$4,943.85 (p & s \$4,500.00).

200-305 The victim, a 20 year old man, was shot in the Elmgrove Hotel in Toronto after a dispute over a wager in the shuffleboard game. He sustained a severe gunshot wound to the abdomen requiring three operations. The offender was convicted on a charge of causing bodily harm with intent and was sentenced to three years in gaol.

Award: \$3,453.06 (p & s \$2,000.00).

200-308 The applicant, a woman 61 years of age, was the victim of an attempted purse snatch as she waited for a bus in Toronto. She was knocked to the ground and sustained fractures of the right elbow and pelvis. The two offenders have never been apprehended.

Award: \$808.80 (p & s \$600.00).

200-309 The applicant, age 29, was an engineer on a Norwegian ship which was docked at Sarnia. On going ashore one evening, he became acquainted with two men and their girlfriends. During the course of the evening, they drove to the outskirts of the city where he was assaulted and robbed by the two men. He sustained multiple lacerations to the head and a compound fracture of the left tibia with associated fracture of the fibula. Severe complications arose and he was returned to Norway for further treatment. The two offenders were convicted of robbery. One was sentenced to five years' imprisonment and the other to 18 months. The total award ordered was the maximum lump sum permitted by the Act. The cost in the amount of \$536.00 was ordered under the authority of Section 21 of the Act.

Award: \$15,536.00 (p & s \$3,000.00).

200-310 The victim, now 42, was assaulted by a group of young men while walking through a Toronto parking lot. He sustained dental damage, fractured ribs and facial injuries. One offender was convicted of robbery and possession of stolen goods. He was sentenced to six years in prison. Award: \$1,646.00 (p & s \$500.00).

200-314 The victim, a 16 year old girl, was assaulted and severely beaten in Toronto, by a man who was to have given her a ride to a babysitting job. She sustained multiple contusions and lacerations to her face and neck, and a broken jaw. The offender was convicted of assault causing bodily harm and was sentenced to 60 days in gaol.

Award: \$1,760.95 (p & s \$1,000.00).

200-315 The victim, age 33, was shot and killed while sitting in his car which was parked on a Toronto street. The offender was convicted of non-capital murder and sentenced to life imprisonment.

Award: \$5,000.00 and continuing payments of \$250.00 monthly to the applicant, the wife of the victim, on behalf of herself and her five children.

200-316 The victim, a single man, then 23 years of age, was assaulted by three men in the Riverview Hotel Beverage Room, Timmins. He sustained bruises and contusions to his head and spent two days in hospital. All three offenders were convicted of assault causing bodily harm. Award: 300.00 (p & s 300.00).

200-317 The applicant, now 20 years of age, was assaulted by two youths as he got off a Toronto Transit Commission bus. He sustained extensive damage to his

lower mouth and teeth. One offender was convicted of assault causing bodily harm in Juvenile Court and was fined \$25.00. As the applicant had provoked the incident, the Board applied Section 17(1) of the Act in determining its award and denied compensation for pain and suffering. Award: \$348.00.

200-318 The victim, a 15 year old girl, was struck in the left calf by a .22 calibre bullet while standing on top of the Scarborough Bluffs. At present she has a slight limp and has been advised to undergo further surgery. The offender has never been apprehended.

Award: \$600.00 (p & s \$600.00).

200-319 The applicant, age 18, was assaulted without provocation while walking down a Toronto street. She sustained a fractured nose. The offender has never been apprehended.

Award: \$150.00 (p & s \$150.00). (Same occurrence as 200-320).

200-320 The applicant, a lady 63 years of age, heard her granddaughter screaming outside her Toronto home. The granddaughter was being assaulted by a man outside of the house. The victim chased and grabbed the assailant by the arm at which time he knocked her to the sidewalk, causing injuries to her right knee. The assailant was not apprehended.

Award: \$325.00 (p & s \$300.00). (Same occurrence as 200-319).

200-321 The victim, age 18, was shot by an unknown assailant while walking along a Toronto street. He sustained wounds to his right buttock. The offender was never identified.

Award: \$275.00 (p & s \$200.00).

200-323 The victim, age 36, was shot in the abdomen during a domestic quarrel at Pefferlaw, Ontario. The resulting wounds necessitated immediate surgery. The offender was convicted of assault causing bodily harm and sentenced to three months definite and three months indefinite. Award: \$3,220.65 (p & s \$1,200.00).

200-324 The victim, a young lady, 22 years of age, was shot at home in Sault Ste. Marie by her father who blamed her for his marital difficulties. The victim sustained a fracture of her left humerus in addition to wounds to her right and left thighs. Her father was convicted of wounding and was sentenced to two vears' imprisonment.

Award: \$2,946.05 (p & s \$2,500.00).

200-330 The victim, age 50, was assaulted without provocation by another boarder at their Hamilton boarding house. The victim sustained a concussion which caused some blurred vision. The offender was convicted of assault and fined \$200.00 or 15 days in gaol. Award: \$740.50 (p & s \$500.00).

200-333 The applicant, age 35, was in his Toronto apartment with two companions when several unknown persons forced their way in and attacked them. The applicant sustained multiple trauma with facial fracture of the right mandibular condyle. One offender was apprehended and charged with assault and robbery. He was sentenced to seven years concurrent on each charge. Award: \$500.00 (p & s \$500.00).

200-342 The applicant, age 34, was stabled in the stomach by an irate customer in the Klondike Hotel, Niagara Falls, where he was hotel manager. The offender was found not guilty of attempted murder by reason of insanity and was ordered to be committed.

Award: \$678.00 (p & s \$500.00).

200-344 The victim, age 53, was fatally shot while tending bar at a wedding reception in Durham, Ontario. The offender who was charged with non-capital murder, was found not guilty by reason of insanity and committed to the Ontario Hospital.

Award: \$4,641.82 to the applicant, the wife of the victim and continuing payments of \$250.00 per month.

200-346 The victim, age 37, was struck on the back of the head while leaving a Toronto tavern. He sustained a fractured jaw and dental damage. The offender remains unknown. The Board exercised Section 17(1) of the Act in making their award.

Award: \$750.00 (p & s \$750.00).

200-348 The victim, a 54 year old Mississauga man, was struck on the head with a shovel by a fellow employee. There was no apparent motive for this assault. The victim sustained a skull fracture and also experiences persistent headaches. The offender, after being convicted of assault causing bodily harm, was remanded to the Ontario Hospital for psychiatric analysis. Award: \$1,267.67 (p & s \$600.00).

200-352 The victim, now 23, was struck in the face with a broken beer glass by another patron of a Harriston hotel. The attack was without provocation. The victim sustained facial lacerations requiring some 40 stitches. The assailant disappeared shortly after this incident and has never been brought to trial. Award: \$983,80 (p & s \$400.00).

200-353 The victim, a 61 year old handyman, had just parked his car on a Toronto street when a youth assaulted him after a heated discussion as to why his car was improperly parked. The victim sustained multiple contusions and broken dentures. The offender was convicted of assault causing bodily harm and was sentenced to 30 days in gaol. Award: \$481.00 (p & s \$350.00).

200-354 The victim, now 85, was attacked and knocked to the ground by a person who attempted to grab her purse while she walked along a Windsor street. She sustained fractures of two fingers of the right hand in addition to strained back muscles. The offender remains unknown. Award: \$500.00 (p & s \$500.00).

200-358 The victim, a 22 year old man, was attacked at the residence of an Ottawa girl by her enraged boy friend. He sustained a stab wound which punctured the left lung. The offender was convicted of assault causing bodily harm and was sentenced to 12 month's probation. The Board in making its award took into consideration Section 17(1) of the Act. Award: \$581.60 (p & s \$250.00).

200-361 The victim, a 13 year old girl, was hit about the head and body with the buckled end of a strap by a fellow cherry picker at Ridgeville, Ontario. She was also grabbed by the hair and choked. She received bruises on her head and buttocks. She suffered from headaches and dizziness. Her assailant was convicted of common assault and given a suspended sentence and put on one year's probation to keep the peace.

Award: \$475.40 (p & s \$200.00).

200-362 The applicant, 61 years of age, was assaulted by a stranger as he walked near his Belleville home. He became seriously depressed and a preexisting epileptic condition was aggravated. The offender was convicted of assault causing bodily harm and was placed on probation for two years. Award: 1,509.00 (p & s 1,500.00).

200-363 The victim, a 21 year old woman, was assaulted in a Guelph hotel. The offender, another woman, broke a glass on her face causing severe lacerations which resulted in permanent scarring. The offender was convicted of assault causing bodily harm and was fined \$100.00 or 20 days in gaol. Award: \$1,089.57 (p & s \$650.00).

200-364 The victim, age 83, responded to a knock on the door of his Toronto hotel room, thinking it was the maid. Two young men pushed their way in and beat him. The applicant sustained multiple facial fractures. The offenders were never apprehended.

Award: \$1,377.00 (p & s \$1,000.00).

200-367 The victim, a 22 year old factory employee, arrived at his Toronto home to find his front door ajar. Upon investigation he found two youths who ran from the premises into a nearby lane. As he gave chase, the applicant fell and sustained a chip fracture of a bone in his right foot. One offender was arrested and charged with robbery.

Award: \$622.16 (p & s \$350.00).

200-368 The victim, a 47 year old detective sergeant of the Windsor Police Department, was shot in the left thigh while trying to prevent a robbery. The bullet passed through his leg. The offender was sentenced to four years in penitentiary on a charge of armed robbery.

Award: \$752.02 (p & s \$400.00).

200-371 The applicant, a 56 year old Canadian National Railway conductor, was entertaining members of his family at his Capreol home, for a barbeque. A group of roofers who were working nearby attempted to join the party and when asked to leave, one struck the victim in the face. The victim sustained a serious injury to his eye in addition to facial lacerations. The offender was convicted of assault and was given a conditional discharge plus six months' probation.

Award: \$1,569.25 (p & s \$600.00).

200-372 A 62 year old Toronto woman was viciously assaulted by a purse snatcher outside her Toronto apartment. She sustained a severely fractured left arm. The offender was never identified.

Award: \$1,010.88 (p & s \$750.00).

200-373 The victim, a 25 year old Kingston high school teacher, was assaulted when attempting to break up a fight between two students at a football game. He sustained a fractured jaw and a minor eye injury. The offender was convicted of causing a disturbance in a public place. He was conditionally discharged for a period of two years and was required to report twice monthly to the local police department.

Award: \$541.75 (p & s \$400.00).

200-374 The victim, 19 years of age, was beaten and robbed as he walked home along a Toronto street. He sustained a severely sprained ankle which required that a walking cast be applied. The assailants remain unknown. Award: 356.00 (p & s \$200.00).

200-377 The victim, a 30 year old motel maid, was attacked while returning home from work in Trenton. The victim was kicked about the face and head. She sustained lacerations to her upper and lower lip, as well as broken upper dentures. The offender remains unknown. Award: 261.00 (p & s 100.00).

200-378 The applicant, age 52, attended the Hamilton wedding of some friends where she was stabbed by her former common-law husband. She sustained two lacerations to her abdomen. The offender was convicted on a charge of wounding with intent and was sentenced to two years less a day definite and 18 months indefinite.

### Award: \$777.82 (p & s \$600.00).

200-380 The applicant, now 24, attended a stag party for a friend in Oshawa. After what appeared to be a minor debate over a card game, the offender pointed a sawed-off shotgun at the victim and shot him in the chest and abdomen. The offender was sentenced to 10 years in prison as a result of being convicted of attempted murder.

Award: \$3,006.74 (p & s \$2,000.00).

200-381 The victim, age 35, was operating his Toronto Transit Commission bus when a passenger attempted to rob him of his run money. The victim defended himself but his attacker fled and has not been apprehended. The victim sustained bruises to his forehead, throat and neck.

Award: \$165.00 (p & s \$150.00).

200-382 The victim is a 32 year old plumber. While at the Pioneer Hotel in Williamsburg, he became embroiled in a fight with another patron and sustained severe damage to his left knee. A charge of assault causing bodily harm laid against the alleged offender was dismissed. The Board applied the provisions of Section 17(1) of the Act.

Award: \$1,368.20 (p & s \$600.00).

200-383 The applicant, a 30 year old male, was the victim of an unprovoked assault in a Toronto house. He sustained stab wounds to the head and lower abdomen and his hearing aid was destroyed. The offender was charged with assault causing bodily harm and sentenced to two years. Award: \$594.00 (p & s \$300.00).

200-384 The victim, a 27 year old man, was standing at a London bus stop talking with two girls when a man got out of his car, after having passed several times, and began punching him. The victim fell to the ground and was then kicked in the right ankle, causing a severe ankle sprain necessitating the use of crutches for walking for several weeks. A charge of assault causing bodily harm was withdrawn by the Crown as the alleged offender was deported to the United States.

### Award: \$922.85 (p & s \$300.00).

200-387 The victim, age 25, a Toronto police officer, was assaulted while attempting to question a driver who had committed a traffic violation. He sustained a fracture of the right radius. The offender was convicted of assault with intent to resist arrest and sentenced to five days in gaol.

Award: \$500.00 (p & s \$500.00).

200-389 The applicant, a 38 year old steel worker, was stabbed by a guest in his Toronto apartment. He sustained wounds in the abdomen and chest. The

charge against the alleged offender was withdrawn. Award: \$1.891.41 (p & s \$1,000.00).

200-391 The applicant, a 45 year old man, was the victim of an upprovoked attack by two men and two women in a Peterborough parking lot. He sustained cuts to the forehead and top of the head, requiring 14 stitches. Two of the offenders were convicted of robbery with violence, one being sentenced to five years, the other to 19 months.

Award: \$765.78 (p & s \$500.00).

200-395 The victim, a 50 year old woman, was assaulted and robbed by an off-duty Toronto taxi driver. As he made his escape, the offender drove over the victim's right leg. She sustained a very severe fracture of her left femur. A bench warrant remains outstanding for the alleged offender who was charged with robberv with violence.

Award: \$1,000.00 (p & s \$1,000.00).

200-396 The offender came to the 37 year old applicant's back door in Oshawa, seeking to call a taxi. The offender who had been drinking used abusive language and an argument developed. They grappled and both fell through the glass of the aluminium storm door. The victim sustained lacerations to his hand and left wrist. The offender was convicted of common assault and was fined \$50.00 or 5 davs.

Award: \$508,18 (p & s \$250.00).

200-398 The victim, a 44 year old Toronto Harbour Commission employee, was assaulted and stabbed by the offender. He sustained nine stab wounds to various parts of his body. The offender was convicted of assault causing bodily harm and sentenced to 30 days in gaol. Award: \$1.020.00 (p & s \$1.000.00).

200-400 The victim, age 33, was best man at a wedding in Toronto. After the ceremony, the bridal party left the church to change their clothes. As they parked their car, they were confronted by two masked men who demanded and received all the cash wedding gifts. During this robbery, the victim was shot in the right shoulder. The offenders were never apprehended. Award: \$700.00 (p & s \$400.00).

200-405 The victim, a 29 year old taxi driver, picked up two male passengers at the bus depot in Toronto. En route to their destination, he was struck on the head with an iron rod causing deep lacerations to his scalp. He has since developed a post concussion syndrome. The offenders were never apprehended. Award: \$605.00 (p & s \$400.00).

200-407 The victim, a 47 year old Toronto nurse, was assaulted by her sisterin-law when she asked for money which was owing to her. She was struck in the face, head and stomach and beaten over the head with an unknown weapon, inflicting a cut and breaking her glasses. The offender was convicted of assault and placed on probation for one year. Award: \$414.50 (p & s \$250,00).

200-408 The applicant, now 29 years of age, was beaten and robbed as he left his retail store in Toronto. He sustained multiple stab wounds of the scalp, face and back. Despite police investigations, no one was ever charged with this offence.

Award: \$3,280.00 (p & s \$2,500.00).

200-409 The applicant, age 46, sustained fractures of the tibia and fibula of his left leg as he attempted to intervene in a fight at the Don Mills Shopping Centre in Toronto. The offender was convicted of assault causing bodily harm and was sentenced to six months in gaol. Award: \$3.020.04 (p & s \$1.500.00)

200-410 The applicant, age 22, investigated screams coming from a ladies washroom at York University. He was confronted by a man who stabbed him in the face, chest and arm. The offender was found guilty of wounding and was sentenced to three months definite and six months indeterminate. Award: \$1,606.14 (p & s \$1,000.00).

200-411 The victim, age 18, was assaulted without provocation, while walking along a Hamilton street. He sustained a fractured jaw in addition to dental damage. The offenders have never been apprehended. Award: \$636.48 (p & s \$400.00).

200-412 The victim, a 42 year old salesman, was assaulted by two unknown men at the place of his residence, the Chancellor Motel in Toronto. He received medical attention for minor injuries, including a fractured rib. The offenders have never been identified. Award: \$357.00 (p & s \$250.00),

200-413 The victim, age 19, was assaulted for no apparent reason while walking along a Toronto street with her boy-friend. She sustained a fractured nose and facial lacerations. The offender, as a result of being convicted of assault causing bodily harm, was fined \$50.00 and placed on probation for a period of one year.

Award: \$460.09 (p & s \$250.00).

200-417 The victim, a somewhat frail Toronto man, age 59, was pushed down a flight of stairs resulting in a fracture of the pelvis. Although charges were not laid against the alleged offender, the Board is of the opinion that the offence of common assault was committed. Award: \$400.00 (p & s \$300.00).

200-418 The victim, a 53 year old man was assaulted, beaten and robbed in Sault Ste. Marie. His dentures and glasses were broken. Several suspects were questioned by the police, but the offenders were not apprehended. Owing to the victim's own conduct, the Board, bearing in mind Section 17(1) of the Act, denied compensation for pain and suffering. Award: \$223.90.

200-419 The victim, a 51 year old lady, was assaulted as she walked to her car which was parked at the Parkway Plaza in Scarborough. She sustained injuries to her right knee and left shoulder. The two youths who attempted to steal her purse were convicted of assault with intent to rob; one was sentenced to six months in gaol; the other was given a suspended sentence plus two years' probation.

Award: \$300.00 (p & s \$300.00).

200-420 The victim, a 40 year old resident of Windsor, was assaulted by a pedestrian who walked in front of his car. The offender, who struck the victim with a pop bottle, was convicted of assault causing bodily harm and was fined \$50.00 or 14 days in gaol in addition to one year on probation. Award: \$604.56 (p & s \$300.00).

200-421 The victim, a 20 year old labourer in the City of Hamilton, was struck

on the head by the offender who wielded an iron bar. The victim sustained fractures of the skull and jaw in addition to bruises and contusions. The offender was convicted of wounding with intent and was sentenced to two years in prison.

### Award: \$1,810.50 (p & s \$850.00).

200-423 The applicant, age 29, was shot following a drinking session at his Nakina, Ontario, residence. He was admitted to hospital with serious injuries to his abdomen, which necessitated surgery. The offender was convicted of dangerous use of a firearm and was placed on probation for one year. Award: \$832.30 (p & s \$750.00).

200-425 The applicant, a 38 year old police constable in the Town of Napanee, was shot while investigating a complaint against the offender. The offender then turned the gun upon himself and committed suicide. The victim received the shotgun blast in the chest and the wounds were extremely severe. Award: \$8,032.90 (p & s \$5,000.00).

200-426 The victim, age 69, is employed as a night watchman at a Toronto sports arena. The offender, on being asked to leave the premises, beat the victim viciously. He sustained a fractured shoulder, facial lacerations and multiple bruises. The offender was convicted of assault causing bodily harm and was sentenced to three days in gaol.

Award: \$955.00 (p & s \$800.00).

200-427 The victim, now 16, was maliciously beaten by a much heavier 15 year old bully and sustained a fractured nose. The Windsor police were notified but the offender escaped prosecution because he was a juvenile. Award: \$600.55 (p & s \$200.00).

200-428 The victim, a 48 year old taxi owner and operator in Toronto, was attacked by three passengers who had been drinking. He sustained a cervical sprain, a fractured malar bone and multiple contusions. The offenders fled and have not been apprehended.

Award: \$493.46 (p & s \$250.00).

200-430 The victim, age 58, was employed as a bartender in the Welland House Hotel in St. Catharines. At the time of this assault, she was at the hotel, but off duty. The one-legged offender, who had been ejected from the hotel, returned and struck her over the head with a crutch causing injuries to both her head and neck. The offender was convicted of assault causing bodily harm and was sentenced to one month in gaol.

Award: \$1,101.05 (p & s \$750.00).

200-434 The victim, a woman 71 years of age, was assaulted by two young men as she was walking along a street in St. Catharines. The offenders seized her purse and spun her around causing her to fall to the ground. She sustained a fracture of the right arm. The two offenders have never been apprehended. Award: \$2,272,90 (p & s \$900.00).

200-436 The victim, age 25, became embroiled in an argument in the Toronto apartment of his estranged wife. During the course of events, he slapped his wife who instantly stabbed the applicant in the chest with a butcher knife. The applicant laid a charge of wounding against his wife but later withdrew this charge out of consideration for his wife and children. The Board finds the merits of this claim as borderline; while finding the applicant a victim of crime within the meaning of Section 5(a) of the Act, the Board has considered the provisions of

Section 17(1) of the Act in rendering its decision and denied compensation for pain and suffering. Award: \$149.10.

200-437 The victim, age 28, a welder by trade, approached a group of youths who were causing a disturbance in the underground parking area of his apartment building in Downsview. One of these youths struck the applicant with a baseball bat. He sustained fractures of his cheek-bone and right forearm and mild concussion. This assault also resulted in permanent damage to his right eve. The offender was convicted of assault causing bodily harm and was sentenced to two years in penitentiarv.

### Award: \$2,536.00 (p & s \$2,000.00).

200-438 The victim, age 43, was confronted by her estranged husband as she returned from work to her home in Toronto. As she approached, he threw a bottle of muriatic acid in her face. She sustained extremely severe burns to her face, neck and upper body. The offender died in a car accident later the same day. The Board ordered an award for pain and suffering in the maximum amount permitted by the Act.

Award: \$15,000.00 (p & s \$15,000.00).

200-440 The victim, a 22 year old man, was assaulted in the Long Branch home of a female acquaintance by another guest. He sustained a cut lip and two broken teeth. The offender was convicted of assault causing bodily harm and was fined \$50.00 or 15 days in gaol. Award: \$1,082.00 (p & s \$100.00).

200-443 The applicant, age 32, a welder by occupation, narrowly avoided a collision in Toronto with another car. The offender, driver of the other vehicle, got out of his car and, without warning, assaulted the victim who sustained extensive dental damage. The offender was convicted of assault causing bodily harm and was fined \$100.00 or seven days in gaol. Award: \$637.50 (p & s \$200.00).

200-444 The applicant, age 25, a university student, was the victim of an unprovoked assault at the Coronation Hotel in Windsor. He sustained stab wounds to his upper and lower back. His four assailants were members of the Devil's Disciples motorcycle club. One of these persons was charged with two counts of assault causing bodily harm and was sentenced to one month consecutive on each count.

Award: \$754.00 (p & s \$500.00).

200-445 The applicant, a 47 year old officer of the Windsor French Canadian Club gave two club members a lift in his car when the club closed at the end of the day's business. When the applicant stopped his car on request the two passengers dragged him from his car and viciously beat him. The assault was supposedly in retaliation for the applicant having fired one of the club's bartenders. The two assailants were both convicted of assault causing bodily harm and fined \$150.00 and placed on probation for one year.

Award: \$1,673.77 ( p & s \$500.00).

200-446 The applicant, a 35 year old optical technician, was assaulted and robbed as he left Larry's Hideaway in Toronto. He sustained a fractured nose. The offender was not apprehended. Award: \$508.57 (p & s \$200.00).

200-447 The applicant, a 25 year old man, was the victim of an unprovoked as-

sault in the parking lot of a Windsor tavern. He sustained minor lacerations and a slight concussion. The offender was convicted of common assault and was sentenced to 30 days in gaol.

Award: \$244.60 (p & s \$150.00).

200-449 The victim, a 20 year old bank teller, was assaulted while walking home in Ottawa. She sustained minor bruises and abrasions. In addition she developed a nervous condition requiring pharmaceutical control. The offender was convicted of common assault, fined \$100.00 and placed on probation for twelve months.

Award: \$921.25 (p & s \$500.00).

200-451 The applicant, now 19, was wounded by gunshot in an unprovoked attempted murder in Teeswater, Ontario. He sustained wounds to the left side of his abdomen. The offender was found not guilty by reason of insanity and was committed to the Ontario Hospital at Penetanguishene.

Award: \$1,758.36 (p & s \$1,000.00). (Same occurrence as 200-452).

200-452 The applicant, then 19 years of age, was shot in the hip by the offender at Teeswater, Ontario, for no known reason. The offender was found not guilty of attempted murder by reason of insanity, and was committed to the Ontario Hospital.

Award: \$1,416.93 (p & s \$600.00). (Same occurrence as 200-451).

200-455 The victim, age 49, is a correctional officer employed at the Don Jail in Toronto. He sustained eye damage as a result of being punched by an angry prisoner. The offender was charged with assault with intent to wound but was never brought to trial as he died shortly after this occurrence. Award: \$500.00 (p & s \$500.00).

200-456 The applicant, age 27, suffered serious wounds when he was shot at his Guelph home by a neighbour. He sustained severe injuries to his right hip and pelvic area. He has partially lost the function of his right leg. The offender was convicted of wounding with intent and was given a suspended sentence plus eighteen months' probation.

Award: \$9,095.00 (p & s \$5,000.00).

200-459 The applicant, age 56, was employed as a groom at Woodbine Race Track in Toronto. The applicant's evidence is that his employer punched him in the nose without provocation. The victim sustained a fractured nasal bone. The alleged offender was charged with assault causing bodily harm which was subsequently dismissed in court. However, the transcript of the evidence indicates that there was an element of doubt in the judge's mind. The Board, therefore, finds the applicant a victim of crime according to Section 5(a) of the Act. Award: \$150.00 (p & s \$150.00).

200-461 The victim, age 29, was shot by her common-law husband as she slept in their Guelph home. She sustained fractures of the tibia and fibula of her left leg, and a large part of her knee-cap was destroyed. The offender was convicted of wounding and was sentenced to one year in prison, Award: \$7,614.90 (p & s \$5,000.00).

200-462 The applicant, a 25 year old St. Thomas electrical technician, had just finished playing a game of hockey when the offender, a member of the opposing team, struck him in the mouth. The victim sustained a fractured jaw in addition to dental damage. The offender was placed on probation for a period of six months.

Award: \$991.72 (p & s \$500.00).

200-463 The victim, a 26 year old man, was assaulted upon leaving a Toronto restaurant where a fight had just taken place. He sustained a stab wound in the right groin and a broken nasal bone. The offender was not identified. Award: \$717.52 (p & s \$300.00).

200-464 The victim, age 30, a self-employed plumber, was assaulted by two men in a Kitchener hotel. As a result of this unprovoked attack, the victim sustained a fractured right leg in addition to experiencing retrograde amnesia. Each of the offenders was convicted on a charge of assault causing bodily harm; they were sentenced to goal terms of two years and 15 months definite and six months indefinite respectively.

## Award: \$4,596.20 (p & s \$1,500.00).

200-465 The applicant, age 44, was assaulted in the washroom of a dance hall in Iroquois Falls and sustained injuries to his right eye and face. The offender was found guilty of assault causing bodily harm and was fined \$200.00 or one month imprisonment,

Award: \$548.30 (p & s \$500.00).

200-471 The victim, now 19, was a part-time Cambridge, Galt, variety store employee, when a male assailant, since convicted, struck her on the head with a pop bottle. The offender, after pleading guilty to robbery with violence, was sentenced to five years in penitentiary. Award: \$415.50 (p & s \$250.00).

200-473 The victim, age 22, was ordered by the son of his landlord to leave his Hamilton apartment. During an ensuing argument, the offender drove a glass into the victim's face causing the loss of the sight of his right eye. The offender later died, apparently from an overdose of drugs. Award: \$4,017.00 (p & s \$3,500.00).

200-474 The applicant is a 30 year old university student. As he left the Evergreens Motor Hotel in Kitchener, he was assaulted by two men. The victim received blows to the body and sustained minor dental damage. The two offenders were convicted of assault causing bodily harm; one was sentenced to 18 months in gaol; the other, 60 days in gaol. Award: \$612.00 (p & s \$150.00).

200-475 The victim, age 18, was shot in Kitchener, by a male companion who committed suicide immediately afterwards. She sustained bullet wounds to her right cheek and left hand. Award: \$968.20 (p & s \$600.00).

200-476 The applicant, a 47 year old Oshawa waitress, was assaulted by her former common-law husband. She was knocked to the floor and kicked, sustaining internal injuries to the stomach and bladder. Although a charge of assault causing bodily harm was dismissed against the alleged offender, the Board, after hearing the evidence of the applicant, feels that she is qualified under the Act. Award: \$477.50 (p & s \$400.00).

200-477 The applicant, 55 years old, is employed as a milkman in Brantford. He awoke in the night and surprised an intruder in his home, who ran to his car to make good his escape. The applicant tried to restrain the offender and was dragged along the driveway. He sustained torn ligaments in his left ankle. The offender was sentenced to 18 months in reformatory, having been convicted on a charge of break, enter and theft. Award: \$1,043.00 (p & s \$600.00).

200-478 The applicant, age 34, was the victim of an unprovoked assault in the Queen's Hotel in Preston. He sustained facial lacerations around the area of his left eye. The offender was sentenced to two months in gaol after having been convicted of assault causing bodily harm. Award: \$871.95 (p & s \$200.00).

200-479 The victim, age 31, an Ontario Provincial Police officer, was assaulted after being called by the offender's mother to her R. R. #1 Dunnville residence. The youth, apparently under the influence of alcohol and drugs, struck the officer breaking his jaw and loosening two teeth. The offender was found guilty of assaulting a peace officer and was sentenced to 30 days in gaol. Award: \$588.16 (p & s \$500.00).

200-482 The applicant, age 28, was assaulted as he refereed a soccer game in Toronto. He sustained a fractured nose in addition to bruises to his head and back. The offender, a player from one of the participating teams, was convicted of assault causing bodily harm and was fined \$300.00 or in default 28 days in gaol.

Award: \$843.16 (p & s \$400.00).

200-483 The victim, a 41 year old man, was attacked without provocation in the parking lot of his Toronto apartment building. He sustained a scalp wound and a minor injury to his shoulder. The offender fled into a nearby ravine and remains unknown.

Award: \$145.40 (p & s \$100.00).

200-484 The applicant, age 68, was returning to his Hamilton home following a political meeting. As he walked down the street, he was beaten and robbed by two teenagers, who have not been apprehended. The victim sustained a fractured right elbow.

Award: \$555.15 (p & s \$500.00).

200-487 The victim, age 21, was murdered in his Toronto home during the course of a party. Two members of a motorcycle gang, on being refused admittance, returned later with a shotgun and wounded three of the persons present. Two of those injured subsequently died. The applicant in this case was the mother of the victim and received compensation for pecuniary loss. The two received life imprisonment and 10 years respectively.

Award: \$1,500.00. (Same occurrence as 200-258 and 200-281).

200-488 The applicant, age 31, a Windsor policeman, was viciously assaulted while making an arrest. He sustained a fractured check-bone and eye damage. The offender was convicted of assaulting a peace officer and sentenced to 90 days in gaol.

Award: \$1,205.00 (p & s \$750.00).

200-489 The applicant, 32 years of age, a machinist by occupation, was assaulted and robbed as he walked along a Toronto street. He sustained various bruises and contusions which were of a minor nature. The offender was charged with assault and robbery but was sentenced to life imprisonment for an unrelated occurrence.

Award: \$159.94 (p & s \$150.00).

200-495 The victim, then 22 years of age, accepted a ride home from a bar with some people that he had just met. He was driven out into the country in Moulton Township where he was severely beaten and robbed. He sustained multiple bruises and a fractured nose. The four assailants were convicted of common

assault and sentenced to various terms. Award: \$523.00 (p & s \$200.00).

200-497 The victim, now 20 years old, was assaulted at the Kitchener Memorial Auditorium, while, as part of his duties as a security guard, he attempted to restore order among a group of patrons who were causing a disturbance. He sustained dental damage and multiple lacerations to his face. The offender was convicted of assault causing bodily harm and was fined \$200.00 or 40 days in gaol. Award: \$375.10 (p & s \$200.00).

200-501 The victim, age 35, had spent the evening with two girl friends at the Leonard Hotel in St. Catharines. As she walked home alone at 1.45 a.m., a stranger offered her a ride. When she refused, he assaulted her and then drove away. She received multiple bruising and superficial abrasions of the face, left eyebrow, lip and other areas of the face. The offender remains unknown. Award: \$324.00 (p & s \$200.00).

200-502 The applicant, now 21, a factory worker, was assaulted and stabbed by a member of the Satan's Choice motorcycle gang in a Peterborough hotel. As a result of this unprovoked attack, the victim sustained a severe wound to his left thigh. The offender was sentenced to one year in gaol on a charge of wounding.

### Award: \$1,537.60 (p & s \$750.00).

200-503 The applicant, a 43 year old Toronto labourer, went to a restaurant to purchase a barbecued chicken. On protesting the price, he was struck, by the waiter, across the face with a steel object. He was taken to hospital by ambulance where a severe laceration was sutured. No conviction was registered as a result of conflicting evidence.

Award: \$677.90 (p & s \$250.00).

200-504 The victim, 13 years old at the time of the assault, was beaten by an older youth while playing a game of road hockey in Toronto. He sustained extensive dental damage. The offender was convicted of assault causing bodily harm and fined \$200.00 or, in default, one month imprisonment. Award: \$410.00 (p & s \$150.00).

200-508 The victim, age 68, was walking along a Toronto street when she saw two youths and heard one say, "I dare you". She was then struck in the face with a baseball. She sustained a fractured nose in addition to facial bruises. The offenders were never apprehended. Award: \$620.95 (p & s \$300.00).

200-510 The victim, age 67, was knocked to the ground as she walked along a Toronto street. Surgery was later performed to correct a fracture of her right hip. Although charges were not laid against the alleged offender, the Board has found the victim  $\infty$  mpensable within Section 5(a) of the Act. Award: \$687.50 (p & s \$400.00).

200-512 The applicant, age 24, a university student, was attacked by a group of eight men as he and a friend hitchhiked back to their Windsor residence. The victim sustained extensive dental damage. The offenders remain unknown. Award: \$601.00 (p & s \$200.00).

200-513 The victim, age 24, was attacked by a member of the Devil's Disciple motorcycle club in Windsor. He sustained minor cuts and abrasions to his face. The offender was convicted of assault causing bodily harm and was sentenced to

60 three months in gaol plus probation of one year.

#### Award: \$214.00 (p & s \$100.00).

200-516 The victim, now 33, a paper company inspector, was assaulted by two persons at his Thorold home. He sustained injuries to both knees, face and left elbow. Each offender was convicted of assault causing bodily harm and sentenced to 10 and 30 days in gaol respectively. Award: \$215.00 (p & s \$200.00).

200-517 The victim, age 15, sustained dental damage as a result of being assaulted by a group of youths as he returned home from a fireworks display at the Kitchener Auditorium. The juvenile offender was charged with assault causing bodily harm and was placed on four months' probation. Award: \$339.00 (p & s \$250.00).

200-518 The victim, now 64 years of age, was assaulted and robbed as he took the day's receipts from his variety store in London to the bank. He sustained a minor concussion and eye injuries. The offender was found guilty of possession of stolen goods and was sentenced to six months' imprisonment to be followed by 18 months' probation.

Award: \$514.00 (p & s \$250.00).

200-519 The victim, a 23 year old Pickering, Ontario, student, was riding his bicycle on Highway #2 when a car pulled up alongside of him. The passenger in the front seat of the car reached out and pushed the applicant causing him to lose his balance and fall. He suffered multiple bruises and abrasions of his chin, left shoulder and left knee. The offender was found guilty of assault causing bodily harm and given two years' suspended sentence and probation. Award: \$163.20 (p & s \$100.00).

200-522 The victim, a 33 year old taxi driver, was beaten and robbed by five passengers as he drove them to their destination in Timmins. He sustained injuries to his face and nose. Three of his assailants were apprehended and convicted of robbery with violence, each receiving one year in gaol and one year on probation.

Award: \$1,247.00 (p & s \$350.00).

200-523 The victim, age 16, was assaulted and robbed by another minor as he walked down a laneway in Toronto. He sustained lacerations of the scalp. The offender was charged with robbery with violence, convicted and placed on probation.

### Award: \$575.00 (p & s \$350.00).

200-524 The victim, age 67, upon returning to his Toronto apartment, found it to have been ransacked. His next recollection was regaining consciousness the following day. He had been beaten and sustained numerous severe injuries which prevented him from working for three months. The offender was never apprehended.

Award: \$3,000.00 (p & s \$1,000.00).

200-525 The victim, age 31, a Toronto Transit Commission streetcar operator, was injured while attempting to apprehend a youth who had just snatched a lady's purse. He sustained multiple bruises and abrasions in addition to a fractured patella. A bench warrant remains outstanding for the alleged offender who was charged with theft.

Award: \$1,090.94 (p & s \$1,000.00).

200-529 The applicant, age 54, was viciously assaulted, outside a Kingston restaurant, for no known reason. In addition to the loss of the sight of his left eye, he sustained severe head injuries. The offender was convicted of assault causing bodily harm, and was sentenced to two years and six months' imprisonment. Award: \$6,910.33 (p & s \$5,000.00).

200-531 The applicant, age 59, was beaten by a group of young people who were causing a disturbance in a Toronto shopping mall where he was employed as a security guard. He sustained severe injury to his left eye. One juvenile was convicted of assault causing bodily harm and was placed on probation. Award: 700.00 (p & s 600.00).

200-533 The applicant, age 54, a car salesman in Windsor, was assaulted by an irate prospective customer. He sustained a fractured right ankle in addition to various lacerations and bruises. The offender, who was convicted of assault causing bodily harm was sentenced to 20 days in gaol plus one year on probation. Award: \$2,855.85 (p & s \$1,000.00).

200-534 The victim, a 9 year old girl, was struck in the back by a .22 calibre bullet as she watched a ball game in the yard of a Markham public school. Even though the offender, age 16, was found not guilty of criminal negligence, the Board finds that he might have been convicted of unlawfully causing bodily harm.

Award: \$1,180.31 (p & s \$750.00).

200-541 The victim, a woman 74 years of age, sustained a concussion, bruises and cuts after being pushed to the ground by three youths who stole her purse as she walked along a St. Catharines' street. All three youths were apprehended and convicted as juveniles.

Award: \$409.00 (p & s \$350.00).

200-542 The victim, a 47 year old Peterborough registered nursing assistant, was assaulted by two men as she crossed the parking lot of the McGillis Hotel. She sustained a concussion along with bruising of her right arm. The offenders were never apprehended.

Award: \$576.53 (p & s \$200.00).

200-548 The applicant, 32, was stabbed in their Preston home, by his wife, who accused him of going out with another woman. This couple's domestic relations had been very stormy. The victim sustained wounds to his back and head. The wife was convicted of wounding and was sentenced to six months plus two years' probation. In determining their Order, the Board applied Section 17(1) of the Act.

#### Award: \$926.18 (p & s \$250.00).

200-551 The victim, a 57 year old self-employed carpenter, on entering the restaurant that he was building outside Coboconk, Ontario, was struck on the head from behind. He sustained multiple fractures of the skull and a cerebral concussion. The offender has never been identified. Award:  $2_{2,530.00}$  (p & s  $2_{2,500.00}$ ).

200-552 The applicant, a 42 year old geophysical operator, was assaulted at the Copacabana Restaurant in the Sudbury area. He sustained fractures of his left tibia and fibula. The offender was convicted of robbery with violence and was sentenced to three years in prison.

Award: \$2,111.00 (p & s \$1,500.00).

200-556 The victim, 18 years of age, was assaulted in a London tavern by two

unknown males. There was no apparent reason for this assault. The victim sustained severe stab wounds to the front of the body, back and both hands. As a result of this vicious assault, one offender was found guilty of wounding and was sentenced to six years in prison; the second offender was found guilty of assault causing bodily harm and was placed on two years' probation. Award: \$1.520.25 (p & s \$1.250.00).

200-558 The victim, a 52 year old Toronto grocery merchant, was stabbed in the abdomen by one of two men who had entered his store and demanded money. The two offenders have never been apprehended. Award: \$7,740.00 (p & s \$2,500.00).

200-559 The victim, 34 years of age, is employed as a ticket salesman at the Toronto Bus Terminal. The offender, who appeared to be impaired, approached the sales counter and struck the plastic shield, knocking it into the applicant's face. The applicant sustained lacerations to his lip and chin plus dental damage. The offender was convicted of assault causing bodily harm. He was fined \$50.00 or 10 days in gaol in addition to being placed on one year's probation. Award: \$633.16 (p & s \$600.00).

200-563 The victim, age 63, was returning to his home from the Polish Hall in London when three men attacked him. He sustained minor injuries to his face and left knee. The offenders remain unknown.

Award: \$468.59 (p & s \$200.00).

200-565 The applicant, age 27, and a friend, were set upon by five young men as they walked along a Toronto street. As a result of this unprovoked assault, the victim sustained injuries to his right hand and face. The offenders were not apprehended.

Award: \$200.00 (p & s \$150.00).

200-568 The victim, a nine year old Toronto boy, was struck in the eye by a stone thrown by another juvenile. He has partially lost the vision of his right eye. The offender was convicted of assault causing bodily harm and received a suspended sentence.

Award: \$1,702.00 (p & s \$1,500.00).

200-571 The applicant, age 24, sustained gunshot wounds to both lower legs outside his Ottawa apartment. The offender was sentenced to four years' imprisonment on a charge of wounding. Award: \$1,341.00 (p & s \$1,000.00).

Award. \$1,541.00 (p & s \$1,000.00).

200-572 The applicant, age 43, a building custodian with the Ontario County Board of Education, was assaulted in the beverage room of the Queen's Hotel in Oshawa. She sustained a fractured nose plus facial bruises. The offender was charged with assault causing bodily harm and was sentenced to four months in gaol.

Award: \$764.67 (p & s \$500.00).

200-573 The victim, a housewife 30 years of age, was assaulted by another woman in the laundry room of their Toronto apartment building. She sustained extensive damage to her lower spine. The offender was found guilty of common assault and was given an absolute discharge. Award: 1,381.79 (p & s 1,000.00).

200-574 The victim, age 19, was standing on Main Street in Kenora, when a man who had just robbed a bank was shot by the police. The bank robber had on his person explosives, with the detonating device held between his teeth.

When he was shot the explosives detonated with a violent blast killing the bank robber and injuring a number of people who were in the vicinity. The applicant was injured as a result of metal fragments being driven into his left leg. The deceased offender has never been identified. Award: \$409.70 (p & s \$350.00).

200-575 The victim, a 34 year old Associate Professor of Sociology, was standing in Allen Gardens in Toronto talking with her husband when she was approached by an elderly man who struck her across the face with his cane. She sustained lacerations and a fracture of her nose. The offender was charged with assault causing bodily harm, but he died before the case came to court. Award: \$762.90 (p & s \$500.00).

200-576 The applicant, age 40, was assaulted in the beverage room of the Queen's Hotel in Stratford, Ontario. She sustained a relatively mild strain to her neck. The offender was convicted of common assault and was fined \$200.00 or 20 days in gaol.

Award: \$739.08 (p & s \$200.00).

200-577 The applicant, 70 years of age, was assaulted and robbed by a group of teenagers as she walked towards her home in Kingston. She sustained a fractured shoulder. The offenders have never been identified. Award: \$1.392.20 (p & s \$350.00).

200-578 The applicant, age 35, was assaulted by two youths as he strolled through High Park in Toronto. He sustained extensive dental damage. His attackers fled and were never apprehended.

Award: \$1,345.70 (p & s \$500.00).

200-585 The applicant, age 44, was assaulted by an intoxicated acquaintance at a Christmas party in Sudbury. She sustained massive haemorrhages to both eyes and facial bruises. The offender was convicted of assault causing bodily harm and was sentenced to six months in prison to be followed by 24 months' probation.

### Award: \$1,315.05 (p & s \$500.00).

200-588 The victim, age 44, a guard at the Guelph Correctional Centre, was knocked to the ground and kicked by an inmate. The victim sustained a severely fractured jaw and nose in addition to dental damage. The offender was found guilty of assault causing bodily harm and was sentenced to six months consecutive to the term being served.

Award: \$1,863.00 (p & s \$1,000.00).

200-593 The applicant, age 32, a registered nurse, was assaulted by a person who had come to St. Joseph's Hospital in Toronto for treatment. She sustained a dislocated shoulder and scratches to her arms and legs. The offender was convicted of assault causing bodily harm and was fined \$150.00 or 15 days in default of payment.

Award: \$592.00 (p & s \$450.00).

200-594 The applicant, now 53, was stabbed by a man he did not know as he crossed an intersection in Toronto. He sustained a severe wound to his chest. Although a thorough investigation was conducted by the police, the offender was never apprehended.

Award: \$1,637.00 (p & s \$750.00).

200-596 The victim, age 60, was assaulted by three youths as he walked through a Toronto park. He sustained minor facial bruises and abrasions. The

64

offenders were not apprehended. Award: \$117.00 (p & s \$100.00).

200-606 The applicant is a 21 year old Kitchener labourer. As he walked home from work, the offenders stopped their car, got out and knocked the victim to the ground. As a result of this senseless assault, the two offenders were convicted of assault causing bodily harm and each one was sentenced to 21 days in gaol. Award: 303.43 (p & s 200.00).

200-610 The applicant, a 23 year old Toronto dock worker, and his girlfriend were customers in the M & G Burger Restaurant. The applicant inadvertantly knocked an ashtray off a table, breaking it. A part-owner working in the restaurant took exception to this conduct and assaulted the applicant. His injuries consisted of lacerations to his scalp and cervical injuries. The offender was convicted of assault causing bodily harm and was fined \$100.00 or 15 days in gaol. Award: \$319.00 (p & s \$150.00).

200-611 The applicant, age 26, accompanied by his wife and a young married couple were leaving a Kitchener restaurant. Three unknown men molested one of the ladies in the party. The applicant, on going to her assistance, was assaulted by the three strangers. He was punched, kicked and rendered unconscious. He suffered injuries consisting of lacerations of the face and inside his mouth, cracked teeth, a scalp wound and a gross external hematoma of the right eye resulting in a dilated right pupil. His assailants have not been apprehended. Award: 2,679.04 (p & s 1,500.00).

200-613 The applicant, age 64, an innocent bystander, was knocked down during a fight between two men in a Toronto subway station. She sustained a cerebral concussion. The offenders were not apprehended. Award: \$542.00 (p & s \$300.00).

200-615 The applicant, age 69, was thrown to the sidewalk in Toronto by a young man who attempted to steal her purse. She sustained three broken ribs and a fracture of the upper left arm. The offender has never been apprehended. Award: \$2,983.00 (p & s \$1,500.00).

200-617 The victim, 42 years of age, was assaulted by an unknown person as he was jogging in the Rosedale ravine in Toronto. He sustained lacerations to his lips in addition to dental damage. The offender was never apprehended. Award: \$617.90 (p & s \$300.00).

200-626 The applicant, a 21 year old university student, was stabbed in the chest at a house party in Sarnia. The offender has never been identified although the police conducted a thorough investigation. Award: 313.56 (p & s 200.00).

200-630 The victim, a 29 year old Hamilton meat packer, became involved in an argument with the offender after an evening of drinking. He was shot twice in the chest by the offender who was convicted of wounding and was sentenced to five years in penitentiary.

Award: \$1,726.75 (p & s \$1,250.00).

200-634 The applicant, now 41 years of age, attempted to intervene in an altercation between two employees in her Toronto dry cleaning establishment. She was struck on the face and sustained minor injuries. The offender was convicted of assault causing bodily harm and was fined \$75.00 or 30 days. Award: 308.00 (p & s 150.00). 200-639 The victim, 70 years of age, requested two youths to leave the front yard of her Toronto home. One youth raised his hand in a threatening manner and the victim fell, breaking her wrist, as she attempted to avoid being struck. The offender was convicted of common assault and was bound over to keep the peace for a period of 12 months on a bond of \$500.00.

Award: \$985.00 (p & s \$750.00).

200-648 The victim, age 25, was assaulted without provocation outside the Ritz Hotel in Port Colborne. He sustained fractures of the cheek and jaw-bone in addition to extensive dental damage. The offender was convicted of common assault and was fined \$80.00 or eight days in gaol.

Award: \$1,293.00 (p & s \$1,250.00).

200-649 The applicant, age 44, was viciously assaulted and robbed in a laneway adjacent to the Russell Hotel in St. Catharines. The victim sustained a traumatic right global rupture and lacerations of his upper and lower lids and scalp. It was necessary to enucleate the right eye which was beyond repair. Before the assault the victim had been drinking heavily and could not identify his assailants. The Board recorded that it was not unmindful of Section 17(1) of the Act in arriving at its decision.

Award: \$4,251.45 (p & s \$4,000.00).

200-650 The victim, age 48, was assaulted while sitting in the lobby of the Queen's Hotel in Oshawa, where he resides. He sustained minor lacerations to his nose and also experienced dizziness for some time subsequent to the assault. The offender was sentenced to 14 days in gaol after having been convicted of assault causing bodily harm.

Award: \$821.20 (p & s \$250.00).

200-653 The victim, age 33, sustained a fractured jaw after having been assaulted while in her room at the Dryden Hotel, Dryden, Ontario. The alleged offender was charged with assault causing bodily harm but failed to appear in court. A bench warrant remains outstanding for his arrest.

Award: \$876.14 (p & s \$750.00).

200-654 The applicant, now 34, responded to a tenant's complaint of noise in the hallway of the apartment building in London, Ontario, where he was the superintendent. He found four persons creating a disturbance. He was kicked by one of these persons and sustained a fractured ankle. The offender was never apprehended.

Award: \$830.65 (p & s \$450.00).

200-657 The victim, a 35 year old machinist, was assaulted in the parking lot of the Empire House Hotel in London. He sustained lacerations to his face and right eye. The offender was convicted of assault causing bodily harm and was sentenced to nine months in prison to be followed by one year on probation. Award: 474.50 (p & s 250.00).

200-658 The applicant, age 32, was assaulted as he attempted to stop a fight in progress in front of the Coronet Motor Hotel in Kitchener. He sustained a fractured rib in addition to facial lacerations. The assault was reported to the police but because of lack of identification, the offender is still unknown. Award: \$530.00 (p & s \$500.00).

200-660 The victim, a 40 year old painter, was assaulted without provocation in the Prince of Wales Hotel, Niagara-on-the-Lake, Ontario. He sustained lacerations to his head. The offender was convicted of assault causing bodily harm and

was sentenced to two months in gaol. Award: \$369.12 (p & s \$250.00).

200-665 The applicant, age 27, was assaulted by her estranged husband who came to her Toronto apartment and attacked her with a knife. She sustained wounds to her back, arm, chest and head. The offender was convicted of wounding and was sentenced to two years and three months in gaol. Award: \$1,755.00 (p & s \$1,750.00).

200-667 The applicant, age 63, a Toronto shipper was assaulted by a taxi driver with whom he had become embroiled in an argument. He sustained minor lacerations to his face plus a fracture of his left ankle. The offender was convicted of common assault and was fined \$120.00 or 21 days in default of payment. Award: \$1,816.10 (p & s \$1,250.00).

200-668 The applicant, age 63, was assaulted upon informing a tenant in her daughter's New Toronto rooming house that he must leave. She sustained multiple bruises to her head and body. In addition she developed an anxiety reaction to this incident. The offender was convicted of assault causing bodily harm and was sentenced to three months in gaol and three years' probation upon release. Award: \$257.50 (p & s \$250.00).

200-670 The victim, a 20 year old student, was shot in the leg as he crossed an intersection in Windsor. The wound became seriously infected necessitating a below the knee amputation of his left leg. The offender has never been identified. Award: \$9,575.56 (p & s \$8,000.00).

200-677 The victim, age 56, is a pensioner who was assaulted and robbed by a group of young thugs as he walked along a Toronto street. He was severely beaten and sustained a fractured left leg in addition to numerous abrasions. The offenders have never been identified. Award: \$860.00 (p & s \$750.00).

200-678 The applicant, age 47, a correctional officer, was assaulted in front of his Barrie home as he assisted a police officer to make an arrest. He sustained a compound fracture of his right leg. The two offenders were charged with and convicted of assault causing bodily harm; each was sentenced to 14 days in gaol. Award: \$1,546.84 (p & s \$1,500.00).

200-681 The victim, age 24, a shipper by occupation, was assaulted without provocation outside a Toronto restaurant. He sustained a fractured jaw and lacerations to his face. The two offenders were convicted of assault causing bodily harm and sentenced to 18 and 12 months in prison respectively. Award: \$1,162.25 (p & s \$1,000.00).

200-683 The victim, now 36, was beset by a gang of youths as he rode his bicycle along a Chatham street. He sustained a fracture of the right leg in addition to lacerations to his mouth. One member of this gang was found guilty of assault causing bodily harm and was sentenced to one month in gaol. Award: \$2,117.00 (p & s \$850.00).

200-684 The applicant, age 38, was shot by an unknown person as he arrived at his place of employment in Hamilton. He sustained a flesh wound and a fracture of his right forearm.

Award: \$2,080.30 (p & s \$850.00).

200-690 The applicant, age 40, was stabled in the chest by a fellow employee at their place of employment in Toronto. The wound has aggravated an asthmatic condition which had been quiescent since childhood. The offender was convicted of wounding and was sentenced to six months in prison plus two years on probation.

Award: \$1,386.00 (p & s \$1,200.00).

200-698 The applicant, now 51 years old, was assaulted by members of a motorcycle gang at a barn dance in Meyersburg, Ontario. He sustained lacerations to his scalp and face. His three assailants were sentenced to varying prison terms.

Award: \$462.00 (p & s \$300.00).

200-699 The applicant, a 29 year old sales representative, was involved in a collision with another vehicle as he left the parking lot of the Holland-Hitch plant in Woodstock. He was assaulted by the driver of the other car without provocation and sustained a fractured nose plus minor lacerations. The offender was convicted of assault causing bodily harm and was fined \$200.00 or two months in default.

Award: \$243.00 (p & s \$150.00).

200-700 The victim, age 58, had been visiting some friends in Toronto and as he walked to his car, he was knocked to the ground by two youths and robbed. He sustained lacerations to his right eye, right ear and a contusion on his head. Both offenders were convicted of common assault. Award: \$389.36 (p & s \$200.00).

200-702 As the applicant, age 31, and her husband crossed the parking lot of a restaurant in Sault Ste. Marie, they were assaulted by four strangers. She sustained minor lacerations to her face and experienced headaches for a period subsequent to the assault. One of the offenders was at trehended and was convicted of assault causing bodily harm. He was sentenced to 60 days in gaol. Award: \$344.76 (p & s \$150.00).

200-703 A group of youths were drinking in a Rexdale parking lot and creating a great deal of noise. The applicant, age 34, a nearby resident, on asking them to move on, was stabbed by one of the youths, with a broken beer bottle. He sustained severe injuries which required major surgery for three hours to repair the lacerations. The offender was convicted of assault causing bodily harm and was sentenced to three months definite and three months indefinite. Award: \$522.00 (p & s \$500.00).

200-704 The victim, now 30, a fork-lift operator, was a patron in the New Toronto Hotel where he was assaulted by another person. This attack was unprovoked. The applicant sustained a severely fractured jaw. The offender who was convicted of assault causing bodily harm was sentenced to three months' imprisonment.

Award: \$713.54 (p & s \$500.00).

200-708 The victim, age 22, employed as a liquid material mixer, came out of a restaurant in Toronto when he was knocked to the sidewalk and robbed. He sustained lacerations to his face plus minor dental damage. The offender has never been identified.

Award: \$330.89 (p & s \$200.00).

200-709 The applicant, age 29, a glazier by trade, became embroiled in a fight outside a St. Catharines apartment building where he had been visiting a friend. He was assaulted by two persons and sustained lacerations to his scalp in addition to a cerebral concussion. Each offender was charged with assault causing bodily harm; one pleaded guilty to common assault and received a suspended sentence; the charge against the other was withdrawn. Evidence given before the Board indicates that the applicant contributed to this incident. For that reason, the Board applied the provisions of Section 17(1) of the Act. Award: \$1,335.06 (p & s \$500.00).

200-712 The applicant, now 42, was injured as he tried to intervene in a fight in the Captain's Table Restaurant, Waubaushene, Ontario. In making a citizen's arrest, he sustained a fracture of his right ankle. The alleged offender was killed in a motor car accident before he could be tried. Award: \$2,535.00 (p & s \$500.00).

200-722 The applicant, age 38, a high school teacher who was accompanied by four of his students, had stopped for gas at a service station in Leeds County. There he was assaulted by the offender who was in a drunken state. He sustained dental damage and multiple bruises to his chest and face. The offender was sentenced to nine months in prison for assault causing bodily harm.

## Award: \$745.00 (p & s \$100.00).

200-727 The applicant, age 42, was tending bar at the Park House Hotel, in Hamilton. In attempting to evict some obnoxious customers, he was stabbed twice in the abdomen. The offender was convicted of wounding with intent, and was sentenced to six months in prison.

Award: \$972.50 (p & s \$750.00).

200-730 The applicant, age 57, was struck from behind by an unknown juvenile cyclist in Toronto. She sustained a major laceration to the back of her left leg.

### Award: \$334.60 (p & s \$300.00).

200-732 The applicant, a 23 year old stockhandler, was riding his bicycle home from his place of employment in Weston when the offender forced him to stop and demanded his bicycle. As a result of the ensuing scuffle, the applicant sustained a mild concussion plus bruises to his head. The offender was sentenced to three months in gaol after having been convicted of assault causing bodily harm. Award: \$210.50 (p & s \$150.00).

200-738 The applicant, now 28, a film processor, was assaulted by three unknown males as he boarded a Toronto subway train. He sustained injuries to his face, neck and shins. None of the offenders have been apprehended. Award: \$590.00 (p & s \$200.00).

200-745 The victim, a 16 year old girl, was found dead, as a result of head injuries, on the roadside in the County of Waterloo. Despite an exhaustive investigation by the police, the person responsible for her death has never been identified. The father of the victim received compensation in relation to funeral expenses.

#### Award: \$1,979.00.

200-746 The applicant, age 68, while employed as night attendant at a service station in London, was stabbed by a man who demanded money. He sustained wounds to his right side and right wrist. The offender was convicted and sentenced to 10 years in prison on a charge of robbery. Award: \$781.00 (p & s \$600.00).

200-750 The applicant, age 86, was accosted by a purse snatching youth as she walked home from church in Chatbam. She sustained a fractured hip. The offender has never been apprehended. Award: 2,30.05 (p & s 1,000.00). 200-755 The applicant, a young lady 26 years of age, was assaulted as she walked by Lorne Park in Brantford. She sustained a fractured jaw in addition to dental damage. Although she can identify her assailant, he has never been located.

Award: \$1,105.38 (p & s \$600.00).

200-758 The applicant, age 83, was assaulted in the Mine Mill Hall in Sudbury. As a result of this unprovoked assault, he sustained a fractured nose and severe swelling and bruising of the face. The offender was convicted of assault causing bodily harm and was fined \$300.00 or 60 days in gaol. He was also suspended from the Union Hall for life.

Award: \$822.65 (p & s \$450.00).

200-761 The victim, a 19 year old girl, was found strangled on the grounds of Erindale Campus, University of Toronto, Mississauga. The offender has never been identified. The father of the victim received compensation in relation to that portion of the funeral expenses which was not covered by insurance. Award: \$264.24.

### SUMMARY WHERE PUBLICATION OF EVIDENCE WAS ORDERED TO BE RESTRICTED

100-556 The victim, a 27 year old female accepted a ride from an unknown man who had offered to drive her to the place where she was to go for a job interview. Approximately 20 miles from their destination, the car was stopped and the driver forcibly removed her from the car and indecently molested her. She fought off her attacker and her screams caused her assailant to flee. A thorough investigation was carried out, but the offender was never apprehended. Award: \$746.70 (p & s \$500.00).

100-808 The applicant, 20 years of age, was the victim of a multiple rape by a group of persons who belonged to a motorcycle club. All five offenders pleaded guilty to rape; four of the five were sentenced to six years in prison and the fifth was sentenced to three years.

Award: \$1,938.00 (p & s \$1,000.00).

100-841 The victim, a 36 year old widow, was returning to her home when two voung men attempted to force her into their car, with the intention of indecently assaulting her. She sustained dental damage plus minor lacerations. The offenders were not apprehended. Award: \$611.78 (p & s \$300.00).

100-960 The victim, age 15, was brutally assaulted and raped by a casual acquaintance who was charged with rape and indecent assault on a female. He was convicted of both offences and sentenced to a total of seven years in penitentiarv.

## Award: \$2,376.00 (p & s \$2,000.00).

200-32 The victim, age 25, was assaulted by three unknown men. He was savagely beaten and sustained a fractured nose, leg and damage to his right eye. One offender was convicted of common assault and placed on six months' probation. Recently, a second suspect has been arrested. Award: \$8,265.61 (p & s \$3,000.00).

200-138 The 47 year old applicant, having previously lost the sight in one eye, became totally blind as the result of an assault committed upon him while a customer in the beverage room of the Hodder Avenue Hotel in Thunder Bay. His application was heard in 1972 and he was subsequently granted an Interim Award pending the outcome of civil proceedings. The Board has now rendered their Final Decision in this matter.

Award: \$8,011.50 plus periodic monthly payments of \$500.00 each for 16 months and thereafter continuing at a reduced rate of \$300.00 per month. (p & s \$4,500.00).

200-243 The victim, a 14 year old Grade 10 student, was assaulted by the driver of a car at which he had directed obscene gestures. He sustained a fractured jaw. The offender was not apprehended. In making an award, the Board considered Section 17(1) of the Act and confined the award to expenses only. Award: \$205.00.

200-282 The victim, a 42 year old man, was attacked in the parking lot of a Mississauga hotel in an unprovoked assault. He sustained lacerations to his evebrow and lips, and bruises to his body. The alleged offender was charged with assault causing bodily harm, but due to lack of identification, the charge was dismissed.

Award: \$613.64 (p & s \$250.00).

200-338 The applicant, age 18, having been released from a Provincial Training School had been placed in a foster home in Newmarket. He was stabled one night without provocation by another boy at the same home. He sustained wounds to the face, neck, chest and back. The offender was found not guilty of attempted murder by reason of insanity.

Award: \$1.525.00 (p & s \$1.500.00).

200-340 The victim, a 53 year old woman, was assaulted and raped in her apartment. The offender was convicted of rape and sentenced to six years in penitentiary.

Award: \$2,904.85 (p & s \$2,500.00).

200-343 The victim, a 26 year old housewife, surprised an intruder in her home. This 14 year old youth attempted unsuccessfully to rape her. The victim suffered much anxiety from this emotionally traumatic experience. The offender was convicted of break and enter with intent to rob and was returned to the training school of which he was already a ward.

Award: \$1,200.93 (p & s \$750.00).

200-349 The victim, a 27 year old woman, was accosted by a man who forced her into a nearby parking lot. There she was not only raped but also stabbed many times in her shoulder, hip, arms and chest. The suspected offender subsequently fatally shot a police officer and then committed suicide. Âward: \$4,069.00 (p & s \$3,500.00).

200-414 The victim, a 25 year old Toronto housewife, was standing with her two children in High Park, when a complete stranger stopped his car and pulled her son into the car. A struggle ensued between herself and the driver over the child and she eventually was pulled into the car. She finally managed to escape. Following the occurrence she was in a state of acute nervous disturbance and was seeing a psychiatrist regularly at the time of the hearing. The offender was convicted of common assault and fined \$75.00.

Award: \$1,389.00 (p & s \$1,000.00). (Same occurrence as 200-415).

200-424 The victim, age 34, was assaulted and raped by an unknown, masked assailant. During this incident, she sustained damage to the tendons of her left hand.

#### Award: \$1,749.00 (p & s \$1,500.00).

200-500 The applicant, age 28, gave evidence that the alleged offender emptied a teapot of boiling water over her head and body as she descended the stairs of her rooming house. The victim sustained extremely severe burns to her upper torso which have resulted in extensive permanent scarring. The accused was charged with wounding. Although this charge was dismissed, the Board finds that the applicant is a victim of a crime within the meaning of Section 5(a) of the Act.

### Award: \$4,103.50 (p & s \$3,000.00).

200-507 The victim, age 27, although not inclined to drink to excess, had spent the major portion of the evening with her husband on a pub crawl. On returning home an argument ensued and the applicant left the house and walked in the direction of her sister's home. She was emotionally upset and accepted a ride from a stranger who subsequently indecently assaulted her. The offender was convicted of indecent assault and sentenced to three years in prison. Award: \$1,471.00 (p & s \$1,000.00).

200-515 The victim, now 14, became involved in an altercation with a boy at

her public school. The assault aggravated pre-existing conditions in her ears. The offender was convicted of being an adjudged delinquent and was referred to the Clarke Institute of Psychiatry. Award: \$616.00 (p & s \$300.00).

200-521 The victim, age 45, was brutally attacked and raped by a juvenile assailant. Although she sustained only minor physical injuries, the after-effects of this emotionally traumatic incident were considerable. The offender was found guilty of rape as well as other outstanding charges. He was sentenced to Hillcrest Training School for an indefinite period. Award: \$2,606.00 (p & s \$2,500.00).

200-538 The victim, age 47, was assaulted by two young men and sustained damage to his right eye, resulting in temporary double vision. One of the assailants has now been identified and court proceedings are to follow. Award: \$686.76 (p & s \$200.00).

200-539 The victim, age 45, was raped and brutally assaulted with the result that she lost the sight of one eye and sustained permanent brain damage. One of the two offenders was found guilty of wounding and was sentenced to five years in prison; the other was convicted of being an accessory after the fact and was sentenced to two years, six months in prison. Award: \$6,660.00 (p & s \$5,000.00).

200-582 The victim, age 23, was indecently assaulted after having accepted a ride while hitch-hiking. She sustained minor injuries after having jumped from the vehicle while it was in motion. The offender was convicted of indecent assault and was fined \$300.00 or six months' imprisonment. Award: \$927.64 (p & s \$750.00).

200-598 The victim, age 18, died as the result of a self-administered overdose of a restricted drug. Her two companions were subsequently convicted for trafficking in a restricted drug. The applicant, mother of the victim, made application for out-of-pocket expenses relating to the funeral. The Board applying the provisions of Section 17(1) of the Act denied compensation.

200-607 The applicant, age 60, was the victim of an attempted rape. She was viciously assaulted and sustained facial injuries which required corrective surgery. The offender has not been identified. Award: \$2,904.25 (p & s \$2,500.00).

200-621 The applicant, age 69, was assaulted and robbed in the Cambridge, Ontario, hotel where he resides. He sustained severe damage to his left eye and it may have to be removed at a later date. One offender was convicted of theft and received a fine of \$50.00 or five days; a charge of robbery with violence is still pending against the other alleged offender. Award: \$2,222.00 (p & s \$2,000.00).

200-637 The victim, age 16, was raped and beaten to death by persons unknown. The applicant, the father of the deceased victim, received compensation for expenses incurred as a result of the death. Award: \$497.37.

200-666 The victim, a registered nurse, was beaten and raped by a person who had given her a ride when she was hitch-hiking to reach the hospital for her night tour of duty. The offender was convicted of rape and of choking with intent. He was sentenced to a total of nine years in prison. Award: \$3,146.78 (p & s \$2,500.00).

200-686 The victim, a one year old baby girl, was struck in the head by a pellet as she and her mother waited for a bus in Ottawa. A juvenile criender was convicted of wounding and was sent to a training school. Award: \$1,007.00 (p & s \$600.00).

200-736 The victim, age 32, was shot and fatally wounded while a guest at a friend's apartment. The alleged offender has been charged with non-capital murder but has not vet come to trial. The award was granted to the common-law wife of the victim as reimbursement of out-of-pocket expenses for the funeral. Award: \$771.00.

200-763 A young girl, 14 years of age, was the victim of a vicious knife attack. wounding and rape with the result that she lost the sight of her right eye. The offender was sentenced to 12 years in prison for wounding plus an additional 12 years concurrent for rape.

Award: \$10,331.00 (p & s \$9,500.00).

#### SUMMARY OF DISALLOWED APPLICATIONS

100-456 The applicant, now 50, was shot by an unknown assailant at his Hamilton home. The applicant has an extensive criminal record for crimes of violence. The Board, is of the opinion that the injury suffered by the applicant is directly related to his character and way of life. The Board exercising its discretion in accordance with Section 17(1) of The Compensation for Victims of Crime Act, denied the application. The offender has never been identified.

100-563 The applicant, age 41, is a member of the Toronto Fire Department. Several explosions occurred as the firemen were attempting to extinguish a fire in a grocery store. The applicant was injured as a result of one of these explosions. Although arson has been intimated, it has not been proven and no convictions have resulted from this occurrence. The applicant has not proven that he sustained his injuries as a result of a criminal act. The application was dismissed.

100-634 The applicant, a 29 year old female, was beaten by her common-law husband in their Toronto apartment. Under these circumstances, Section 4(2) of The Law Enforcement Compensation Act precludes any award for pain and suffering. At the time of the assault the applicant was not employed and has made no claim for lost income. Although the Board accepts that the applicant is a victim of crime, she has established no claim for which she is compensable. The application is dismissed.

100-895 The 35 year old husband of the applicant was found unconscious in a Lisle, Ontario, parking lot following a Royal Canadian Legion party. Following transfer to the Toronto General Hospital his injuries were diagnosed as a head injury resulting in intracranial pressure. He died shortly thereafter. No evidence was submitted to prove that an assault had taken place. However, the applicant was advised that she could re-apply to the Board should additional evidence become available. The application is dismissed.

100-906 The applicant, age 26, was struck twice by a soccer ball as she walked through a recreation area in Scarborough. She did not report this incident to the police department until three days later, nor did she lay charges against the offender. The Board is not satisfied that the applicant is a victim of a crime of violence and the application is denied.

200-102 The victim, then age 11, admits to having spit in the face of a companion. Whereupon he was struck in the mouth and sustained serious dental damage. The assault was not reported to the police. The Board is of the opinion that the applicant provoked the attack and thereby disqualifies himself as a victim of a crinic of violence. The application was rejected; however, the Board incurred an expense of \$30.15 for medical reports required as evidence.

200-133 This 43 year old Toronto maintenance worker alleges that on leaving the Elm Grove Hotel in Toronto he was hit on the head and robbed. He was uncooperative with the police and his evidence before the Board was extremely vague. The application was dismissed.

200-212 The applicant, age 35, an electrical foreman, was assaulted by two strangers with whom he had been drinking at an apartment in Toronto. The Board considered the provisions of Section 17(1) of the Act. Having in mind the conduct of the victim, the Board disallowed this application. However, the Board did order payment in the amount of \$405.00 to cover the cost of assembling the claim.

200-214 The victim, a 44 year old man, advised that he was assaulted on a

Toronto street. A Toronto police officer gave evidence at the hearing that he observed the applicant stumble and fall down causing the injuries outlined in the application. The application was dismissed.

200-289 The 63 year old applicant claimed that he was assaulted in Oshawa while posting some letters. However, the Board's investigator ascertained that the injuries were received in a fall. The application was dismissed.

200-328 The victim, age 46, became involved in a mild altercation with one of her neighbours at her Oshawa home. There were no injuries of any consequence sustained by either party. In addition, countercharges which had been laid by both persons were withdrawn. The Board could find no basis for making an award and the application was dismissed.

200-365 The applicant, age 34, was shot four times at the Wellington Tavern in Windsor. He sustained wounds to his abdomen, left arm and left hip. The offender was found not guilty of attempted murder in that he acted in self-defence when attacked by the applicant. It is the decision of the Board, that having regard to Section 17(1) of the Act, that no award for compensation be made. However, the Board allowed costs of assembling this application in an amount of \$748.96.

200-415 The victim, a two year old boy, was pulled away from his mother and pulled into a car by a driver in High Park in the City of Toronto. His mother eventually succeeded in getting him from the car. There was no evidence produced at the time of the hearing that the child sustained any injury. The application was dismissed. (Same occurrence as 200-414).

200-448 The victim, a 61 year old Toronto seamstress, was struck on the head by a soft drink can which had apparently fallen out of a window above her. She suffered a laceration to her scalp and subsequent headaches. There was no evidence as to where the pop can came from or the circumstances under which it fell from above. The application was dismissed.

200-454 The applicant, a 75 year old taxi driver, went to a Niagara Falls hotel to pick up a fare. While standing near the exit, he was knocked down by another patron who was rushing from the beverage room. No report was made to the police and the hospital notes indicate that the applicant fractured his hip during a fall on the street. Therefore, the Board was unable to find this applicant a victim of crime. The application was dismissed, but costs of \$18.50 were ordered, covering attendance at the Hearing, in accordance with Section 21 of the Act.

200-514 The victim, age 19, died as the result of injuries sustained during a brawl at a Toronto restaurant. The applicant, the mother of the victim, incurred no financial loss as the result of the death of her son. While the Board has every sympathy for the applicant, no award could be made.

200-537 The victim, age 18, was assaulted by the wife of a man with whom she had been keeping company. She was struck on the face causing a deep cut and she also sustained minor damage to her right knee. The offender was convicted of assault causing bodily harm and was fined \$100.00 or 15 days in gaol. In arriving at its decision, the Board applied the provisions of Section 17(1) of the Act. Accordingly, this application was dismissed.

200-567 The applicant, age 30, sustained a fractured jaw and dental damage when assaulted in a female acquaintance's apartment in Timmins. Even though he was able to identify the offender, the applicant did not lay criminal charges.

In their decision, the Board applied Section 17(1a) of the Act. This application was rejected.

200-651 The applicant, age 32, picked up a strange woman at the Brown Derby and accompanied her to the Rex Hotel in Toronto. There he was assaulted by two men. The applicant gave evidence that was both contradictory and untrue. The Board did not find this applicant to be a credible witness. The application was dismissed within the provisions of Section 17(1) of the Act.

200-691 The victim alleges that he was assaulted at his place of employment in Toronto by a fellow employee. Investigation showed that the applicant was the author of his own misfortune and therefore the Board applied the provisions of Section 17(1) of the Act. The application was denied.
