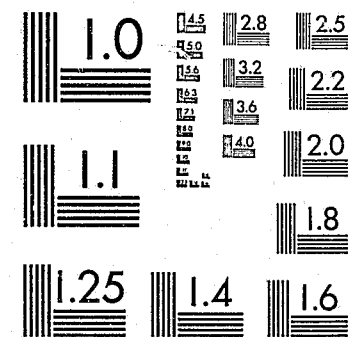

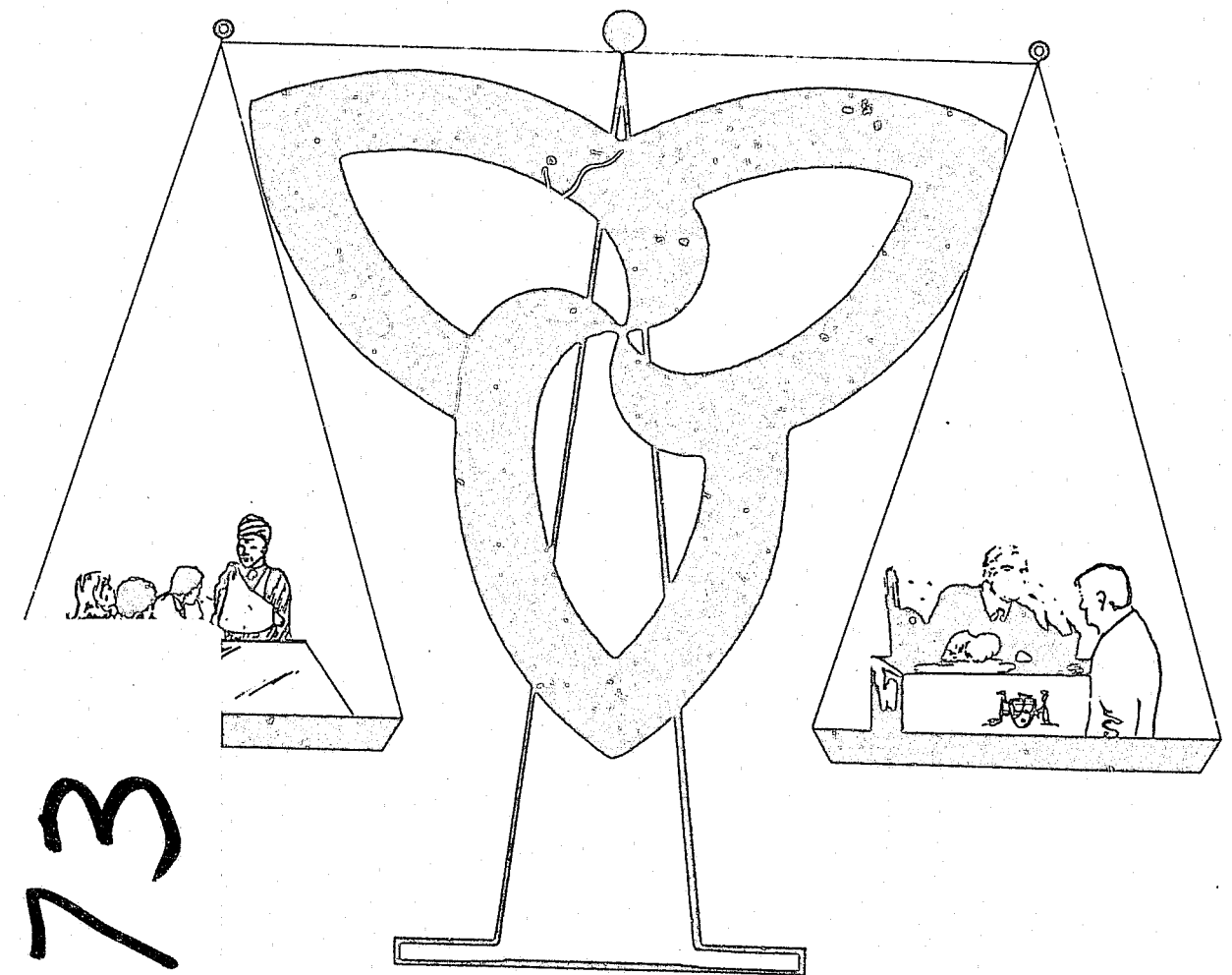

PROGRAMME DESCRIPTION

The Legislation

The legislation under which the Board functions is The Compensation for Victims of Crime Act, 1971, which came into force on September 1, 1971 superseding The Law Enforcement Compensation Act, 1967.

The Board is required by the Act to find the commission of a crime (in the principal class of applications coming before it). A basic qualification for the consideration of an award is that there must be adequate and reliable evidence in this regard. In addition, the Board is required to consider all relevant circumstances including the behaviour of the victim at the time of the incident and the co-operation given by the victim to the law enforcement agencies.

Section 6 of the statute prescribes a one-year limitation period for filing an application for compensation, but the Board may extend the time as it considers warranted. During the year, 147 requests for extension of the limitation period were received, of which 126 were approved.

Subrogation

The Board is subrogated to all the rights of any person to whom payment is made under this Act, to recover damages by civil proceedings in respect to injury or death and \$12,660.66 was recovered during the fiscal year.

Hearings

The members of the Board, of whom twelve are on a part-time basis, usually sit in panels of two.

During the fiscal year, hearings, in addition to those held in Toronto, took place in Kenora, Thunder Bay, Sudbury, Sault Ste. Marie, Windsor, London and Ottawa. This is done to facilitate applicants, and to generate a better understanding of the work of the Board across the province.

Administration and Productivity

The administrative staff of the Board is comprised of the Registrar, the Chief of Investigation and three investigators, in addition to a clerical, stenographic and secretarial staff of eight. This small staff has been most dedicated in its efforts to maintain a high standard of service to the Board and to the public. Improvement in procedures by the staff has enabled the Board to increase its output significantly.

In this fiscal year the Board heard 985 applications as against 858 in the previous year which represents an increase of 15%, while the cost of administering the programme rose from \$466,000.00 to \$551,000.00 or by 18%. Total awards ordered increased by 12% from \$2,170,688.91 to \$2,434,343.92 while the average award rose from \$2,059.79 to \$2,132.14 or by 4%.

The number of applications received rose from 1190 in 1979-80 to 1274 (7%) in this fiscal year.

Public Awareness

Large posters, together with a supply of explanatory brochures, are displayed in hospital emergency wards and staff lounges. The various police forces throughout the province have been provided with wallet-size cards which are designed to draw to the attention of the victims of crimes of violence that they may be eligible for compensation and advising how to apply to the Board. The daily hearing agenda and a selection of typical Board Orders are provided to the news media.

Cost Sharing

Awards made under The Compensation for Victims of Crime Act are cost shared between the Federal Government and the Government of Ontario. The contribution by the Federal Government amounts to 50% of the awards (net of any recoveries) to a maximum of ten cents per capita of the population of Ontario. For the fiscal year 1979-80 this share amounted to \$849,980.00.

100-993 The applicant, an 11 year old girl, was shot by a pellet gun and hit in the left eye. She sustained a tear of the peripheral iris, a cleavage of the chamber angle and a traumatic cataract. The offender was convicted under the Juvenile Delinquents Act and sent to training school.
Award: \$5,358.00 (incl. pain and suffering \$5,000.00)

200-1583 The applicant, a 31 year old woman, was stabbed by her husband several times in a fit of rage. She sustained lacerations to the neck, left arm, back and lungs. She had voice and swallowing problems, permanent and visible scars, Horner's syndrome in her right eye, and shortness of breath. Her husband committed suicide.
Award: \$7,950.00 (incl. pain and suffering \$7,500.00)

200-1958 The applicant, a 44 year old labourer, was robbed and severely beaten in a parking lot. He sustained injuries to all facial structures with complete destruction of their normal anatomical relationship, destruction of the right eye and a neurological inability to move his left arm and upper extremity. The two offenders were convicted of robbery with violence and sentenced to six years imprisonment.
Award: \$15,355.00 (incl. pain and suffering \$15,000.00)

200-1995 The applicant, a 30 year old factory piece worker, was shot in her home. Her son was injured and her daughter was killed in the incident. The applicant sustained a comminuted compound fracture of the right humerus and a traumatic injury to her left ear. The offender was convicted of assault causing bodily harm and using a firearm in a dangerous manner.
Award: \$13,150.16 (incl. pain and suffering \$6,500.00)

200-2435 The applicant, a 39 year old produce manager, was assaulted in a tavern. He sustained a fractured nose and facial lacerations. The offender was convicted of assault causing bodily harm. The Board took into consideration the terms of Section 17(1) and 17(1a) and made a reduced award for pain and suffering.
Award: \$886.35 (incl. pain and suffering \$500.00)

200-2658 The applicant, a 20 year old miner, was assaulted while visiting an apartment. He sustained a broken collar bone which required three operations. The offender was convicted of common assault and sentenced to 30 days in jail.
Award: \$4,147.14 (incl. pain and suffering \$2,000.00)

200-2759 The applicant, a 25 year old unemployed man, was assaulted by two men when he complained that they were being noisy. He sustained a conjunctival hemorrhage and a swollen nose. One offender was convicted of assault and fined \$150.00 or 15 days. There is no record of the disposition of the charge against the other offender.
Award: \$300.00 (incl. pain and suffering \$300.00)

200-2864 The applicant is the mother of an 11 year old girl who was hit in the eye by a rock thrown by a member of a gang of boys. She sustained a serious eye injury and the eye was eventually removed. No report was made to the police.
Award: \$10,338.00 (incl. pain and suffering \$10,000.00)

200-3060 The applicant, a 27 year old commercial artist, became involved in a fight in the parking lot of a hotel where he had been drinking. The applicant sustained contusions to his face and scalp, a haematoma to the right eye, a broken nose, severe brain damage and partial loss of visual acuity. The offender was charged with assault causing bodily harm and sentenced to two years in jail. The Board reduced the award for pain and suffering, citing Section 17(1) of the Act.
Award: \$9,549.08 (incl. pain and suffering \$6,000.00)

200-3235 The applicant, a 26 year old transport driver, was shot while hunting. He sustained fractures to his right clavicle and right scapula. These injuries prevented him from returning to his job. Charges were dropped due to an error by the Crown.
Award: \$7,743.83 (incl. pain and suffering \$3,500.00)

200-3269 The applicant, a 20 year old tavern manager, was robbed and stabbed as he went home with the receipts for the night. He was stabbed in the thumb and his flexor tendon was cut. The assailant is unknown.
Award: \$1,885.44 (incl. pain and suffering \$1,000.00)

200-3284 The applicant, a 24 year old steel worker, was attending a party in the house where the accused lived. The accused was upset and shot the applicant in the right leg with a shot gun. The applicant sustained a compound fracture of the tibia and fibula of the right leg. The offender was convicted of wounding and sentenced to two years less a day in jail plus 12 months indeterminate.
Award: \$8,067.85 (incl. pain and suffering \$4,000.00)

200-3310 The applicant, a 15 year old student, was knocked to the ground and kicked while parking cars at his school. He sustained a laceration to his forehead, cuts and bruises, and damage to his front teeth. The offenders were convicted of assault causing bodily harm.
Award: \$1,554.00 (incl. pain and suffering \$1,200.00)

200-3325 The applicant, a 46 year old bush contractor, was sitting in a hotel when the offender, with whom he was not acquainted, struck him over the head with a pool cue. He sustained a depressed skull fracture and a concussion. A bench warrant for the offender was issued.
Award: \$8,370.00 (incl. pain and suffering \$4,000.00)

200-3381 The applicant, a 53 year old woodcutter, was cut on the left hand by an axe. He sustained lacerations of the wrist, two profundus tendons and the ulnar nerve. The offender was convicted of wounding and sentenced to two years less a day imprisonment. As the applicant had been drinking heavily, the Board invoked Section 17(1) of the Act to make a reduced award.
Award: \$1,872.61 (incl. pain and suffering \$1,000.00)

200-3439 The applicant, a 58 year old millhand, was attacked by a tenant with a hammer when he returned home from work. He was struck on the head, and sustained a depressed right frontal skull fracture and lacerations. The offender was convicted of wounding and sentenced to 18 months in jail.
Award: \$4,069.33 (incl. pain and suffering \$2,500.00)

200-3453 The applicant, a 20 year student, was dating a woman whose former boyfriend harassed them. The offender followed them to their apartment parking lot until the police were called. The applicant went to find the offender, and when he did, was shot five times. He sustained injuries to the left pectoral region, the left and right calf regions, right axilla and abdomen. The offender was convicted of wounding with intent and sentenced to 5 ½ years imprisonment.
Award: \$4,066.52 (incl. pain and suffering \$3,500.00)

200-3511 The applicant, a 22 year old student, was given a ride by the two offenders who attempted to rob him, and who pushed him out of the moving car. He sustained a compound fracture of the femur and missed school and employment for 18 months. The two offenders were convicted of assault causing bodily harm, and sentenced to 90 days in jail and a \$500.00 fine.
Award: \$6,046.08 (incl. pain and suffering \$3,000.00)

200-3614 The applicant, a 35 year old rate clerk, was assaulted and robbed by two unknown males. The applicant sustained a cerebral concussion, numerous contusions and suffered nervous anxiety for several months.
Award: \$3,761.16 (incl. pain and suffering \$3,000.00)

200-3689 The applicant, a 34 year old painter, was shot in the neck and shoulder while leaving a hotel, after having seen a body lying in the parking lot. The two offenders were charged with three counts of murder and sentenced to life imprisonment.
Award: \$6,078.55 (incl. pain and suffering \$5,000.00)

200-3865 The applicant is the mother of the victim, a 23 year old labourer. He was shot while in a truck and died the next day. The offenders were acquitted of manslaughter. The claim was for funeral expenses.
Award: \$1,233.00

200-3884 The applicant, a 40 year old hotel manager, was the victim of an unprovoked attack in the parking lot of his hotel. He sustained bruised ribs, lacerations and a fractured right hand. The offender was convicted of assault causing bodily harm and sentenced to 90 days imprisonment plus one year's probation.
Award: \$1,181.00 (incl. pain and suffering \$1,000.00)

200-3912 The applicant, a 47 year old restaurant owner, was attacked by unknown assailants as he left his restaurant. He sustained a comminuted bicondylar fracture of the knee and a pulmonary embolism which probably resulted from venous thrombosis of the lower limbs.
Award: \$10,368.90 (incl. pain and suffering \$7,500.00)

200-3978 The applicant, a 31 year old man, was assaulted by a gang of youths. He sustained severe swelling and an abrasion of the right cheek and a fracture to the right zygomatic arch. Charges against the alleged offender were dropped over problems with identification.
Award: \$681.50 (incl. pain and suffering \$350.00)

200-4051 The applicant, a 23 year old police officer, was assaulted when he came to the aid of another police officer. He was pushed over a hedge, jumped on, punched and kicked. The two alleged offenders were acquitted.
Award: \$1,833.92 (incl. pain and suffering \$1,800.00)

200-4090 The applicant is the sister of the victim who died in a fire in a jail. The claim was for a trust fund for the victim's child plus funeral expenses. The first claim was disallowed, as the victim did not support his daughter.
Award: \$279.40

200-4106 The victim, a 31 year old machinist, was beaten by a taxi driver who had parked his taxi in the applicant's driveway. He sustained damage and swelling to his right eye, abrasions, bruised ribs and a right orbital blow-out fracture. The offender was convicted of assault causing bodily harm and sentenced to a fine of \$750.00 or three months in jail plus probation for two years.
Award: \$4,850.22 (incl. pain and suffering \$2,500.00)

200-4169 The applicant, a 24 year old pipe fitter, was assaulted in a restaurant by the manager, after stealing some of the decor. The alleged offender was charged with assault causing bodily harm. The case was dismissed. The award was reduced by the Board, which cited Section 17(1).
Award: \$4,072.21 (incl. pain and suffering \$1,700.00)

200-4238 The applicant, a 22 year old auto worker, was playing pinball in a hotel with the three offenders. One began to harass him and the other two attacked him with a bat and an oar. He sustained a fractured skull and large lacerations. Two offenders were sentenced to 90 days in jail, and the charges against the third were withdrawn.
Award: \$5,057.55 (incl. pain and suffering \$2,000.00)

200-4260 The applicant, a 32 year old postal clerk, was assaulted by a fellow employee against whom he was to have testified in court. He sustained a head injury, and his vision deteriorated. The Crown did not prosecute as no witness would come forward.
Award: \$6,000.00 in 12 monthly payments (incl. pain and suffering \$6,000.00)

200-4277 The applicant, a 19 year old unemployed labourer, was shot by an unknown offender while he was driving his car. Two bullets lodged in the applicant's neck and shoulder.
Award: \$4,277.20 (incl. pain and suffering \$4,000.00)

200-4297 The applicant, a 22 year old barber, was crushed between two cars at a service station when the driver of one car was assaulted. The applicant sustained fractures to his right femur and left pelvis and a contusion to his left testicle. The offender was convicted of assaulting the driver and sentenced to 30 days in jail.
Award: \$5,271.20 (incl. pain and suffering \$4,000.00)

200-4316 The applicant is the mother of the victim, an 8 year old boy. He was struck in the right eye with a blunt instrument by the alleged offender, who was also a minor, and lost the sight of the eye.
Award: \$5,340.00 (incl. pain and suffering \$5,000.00)

200-4391 The applicant, a 31 year old sales executive, was assaulted and robbed without provocation in a restaurant. He sustained lacerations, a broken nose, bruises and two black eyes. The offenders were convicted of assault causing bodily harm and robbery.
Award: \$1,761.05 (incl. pain and suffering \$1,500.00)

200-4444 The applicant, a 39 year old hairdresser, was shot by her estranged husband, who later shot himself. She sustained a ruptured artery and holes in the large and small intestines. A bullet lodged in the spine and could not be removed.
Award: \$15,652.60 (incl. pain and suffering \$15,000.00)

200-4460 The applicant, a 31 year old police constable, was injured in the left eye when the offender threw an object at him while he was investigating a domestic dispute. He sustained a perforated globe and lacerated lower lid. The offender was convicted of assault causing bodily harm.
Award: \$3,590.09 (incl. pain and suffering \$3,500.00)

200-4501 The applicant, a 34 year old newspaper reporter, picked up a group of hitch-hikers. Some of these assaulted him, leaving him lying on the side of the road. He sustained a broken nose, black eyes, abrasions and contusions. The offenders were convicted of assault causing bodily harm: one was sentenced to 90 days in jail and the other to two years less a day.
Award: \$1,522.57 (incl. pain and suffering \$1,500.00)

200-4508 The applicant, a 51 year old city field-worker, was assaulted on his job. He sustained a severe concussion, cuts and bruises. The offender was convicted of assault causing bodily harm and sentenced to 12 months in jail.
Award: \$1,410.00 (incl. pain and suffering \$1,200.00)

200-4590 The applicant, a 20 year old truck driver, was waiting for a taxi when a man grabbed his crutch and beat him over the head. He suffered concussion, double vision and headaches. The offender was convicted of assault causing bodily harm and fined \$500.00 or three months in jail.
Award: \$3,285.40 (incl. pain and suffering \$3,000.00)

200-4625 The applicant, a 44 year old nurse, was pushed to the ground when her purse was stolen. She sustained an undisplaced fracture of her hip. The offender received a suspended sentence and six months probation.
Award: \$1,878.58 (incl. pain and suffering \$800.00)

200-4653 The applicant is the mother of the victim, an 8 year old boy. A container of flaming gasoline was thrown at the victim, who sustained deep burns to his right leg, a minor burn to his stomach and a laceration over his right eye. The offender is unknown.
Award: \$2,514.58 (incl. pain and suffering \$2,000.00)

200-4674 The applicant, a 19 year old woman, was involved in a fight with the offender which was ended by the police. The offender returned and cut the applicant with a broken bottle. The applicant suffered a complete loss of eye-sight in her right eye and lacerations to her right hand. The offender was convicted of wounding and sentenced to one year in jail.
Award: \$1,000.00 (incl. pain and suffering \$1,000.00) Plus \$100.00 a month for 50 months

200-4696 The applicant, a 29 year old contractor, was assaulted by four hotel employees over non-payment of a bill. He sustained a broken nose and a lacerated tendon. No charges were laid. The Board cited Section 17(1) of the Act to reduce the award.
Award: \$1,636.19 (incl. pain and suffering \$750.00)

200-4716 The applicant, a 20 year old apprentice carpenter, was struck on the head with a hatchet. He sustained deep lacerations of the scalp and a Colles fracture of the left wrist. The offender was convicted of assault causing bodily harm and sentenced to two years less a day in jail.
Award: \$4,858.87 (incl. pain and suffering \$1,700.00)

200-4730 The applicant, a 36 year old machinist, became involved in an altercation with a co-worker, who struck him around the head, face and back with a hammer. The applicant sustained soft tissue trauma to the head and neck, lacerations to the left ear and scalp and a concussion. The offender was convicted of assault causing bodily harm and given a suspended sentence and put on probation for two years.
Award: \$2,010.00 (incl. pain and suffering \$1,500.00)

200-4773 The applicant is the father of the victim, a 2½ year old girl who was shot in the face with a flare gun by her 12 year old half brother. She sustained severe burns to her face, chest, arms, hands and legs, and a comminuted compound fracture of the skull. She will be left with significant disfigurement.
Award: \$13,120.03 (incl. pain and suffering \$12,000.00)

200-4794 The applicant, a 51 year old handy man, was beaten by two unknown youths outside the laundromat where he worked. He was kicked unconscious and sustained a broken jaw.
Award: \$1,949.70 (incl. pain and suffering \$800.00)

200-4807/8 The applicant is the father of the two victims, boys aged 11 and 5. The alleged offender beat them with the leg of one boy. They sustained bruises on the face and one had a bleeding nose. Charges against the alleged offender were dismissed.
Award: \$400.00 (incl. pain and suffering \$400.00)

200-4811 The applicant, a 31 year old hairdresser, was beaten with an iron pipe by the offender, who was a member of a family which was feuding with the applicant's family. The applicant sustained a fractured arm and multiple bruises. The offender was convicted of assault causing bodily harm and fined \$500.00 or two months in jail, plus 18 months probation.
Award: \$3,280.00 (incl. pain and suffering \$2,500.00)

200-4829 The offender, a 34 year old nurse, was sitting by an open window in a streetcar when she was hit on the neck by a potato thrown by an unknown offender. She wore a cervical collar for five weeks.
Award: \$887.11 (incl. pain and suffering \$600.00)

200-4848 The applicant, a 57 year old teacher, was assaulted and robbed in the elevator of his apartment building. He sustained a laceration to the back of the head. The offenders were convicted of robbery and each was sentenced to 18 months in jail.
Award: \$500.00 (incl. pain and suffering \$500.00)

200-4899 The applicant, a 32 year old taxi driver, was stabbed and robbed by two passengers in his vehicle. He sustained multiple lacerations and stab wounds. No offenders have been apprehended.
Award: \$1,363.00 (incl. pain and suffering \$750.00)

200-4908 The applicant, a 68 year old store owner, was stabbed on the hand in a robbery of her store. The wound was relatively minor, but there were complications. The three offenders were convicted of robbery.
Award: \$1,530.00 (incl. pain and suffering \$1,200.00)

200-4912 The applicant, a 29 year old garage man, was assaulted and sustained a deep laceration to the head. The offender was found guilty of assault causing bodily harm and fined \$400.00.
Award: \$545.00 (incl. pain and suffering \$500.00)

200-4963 The applicant, a 37 year old cleaning woman, became involved in a dispute over a seat at a racetrack. The offender punched her in the abdomen, where the applicant had recently had exploratory surgery. The offender was convicted of common assault and fined \$100.00.
Award: \$1,740.00 (incl. pain and suffering \$600.00)

200-5023 The applicant, a 28 year old Assistant Crown Attorney, was assaulted without provocation during a hockey game. He suffered a lacerated lip and considerable dental damage. The offender was given a conditional discharge.
Award: \$1,839.95 (incl. pain and suffering \$1,250.00)

200-5046 The applicant, a 53 year old chef, was assaulted by three unknown offenders as he returned to the camp where he worked. He sustained a fracture of the right neck of the jaw.
Award: \$686.22 (incl. pain and suffering \$450.00)

200-5063 The applicant, a 41 year old checker, was the victim of an unprovoked assault. He sustained a depressed frontal parietal skull fracture with disruption of right frontal and temporal lobes. The offender was convicted of assault causing bodily harm and sentenced to three years in a federal penitentiary.
Award: \$11,561.16 (incl. pain and suffering \$6,000.00)

200-5068 The applicant, a 46 year old janitor, drove an acquaintance home from a bar, and dropped him off. This person followed the applicant and attacked him with a meat cleaver. The applicant sustained deep lacerations to his right shoulder, chin and neck, and lesser lacerations to his ear and face. The offender was convicted of attempted murder and sentenced to four years in a federal penitentiary.
Award: \$4,211.42 (incl. pain and suffering \$3,500.00)

200-5074 The applicant, a 37 year old labourer, was insulted by the two offenders. When he replied, they approached and assaulted him. He sustained abrasions and an incomplete undisplaced fracture of the thumb. The two offenders were convicted of assault causing bodily harm.
Award: \$1,272.99 (incl. pain and suffering \$750.00)

200-5099 The applicant, a 28 year old cushion filler, had visited a friend and was leaving when he became involved in a fight as a result of racial slurs. He suffered a crack fracture of the left tibia. Charges against the three alleged offenders were dismissed because of the lack of identification as to who did the striking.
Award: \$4,562.75 (incl. pain and suffering \$1,000.00)

200-5101 The applicant, a 23 year old truck driver, was hit on the head by a beer bottle as he left a party. He sustained a laceration on his right forehead, a haematoma in his right upper eyelid and abrasions and bruising about the face. Charges against the alleged offender were withdrawn because the applicant refused to testify in court. The Board therefore cited Section 17(1a) of the Act to reduce the award.
Award: \$574.34 (incl. pain and suffering \$300.00)

200-5113 The applicant, a 26 year old salesman, was pulled from his car and beaten when he stopped to help the unknown offender on the highway. He sustained a fractured nose, lost two teeth, and had substantial dental work done.
Award: \$2,337.60 (incl. pain and suffering \$1,000.00)

200-5115 The applicant, a 38 year old nurse's aide, was struck by a railroad spike which was thrown at the bus she was riding. She sustained lacerations to the right temple, two black eyes and a mild concussion. The offender was convicted of willful damage.
Award: \$954.75 (incl. pain and suffering \$600.00)

200-5127 The applicant, a 46 year old security guard, was the victim of a racial assault outside his home. He was saying goodbye to two friends when the alleged offenders made racial slurs and then assaulted the applicant. He sustained bruising and swelling to his face and chest, and an injury to the small finger of his right hand. Assault charges against the alleged offenders were dismissed because of problems of identification.
Award: \$571.40 (incl. pain and suffering \$500.00)

200-5138 The applicant, a 35 year old man, was shot by his business partner in a dispute over how their business was conducted. The bullet passed through the left side of the chest and exited from the back. The offender was convicted of assault causing bodily harm and sentenced to 30 days in jail plus one year's probation.
Award: \$1,871.00 (incl. pain and suffering \$1,500.00)

200-5144 The applicant, a 32 year old police constable, was assaulted while arresting the offender for assaulting his partner. The applicant sustained a bite to his left hand, abrasions, and a twisted knee which required surgery. The offender was convicted of assaulting a peace officer and sentenced to two months in jail.
Award: \$3,536.00 (incl. pain and suffering \$3,500.00)

200-5158 The applicant is the mother of the victim, a 22 year old unemployed woman who was shot in the applicant's house by a man she was involved with. The victim had been arguing with the offender. The Board cited Section 17(1) of the Act to make a reduced award for the care and upkeep of the victim's daughter. Award: \$2,025.00 plus \$75.00 a month, to continue up to age of 18 of the victim's daughter.

200-5180 The applicant, a 30 year old disabled man, became involved in an argument with the offender over the behaviour of their sons. The offender assaulted the applicant, who sustained injuries to the lumbo-sacral area and the sacroiliac joint. The offender was convicted of common assault and given a conditional discharge with one year probation. Award: \$1,478.91 (incl. pain and suffering \$1,000.00)

200-5182 The applicant, a 26 year old police constable, was injured by a car ramming him while he was making an arrest. He sustained severe soft tissue damage and bruises to both knees. The offender was convicted of common assault and fined \$300.00. Award: \$2,500.00 (incl. pain and suffering \$2,500.00)

200-5186 The applicant, a 31 year old accountant, was assaulted by the two offenders after they had an argument with his father. The applicant sustained lacerations, contusions, a dislocated shoulder and a fractured finger. Both offenders were convicted of assault causing bodily harm. Award: \$11,157.24 (incl. pain and suffering \$7,500.00)

200-5203 The applicant, a 53 year old welder, was the victim of an unprovoked assault in his residence. He sustained a broken lower jaw, facial lacerations and numerous bruises. The offender was convicted of assault causing bodily harm and sentenced to nine months in jail. Award: \$3,262.75 (incl. pain and suffering \$2,500.00)

200-5209 The applicant, a 66 year old pensioner, was the victim of an assault in his own residence by the husband of the woman he lived with. He sustained lacerations and a fractured nose. The offender was convicted of assault causing bodily harm and sentenced to three months in jail or a fine of \$1,500.00. Award: \$3,334.20 (incl. pain and suffering \$3,000.00)

200-5226 The applicant, a 21 year old student, was struck on the head with a bottle during an altercation with the offender at a party. The applicant suffered multiple lacerations. There is an outstanding warrant against the offender. Award: \$1,035.00 (incl. pain and suffering \$800.00)

200-5235 The applicant, a 34 year old sales manager, was struck in the eye during an altercation over hiring practices. His glasses broke and he sustained cuts to his cheeks and nose. The offender was convicted of assault causing bodily harm

and fined \$500.00 or 60 days in jail. The Board cited Section 17(1) of the Act to reduce the award. Award: \$1,111.29 (incl. pain and suffering \$1,000.00)

200-5248 The applicant, a 36 year old police officer, was assaulted while investigating the offender, who attempted to gouge his eyes. The applicant sustained scratches to both eyeballs, face and ear. The offender was convicted of resisting arrest and sentenced to four months in jail. Award: \$500.00 (incl. pain and suffering \$500.00)

200-5258 The applicant, a 24 year old waiter, was assaulted as he walked along the street. He sustained a laceration to his lip, bruising and a sore hip. Charges against the alleged offender were dismissed for lack of positive identification. Award: \$1,443.08 (incl. pain and suffering \$500.00)

200-5277 The applicant, a 25 year old taxi driver, was assaulted when he rolled down his car window to speak to the offender who, he presumed, wanted directions. The applicant suffered a fractured nose. The offender was convicted of assault causing bodily harm and sentenced to 30 days in jail or a \$200.00 fine. Award: \$2,360.00 (incl. pain and suffering \$500.00)

200-5285 The applicant, an 18 year old unemployed male, was assaulted by the brother of a man who had loaned the applicant money. He sustained a black eye and a fractured cheek-bone. The offender was convicted of assault causing bodily harm and sentenced to 90 days in jail and one year probation. Award: \$1,350.00 (incl. pain and suffering \$1,000.00)

200-5290 The applicant, a 33 year old extruder operator, was stabbed by the husband of a woman who had a child by the applicant. He received cuts to his hand and thigh, requiring thirty stitches. The offender was convicted of assault causing bodily harm and sentenced to 6 months in jail or \$500.00, plus 6 months probation. Award: \$808.63 (incl. pain and suffering \$500.00)

200-5299 The applicant, a 43 year old machine operator, became involved in a fist fight with the offender, who then got a knife. The applicant was stabbed as he attempted to drive away. He sustained lacerations to his left arm and hand. The offender was convicted of possession of a dangerous weapon. The Board invoked Section 17(1) of the Act to reduce the award. Award: \$999.70 (incl. pain and suffering \$500.00)

200-5303 The applicant, a 55 year old custodian, was assaulted by a stranger who was visiting his house with a friend. The applicant suffered a bruised rib cage. The offender was convicted of robbery and sentenced to five years imprisonment. Award: \$1,191.50 (incl. pain and suffering \$500.00)

200-5310 The applicant, a 49 year old spray painter, was assaulted by a man who broke into his home. He sustained a laceration to his forehead and a neck injury. The offender pleaded guilty to common assault and was fined \$100.00 or 3 days in jail.
Award: \$1,277.98 (incl. pain and suffering \$500.00)

200-5313 The applicant, a 49 year old unemployed man, was sitting with his landlady when her son, who was very drunk, came and assaulted him. The offender stabbed him in the chest and left hand. The offender was convicted of assault causing bodily harm and given a suspended sentence and two years probation.
Award: \$2,030.00 (incl. pain and suffering \$2,000.00)

200-5349 The applicant, a 64 year old dairy employee, was robbed and assaulted by two unknown offenders. He sustained a severe scalp laceration and haematomas to the shoulders, left hip and knee.
Award: \$3,885.00 (incl. pain and suffering \$2,500.00)

200-5364 The applicant, an 18 year old student, was assaulted in a classroom incident with the offender. He sustained a stab wound to the right wrist which became infected. The offender was convicted of assault causing bodily harm and given a suspended sentence plus one year probation.
Award: \$1,615.50 (incl. pain and suffering \$1,200.00)

200-5391 The applicant, a 23 year old police constable, was assaulted while arresting the offender in a hotel for causing a disturbance. He sustained a broken middle finger. The offender was convicted of assaulting police, obstructing police and resisting arrest, and was sentenced to six months in jail.
Award: \$750.00 (incl. pain and suffering \$750.00)

200-5395 The applicant, a 24 year old trackman, was injured while attempting to constrain a passenger on a train. He sustained a serious fracture of the middle finger. The offender was convicted of common assault and sentenced to five days in jail. The Board awarded the applicant the cost of his unsuccessful hearing before the Workmen's Compensation Board.
Award: \$5,438.56 (incl. pain and suffering \$2,500.00)

200-5413 The applicant, a 34 year old janitor, was assaulted during an argument concerning a near accident which he and the offender were involved in. He sustained dental injuries and multiple contusions. The offender was convicted of common assault and sentenced to one day in jail.
Award: \$2,233.00 (incl. pain and suffering \$750.00)

200-5424 The applicant, a 26 year old carpet cleaner, was assaulted in a tavern. He sustained a lacerated lip which required stitches and left a permanent scar. The offender pleaded guilty to common assault and was sentenced to 10 days in jail.
Award: \$776.40 (incl. pain and suffering \$500.00)

200-5439 The applicant, a 19 year old labourer, was struck in the face by a bottle thrown during a fight which did not involve him. He required 30 stitches to the face. The offender was convicted of wounding and sentenced to one year in jail and one year probation.
Award: \$836.93 (incl. pain and suffering \$650.00)

200-5468 The applicant, a 31 year old machine operator, was cut with a knife while attempting to stop a fight. He sustained lacerations to the cheek, foot and index finger. The offender was convicted of assault causing bodily harm and sentenced to three months in jail or \$350.00.
Award: \$1,023.36 (incl. pain and suffering \$800.00)

200-5474 The applicant, a 27 year old welder, was assaulted when he attempted to aid his friend who was being beaten by several unknown offenders. The applicant sustained a fractured skull, a concussion, and complete deafness in one ear.
Award: \$16,228.50 (incl. pain and suffering \$7,500.00)

200-5487 The applicant, a 33 year old truck driver, was hit in the face with a bottle in an unprovoked attack. He sustained deep lacerations to his face. The offender was convicted of assault causing bodily harm and sentenced to 18 months in jail.
Award: \$1,760.20 (incl. pain and suffering \$1,500.00)

200-5492 The applicant, an 18 year old student, was assaulted by a group of unknown offenders in a restaurant parking lot. He sustained three fractured front teeth, a black eye and multiple bruises.
Award: \$1,026.00 (incl. pain and suffering \$300.00)

200-5507 The applicant, a 20 year old window cleaner, was stabbed during an argument at a wedding. Besides several minor lacerations, he sustained a laceration of the liver and a perforation of the stomach. The offender pleaded guilty to assault causing bodily harm and was sentenced to 70 days in jail.
Award: \$3,339.40 (incl. pain and suffering \$3,000.00)

200-5516 The applicant is the mother of the victim, a 4 year old girl who was hit by a fragment of a bullet which struck the car she was travelling in. She sustained minor lacerations. The offender was convicted of endangering life by discharging a firearm.
Award: \$500.00 (incl. pain and suffering \$500.00)

200-5528 The applicant is the mother of the victim, a 16 year old male, who was assaulted during an argument. He sustained a fractured jaw. The offender was convicted of assault causing bodily harm and given a conditional discharge.
Award: \$1,760.00 (incl. pain and suffering \$1,000.00)

200-5552 The applicant, a 35 year old security guard, was attacked for no apparent reason while at his desk. He suffered wounds to his face and scalp, and his interior juglar vein was severed. The offender was found not guilty by reason of insanity.

200-5563 The offender, a 32 year old taxi driver, was stabbed by another taxi driver. There is some evidence that the applicant provoked the offender. The applicant sustained a deep stab wound to his knee and other minor cuts. The offender was convicted of wounding and sentenced to seven days in jail. The Board invoked Section 17(1) of the Act to reduce the award.
Award: \$567.78 (incl. pain and suffering \$300.00)

200-5573 The applicant, a 39 year old housewife, was attacked without provocation by her son-in-law. She sustained a fractured nose and a laceration over her eye. The offender was convicted of assault causing bodily harm and sentenced to 7 days in jail.
Award: \$1,086.80 (incl. pain and suffering \$1,000.00)

200-5592 The applicant, a 23 year old unemployed man, was assaulted when he tried to break up a fight in a bar. He was knocked unconscious and sustained a fractured floor of the left orbit and lacerations. The offender was convicted of assault causing bodily harm and sentenced to 15 days in jail.
Award: \$1,029.30 (incl. pain and suffering \$700.00)

200-5603 The applicant, a 37 year old engineer, was assaulted following a minor traffic accident with the offender. He sustained bruises, cuts and abrasions to his face, and minor dental damage. The offender was convicted of common assault and fined \$300.00 or 21 days in jail.
Award: \$672.00 (incl. pain and suffering \$350.00)

200-5618 The applicant is the mother of the victim, an 11 year old girl, who was assaulted during an argument with the offender. She sustained a fractured nose. The offender was found delinquent by the court.
Award: \$400.00 (incl. pain and suffering \$400.00)

200-5628 The applicant, a 16 year old male, was the victim of an unprovoked assault by two drunken offenders. He sustained extensive facial lacerations and fractures to the nose, sinus, cheek-bone and two front teeth. The offenders were convicted of assault causing bodily harm and sentenced to five months and three months in jail respectively.
Award: \$3,844.00 (incl. pain and suffering \$2,500.00)

200-5632 The applicant, a 36 year old nursing assistant, was assaulted by the offender who robbed her. She sustained a fractured nose, lacerations and a swollen right eye. The offender was convicted of robbery and sentenced to six months in jail.
Award: \$1,210.00 (incl. pain and suffering \$1,200.00)

200-5634 The applicant, a 25 year old upholsterer, was assaulted and robbed when he left a tavern in an intoxicated condition. He sustained a mild concussion, facial lacerations, and a compound fracture of the nose. The offender was convicted of assault causing bodily harm and sentenced to six months imprisonment.

The Board invoked Section 17(1) of the Act to reduce the award.
Award: \$388.20 (incl. pain and suffering \$350.00)

200-5657 The applicant, a 31 year old loader operator, was beaten, robbed and was the victim of extortion by four alleged offenders, including his estranged wife. He sustained a compound fracture of the jaw. Two offenders were convicted of extortion.
Award: \$2,608.80 (incl. pain and suffering \$1,500.00)

200-5666 The applicant, a 32 year old woman, was the victim of an unprovoked assault. She sustained a fractured nose. The offender was convicted of assault causing bodily harm and fined \$350.00 or 90 days in jail.

200-5668 The applicant, a 27 year old production manager, was stabbed with a broken glass in an altercation over a pool table. He sustained an acute tension pneumothorax. The offender was convicted of assault causing bodily harm and sentenced to six months in jail.

200-5680 The applicant, a 36 year old cabinet maker, was assaulted when he came to the aid of the offender's wife. He sustained two fractured ribs and bruises. The offender was convicted of assault causing bodily harm and fined \$200.00 or ten days in jail plus one year probation.
Award: \$1,161.72 (incl. pain and suffering \$750.00)

200-5683 The applicant, a 27 year old warehouse manager, was struck over the head with a pool cue after winning several dollars from the offender in a game of billiards. He sustained a fractured jaw, multiple lacerations to his face and dental injuries. The offender was convicted of common assault and sentenced to 30 days in prison plus one year probation, plus \$300.00 restitution to the victim.
Award: \$1,578.00 (incl. pain and suffering \$1,600.00 less restitution)

200-5714 The applicant, a 64 year old machine operator, was assaulted during an argument in his work place. He sustained four fractured ribs and contusions. The offender was convicted of common assault and given a suspended sentence.

200-5717 The applicant, a 19 year old unemployed man, was assaulted while assisting a bartender evict an unruly customer. He sustained lacerations to the face. The offender was convicted of assault causing bodily harm and sentenced to five months in jail.
Award: \$575.00 (incl. pain and suffering \$500.00)

200-5721 The applicant, an 18 year old student, was involved in a fight in his school. He sustained a fractured cheek-bone. The offender was charged with assault causing bodily harm and given an absolute discharge.

200-5733 The applicant, a 26 year old man on a disability pension, was assaulted and robbed by unknown offenders who probably attacked him because he was crippled. He sustained multiple cuts, bruises and contusions to his legs, head, ribs and face.
Award: \$1,360.05 (incl. pain and suffering \$1,000.00)

200-5746 The applicant, a 23 year old engineering technician, was assaulted by a man who almost ran into his car. The applicant sustained a fracture of the left nasal bone and a minor laceration. The offender was found guilty of common assault and given an absolute discharge.
Award: \$1,235.60 (incl. pain and suffering \$800.00)

200-5753 The applicant, a 54 year old police constable, was shot in the left arm with a shotgun by the driver of a car which he had stopped. He sustained severe damage to the tendons, radial nerve and muscles of the left arm. The offenders were convicted of murder and sentenced to life imprisonment in a related trial.
Award: \$8,262.12 (incl. pain and suffering \$7,500.00)

200-5767 The applicant, a 27 year old civil servant, was struck by a brick thrown through his windshield as he was driving on the highway. 200-5807 The applicant, a 43 year old unemployed man, was assaulted by two unknown offenders as he entered his apartment building. 200-5820 The applicant is the mother of the victim, a 26 year old man who was stabbed to death in a fight. The offender was acquitted of a charge of murder. The Board cited Section 17(1) of the Act to reduce the award for funeral expenses.
Award: \$500.00

200-5823 The applicant, a 33 year old legal secretary, was assaulted during her lunch hour. She was struck with a bottle above the mouth. She sustained serious lacerations of the lip. No offender has been apprehended.
Award: \$2,355.75 (incl. pain and suffering \$2,000.00)

200-5829 The applicant, a 19 year old labourer, was assaulted without provocation as he was walking at night. He sustained several large haematomas to his head and lacerations requiring stitches near his eye. Five youths were charged with assault causing bodily harm. 200-5834 The applicant, a 42 year old police constable, was assaulted while investigating a complaint. He sustained twisting injuries to the left knee and right shoulder. The offender was charged with assault causing bodily harm and sentenced to 30 days in jail plus six months probation.

Award: \$250.00 (incl. pain and suffering \$250.00)

200-5843 The applicant, a 54 year old unemployed man, was robbed of two dollars and assaulted by unknown offenders as he entered a restaurant. He assumed that someone in the restaurant had called the police. The applicant sustained an injury to his eye, which had to be removed. The Board invoked Section 17(1a) of the Act to reduce the award.

Award: \$3,305.00 (incl. pain and suffering \$3,000.00)

200-5852 The applicant, a 19 year old man, was robbed and assaulted as he returned home from a bar. He sustained a fractured jaw, cracked nasal bones and a badly bruised face. Charges against the alleged offenders were withdrawn.

Award: \$2,564.68 (incl. pain and suffering \$1,500.00)

200-5858 The applicant, a 13 year old boy, was struck in the eye by a pellet fired by the offender, another juvenile. The eye of the victim had to be removed. The offender was convicted of dangerous use of a firearm under the Juvenile Delinquents Act.

Award: \$5,220.00 (incl. pain and suffering \$5,000.00)

200-5861 The applicant, a 70 year old retired man, was assaulted in a bus terminal washroom by the offender, a known violent drunk. The applicant sustained severe lacerations to the head, a fractured nose and cheek-bone, and a cracked rib. The offender was convicted of assault causing bodily harm and sentenced to 3½ years in jail.

Award: \$3,736.85 (incl. pain and suffering \$3,500.00)

200-5873 The applicant's common-law wife died of a beating she received when she was in a tavern. The offender was convicted of manslaughter and sentenced to 30 months in jail. The applicant was granted an award for funeral expenses incurred.

Award: \$1,000.00

200-5887 The applicant, a 21 year old truck driver, was assaulted for no apparent reason in a bar. He sustained a fractured jaw. The offender was convicted of assault causing bodily harm and sentenced to eight months in jail.

Award: \$1,930.05 (incl. pain and suffering \$1,000.00)

200-5892 The applicant, a 67 year old retired man, was assaulted by unknown offenders who had broken into his apartment. He suffered contusions to his head and bruises to his hand.

Award: \$500.00 (incl. pain and suffering \$500.00)

200-5895 The applicant, a 19 year old student, was assaulted without provocation by a person she was with in a restaurant. She sustained a fractured nose with deviated septum. The alleged offender was found to be mentally unfit to stand trial.

Award: \$935.00 (incl. pain and suffering \$800.00)

200-5901 The applicant, a 31 year old unemployed woman, was assaulted by her common-law husband after they had attended a dance. Both the offender and the applicant were intoxicated. The applicant's sister laid a charge against the offender several days after the incident. The offender was convicted of assault causing bodily harm and sentenced to 12 months imprisonment.

Award: \$1,500.00 (incl. pain and suffering \$1,500.00)

200-5909 The applicant, a 28 year old mill operator, was the victim of an unprovoked assault in a hotel. He sustained a fractured nose and cheek-bone, cuts and bruises. The offender was convicted of assault causing bodily harm and sentenced to six months in jail plus two years probation.

Award: \$3,086.55 (incl. pain and suffering \$2,000.00)

200-5923 The applicant, a 45 year old miner, was stabbed when he confronted the offender, who had just murdered the applicant's common-law wife. He sustained a stab wound to the left flank. The offender was found guilty of second degree murder.

Award: \$1,576.75 (incl. pain and suffering \$1,500.00)

200-5927 The applicant, a 63 year old companion-housekeeper, was beaten until she was unconscious by two unknown offenders who had broken into her home. She sustained severe facial lacerations, a haemorrhage in her right eye and bruised ribs and back.

Award: \$2,017.60 (incl. pain and suffering \$2,000.00)

200-5936 The applicant, a 21 year old maintenance mechanic, was assaulted by a man who had been harassing his girlfriend. The applicant sustained severe dental injuries, lacerations to the lip and two black eyes. The offender was convicted of common assault and received a conditional discharge plus one year probation.

Award: \$1,663.31 (incl. pain and suffering \$1,500.00)

200-5942 The applicant, a 21 year old labourer, was assaulted when he tried to assist the offender, who had fallen off a motorcycle. He sustained serious dental injuries. The offender was convicted of assault causing bodily harm and fined \$400.00 or 50 days in jail.

Award: \$2,664.00 (incl. pain and suffering \$500.00)

200-5949 The applicant, a 27 year old salesman, was assaulted while leaving a restaurant. He sustained a fractured nose, and bruising, swelling and lacerations to his face. The offender was convicted of common assault and was fined \$500.00 or 14 days in jail. As both parties were intoxicated, and there were serious discrepancies in testimony, the Board invoked Section 17(1) of the Act to reduce the award.
Award: \$530.08

200-5957 The applicant, an 18 year old male, was assaulted with a baseball bat wielded by the offender. He sustained a severe fracture to the left elbow. The offender was convicted on a charge of weapons dangerous and fined \$200.00 plus 18 months probation.
Award: \$1,700.00 (incl. pain and suffering \$1,700.00)

200-5961 The applicant, a 24 year old housewife, was injured when she, her husband and two other relatives were attacked. She sustained a fractured left ankle and torn ligaments. The offender was convicted of common assault and was sentenced to 30 days in jail.
Award: \$3,528.85 (incl. pain and suffering \$2,500.00)

200-5964 The applicant is the wife of a 49 year old train conductor who had been killed in a drunken brawl. One offender was convicted of manslaughter and another of assault causing bodily harm. As all parties were intoxicated, and the victim may have instigated the fight, the Board invoked Section 17(1) to reduce the award.
Award: \$7,018.00

200-5969 The applicant, a 17 year old student, was assaulted by the offender who objected to his riding a motorcycle in a schoolyard. He sustained a fracture to the jaw. The offender was convicted of common assault and fined \$400.00 or 40 days in jail.
Award: \$881.00 (incl. pain and suffering \$650.00)

200-5976 The applicant, a 19 year old labourer, was assaulted by two unknown offenders who thought he had broken the windshield of their car. He sustained a haemorrhage of both eyes, severe facial contusions, a fractured nose, lacerations, bruised ribs and considerable dental damage.
Award: \$2,810.81 (incl. pain and suffering \$2,000.00)

200-5982 The applicant, a 29 year old hotel manager, was assaulted and stabbed when he told the offender that no more drinks would be served to him. The applicant sustained lacerations to the head, chest and arm, a punctured left lung and a severed artery in the left arm. The offender was convicted of wounding and sentenced to eight years in jail.
Award: \$4,260.00 (incl. pain and suffering \$4,000.00)

200-5984 The applicant, a 21 year old housewife, was shot and stabbed by the offender, a former lover, while lying in bed with her husband. She sustained

lacerations and gunshot wounds to her abdomen and thigh. The offender was convicted of attempted murder and sentenced to six years imprisonment.
Award: \$2,220.00 (incl. pain and suffering \$2,200.00)

200-5989 The applicant, a 55 year old store manager, was shot during a robbery of his store by an unknown offender. He sustained a gunshot wound to his right leg, damaging muscles and the calf muscle-tendon.
Award: \$3,523.00 (incl. pain and suffering \$3,000.00)

200-6000 The applicant, a 30 year old woman, was punched in the nose by a ward of the Children's Aid Society. She sustained a fractured right nasal bone. The offender was convicted of assault in Juvenile Court.
Award: \$770.00 (incl. pain and suffering \$700.00)

200-6004 The applicant, a 56 year old taxi driver, was robbed and assaulted while on duty. He sustained abrasions, lacerations, and a black eye. The offender was convicted of robbery with violence and was sentenced to 17 months in jail.
Award: \$3,656.90 (incl. pain and suffering \$2,000.00)

200-6007 The applicant, a 33 year old buyer, was assaulted without provocation by three offenders, of which only one was caught. The applicant sustained lacerations, bruises and swelling of the head, and a swollen knee. The offender was convicted of assault causing bodily harm and sentenced to 10 days in jail plus one year probation.
Award: \$800.00 (incl. pain and suffering \$800.00)

200-6016 The applicant is the father of the victim, a 16 year old male, who was assaulted after asking the offender if he had damaged a school locker. The victim sustained swelling and bruising to the right hemiscrotum and a laceration of the right testicle. The offender was convicted of assault causing bodily harm under the Juvenile Delinquents Act.
Award: \$2,062.25 (incl. pain and suffering \$1,500.00)

200-6025 The applicant, a 58 year old crossing guard, was robbed and assaulted in a mall by an unknown offender. He sustained a fractured jaw and cheek-bone, bruises and a broken dental plate.
Award: \$1,690.00 (incl. pain and suffering \$1,500.00)

200-6028 The applicant is the mother of the victim, a 14 year old boy who was assaulted when he told the offender that people were looking for him. The victim sustained lacerations and dental damage. The offender was convicted of common assault under the Juvenile Delinquents Act.
Award: \$587.40 (incl. pain and suffering \$500.00)

200-6035 The applicant, a 23 year old student, received a severe beating from the two offenders, an acquaintance and her cousin. Both men were known to

be unstable. She sustained lacerations, multiple bruises, burned skin and internal damage. The offenders were convicted of assault causing bodily harm and were both sentenced to one year in jail and three years probation.
Award: \$2,689.00 (incl. pain and suffering \$2,500.00)

200-6038 The applicant, a 27 year old construction worker, was the victim of an unprovoked assault in a tavern. He sustained lacerations, a chipped tooth and sustained muscle spasms to his neck. Charges against the alleged offender were dismissed.
Award: \$988.50 (incl. pain and suffering \$400.00)

200-6050 The applicant, a 30 year old police officer, was injured when the offender fell on top of him during an arrest. The applicant sustained acute disc protusion. The offender was convicted of assaulting a peace officer and fined \$300.00 or 30 days in jail.
Award: \$3,259.50 (incl. pain and suffering \$3,000.00)

200-6056 The applicant, a 48 year old clerk, was pushed over by an unknown offender who was running from a fight. She sustained multiple contusions of the chest, right shoulder and right elbow.
Award: \$625.50 (incl. pain and suffering \$500.00).

200-6969 The applicant, a 51 year old labourer, was assaulted and robbed in an unprovoked attack. He sustained cervical strain, contusions of the spine and degenerative disc disease. The offender was convicted of robbery with violence and sentenced to three years probation.
Award: \$1,448.26 (incl. pain and suffering \$1,000.00)

200-6074 The applicant, a 41 year old parking attendant, was assaulted by a customer who was angry that his car had been moved. She sustained contusions and bruising around the left eye. The offender was convicted of assault causing bodily harm and put on probation. The award was reduced by the Board, which cited Section 17(1) of the Act.
Award: \$510.50 (incl. pain and suffering \$300.00)

200-6080 The applicant, a 35 year old jewellery sales clerk, was assaulted by unknown offenders during an armed robbery of her store. She sustained a laceration to her lip.
Award: \$981.20 (incl. pain and suffering \$750.00)

200-6091 The applicant, a 17 year old student, was assaulted without provocation by the offender. He sustained a fractured jaw. A warrant is outstanding against the offender.
Award: \$1,020.00 (incl. pain and suffering \$750.00)

200-6102 The applicant, a 26 year old machine operator, was assaulted by the offender in their place of employment. He sustained a fracture of the left

clavicle, a minor facial laceration and bruises. The offender was convicted of common assault and fined \$250.00 or 30 days in jail.
Award: \$2,382.27 (incl. pain and suffering \$750.00)

200-6104 The applicant, a 25 year old police constable, received an injury to his hand while arresting the offender, who resisted. He sustained damage to the median nerve. The offender was convicted of assaulting a peace officer and sentenced to 30 days in jail.
Award: \$4,000.00 (incl. pain and suffering \$2,500.00)

200-6108 The applicant, a 39 year old truck driver, was assaulted when he confronted the two offenders, who had assaulted his girlfriend and several other people in a line-up. He sustained fractures to his jaw and cheek-bone and abrasions. The two offenders were convicted of assault causing bodily harm and sentenced to six months and three months respectively.
Award: \$3,540.72 (incl. pain and suffering \$2,000.00)

200-6116 The applicant, a 45 year old stockkeeper, was assaulted during a robbery of his home. He sustained lacerations and fractures to his nose and cheek-bone. Three offenders were sentenced on various counts. The Board invoked Section 17(1) of the Act to reduce the award as the applicant had invited one of the offenders, a complete stranger, to stay at his home.
Award: \$925.92 (incl. pain and suffering \$700.00)

200-6119 The applicant, a 28 year old police officer, slipped on ice while chasing a suspect and sustained a fracture of the right radial head. No charges were laid.
Award: \$600.00 (incl. pain and suffering \$600.00)

200-6123 The applicant, a 33 year old housewife, was beaten by her neighbours, one of whom was the wife of a man the applicant had had an affair with. She received a blow to the head. The offenders were found guilty of common assault and fined \$50.00 or five days in jail.
Award: \$823.00 (incl. pain and suffering \$750.00)

200-6140 The applicant, a 29 year old police constable, was kicked in the knee by an unknown offender at a concert. He suffered a contused patella.
Award: \$297.16 (incl. pain and suffering \$250.00)

200-6148 The applicant, a 31 year old store owner, was assaulted by three intoxicated unknown offenders who damaged his store. He sustained a fracture to the left wrist and bruises to his knee and ribs.
Award: \$2,020.23 (incl. pain and suffering \$1,500.00)

200-6152 The applicant, a 34 year old machine operator, was assaulted by two alleged offenders at a bus stop. She sustained burns to her chest and bruises to her back. Charges against the alleged offenders were withdrawn.
Award: \$1,052.16 (incl. pain and suffering \$800.00)

200-6155 The applicant, a 20 year old unemployed male, was the victim of an unprovoked assault in a discotheque. He sustained lacerations, contusions and soft tissue injuries to his face and head. The offender was convicted of assault causing bodily harm and given an absolute discharge.
Award: \$1,400.00 (incl. pain and suffering \$900.00)

200-6167 The applicant, a 36 year old labourer, was beaten and robbed outside a hotel. He sustained lacerations, a fracture of the cheek-bone, black eyes, bruised ribs and chipped teeth. The two offenders were convicted of robbery with violence and sentenced to 30 months in prison.
Award: \$2,546.54 (incl. pain and suffering \$1,500.00)

200-6169 The applicant, a 31 year old store owner, was assaulted by the offender, who was the bouncer of the bar he was in, without provocation. He sustained a fractured nose, lacerations and a swollen foot. The offender was convicted of assault causing bodily harm and received three months in jail.
Award: \$822.60 (incl. pain and suffering \$500.00)

200-6171 The applicant, a 31 year old fork lift operator, was struck in the mouth with a brick thrown by the offender. He lost three upper teeth and sustained lacerations. The offender was convicted of assault causing bodily harm and sentenced to 30 days in jail plus two years probation and \$2,400.00 restitution, of which only \$300.00 has been paid.
Award: \$1,262.00 (incl. pain and suffering \$1,200.00)

200-6178 The applicant, a 49 year old maintenance oiler, was injured while assisting a policeman end a disturbance. He sustained two fractures to his left leg, one of which was particularly serious. No charges were laid.
Award: \$4,552.97 (incl. pain and suffering \$3,000.00)

200-6186 The applicant, a 22 year old police constable, was assaulted by the offender while arresting him. The applicant sustained a fracture of the fifth metacarpal. The offender was convicted of assaulting a peace officer and sentenced to four months in jail.
Award: \$1,017.00 (incl. pain and suffering \$350.00)

200-6196 The applicant, a 56 year old crane operator, was assaulted by two unknown offenders who had broken into his house. He sustained multiple scalp lacerations, a mild concussion, contusions, broken dentures and bruises to the ribs.
Award: \$1,779.48 (incl. pain and suffering \$1,200.00)

200-6203 The applicant, a 26 year old police constable, was rammed over the trunk of a car as he was investigating a disturbance. He sustained a deep contusion of the back. The offender was charged with obstructing police and was sentenced to two months imprisonment.
Award: \$1,283.20 (incl. pain and suffering \$1,000.00)

200-6215 The applicant, an 18 year old safe rebuilder, was the victim of an unprovoked attack in which the offender struck him about the head with a large iron bar. He suffered multiple lacerations and extensive dental damage. The offender was convicted of assault causing bodily harm and sentenced to five days in jail and 18 months probation.
Award: \$2,134.00 (incl. pain and suffering \$1,000.00)

200-6224 The applicant, a 16 year old inmate of a Correctional Centre, was assaulted without provocation by several alleged offenders. He sustained injuries to the right hand and both eyes, and required dental work. No charges were laid.
Award: \$1,050.00 (incl. pain and suffering \$700.00)

200-6229 The applicant, a 50 year old housewife, claimed that she was the victim of assault causing bodily harm by an unknown offender. She sustained a black eye and a minor laceration. As there were discrepancies in her testimony, the Board reduced the award.
Award: \$250.00 (incl. pain and suffering \$200.00)

200-6237 The applicant, a 24 year old truck driver, was shot twice in the back by his employer's son without provocation. He sustained two gunshot wounds, and one bullet was left in his body. The offender was convicted of attempted murder and sentenced to three years imprisonment.
Award: \$8,110.80 (incl. pain and suffering \$3,500.00)

200-6242 The applicant, a 29 year old police constable, fell while pursuing juveniles he observed running from the scene of a fire. He sustained a fracture of the right kneecap. No charges were laid.
Award: \$1,850.00 (incl. pain and suffering \$1,500.00)

200-6247 The applicant is the mother of the victim, a 13 year old boy. He was assaulted when he tried to explain that the offender's car had not been damaged. He sustained minor lacerations to the face. The offender was convicted of assault causing bodily harm and fined \$250.00 or 25 days in jail. The Board invoked Section 17(1) of the Act to reduce the award.
Award: \$120.00 (incl. pain and suffering \$100.00)

200-6253 The applicant, a 45 year old parking lot attendant, was assaulted, with robbery being the motive. The police intervened before completion of the robbery. The applicant sustained a severe contusion to the face and a fractured cheek-bone. Charges against the alleged offender were dropped due to the lack of proper identification.
Award: \$2,061.35 (incl. pain and suffering \$1,200.00)

200-6257 The applicant, a 63 year old mine mechanic, was assaulted by three unknown offenders who apparently had mistaken him for their intended victim. He sustained a fractured jaw, multiple abrasions, bruises and two cracked ribs.
Award: \$3,213.67 (incl. pain and suffering \$2,000.00)

200-6266 The applicant, a 54 year old car salesman, was the victim of an unprovoked attack. He sustained facial lacerations and bruises, a fracture of the zygomatic arch and some nerve damage. Charges against the alleged offender were dismissed.

Award: \$1,485.00 (incl. pain and suffering \$800.00)

200-6273 The applicant, a 28 year old labourer, was assaulted and robbed in a tavern. He sustained an undisplaced nasal fracture and superficial abrasions. The offender was convicted of robbery and sentenced to three years imprisonment.

Award: \$693.80 (incl. pain and suffering \$500.00)

200-6276 The applicant, a 26 year old police officer, was injured while chasing the offender in a police cruiser. He sustained a deep tissue bruise to the right knee. The offender was convicted of dangerous driving and fined \$500.00 or 60 days in jail.

Award: \$2,038.50 (incl. pain and suffering \$1,500.00)

200-6278 The applicant, a 50 year old business man, was assaulted by a gas station attendant who had refused to clean his car windows. The applicant sustained a severe laceration to the right shoulder and a contusion. The offender was convicted of assault causing bodily harm and fined \$50.00 or ten days in jail. Because the applicant had told the attendant that he would be reported to his supervisors and called him a "smart punk", the Board invoked Section 17(1) of the Act to reduce the award.

Award: \$1,200.00 (incl. pain and suffering \$1,000.00)

200-6280 The applicant, a 30 year old truck driver, was assaulted without provocation. He sustained bruises and contusions to his face, a subconjunctival haemorrhage and a mild cerebral contusion. One offender was convicted of assault causing bodily harm and sentenced to 90 days in jail plus one year probation. A bench warrant is outstanding on the other offender.

Award: \$2,265.00 (incl. pain and suffering \$800.00)

200-6293 The applicant is the father of the victim, a 17 year old student who was shot in the thigh as he walked to a bus stop. He was left with a six inch permanent scar. Charges against the alleged offenders were dismissed due to the lack of witnesses.

Award: \$1,005.00 (incl. pain and suffering \$1,000.00)

200-6298 The applicant, a 22 year old unemployed man, was struck on the head by a beer bottle thrown from a car by an unknown offender. He sustained a large laceration across his forehead and required sutures.

Award: \$1,308.00 (incl. pain and suffering \$1,000.00)

200-6304 The applicant is the father of the victim, a 16 year old girl who was stabbed by the offender, for whom she had refused to testify in court.

She sustained two stab wounds causing a left pneumothrax, a lacerated liver and a lacerated right kidney. The offender was convicted of assault causing bodily harm and intent to wound, and sentenced to 18 months imprisonment plus two years probation.

Award: \$3,750.00 (incl. pain and suffering \$3,750.00)

200-6309 The applicant, a 23 year old policeman, was struck on the ear by a woman he was attempting to calm down. He sustained a traumatic perforation of the ear drum and was left with a 5 to 8 per cent permanent loss of hearing in the left ear. The offender was committed to a psychiatric hospital.

Award: \$1,000.00 (incl. pain and suffering \$1,000.00)

200-6312 The applicant, a 19 year old painter, was assaulted while trying to remove the offender, who had come uninvited, from a party. He sustained a fractured nose and the loss of four teeth. The offender was convicted of assault causing bodily harm and sentenced to eight months in jail and one year probation. The Board invoked Section 17(1) of the Act, to reduce the award, as the applicant had unnecessarily followed the offender.

Award: \$2,220.00 (incl. pain and suffering \$800.00)

200-6317 The applicant, a 32 year old factory worker, was assaulted without provocation outside of a hotel. He sustained a fractured nose and two black eyes. The offender was convicted of assault causing bodily harm and fined \$500.00 or 60 days in jail.

Award: \$2,173.88 (incl. pain and suffering \$800.00)

200-6323 The applicant, a 17 year old student, was shot in the neck with a pellet gun by an unknown offender. The pellet was removed because it caused continuing pain.

Award: \$465.00 (incl. pain and suffering \$350.00)

200-6327 The applicant is the mother of the victim, a 14 year old boy, who was shot by a pellet gun while riding a bicycle. The pellet lodged deeply in his right arm. The alleged offender had charges against him which were dismissed in Juvenile Court.

Award: \$600.00 (incl. pain and suffering \$600.00)

200-6331 The applicant, a 41 year old training school supervisor, was the victim of an assault by several unknown offenders. He sustained serious head and back injuries, and multiple bruises and lacerations.

Award: \$11,170.00 (incl. pain and suffering \$10,000.00)

200-6337 The applicant is the mother of the victim, a 6 year old girl who was kicked in the abdomen when she tried to stop the offender from stabbing her mother. She received a mild head injury and demonstrated the effects of psychological trauma. The offender was convicted of wounding and sentenced to three years in jail.

Award: \$1,630.00 (incl. pain and suffering \$1,500.00)

200-6344 The applicant, a 22 year old apprentice carpenter, was struck as he walked by the offender and a third man, who were fighting. He sustained fractures to the nasal bones and the maxilla, broken dentures, lacerations and bruises. The offender was convicted of assault causing bodily harm and fined \$400.00 plus 12 months probation.
Award: 2,839.45 (incl. pain and suffering \$2,000.00)

200-6347 The applicant, a 66 year old retired woman, was knocked down when her purse was stolen by the unknown offender. She sustained bruises and soreness to her left knee and wrist. She also suffered serious mental trauma.
Award: \$1,166.00 (incl. pain and suffering \$1,000.00)

200-6353 The applicant, a 26 year old police constable, was assaulted at a county fair. He sustained a swollen lower lip bruises. All three offenders were convicted of assaulting a peace officer and fined \$300.00 or 40 days in jail.
Award: \$400.00 (incl. pain and suffering \$400.00)

200-6368 The applicant, a 42 year old apartment superintendent, was assaulted when he tried to stop the offender from stealing signs. He sustained a fractured nose and bruises. The offender was convicted of assault causing bodily harm and fined \$200.00 or ten days in jail.
Award: \$950.00 (incl. pain and suffering \$800.00)

200-6376 The applicant, a 22 year old fork lift operator, was struck on the head with a metal object in a case of mistaken identity. He sustained lacerations to his skull. The offender was convicted of common assault and was fined \$300.00 or 30 days in jail.
Award: \$966.00 (incl. pain and suffering \$700.00)

200-6382 The applicant, a 67 year old retired woman, was pushed to the ground when her purse was snatched by an unknown offender. She sustained a fractured humerus.
Award: \$1,096.00 (incl. pain and suffering \$750.00)

200-6400 The applicant, a 43 year old labourer, was shot in the foot while sitting in a restaurant. The wound was not serious. The offender is unknown.

200-6404 The applicant, a 49 year old medical technician, was knocked down and robbed by two unknown men on a bicycle. She sustained bruises and lacerations to her right elbow and arm.

200-6412 The applicant, a 19 year old student, was assaulted by the unknown offender when a girl he was helping to climb over a fence fell. The applicant sustained a fractured nose, black eyes and a swollen lip.

200-6415 The applicant, an 18 year old labourer, was assaulted by two motorcycle gang members. He sustained lacerations and contusions of the face and back, and a fractured nose. The offenders were convicted of assault causing bodily harm and received jail sentences of three and six months.
Award: \$1,367.40 (incl. pain and suffering \$1,000.00)

200-6422 The applicant, a 53 year old woman, was punched in the nose by the offender when she tried to move a mop on the offender's balcony. She sustained a swollen nose. The offender was convicted of common assault and given an absolute discharge.
Award: \$300.00 (incl. pain and suffering \$300.00)

200-6433 The applicant is the sister of the victim, a 39 year old silversmith who was murdered. The offender was convicted of second degree murder and sentenced to 10 years imprisonment. The claim was for funeral expenses.

200-6438 The applicant, a 19 year old apprentice, and two friends were attacked when they prevented the offenders from stealing a tape deck from a car. 200-6925 The applicant, a 19 year old labourer, was assaulted without provocation and struck with a tire iron. He sustained fractured nasal bones. The offender was convicted of assault causing bodily harm and sentenced to 30 days in jail and one year probation.
Award: \$812.00 (incl. pain and suffering \$600.00)

200-6935 The applicant, a 21 year old labourer, was assaulted when he objected to the offender's harassment of a cripple. He sustained black eyes, a swollen nose, and painful ribs. The offender was found guilty of assault causing bodily harm and sentenced to 50 days imprisonment.
Award: \$500.00 (incl. pain and suffering \$500.00)

200-6942 The applicant, a 52 year old school janitor, was assaulted and robbed while returning from church. He sustained multiple contusions, abrasions and hematomae of the face. No offenders were apprehended.
Award: \$1,145.00 (incl. pain and suffering \$1,000.00)

200-6946 The applicant, a 54 year old bartender, was assaulted when he refused to serve the alleged offender. He sustained a sub-conjunctival haemorrhage. There is a warrant outstanding for the arrest of the alleged offender.
Award: \$510.32 (incl. pain and suffering \$500.00)

200-6960 The applicant, an 18 year old student, was the victim of an unprovoked attack. He sustained contusions to the lower lip and the loss of three teeth. One offender was convicted of assault causing bodily harm in this incident. Award: \$1,038.80 (incl. pain and suffering \$1,000.00)

200-6967 The applicant, a 58 year old labourer, was struck during a fight in a bar which did not involve him. He fell backwards, struck his head, and became paralyzed on the left side. The offender was convicted of common assault and sentenced to three months in jail. Award: \$5,000.00 (incl. pain and suffering \$5,000.00)

200-6976 The applicant, a 23 year old swimming pool attendant, was assaulted by two offenders whom he had told not to smoke in the pool area. He sustained a laceration to the lip and bruises. The two offenders were convicted of assault causing bodily harm: one was sentenced to three months in jail, and the other received a suspended sentence. Award: \$350.00 (incl. pain and suffering \$300.00)

200-6986 The applicant, a 60 year old woman, was assaulted by her daughter's estranged husband when he wanted to take out his sick child. She sustained a bump on her forehead and pain in her ribs and abdomen. The offender was convicted of assault causing bodily harm and sentenced to 10 days in jail or a fine of \$100.00. Award: \$1,056.00 (incl. pain and suffering \$750.00)

200-6992 The applicant, a 30 year old machine operator, was assaulted for reasons not easily discerned while intoxicated. He sustained a fractured skull, concussion and contusions. The alleged offender was acquitted because of lack of identification. The Board invoked Section 17(1) of the Act to reduce the award. Award: \$2,703.75 (incl. pain and suffering \$1,500.00)

200-7005 The applicant, a 29 year old labourer, was stabbed by the co-owner of his cottage while he was sleeping. He sustained a stab wound in the upper right abdomen and holes in the stomach, duodenum, pancreas, and inferior vena cava. It is doubtful he will ever be able to hold a permanent job. The offender was convicted of wounding and sentenced to two years less a day in jail plus probation and the condition that he receive psychiatric care. Award: \$16,500.00 (incl. pain and suffering \$7,500.00) Plus continuing monthly payments of \$500.00

200-7011 The applicant, a 20 year old kitchen helper, was the victim of an unprovoked assault on the subway. He sustained a swollen jaw and his glasses were broken. The offender was found guilty of common assault and given a suspended sentence with 12 months probation and paid \$100.00 restitution. Award: \$140.00 (incl. pain and suffering \$100.00)

200-7017 The applicant, a 27 year old unemployed man, was assaulted by the offender, who tried to coerce him into joining a motorcycle club. The applicant was slashed with a knife and sustained a laceration to his left wrist, severing all the extensor tendons and the superficial dorsal radial nerve. The offender was convicted of wounding and sentenced to one year imprisonment and two years probation. Award: \$1,666.00 (incl. pain and suffering \$1,200.00)

200-7021 The applicant, a 71 year old woman, was assaulted when her purse was stolen by an unknown offender. She sustained lacerations, bruises, and a dislocation and fracture of the shoulder. Award: \$1,334.17 (incl. pain and suffering \$1,000.00)

200-7029 The applicant, a 21 year old labourer, was assaulted during a soccer game by the offender, a member of the opposing team. He sustained lacerations, a fractured nose which had long term problems and two black eyes. The offender was convicted of assault causing bodily harm and given a one year conditional discharge. Award: \$1,647.75 (incl. pain and suffering \$1,200.00)

200-7036 The applicant is the father of the victim, a 14 year old girl who had been murdered. The two offenders were convicted of murder and sentenced to life imprisonment. The award was for expenses to the applicant and his wife. Award: \$1,466.60

200-7043 The applicant, a 41 year old taxi driver, was assaulted by his passengers during a dispute over the fare. He sustained multiple abrasions and lacerations to his face, elbows and knees. The offenders were convicted of common assault and sentenced to seven days in jail and a \$100.00 fine. Award: \$1,520.00 (incl. pain and suffering \$750.00)

200-7050 The applicant, a 23 year old nursing assistant, was assaulted without provocation by the alleged offender, a patient. She sustained a separation of the left ribs from the sternum. No charges were laid against the patient. Award: \$1,946.39 (incl. pain and suffering \$1,500.00)

200-7052 The applicant, a 29 year old police constable, was grabbed around the neck while transporting the offender to the police station. He sustained a sprained neck. The offender was convicted of being intoxicated in a public place and fined \$25.00. Award: \$500.00 (incl. pain and suffering \$500.00)

200-7055 The applicant, a 51 year old housewife, was attacked with a knife by the offender, who was robbing her home. She sustained deep lacerations to the head, chest, arm and hands. The offender was convicted of wounding, attempted murder, robbery and break and enter, and was sentenced to 12 years imprisonment.

Award: \$2,970.25 (incl. pain and suffering \$2,500.00)

200-7059 The applicant, a 24 year old police constable, was assaulted when she arrested the offender for shoplifting. She sustained a fractured wrist. The offender was convicted of assault causing bodily harm and sentenced to one month in jail.

Award: \$350.00 (incl. pain and suffering \$350.00)

200-7145 The applicant, a 25 year old order clerk, was pushed onto the subway tracks by the offender while waiting for the train. She sustained a fractured left elbow and bruises to her face, legs and body. The offender committed suicide.

200-7279 The applicant, a 38 year old sales representative, was assaulted by the offenders who he had warned not to smoke marijuana in the lounge he was patronizing. 200-6507 The applicant is the mother of the victim, a 2½ year old child who saw his mother assaulted.
Award: \$2,180.00 (incl. pain and suffering \$2,000.00)

200-6514 The applicant is the Official Guardian. The victim, an infant, was assaulted by her father and his wife.
Award: \$3,000.00 (incl. pain and suffering \$3,000.00)

200-6561 The applicant, a 21 year old waitress, was the victim of indecent assault.
Award: \$1,706.00 (incl. pain and suffering \$1,000.00)

200-6574 The applicant, a 47 year old police officer, was assaulted.
Award: \$800.00 (incl. pain and suffering \$800.00)

200-6645 The applicant, a 24 year old teacher, was the victim of attempted rape and assault causing bodily harm.
Award: \$4,826.75 (incl. pain and suffering \$4,500.00)

200-6852 The applicant, a 50 year old sales clerk, was the victim of an indecent assault.
Award: \$1,058.80 (incl. pain and suffering \$1,000.00)

200-7140 The applicant, a 29 year old treasury assistant, was the victim of indecent assault.
Award: \$3,000.00 (incl. pain and suffering \$2,500.00)

200-7210 The applicant, a 23 year old investigator, was raped and assaulted.
Award: \$5,359.00 (incl. pain and suffering \$5,000.00)

200-7316 The applicant, a 43 year old taxi driver, was raped in her taxi.
Award: \$2,800.07 (incl. pain and suffering \$2,500.00)

200-7346 The applicant is the mother of the victim, a 9 year old boy who was the victim of indecent assault.
Award: \$1,872.00 (incl. pain and suffering \$1,500.00)

SUMMARY OF DISALLOWED APPLICATIONS

200-1759 The applicant, a 21 year old driver, was arrested by the Metropolitan Police Department and transferred to the Chingacousy Police Department. While in custody, it was discovered that the applicant was ill. He had bacterial meningitis and a subdural haematoma which could have resulted either from a head injury or the meningitis. The Board found that the applicant was not a victim of a crime of violence under Section 5 of the Act, and denied the application.

200-1980 The applicant is the wife of the deceased and asked only for funeral expenses. The Board was unable to find that the victim was a victim of a crime of violence within the meaning of Section 5 of the Act. The Board therefore denied the application.

200-2907 The applicant, a 29 year old musician, was harassed by three men in a car while he was driving. The applicant radioed the police and followed the men and was involved in a minor accident with their car. The Board denied the application because a crime of violence within the meaning of Section 5 of the Act had not occurred. The Board also invoked Section 17(1a) of the Act.

200-3138 The applicant, a 19 year old student, confronted a person who had made a derogatory remark to him. The offender struck the applicant in the nose, fracturing it and chipping a tooth. The offender was convicted of assault causing bodily harm and fined \$200.00. The Board invoked Section 17(1) and Section 17(1a) to deny the application.

200-3380 The applicant, a 19 year old clerk, received injuries as a result of the explosion of a home-made bomb. He claimed that he had been handed the object and it exploded in his hand. Police investigation revealed that the applicant had been implicated in the building of several such devices, which would not explode spontaneously. The Board denied the application.

200-3540 The applicant, a 27 year old pressman, was drinking in a bar. He left for a few minutes and returned with an injured jaw. He had no recollection of how it happened. The Board could not conclude that the applicant's injuries resulted from a crime of violence within the meaning of Section 5. Further, the Board invoked Section 17(1a) to deny the application.

200-3624 The applicant, a 27 year old labourer, was slashed by a knife as he left a tavern. There was significant discrepancies between the testimony he gave to the Board and the statement he had given to the police. It was clear that the applicant was intoxicated at the time of the assault. The Board denied the application.

200-3791 The applicant, a 53 year old woman, was involved in a fight in the elevator of a building owned by her family. Criminal charges were laid against both the offender and the applicant. Both were convicted. The Board cited Section 17(1) of the Act to deny the application.

200-3920 The applicant, a 37 year old account supervisor, was with a female friend and picked up two strangers, a male and a female. They engaged in sexual activities in the applicant's apartment, after which the two offenders robbed and stabbed the applicant. The Board invoked Section 17(1) of the Act to deny the application.

200-4002 The applicant, a 37 year old worker, was involved in a dispute with a co-worker. The applicant claimed that there had been a racial slur. His employers characterized him as a troublemaker. Charges against the offender were dismissed. The Board invoked Section 17(1) and Section 17(1a) of the Act to deny the application. Interpreter's fees were awarded.
Award: \$100.00

200-4037 The applicant, a 21 year old mechanic, was involved in an accident. The driver of the other car punched him and the applicant then threatened the other driver with a stick. A brawl ensued, during which the applicant was kicked in the eye. The Board held that by using the stick, the applicant contributed to his injury and invoked Section 17(1) of the Act to deny the application.

200-4045 The applicant is the mother of the victim, a 14 year old boy. He was struck in the eye by a piece of wire held by his friend. The Board found that no crime of violence took place, and that the application did not come within Section 5 of the Act.

200-4206 The applicant, a 61 year old unemployed and disabled man, met a prostitute he knew in a bar. Her two companions beat and robbed him. One offender was convicted of assault and a bench warrant is outstanding on the other. The Board invoked Section 17(1) of the Act to deny the application.

200-4232 The applicant, a 30 year old janitor, was involved in a brawl outside a tavern. He received an injured knee. Both the alleged offenders and the applicant were charged, but all charges were dismissed or withdrawn. The Board invoked Section 17(1) of the Act to deny the application.

200-4434 The applicant is the wife of the victim, a 47 year old night watchman who was shot to death by a 16 year old boy he had picked to engage with in homosexual activities. This boy claimed that the victim had attempted to force him with a gun to perform certain acts, and that in a struggle the victim had been shot. The Board invoked Section 17(1) of the Act to deny the application.

200-4633 The applicant, a 47 year old postal employee, was injured in a fight between himself and a friend which occurred when both men were intoxicated. The applicant could not remember the cause of either the fight or his injuries. The Board invoked Section 17(1) of the Act to deny the application.

200-4667 The applicant, a 40 year old electrician, claimed he was assaulted without provocation. His friend called the police and when they arrived, the applicant was uncooperative and abusive. He did not lay a charge against the alleged offender. The Board cited Section 17(1a) of the Act to deny the application.

200-4707 The applicant, a 51 year old contractor, claimed he was assaulted by a taxi driver. The police said that the applicant was intoxicated, did not lay charges and changed his story several times. The Board, having regard to all this, invoked Sections 17(1) and 17(1a) of the Act to deny the application.

200-4760 The applicant, a 31 year old truckdriver, was assaulted and robbed by unknown offenders. He was known as a gambler and bookmaker and at the time of his assault owed \$12,000.00 in gambling debts. The Board cited Section 17(1) of the Act to deny the application.

200-4933 The applicant, a 22 year old student, was intoxicated when he turned on the television in his university residence at 2:00 a.m. When the alleged offender asked him to turn it off, the applicant threatened him with his karate expertise. The alleged offender then struck the applicant with a metal bar. The Board invoked Section 17(1) of the Act to deny the application.

200-5152 The applicant, a 59 year farm worker, was lacerated in a bar room fight. The police reported that the applicant had been intoxicated and had provoked the fight. The Board therefore invoked Section 17(1) of the Act to deny the application.

200-5215 The applicant, a 43 year old welfare recipient, received a concussion while in an intoxicated state, and gave conflicting evidence as to how it was inflicted. He did not report to the police until two months after the alleged crime. The Board invoked Section 17(1) and 17(1a) to deny the application.

200-5327 The applicant, a 19 year old carpenter, was shot in the back by a man who thought he was a prowler. The applicant claimed he was relieving himself, but the offender claimed that he was looking into a ground floor window. The applicant had previous convictions for trespassing and was on probation. The Board cited Section 17(1) to deny the application.

200-5377 The applicant, a 24 year old painter, was assaulted in a hotel parking lot. He was intoxicated, refused to assist the police, and was violent in the

ambulance. The Board therefore invoked Sections 17(1) and 17(1a) of the Act to deny the application.

200-5402 The applicant, a 29 year old teacher, was involved in a fight while returning from a pub. His medical claims could not be supported by the medical reports. The Board was of the opinion that the fight could have been avoided and invoked Section 17(1) of the Act to deny the application.

200-5441 The applicant, a 33 year old miner, claimed he was assaulted by an unknown hitch-hiker. The police evidence showed that he was intoxicated. There were many inconsistencies in the various tellings of the applicant's story. The Board therefore found that the applicant did not establish that he was a victim of a crime of violence.

200-5485 The applicant, a 25 year old bar bouncer, was assaulted at a party. He did not report it to police for two weeks. He claimed he was afraid. The police stated that he had said that he wanted to settle the affair in his own way. The Board invoked Section 17(1a) to deny the application.

200-5556 The applicant, a 77 year old man, claimed his leg was broken when he was arrested by the police. Medical records showed the he told the hospital that he had fallen off a curb. The Board found that the applicant was not a victim of a crime of violence.

200-5604 The applicant, a 15 year old male, was attacked by three youths, and sustained a fractured jaw. It was apparent from testimony that the applicant was a fighter and a trouble-maker, and intimidated others. The Board therefore invoked Section 17(1) of the Act to deny the application.

200-5642 The applicant, a 40 year old decorator, received injuries to his head which left him with brain damage. He claimed that he had been struck on the head by unknown persons in a restaurant. Witnesses claimed that he had fallen down a set of stairs. The Board therefore was unable to establish that the applicant was the victim of a crime of violence and denied the application.

200-5758 The applicant, a 27 year old factory worker, was stabbed during a fight. Evidence showed that he struck the first blow with a length of chain. The Board invoked Section 17(1) to deny the application.

200-5830 The applicant, a 26 year old foreman, was struck with a baseball bat on the head. The police stated that he approached the offender to fight him, and was intoxicated. The Board therefore invoked Section 17(1) of the Act to deny the application.

200-5896 The applicant, a 45 year old optical technician, was struck in the face with a glass while in a tavern. Testimony showed that he was intoxicated and had provoked the offender. The Board therefore invoked Section 17(1) of the Act to deny the application.

200-5975 The applicant, a 22 year old accountant, was injured by a hockey stick while playing hockey. He laid a private charge against the alleged offender, who was acquitted by the trial judge because there was no intent. The Board accepted the reasoning of the trial judge and found that the applicant was not the victim of a crime of violence. The application was therefore denied.

200-6019 The applicant claimed for herself and her two young children, who were abducted by the woman's mother during a custody battle. The only claim was for pain and suffering as a result of "nervous shock". As the children were comfortable and unalarmed with their grandmother, and the applicant knew where they were, the Board found that "nervous shock" was not suffered. The application was denied.

200-6060 The applicant is the father of the victim, a 20 year old labourer who died after being punched once in the face. The drug P.C.P. was found on the person of the victim, and the circumstances of his death were similar to those of an overdose of that drug. Medical opinion was that the victim would not have died if he had not been under the influence of drugs. The Board therefore invoked Section 17(1) of the Act to deny the application.

200-6098 The applicant, a 21 year old taxi dispatcher, followed home a man with whom he had had a fight. As he sat in his own car outside the offender's home, the offender assaulted him with a tennis racket. The Board cited Section 17(1) of the Act to deny the application.

200-6261 The applicant, a 22 year old student, claimed she was assaulted and raped by two men as a result of a dispute over money. She did not call the police for 27 hours, at first refused to make a complaint, and then failed to testify at the alleged offender's trial. The Board therefore invoked Section 17(1a) to deny the application.

200-6320 The applicant, a 19 year old labourer, was assaulted by a man who was intoxicated and angry about the loss of some money. Knowing this, the applicant met the offender outside of the tavern which they were in when asked to. The Board invoked Section 17(1) of the Act to deny the application.

200-6356 The applicant, a 19 year old labourer, was stabbed when he and a companion attempted to join a group of people to drink. The applicant was already intoxicated, and he forced himself upon these people. The Board invoked Section 17(1) of the Act to deny the application.

200-6425 The applicant, a 30 year old cook, was involved in a bar room fight, and was cut in the face with a broken glass. He and the offender broke a glass and a bottle to fight with simultaneously. The Board invoked Section 17(1) to deny the application.

200-6546 The applicant, a 51 year old tire builder, was assaulted by the father of a juvenile he believed had damaged his son's car. The offender thought the applicant was going to harm his son. The Board considered that the applicant was taking the law into his own hands and cited Section 17(1) of the Act to deny the application.

200-6578 The applicant, a 19 year old plumbing apprentice, agreed to fight the offender. He was struck over the head with a jack handle. The applicant never reported the incident to the police, and did not appear before a Justice-of-the-Peace for almost two months. The Board therefore invoked Sections 17(1) and 17(1a) to deny the application.

200-6586 The applicant, an 83 year old woman, was knocked over by one of a group of boys who were running backwards in play. The Board found that she was not a victim of a crime of violence and the application was therefore denied.

200-6618 The applicant, a 21 year old unemployed man, was assaulted after he kicked the offender and told him to "get lost". Both the offender and the applicant were intoxicated. The Board invoked Section 17(1) of the Act to deny the application. However, the Board made an allowance for costs under Section 21 of the Act.
Award: \$306.00

200-6708 The applicant, a 65 year old farmer, was injured when he fell out of a barn. He contacted the police 18 days later and claimed he had been pushed out. The police concluded that he had fallen. The Board found that the applicant had not been the victim of a crime of violence, and denied the application.

200-6769 The applicant, a 31 year old labourer, was refused a beer at a friend's house because he was already intoxicated. He was struck over the head with a bottle, but the police concluded that he attacked the offender first. The Board therefore invoked Section 17(1) to deny the application.

200-6899 The applicant, a 28 year old welfare recipient, was assaulted by the man she was living with. He had assaulted her before, and she knew of his criminal record. The applicant was belligerent and uncooperative with the police, refusing to give them any information. The Board invoked Section 17(1) and Section 17(1a) to deny the application.

200-6939 The applicant, a 17 year old student, was stabbed during a fight he had willingly entered into. He had seen the offender's knife, and suspected that

he was on some sort of drug before the fight. The Board invoked Section 17(1) of the Act to deny the application.

200-6997 The applicant, a 55 year old disability pensioner, was involved in an argument with the alleged offender's mother. The alleged offender told the applicant to go away. The applicant attacked him with a carpet knife as he left. The applicant was convicted of assault causing bodily harm and sentenced to 18 months probation. The alleged offender was not charged. The Board invoked Section 17(1) to deny the application.

200-7013 The applicant, a 26 year old ambulance driver, was kicked by a patient who was on a stretcher. Charges against the alleged offender were dismissed since there was no evidence of intent. The Board concluded that the applicant was not the victim of a crime of violence and denied the application.

200-7057 The applicant, an 18 year old mechanic, claimed he was assaulted without provocation by an unknown offender. He did not report the incident to the police for two days and refused reasonable cooperation with them. The Board invoked Section 17(1a) of the Act to deny the application.

200-7165 The applicant, a 40 year old unemployed woman, was assaulted while moving out of her apartment. She claimed she was sexually assaulted, although the police had no record of that. She never laid charges against the alleged offender. The Board cited Section 17(1a) of the Act to deny the application.
