- **“Don’t Shake the Baby” Contacts.** This national public awareness campaign, organized in the 50 States, the District of Columbia, and Puerto Rico, focuses on decreasing the incidence of shaken baby syndrome and thereby decreasing the number of deaths and disabilities caused by child maltreatment.
- **Parents Anonymous, Inc., Contacts.** This parent self-help program sponsors neighborhood-based support groups throughout the United States and in several foreign countries.
- **Prevent Child Abuse America State Contacts.** This not-for-profit, volunteer-based organization is committed to the prevention of child maltreatment through education, research, public awareness, and advocacy services to community members.
