We empower grantees by taking a mindful and genuine approach that builds on their existing strengths, resources, and capacities.

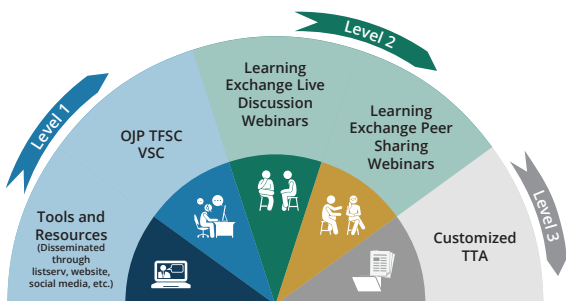
