## JUVENILE JUSTICE COORDINATING COUNCIL TO DISCUSS THE IMPACT OF JUVENILE REENTRY PROGRAMS

WASHINGTON — Members of the Federal Coordinating Council on Juvenile Justice and Delinquency Prevention will convene March. 4 at the Office of Justice Programs to discuss opportunities for federal partnerships that support delinquency prevention and intervention programs for youth.
