JUSTICE DEPARTMENT INVESTS MORE THAN \$43 MILLION IN RESEARCH THAT SUPPORTS PUBLIC SAFETY PRACTICES

WASHINGTON, DC – The Justice Department's Office of Justice Programs today announced it has awarded more than\$43 million to more than 50 institutions, agencies and organizations for research and evaluation projects that identify data-driven programs for reducing crime and promoting justice. The awards span research topic priorities such as prisoner reentry, human trafficking, forensic science and police officer safety and wellness.

The FY 2020 awards include the following:

Assessing the Effectiveness of the Second Chance Act Grant Program: A Phased Evaluation Approach

NIJ awarded more than \$1.1 million to support research to evaluate the effectiveness of the Second Chance Act grant program in improving reentry and reducing recidivism.

Longitudinal Research on Delinquency and Crime

NIJ awarded more than \$3.3 million to conduct an expansion or extension of one or more ongoing longitudinal research studies that focus on delinquency and crime throughout the life-

course of the individual. The research findings will inform efforts to prevent the onset of delinquency and to intervene in the lives of juvenile and young adult offenders.

National Youth Gang Survey

Research and Evaluation in Safety, Health and Wellness in Criminal Justice System
