# DEPARTMENT OF JUSTICE INVESTS MORE THAN \$87 MILLION IN GRANTS TO ADDRESS SCHOOL VIOLENCE

WASHINGTON – In 2018, Congress passed the Student, Teachers, and Officers Preventing School Violence Act of 2018 (STOP School Violence Act). Among its provisions, the Act authorizes the Department of Justice to manage grant programs that support states, local governments and federally recognized Indian tribes to prevent and reduce school violence.

STOP School Violence, a program of the Office of Justice Programs' Bureau of Justice Assistance, is designed to improve school security by providing students and teachers with the tools they need to recognize, respond quickly to and help prevent acts of violence. In addition to STOP School Violence Act funding, OJP's National Institute of Justice is investing in research on school violence.

### BJA's STOP School Violence Program

Category I - States: Train school personnel and educate students on preventing student violence against others and themselves, to include anti-bullying training. This can also include specialized training for school officials to respond to mental health crises.
