### **NEW Project Period Learning Path**

We now have two courses available on the topic of Project Period Extensions.

- Course #1 is Introduction to Project Period Extensions.
- Course #2 is Project Period Extension Grant Award Modification (GAM). Please see



the description below for what is covered in each course.

• The final course, Course #3 will cover the Budget Modification GAM. This course is still under construction.

When you submit the code, you will receive an email to access the training.

**Course #1 (30 minutes)** -Introduction to Project Period Extensions - This course covers the requirements and criteria for submitting a project period extension, the process for requesting an extension, and how to receive additional support during this process.

**Course #2 (30 minutes)** –Project Period Extension Grant Award Modification (GAM) – This course covers how to discuss the extension process with your Grant Manager, prepare a justification and a revised project timeline, and submit the Project Period Extension GAM.

## **TFMC Spotlight**

#### **Meet April Bird**



April Bird Tribal Financial Management Center (TFMC) Lead Financial Specialist

April is a member of the Eastern Band of Cherokee Indians in North Carolina. "I have always wanted to help other tribes with the knowledge that I have received here on my reservation or on the Qualia boundary," said April Bird. She has for four years worked as a Lead Financial Specialist for the Tribal Financial Management Center (TFMC) and helped many tribes find potential financial resources and succeed in achieving their goals. She leads the training and technical assistance team (TIA) who help tribes across the lower 48 and in Alaska with the financial aspects of their TVSSA awards and the CTAS Purpose Area 6.

She shares her knowledge of budgeting, finance, and financial management tools with grantees so they can then help their victims of crime.

One of the best changes she has recently seen is the growth in grantees' recognizing TFMC as people who can assist with their budgets, reporting, and financial reporting. "They will say, 'You helped me with this before. Can you

help me with this again?" said Bird, which they gladly continued helping them. If onsite meetings aren't possible, there are always virtual office hours. Virtual office hours allow grantees to join a call and share questions and answers. "It's beneficial to the grantees because they may have something [such as similar questions] along the same lines as someone else," said Bird. Questions may range from do I have to do a budget modification, or do I have to let my grant manager know? Grantees who attend the virtual office hours gain knowledge through listening to other people's questions and answers.

Some virtual office hours may be topic specific such as project period extensions. They may also have virtual breakout rooms where financial specialists can meet individually with a grantee. Once grantees have been assisted then they are brought back into the main virtual room. This method also allows grantees to gain knowledge through a one-on-one interaction. Meeting this way also helps grantees fulfill a requirement of the award, which is to pass the Grant Financial Management Training (GFMT). By providing these different

communication options, grantees can comfortably communicate and get their questions answered.

She hopes to continue helping grantees gain the financial knowledge they need so that they can successfully grow their victims of crime programs and assist their victims. There still exist many areas that desperate need these services for women and men of domestic violence. "If we can make just a small difference to help these grantees get their funding and be able to draw down their funds so that they can create things like safe places, it makes me feel better about the work that I do. And it makes me want to be successful and help as many people as I can."

NIJ FY24 Research on the Abuse, Neglect, and Financial Exploitation of Older Adults

The NIJ seeks applications for funding for rigorous research and evaluation projects in four topical areas:

- Evaluation of programs that seek to prevent, intervene in, or respond to the abuse, neglect, and financial exploitation of older adults.
- Evaluation of prevention and education programs related to financial fraud and exploitation of older adults.
- Research on individuals who abuse (either financially, physically, sexually, and/or emotionally) or neglect older adults.
- Forensic research involving the development of radiographic evidence and bioinformatic approaches relevant to the physical abuse of older adults.

**Reminder: JustGrants Account Management and Security Policy** Don't forget to log in to your JustGrants account **at least once every 90 days!** Accounts that are inactive for 90 days are disabled. You also must also change your password every 90 days. You can reset your password at any time while your account is active.

If your account is disabled and you need to reactivate it, you must contact the <u>JustGrants service desk</u> to first reactivate your account. The service desk will then email you to initiate your password reset. Only the Entity Administrator <u>can assign</u> <u>appropriate roles</u> to all users from your organization in JustGrants. An active Entity Administrator is critical for timely application submission and management of awards. An entity cannot apply for DOJ funding opportunities if an Entity Administrator's account is disabled due to inactivity, so it is critical to keep the account active.
