TFMC Coordinated Tribal Assistance Solicitation Orientation

Thank you to everyone who joined us for the Coordinated Tribal Assistance Solicitation Orientation (CTAS) orientation, January 14–15, in Seattle, WA. This orientation brought together 17 attendees from 10 different entities, including 12 Purpose Area 6 grantees. TFMC financial specialists provided technical assistance and covered topics such as budget clearance, budget modifications, FFRs, and financial policies and had in-depth discussions about indirect cost rates and agreements. In addition, grantees participated in financial training for certification. The orientation provided valuable guidance to support Purpose Area 6 grantees in navigating financial compliance and grant management.

TFMC Spotlight

Meet Francine Andrew

For the past 3 years, Francine Andrew has been a driving force in strengthening the tribal justice system and supporting her community.

A key factor in Francine's success has been the support of TFMC, which she credits for making her work more efficient and impactful. She speaks highly of the invaluable training and resources TFMC provides, particularly the open office hours in Seattle, WA, which allowed her to gain best practices and strategies for effective grants management. This guidance has been instrumental in navigating the complexities of



securing and utilizing funding to enhance tribal justice initiatives.

Additionally, her technical specialist played a crucial role in helping her develop stronger time management skills and guiding her through the process of creating a detailed budget—a skill that has been essential in securing and managing funding.

Starting as a tribal courts planner and now serving as both the tribal courts director and OVC coordinator for the Ohogamiut Traditional Council, Francine has dedicated herself to ensuring her people have access to a fair and effective tribal court system. Through her leadership, she has successfully passed four tribal court codes, completed a comprehensive tribal court assessment, and managed over half a million dollars in funding to strengthen judicial services.

Beyond her legal work, Francine is deeply committed to community service. She volunteers at a food bank operated by the Marshall Traditional Council, her tribe's sister community, ensuring families have access to essential resources.

However, her most pressing mission is establishing a women's shelter—a critical need in her region that she is determined to address, reinforcing her dedication to justice and support for those most vulnerable in her community.

The shelter serves as a vital lifeline for women in crisis. With OVC resources, Francine has created outreach materials, distributing brochures at clinics and community spaces to raise awareness about available services.

One of her greatest achievements has been directly assisting women by providing resources, emergency contacts, and even plane tickets to ensure their safety. Though proud of her impact, staffing remains a major challenge. For years, she managed everything alone, but with newly available resources, she can now build a team to establish a fully functioning tribal court and the much-needed women's shelter.

Looking ahead, Francine is excited about the future because she now has the resources to grow her team and expand her work. Her advice to anyone interested in the field of tribal justice and community service is simple but powerful: "The work might be hard, and you may not have a lot of resources, but don't let that stop you. Just keep going. Teach yourself, and things will get better in the long run."

National Crime Victim's Rights Week 2025 April 6–12, 2025

Every April, OVC leads communities throughout the country in their annual observances of National Crime Victims' Rights Week (NCVRW).

This year's theme of KINSHIP is a call to action to recognize that shared humanity should be at the center of supporting all survivors and victims of crime. KINSHIP is a state of being with survivors that drives vital connections and increases access to services, rights, and healing. KINSHIP is where victim advocacy begins.

Federal Financial Reports (known as the "SF-425" or the "FFR") are due quarterly as follows:

Reporting Quarter

January 1 — March 31

Due No Later Than

April 30
